


Appeal u/s 4 of Service Tribunal Act against the office order No.129-30 dated 05/01/2013 passed by respondent No 3 vide which mutual exchange of post of respondent No.4 & 5 is based on malafide intention and ineffective upon the right of the appellant, which is illegal against law and facts.

Respectfully Sheweth,

1. That appellant was serving PST teacher in Govt Primary School Hoti Jalander Bagh Mardan.

- 2. That petitioner was most senior teacher in Government Primary School Haji Marban.
- 3. That petitioner was promoted to B-15 according to the promotion/upgrade of P213 B-15 to B-14 and P213 B-14 to P213 B-15 vide Government of KPK elementary and secondary Education Notification No. 20(B&A) vide Endst No 3062-G dated 26/3/2013. (Copy of Notification No. 20(B&A) vide Endst No 3062-G dated 26/3/2013 is attached as annex A)
- 4. That as per posting on promotion policy, senior most P213 B-15 will be retained in their present posting in same school as per the seniority list. Copy of that petitioner was entitled to retained in their present school, but after promotion he was adjusted in G2 Jalander Bagh vide notification dated 26/03/2013 and respondent No.4 with malafide intention mutual exchanged the post with respondent No.2, because respondent No.2 was senior than petitioner and planned to retained in the same school as P213. (Copy of Notification dated 13/02/2013 is attached as annex B)
- 6. That appellant filed departmental appeal on 10/01/2013 against the impugned order No.129-30 dated 02/01/2013 which remained un-responded even after lapse of 90 days. (Copy of departmental appeal is attached as annex C)
- 7. That impugned office order No.129-30 dated 02/01/2013 and adjustment of appellant at G2 Jalander Bagh Marban is illegal against law and facts on the following grounds. (Copy of impugned office order No.129-30 dated 02/01/2013 is attached as annex D)
- a. That impugned office letter No.129-30 dated 02/01/2013 issued from the office of respondent No.3 regarding mutual transfer of respondent No.4 and 2 is illegal against law and facts.
- b. That petitioner was entitled to retain in their present school, but after promotion he was adjusted in G2 Jalander Bagh.


GRANDS

- c. That respondent No.4 with malafide intention mutual exchanged the post with respondent No.5, because respondent No.4 was senior then petitioner and planned to retain the post in the same school as HPST.
- d. That appellant was most senior teacher in GPS Hoti while due to impugned office letter, appellant was adjusted in GPS Galandar bagh, which is against the posting on promotion policy.
- e. That again on 01/04/2013 appellant requested to the competent authority against the impugned office order, but competent authority didn't respond. (Copy of application dated 01/04/2013 is attached as annex E)
- f. That primary object of the court is to give justice and to decide the case on the bases of material on record.

So it is therefore humble prayed that impugned order No.129-30 dated 05/01/2013 may please be set aside and the appellant may please be permitted to continue the services on GPS Hoti Mardan as HPST. Any other relief deemed fit may also be graciously granted in favour of the appellant.

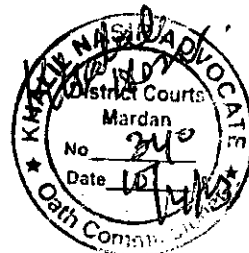

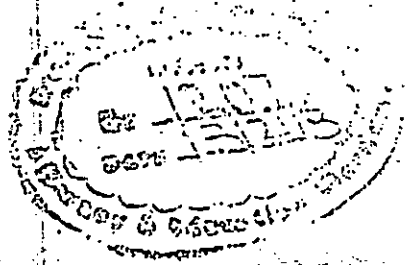

4. On Promotion of PST B-12 to the post of Senior PST B-14 and PSHT B-15, may be posted in the same UCs Subject to the provisions of sanctioned post.
5. Senior most PSHT B-15, SPST B-14 & PST B-12 (According to the Seniority list) may be retained in the school of their present posting and junior most may be transferred to other schools.
6. In their promotion order it should be mentioned that their Inter-seniority on lower post will remain intact.
7. If anyone forego promotion, Entry to this effect may be made in his/her Service book.
8. Minimum qualifications for the above posts have already been prescribed in the Service Rules notified vide Government of Khyber Pakhtunkhwa Elementary and Secondary Education Department Notification No. SO (PE) 4-5/2010 Meeting/2012/Teaching Cadre Dated the November 13, 2012.

For further directed to further clarify that:

1. On promotion Qari B-12 to the post of Senior Qari B-15, CT B-15 to Senior CT B-16, AT B-15 to Senior AT B-16, TT-15 to Senior TT B-16, DM B-15 to Senior DM B-16 and PET B-15 to Senior PET B-16, will be posted in High and Higher Secondary Schools.
2. 1/3 Qari B-12 posts will be upgraded to Senior Qari B-15, CT B-15 to Senior CT B-16, AT B-15 to Senior AT B-16, TT-15 to Senior TT B-16, DM B-15 to Senior DM B-16 and PET B-15 to Senior PET B-16 in High and Higher Secondary Schools only in Elementary and Secondary Education Department at District Level.
