





Prayer:- To set aside the orders of respondents No.1 and 2 vide corrigendum No. 6263-66 dated 18.2.2013 and endorsement No. 7115-29 dated 5.3.2013 and the appellant may kindly be transferred to Sardar Garhi.

Respectfully Sheweth:

1. That appellant was appointed as a Primary School Teacher in the Education Department vide order dated 1.5.1975.
2. That the appellant was appointed in Government Primary School Audit Colony Kohat Road, Peshawar.
3. That the appellant performed his duties in the said School for the last 38 years without any complaint from the general public of the locality as well as from the department concerned.
4. That the appellant was promoted as Senior Head Teacher Primary School BPS-15 on 6.2.2013 and, therefore, he was transferred vide Notification No. 3570-4102/ADJ/PSHT dated 6.2.2013 to Village Sardar Garhi. (Copy of the order dated 6.2.2013 is attached as annexure 'A').
5. That without any reason and for malafide intention the appellant was transferred vide Corrigendum No. 6263-66 dated 18.2.2013 to Village Fazil Garhi. (Copy of the corrigendum dated 18.2.2013 is attached as Annexure 'B').
6. That the appellant then was transferred vide Endorsement No. 7115-29 dated 5.3.2013 to Village Rano Garhi. (Copy of the order dated 5.3.2013 is attached as annexure 'C').
7. That the appellant submits that the orders dated 18.2.2013 and 5.3.2013 may kindly be set aside on the following grounds inter alias:-

GROUNDS:

3

- a. That the orders of the authority are against law and facts on the record.
- b. That the authority has not consulted the relevant law on the subject and thus the orders are not according to law.
- c. That the orders of the respondents are based upon malafide and want to punish the appellant without any reason.
- d. That from the orders it is quite clear that on 6.2.2013 the appellant was transferred to Sardar Garhi, on 18.2.2013 the appellant was transferred to Fazil Garhi and on 5.3.2013 the appellant was transferred to Rano Garhi which clearly show the malafide of the respondents.
- e. That on account of political pressure the appellant is transferred from one place to another and from another place to another without showing any good reason.
- f. That the appellant is the resident of Village Sardar Garhi, therefore, according to law he will perform his service in Village Sardar Garhi.
- g. That the appellant is going to be retired from service in the next two years, therefore, according to law he will perform his services in Village Sardar Garhi.
- h. That in a few days 3 transfer orders were passed against the appellant which clearly show that the appellant is being punished by the respondents concerned for no reasons.
- i. That the respondents have made the appellant as a shuttle cock and his transferred without any reason from one place to another.
- j. That the appellant is a Heart patient and the Doctors have advised him not to travel for more distance.

- k. That the appellant also submitted appeal but instead of cancellation of his transfer he was further transferred to Village Rano Garhi. (Copies of the appeal dated 28.2.2013 and order dated 5.3.2013 are attached as annexures 'E' & 'F' respectively).
- l. That the persons who will take charge from the appellant belongs to Village Wadpaga which is attached to Village Rano Garhi, therefore, the transfer of Ihsan Ullah Shah is more beneficial if he is transferred to Village Rano Garhi. In the same manner Misal Khan is also the resident of Village Rano Garhi so it is also proper to transfer Misal Khan to Village Rano Garhi.
- m. That the respondents have violated the mandatory provision of law.


It is, therefore, respectfully prayed that on acceptance of this service appeal the Corrigendum No. 6263-66 dated 18.2.2013 and Transfer Order No. 7115-29 dated 5.3.2013 may kindly be set aside and the appellant may kindly be transferred to Village Sardar Garhi.

Any other relief though not specifically asked for to which the appellant is found entitled in the circumstances of the case may also be granted in favour of the appellant against the respondents.





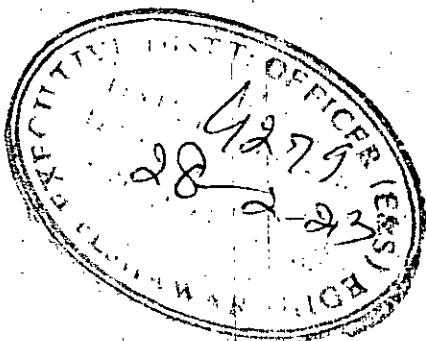
