

Contended that the appellant was appointed in the respondent department in the year 1992. While working as C.T Teacher at GHS Nawagai, the appellant was transferred to GHS Ashary on 12.1.2013. The appellant preferred a departmental appeal on 14.1.2013 which was rejected on 11.2.2013 by stating the reason that the transfer has been made on the basis of long tenure at GHS Nawagai. It transpires that the appellant was posted at GHS Nawagai in the year 1996 and remained there for about 7 years and was transferred, as such there seems no illegality in the impugned transfer order. Counsel for the appellant stated that the appellant has been transferred in order to create vacancy for another person. There is no merit in the appeal and the same is hereby dismissed in limine. File be consigned to the record.



Respectfully Sheweth:

Appellant very humbly submits as under:

1. That appellant was posted as C.T teacher at G.H.S Nawagai and performing his duties very efficiently and honestly.
2. That on 12 / 01 / 2013 respondent has issued the impugned transfer letter of appellant from G.H.S Nawagai to G.H.S Ashary without any need and tainted with Malafide intentions & in utter disregard of procedure available on the subject of transfer.
(copy of transfer order is attached herewith as Annexure "A")
3. That feeling aggrieved from the above said order of transfer appellant filed departmental appeal on 14 / 01 / 2013 to the respondent no 1.
(Copy of the departmental appeal is attached herewith as Annexure "B")
4. That the departmental appeal of the appellant is dismissed vide order no 12233 – 86 dated: 11 / 02 / 2013.
(copy of the departmental appeal dismissal order is attached herewith as Annexure "C")
5. That appellant mortally aggrieved from both the impugned order of transfer dated: 12 / 01 / 2013 and impugned order of dismissal of departmental appeal dated 11 / 02 / 2013 preferred this service appeal on the basis of following amongst other grounds , which are as under :-

GROUNDS

- (a) That the impugned order of transfer dated:- 12.01.2013 is illegal , perverse and against the law & respondents have not treated appellant in accordance with law , rules and policy available on subject and acted in violation of art – 4 alongwith other relevant articles of the constitution of Islamic Republic of Pakistan.

(b) That the impugned order of transfer dated:- 12 / 01 / 2013 & 11 / 02 / 2013 not in accordance with law rules available on subject because appellant was transferred from his post / station on no grounds and the person / respondent who was transferred to the post of appellant has requested for his transferred to the station near to his home station but respondent no 1 with Malafide intentions in order to adjust both respondents no 5 & 6 on present seats by the respondent no 1. Whereas respondent could be earlier adjust to the said seat but a game was played through sending appellant to G.H.S Ashary and latter on respondent who is shifted / transferred to G.H.S Nawagai and latter on mutually transferred both respondents Ashary and Sura / vice versa, hence the impugned order is based on Malafide intentions & is illegal one and liable to be set aside.

(copy of the mutual transfer order are attached herewith as Annexure "D")

(c) That the impugned order of transfer is totally illegal because on appellant departmental appeal remarks was given by respondent that appellant was transferred on long tenure basis where as there are other persons whose tenure is more than appellant was not transferred & who is currently working in G.H.S Ashary but appellant was politically victimize for no fault. It is pertinent to mention here that Muhammad Shafee G.H.S Sura , Bashir Ahmad G.H.S Nawagai both are senior and on the basis of long tenure may be transferred earlier but the respondent discriminatory transferred the appellant , hence impugned transfer order is liable to be set aside. **(copy of record of schools are attached herewith as Annexure "F")**

(d) That impugned transfer order dated: 12 / 01 / 2013 is illegal and not maintainable and based on malafide because there is vacant post was available at G.H.S Agarai near to respondent no 4 residence & respondent no 4 has already

submitted his request but despite of this application in this connection fact the respondent no 1 passed the impugned transfer order dated:- 12 / 01 / 2013 and subsequently with melafide designed made an order of mutual adjustment dated:- 15 / 02 / 2013 hence impugned order is liable to be set aside. (vacant seat order , application & transfer order are attached herewith)


- (e) That impugned order of transfer dated: 12 / 01 / 2013 departmental dismissal order dated 11 / 01 / 2013 are illegal because no personal hearing chance was given to appellant and the impugned orders are passed in utter disregard of the principal of natural justice i.e. Audi altaram partarem hence the impugned order in respect of appellant transfer is liable to be set aside.
- (f) That appellant therefore various reasons /quarries and causes the impugned order are not maintainable and not lawful , therefore liable to be set aside and assumed the jurisdiction not vested in it by any law and is patient & gross illegality.
- (g) That appellant will take to seek the permission of the Hon'ble Tribunal to advance some more grounds at the time of hearing of arguments.

It is, therefore, prayed that On acceptance of this instant service appeal , this Hon'ble Tribunal Court may graciously be pleased to set aside the impugned order of transfer dated: 12 / 01 / 2013 and the appellant may kindly be posted remain on previous seat / station at G.H.S Nawagai.





POSTING / TRANSFER POLICY OF THE PROVINCIAL GOVERNMENT.

- i) All the posting/transfers shall be strictly in public interest and shall not be abused/misused to victimize the Government servants.
- ii) All Government servants are prohibited to exert political, Administrative or any other pressures upon the posting/transfer authorities for seeking posing/transfers of their choice and against the public interest.
- iii) All contract Government employees appointed against specific posts, can not be posted against any other post.
- iv) The normal tenure of posting shall be three years subject to the condition that for the officers/officials posted in unattractive areas the tenure shall be two years and for the hard areas the tenure shall be one year. The unattractive and hard areas will be notified by the Government.
- v) While making postings/transfer from settled areas to FATA and vice-versa, specific approval of Governor, NWFP needs to be obtained.
- vi) While making postings/transfers of officers/officials up to BS-17, from settled areas to FATA and vice-versa approval of the Chief Secretary NWFP needs to be obtained. Whereas, in case of posting/transfer of officers in BS-18 and above, from settled areas to FATA and vice versa, specific approval of the Governor NWFP shall be obtained.
- vi (a) All Officers/officials selected against Zone-I/FATA quota in the Provincial Services should compulsorily serve in FATA for atleast eighteen months in each grade. This should start from senior most scales/grades downwards in each scale/grade of each cadre.
- vii) Officers may be posted on executive/administrative posts in the Districts of their domicile except District Coordination Officers (D.C.Os) and DPOs/Superintendent of Police (SP). Similarly Deputy Superintendent of Police (DSP) shall not be posted at a place where the Police Station (Thana) of his area/residence is situated.
- viii) No posting/transfers of the officer's/officials on detailment basis shall be made.
- ix) Regarding the posting of husband/wife, both in Provincial services, efforts where possible would be made to post such persons at one station subject to the public interest.
- x) All the posting/transferring authorities may facilitate the posting/transfer of the unmarried female government Servants at the station of the residence of their parents.
- xi) Officers/officials except DCOs and DPOs/SPs who are due to retire within one year may be posted on their option on posts in the Districts of their domicile and be allowed to serve there till the retirement. DCOs and DPOs who are due to retire in the near future may also be posted in the District of their domicile subject to the condition that such post shall be against non-administrative posts of equivalent scales;
- xii) In terms of Rule-17(1) and (2) read with Schedule-III of the NWFP Business 1985, transfer of officers shown in column 1 of the list shall be made by the authorities shown against such officer in column 2.
