


RE-INSTATEMENT

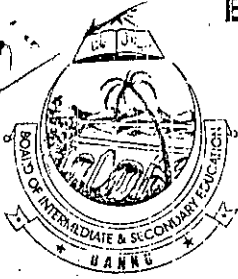

Special Atorny for the appellant alongwith counsel for the appellant and Mr. Muhammad Jan, GP for the respondents present and heard on preliminary. Counsel for the appellant Contended that the appellant has not been treated in accordance with the law/rules. She was appointed as PST Teacher on 23.04.2012. After being ~~fit~~ fit Medically, she duly took over charge of her post and started performing her duties, however vide the impugned order dated 02.10.2012, her appointment order was withdrawn from the date of taking over charge allegedly on the ground that her HSSC certificate obtained from AIOU, Islamabad was fake. The appellant received the withdrawal order on 15.10.2012. He further contended that the ground made for cancelation of the appointment order of the appellant is totally false and baseless as the appellant obtained her HSSC certificate from BISE Bannu and not from AIOU, Islamabad. The same certificate was also sent to the controller of examination BISE Bannu by the then EDO Bannu vide letter dated 06.04.2012 and same was verified as correct by the concerned controller of examination BISE Bannu as is evident vide letter dated 21.04.2012. The appellant submitted departmental appeal on 12.11.2012 but with no response till the expiry of 90 days statutory period. Points raised need consideration. The appeal is admitted to regular hearing subject to all legal objections. The appellant is directed to deposit the security amount and process fee within 10 days. Thereafter, notice be issued to the respondents. Case adjourned to 06.11.2013 for submission of written reply.





02-10-2012 received to the appellant on 15/10/12 (Copy of the withdrawal order is annexure as "B").


3. That the appellant was appointed in BPS-7 as PST Teacher but the same post was upgraded in BPS-12 vide through notification vide No. SO(BKA)1-18/FASE/2012 dated 01-07-2012. (Annex C)
4. That after up gradation and as per notification the respondent No.4 exceeded his powers by issuing withdrawal order of the appellant because the present case comes in the jurisdiction/ purview of District Coordination Officer.
5. That the appellant appointment order was withdrawn by making a sole ground that the FA certificate of the appellant was submitted for verification by the department to controller of exams Allama Iqbal Open University Islamabad and the same has been declared as fake.
6. That the appellant has collected her FA certificate from BISE Bannu and it is highly pertinent to mention here that the said FA certificate of AIOU Islamabad which has made the sole ground for termination, is missing in the apply form.
7. That the appellant has attached / submitted FA certificate of BISE Bannu and respondent department has got verified the same certificate from concern board and it is correct in all respects. (Copy of FA certificate is annexure as "D").
8. That the FA certificate produced by the appellant has been issued by the authority of Bannu Education Board and the same is accurate in each and every respect and has been received to the respondent department as verified.
9. That the appellant is in possession bachelor of arts (B.A) degree and the result of which has been declared on 09-09-2011 prior to appointment process.

That feeling aggrieved that appellant has no other efficacious remedy but to invoke the jurisdiction of this honourable tribunal on the following amongst other grounds.

- A. That the FA certificate which was made basis for issuing the impugned order of termination has neither been placed/ produced by the appellant nor the same has no nexus with her.
 - B. That the respondents have flagrantly violated the rules of natural justice by providing no chance of personal hearing and thus condemned the appellant unheard.
 - C. That no chance of defense has ever been provided to the appellant because the said impugned withdrawal order was received to her when she was engaged in learning and teaching the students in class. Reliance may be placed on 2000-SCMR-1973.
 - D. That no proper procedure for terminating her services had been adopted in the appellants termination but in an arbitrary manner.
 - E. That the appellant has not been treated in accordance with law under the rules.
 - F. That the order of respondent No.4 in terminating the services of appellant is illegal, based on surmises and conjectures as well as having no logical and legal reasons behind the same.
 - G. That the respondent department has totally ignored the FA certificate issued by the authority of Bannu Education Board and has not added the merit score of her BA degree, Issued by the University of Science & Technology Bannu.

It is therefore, most humbly prayed that on acceptance of this instant appeal, the impugned order may be set aside and the respondents be directed to reinstate the appellant in to services with all back benefits. Any other relief / remedy deem fit under the circumstances may also be granted please.

5. That due to some clerical mistake committed during the feeding of data by the officials have created the present confusion which resulted in the issuance of with drawl orders of the appellant.

- 11. That the instant case needs proper hearing because no one can be blamed unheard


