Appeal under Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 against the order No. 17 dated 14-06-2013 of the Respondent No. 1 (copy of which was never communicated to the Appellant, however on getting information the same was obtained on 21-08-2013), whereby joint second appeal of the Respondents No. 4 to 7, to which the Appellant has not been made party at any stage, was accepted and the established seniority position as it was borne on the earlier Final Seniority Lists was disturbed and the Respondents No. 4 to 7 were shown senior to the Appellant in a new seniority list as it stood on 30-06-2013. The order impugned as well as the seniority list issued vide No. 265-66/G dated 29-07-2013 by the Respondent No. 3 is against the law, facts and Shariah, hence liable to be set aside and seniority position of the Appellant may very kindly be restored to Serial No. 1 / top reckoning from the date of appointment i.e. 1-12-1985.

<u>Prayer:</u>

It is very respectfully prayed that on acceptance of this appeal the new seniority list issued vide No. 265-66/G dated 29-07-2013 by the Respondent No. 3 being against the law, facts and Shariah, hence liable to be set aside and seniority position of the Appellant may very kindly be restored at Serial No. 2 reckoning from the date of appointment i.e. 14-04-1988 as per the Final Seniority List issued on 31-12-2012.

Respectfully Sheweth:

*Facts:* 

- i. That the Appellant is regular Forest Guard presently posted at Kalam Forest Division at Madyan, Swat.
- *ii.* That in the final seniority list as issued on 31-12-2012 and in those issued earlier than that the Appellant is at Serial No. 2.

iii. That the seniority aforesaid as far as the Appellant is concerned has never been challenged in any forum, which has got an absolutely finality and is holding the field as good.

iv. That the Respondents No. 4 to 7 started litigation, unauthorisidly and without any lawful justification, against the Appellant Forest Guard of Kalam Forest Division Swat, my date of regular appointment is 14-04-1988, which is obviously prior to those of the Respondents aforesaid.

v.

That the Respondents No. 4 to 7 objected to my seniority position on the sole ground that it shall be reckoned from his arrival in Kalam Forest Division Swat dated 26-04-2004 instead of first appointment i.e. 14-04-1988, however on acceptance of the appeal of the Appellant the Respondent No. 2 reversed the decision of Respondent No. 3 and ordered in his capacity as appellate authority on 27-05-2010 vide order No. 8, therefore, the Appellant is to be placed in the seniority list considering the reckoning date as 14-04-1988. Copy of the order is enclosed as Annexure "A". The seniority list as stood on 31-12-2012 reflects the name of the Appellant at Serial No. 2. Copy of the seniority list of 31-12-2012 is enclosed as Annexure "B".

vi. That against the law the Respondents No. 4 to 7 filed second departmental appeal before the Respondent No. 1, who unlawfully entertained the same and reversed the order of the Respondent No. 2. Copy of the order is enclosed as Annexure "C".

vii. That in presence of the orders of the Respondent No. 1 the Respondent No. 3 shuffled the seniority list of the Appellant by placing him at Serial No. 18 while further travelling beyond his jurisdiction also wrongly placed one Habibur-Rahman at Serial No. 8, hence this service appeal on the following grounds.

#### <u>Grounds:</u>

- a. That the entire proceedings by the Respondent No. 1 have been carried out at the back of the Appellant. A very serious adverse action has been taken against him without associating him with the proceedings. This is the treatment in contravention of the law.
- b. That in the earlier seniority list the Appellant has been shown on proper place in accordance with the law on the basis of which the Appellant has established right and legitimate expectancy of his promotion.
- c. That the seniority list dated 30-06-2013 is manifestly detrimental to the relevant provision of the Constitution, Civil Servants Act and rules made there under and also against the Shariah. The same is without any support of legal provision and also without any footing, hence liable to be set aside.

- d. That by now it is the cardinal principle of the administration of justice that no action whatsoever, which is adverse shall be taken against any Civil Servant without giving him the opportunity of being heard and this opportunity shall be fair, transparent and meaningful and should not be just an eye wash to evade the cannon of the law and spirit of the Shariah.
- e. That disturbing established seniority right of an employee is a very serious matter which cannot be made in a cursory and slip shod manner as has been done in the case of the Appellant.
- *f.* That the Appellant seeks to place reliance on more grounds at the time of arguments, with the leave of this Honourable Tribunal.

It is very respectfully prayed that on acceptance of this appeal the new seniority list issued vide No. 265-66/G dated 29-07-2013 by the Respondent No. 3 being against the law, facts and Shariah, hence liable to be set aside and seniority position of the Appellant may very kindly be restored at Serial No. 1 / top reckoning from the date of appointment i.e. 14-04-1988 as per the Final Seniority List issued on 31-12-2012.

Any other relief deemed appropriate may also very kindly be granted.

#### **BRIEF HISTORY OF THE CASE**

Mr. Shakirullah Forest Guard, appointed on 14.4.1988, was transferred from Swat Forest. Division to Kalam Forest Division in the interest of public service. While issuing seniority list of Forest. Guards stood on 31.10.2009, the DFO Kalam considered the seniority of the above named Forest Guard from the date he reported arrival In Kalam Forest Division i.e. 26.4.2004.

#### DISCUSSION

Being aggrieved the Forest Guard preferred an appeal received vide DFO Kalam letter No.1347/G, dated 15.01.2010. The Divisional Forest Officer Kalam was asked vide this office No.6812/E, dated 04.02.2010 for his comments and detail report. In response the DFO Kalam vide his letter No.1748/G, dated 06.3.2010 offered his comments. The official was heard in person on 06.5.2010. Relevant documents of the case have been perused. It was noticed that the in most of the cases, seniority has been granted from the date of appointment. Moreover Court decisions in similar cases also confirms that seniority was granted from the date of appointment.

#### **ORDER**

From the afore mentioned discussion it is clear that the seniority of the above named appellant fixed by the DFO Kalam from the date of his arrival in Kalam Forest Division is not justified, therefore, I Mohammad Ikram Khan, Conservator of Forests Malakand Circle in the capacity of Appellate authority hereby accept the appeal of Mr. Shakirullah Forest Guard. #### BRIEF HISTORY OF THE CASE:-

Mr.Shakirullah was appointed as Forest Guard in Dir-Swat Watershed Management Project vide office order No.89, dated 12/4/1988 and joined his duty on 14/4/1988. On completion of Project period, he was adjusted in Swat Forest Division and thereafter transferred to Kalam Forest Division on mutual basis with Anwar Zeb Forest Guard vide Conservator of Forests, Malakand Forest Circle office order No.35, dated 03/5/2013 on the grounds/reasons at S.No.(IV) mentioned therein that " it should not be counted towards regularization of their services in the Department".

On arrival in Kalam Forest Division, Mr.Shakirullah Forest Guard was placed at S.No.24 of the Seniority list of Forest Guards of Kalam Forest Division as it stood on 30/6/2006 with effect from his date of arrival in Kalam Forest Division.

Being aggrieved Mr.Shakirullah Forest Guard preferred a Departmental appeal to Conservator of Forests, Malakand Forest Circle for determination of his seniority from the date of his appointment instead of the date of his arrival in Kalam Forest Division. The said appeal was accepted by Conservator of Forests, Malakand Forest Circle vide office order No.81, dated 27/5/2010 and granted seniority to the appellant from the date of his appointment i.e. 14/4/1988. In response the seniority of the appellant was fixed at S.No.3 in the seniority list of Forest Guards of Kalam Forest Division as it stood on 30/6/2011.

Against the Conservator of Forests Malakand Forest Circle office order No.81, dated 27/5/2010, M/S Shoukat Ali, Munawar-ul-Islam, Gubgl Khan and Muhammad Nawaz Forest Guards of Kalam Forest Division preferred an appeal to the undersigned for reconsideration of the seniority of Mr.Shakirullah Forest Guard.

#### **DISSCUSSIONS:-**

The application of the Forest Guards was sent to Conservator of Forests, Malakand East Forest Circle vide this office letter No.2415/E, dated 20/3/2013 for comments and detail report. In response the Conservator of Forests, Malakand East Forest Circle vide his letter No.7064/E, dated 07/5/2013 has reported that the Departmental appeal of Shakirullah Forest Guard was accepted by his office, therefore, no action is required to be taken by him and supplied photo copies of relevant documents.

After detail scrutiny of the documents the applicants were called for personal hearing vide this office letter No.3363-69/E, dated 28/5/2013 and accordingly the appellants were heared in person on 5/6/2013 and also Mr.Shakirullah Forest Guard was given the opportunity of hearing which he himself accepted the seniority of Mr.Shamsur Rehman Forest Guard as he is senior to him as per appointment date in the Project. The DFO Kalam also participated and produced the relevant documents. During the course of hearing, the following rules/instructions were discussed in detail:-

1) As per Project policy at S.No.10(vi) of the Khyber Pakhtunkhwa policy regulating appointment to post in Developmental Projects, ex-Project employees shall have no right of adjustment against the regular post. However, if eligible, they may also apply and compete for the post with other candidates.

- 1) As per Project policy at S.No. 10(vi) of the Khyber Pakhtunkhwa policy regulating appointment to post in Developmental Projects, ex-Poject employees shall have no right of adjustment against the regular post. However, if eligible, they may also apply and compete for the post with other candidates.
- 2) As per Finance Department Khyber Pakhtunkhwa letter No.SOR-III(FD)4-141/98, dated 11/7/1998 the project employees recruited after 30/3/1989 would be on contract basis and their services would not counter for pension and the said date has been treated as cut of date. The entire service of the employees recruited before 30/3/1989 shall count for the pensionary benefit.
- 3) As per para-8(2) of Khyber Pakhtunkhwa Civil Servants (appointment, Promotion and Transfer) Rules 1989, a person so transferred shall be placed at the bottom of the cadre strength which he joins for the purpose of determining his seniority.

#### ORDER :-

In light of the detailed discussion personal hearing of appellants and the affectee as well as provisions of different rules quoted above, I Hasham Ali Khan Chief Conservator of Forests Malakand Forest Region (Region-III) in the capacity of appellate authority accept the appeal of Forest Guards, set aside the office order No. 81, dated 27/5/2010 of Conservator of Forest Malakand Forest Circle and do hereby ordered that :-

The DFO Kalam should determine seniority of the Forest Guards on the following guidelines to streamline the seniority as per approved rules:

- 1) To prepare seniority list of those Forest Guards who were on the strength of Behrain, Kalam and Utror Ranges of the then Swat Forest Division who were later on trapsferred to newly created Kalam Forest Division.
  - The Forest Guards so transferred from other Divisions/Projects should be placed in the seniority lists from their date of arrival in Kalam Forest Division.
