RESPECTFULLY SHEWETH:

Facts of the case are as under :-

1. That the appellant was appointed as CHOWKIDAR in the Regional Office of Information Kohat Division, Kohat vide order No. LNF/ADK / 322-27, on 6/10/1989, . (Copy of appointment letter is attached).
2. That from the date of appointment the appellant performed his duties well and to the entire satisfaction of the Superior till date.
3. That the appellant was transfer from Kohat to Regional Office Head Quarter Peshawar and he remained there from 9/7/2001 to 1/9/2008.
4. That the appellant has been transferred from Regional Office Headquarter Peshawar to Regional Office Kohat on 30/8/2008 and the Respondent No.5, filed an appeal against the said transfer order but the appeal of the Respondent # 5 was dismissed.
6. That now the appellant has been transferred again from the Regional Office Kohat to Headquarter Peshawar vide order dated 1/8/2013.
7. That feeling aggrieved the appellant filed Departmental appeal which was rejected on 26/08/2013, hence this service appeal on the following amongst the other grounds :-

G R O U N D S:

- A). That the impugned order dated 1/8/2013, of Respondent No.2, is against law , facts and justice and is liable to be set-aside.
- B). That the appellanthas^{has} not been dealt with in accordance with law and Rules.
- C). That the transfer order of the appellant dated 1/8/2013 is based on malafidây.
- D). That the Departmental appeal of the appellant has been rejected on the reasons that there is complete Ban on transfer / posting of the Officials, then why the applt: has been transferred when there is complete Ban on posting / transfer.
- E). That the appellant was appointed initially as CHOWKIDAR for the single post created in the Regional Office of Information Kohat Division Kohat., while the Respondent No.5, initally appointed as Sweaper.
- F). That according to the Govt: Policy , the Class-IV employees must be performed their dutitâes in their District.
- G). That there is no male person in the family of the appellant So due to such transfer , the family of appellâant suffers a lot of trouble.

H). That some other grounds may be adduced at the time of arguments with the permission of this Hon'ble Tribunal.

It is, therefore, most humbly prayed that on acceptance of this appeal, the impugned order dated 1/8/2013, may kindly be set-aside and the appeal may kindly be remain intact in Regional Information Office Kohat District Kohat.

Any other relief which this Hon'ble Tribunal may deem fit for the safe administration of justice.



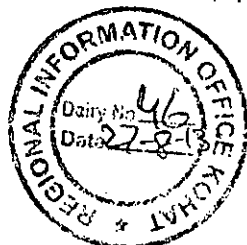

Section 10 of the NWFP Civil Servants Act, 1973.

Posting and Transfer. Every civil servant shall be liable to serve anywhere within or outside the Province, in any post under the Federal Government, or any Provincial Government or Local authority, or a Corporation or body set up or established by any such Government:-

Provided that nothing contained in this section shall apply to a civil servant recruited specifically to serve in a particular area or region;

Provided further that, where a civil servant is required to serve in a post outside a service or cadre, his terms and conditions of service as to his pay shall not be less favourable than those to which he would have been entitled if he had not been so required to serve.

Transfer of low paid Government Servants from their home Districts.

Sl.No.2

The Government has decided to continue existing policy regarding posting of class-III and Class-IV Government Servants in their Home Districts except on complaint and in the public interest. It has also been decided that the office bearers of the Association should not ordinarily be transferred for the year they are office bearers as such

Joint Para-wise comments on behalf of Respondents No.1-3.

RESPECTFULLY SHEWETH

Preliminary Objections

1. That the appellant has got no cause of action/ locus standi to file the instant appeal.
2. That the appellant's claim is based on mis-statement to misguide the Hon'ble Tribunal, therefore, his appeal is liable to be dismissed.
3. That the appellant has not come to this Hon'able Tribunal with clean hands, hence dis-entitled for any relief.
4. That no legal right of the appellant has been infringed, therefore, the appeal in neither competent nor maintainable.
5. That all the Regional Information Offices have been closed as a result of rationalization and Respondent No.4 too has been adjusted in some other department, therefore, the appeal is liable to be dismissed.
6. That the appellant has already passed his tenure in the RIO Kohat prior to his posting in the Directorate of Information Peshawar, therefore, his appeal is not maintainable.

REPLY ON FACTS

1. Para 1 pertains to appellant's record, hence needs no comments.
2. Para 2 is incorrect. A number of explanations already called from the appellant and enquiry has also been conducted against him in a theft case and he was found guilty. The appellant has accordingly been penalized (Flag- A&B).
3. Pertains to record.

6. In response to Para-6, it is submitted that the appellant was transferred from RIO Kohat to HQ office Peshawar after serving for round about 5 years in the Regional Office. The Respondent No.4, who too hails from Kohat, was transferred in place of him in the best interest of public and according to law & policy.
7. In response to Para-6, it is submitted that the appeal of the appellant was disposed of on merit basis and according to Posting/Transfer Policy of the Provincial Government (Flag-C).

ON GROUNDS

- A. Ground A of the appeal is incorrect. The order dated 01/08/2013 of the respondent No. 2 is based on justice and not against the Law and facts. The same order is, therefore, not liable to be set a-side.
- B. Incorrect. The appellant has fully been dealt with in accordance to law and rules.
- C. In response to Ground-C, it is submitted that no malafide intention is involved in the transfer order of the appellant as already explained vide Para-6 above.
- D. In response to para-D of the Grounds, it is submitted that the appellant was transferred from Regional Information Office Kohat to the Directorate of Information Peshawar vide order No. INF/Estt/1-28/4010-15 dated 01-08-2013 (Flag-D) while the ban on appointment/recruitment & transfers was imposed by the Minister for Information, Culture and PHE vide No. PS/Min/PHE/KPK/2013/18 dated 12-08-2013 (Flag-E). Thus the appellant's claim of transferring him during the period of ban has no logic. Furthermore, the appeal of the appellant was rejected on the ground that he had already served for around 5 years in the Regional Information Office Kohat.
- E. In reply to Ground-E of the appeal, it is submitted that the post of sweeper was abolished as a result of right sizing/devolution plan and the respondent No. 4

was adjusted as Naib Qasid (BS-1) in District Information Office Hangu vide Office Order No. INF/ESTT/8/405/6164 dated 10-10-2001 (Flag-F). Following the closure of District Information offices, the Respondent No.4 was transferred to RIO Kohat and adjusted against the post of chowkidar vide Office Order No. No. INF/ESTT/1626 dated 07-09-2004 (Flage-G).

F. In response to Ground-F, it is submitted that both the appellant and respondent No.4 hail from Kohat. Only one official was to be posted against the said post at the same time. Secondly according to section 10 of civil servant act 1973 A civil servant is to serve any where within the province. So the impugned order is according with law.

G. No comments.

H. Further submissions will be made during hearing of the appeal in the Honorable Tribunal.

It is, therefore, humbly prayed that the instant appeal being devoid of any merit may very graciously be dismissed with cost in favor of the government.





Subject: POSTING/TRANSFER POLICY OF THE PROVINCIAL GOVERNMENT

Dear Sir,

I am directed to refer to the subject stated above and to say that in supersession of all policy instructions issued in this behalf, the competent authority has approved the following Posting Transfer Policy:-

- i) All the postings/transfers shall be strictly in public interest and shall not be abused/misused to victimize the Government servants.
- ii) All Government servants are prohibited to exert political, Administrative or any other pressures upon the posting/transfer authorities for seeking posting/transfers of their choice and against the public interest.
- iii) All contract Government employees, appointed against specific posts, can not be posted against any other post.
- iv) The normal tenure of posting shall be three years subject to the condition that for the officers/officials posted in unattractive areas, the tenure shall be two years and for the hard areas the tenure shall be one year. The unattractive and hard areas will be notified by the Government.
- v) Months of March and July are fixed for posting/transfer of the officers/officials excluding the officers in B-19 and above in the Province. Posting/transfer in Education and Health Departments shall be made in March while the remaining Departments shall make posting/transfers in July. There shall be a ban on posting/transfers throughout the year excluding the aforesaid two months. However, there shall be no restriction in cases where postings/transfers of Government employees become inevitable in other months due to promotion/retirement/creation of new posts/return from long leave/involvement in disciplinary proceedings and adjustment of surplus staff for which specific relaxation shall be obtained from the Chief Minister.
- vi) While making postings/transfers from settled areas to FATA and vice-versa, specific approval of the Governor, NWFP needs to be obtained.
- vii) Officers may be posted on executive/administrative posts in the Districts of their domicile except District Coordination Officers (D.C.Os) and Superintendent of Police (SP). Similarly Deputy Superintendent of Police (DSP) shall not be posted at a place where the Police Station (Thana) of his area/residence is situated.

- ix) Regarding the posting of husband/wife, both in Provincial services, efforts where possible would be made to post such persons at one station and this will be subject to the public interest.
- x) All the posting/transferring authorities may facilitate the postings/transfers of the unmarried female Government Servants at the station of the residence of their parents.
- xi) Officers/officials except DCOs and SPs who are due to retire within one year may be posted on their option, on posts in the Districts of their domicile and be allowed to serve their till the retirement.
- xii) In terms of Rule-17(1) and (2) read with Schedule-III of the Government of NWFP Rules of Business 1985, transfer of officers shown in column 1 of the following table shall be made by the authorities shown against each officers in column 2 thereof:-

xiii) While considering postings/transfers proposals all the concerned authorities shall keep in mind the following:-

- a) To ensure the posting of proper persons on proper posts, the annual confidential reports, past and present record of service, performance on post held presently and in the past and general reputation with focus on the integrity of the concerned officers/officials be considered.
- b) Tenure on present post shall also be taken into consideration and the posting/transfers shall be in the best public interest.

xiv) Government servants including District Govt. employees feeling aggrieved due to the orders of posting/transfers authorities may seek remedy from the next higher authority/the appointing authority as the case may be through an appeal to be submitted within seven days of the receipt of such orders. Such appeal shall be disposed of within fifteen days. The option of appeal against posting/transfer orders could be exercised only in the following cases:-

- i) pre-mature posting/transfer or posting/transfer in violation of the provisions of this policy.
- ii) Serious and grave personal (humanitarian) grounds.

2. To streamline the postings/transfers in the District Government and to remove any irritant/confusions in this regard the provision of Rule 25 of the North-West Frontier Province District Government Rules of Business 2001 read with schedule -IV thereof is referred. As per schedule-IV the posting/transferring authorities for the officers/officials shown against each are as under :-

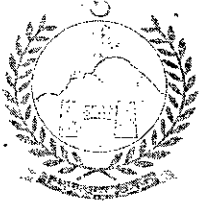
