TO **ABSORBED** REGULARIZED AND **EMPLOYEES** WERE **SHOWN** SENIOR TO THE APPELLANT MAY KINDLY BE SET ASIDE.

PRAYER

To set aside the impugned final seniority list notification dated 25/05/2022, issued by

respondent No.2 is against the norms of service rules, liable to be set aside and respondents be directed to rectified/modified and issued the correct seniority list whereby the appellant be placed above regularized and absorbed employees at Serial No. 22 as earlier be placed tentative seniority list dated 20/02/2022.

Respectfully Sheweth:-

- That two posts of Planning Officer BPS-17 were 1. advertised by the Khyber Pakhtunkhwa Public Service Commission through advertisement No. dated 29/12/2016, the 6/2016 appellant qualified test and interview and recommended for appointed vide order dated 27/03/2018 followed by the an appointment order dated 29/10/2018. (Copies of the advertisement, recommendation, appointment attached as Annexure-A, B and respectively)
- 2. That Khyber Pakhtunkhwa Provisional Planning Service Rules 2018 had already been notified on

22/02/2018, pursuant to that the appellant got placed at the strength of Planning and Development Department Khyber Pakhtunkhwa in Provincial Planning Service Cadre.

- 3. That the department issued tentative seniority list of PPS BS-17 and circulate vide notification dated 20/02/2020 whereby the appellant accurately in accordance law, rules and regulations be placed at Serial No. 22. (Copy of the tentative seniority list is attached as Annexure-E).
- in the wake of Khyber That later on, Pakhtunkhwa Regularization of Service Act 2018 07/03/2018, Project Employees dated Planning and Development Department Khyber Pakhtunkhwa got regularized, to enactment of the Act ibid, project employees as well as regularized employees of erstwhile FATA got encadre into the Provincial Planning Service vide notification dated departmental 22/03/2019, 09/01/2020 and 26/05/2021 absorption/inclusion.(Copies notifications are attached as Annexure-F, G & H respectively)

- three tentative seniority lists issued by the department in October 2020, July 2021 and April 2022 respectively, wherein the appellant illegally, unlawfully by violate the rules and regulation moved from at Sérial No. 22 and replaced at Serial No. 104, 102 and 100 respectively. (Copies of three seniority lists are attached as Annexure-I, J and K respectively)
- all these appellant against tentative 6. seniority lists filed a representation rectification of the seniority position of the appellant in accordance with the tentative seniority list circulated in February 2020, with that absorbed regularized further prayer employees from date of publication of the names of employees in official Gazzette Notification for regularization and en-cadrement are to be inserted and separately in the seniority list for clarity and the appellant be placed at Serial No. and regularized/absorbed employees be 22 placed below position from appellant in seniority list as per the law, rules and regulation. (Copies of the certificate/representation are attached as Annexure-Le
- 7. That the respondents got deaf ear and subsequently issued the final seniority list

through impugned notification dated 25/05/2022 whereby the appellant has been illegally placed below regularized and absorbed employees in the seniority list of BS-17 of BPS officers. (Copy of the impugned seniority list is attached as Annexure-M)

- 8. That appellant filed representation/departmental appeal against the impugned notification/final seniority list dated 25/05/2022 before the respondent No. 1, which result still awaited. (Copies of departmental appeal is attached as Annexure-N)
- 9. That the appellant aggrieved from the action and inactions of the respondents, the impugned final seniority list Notification dated 25/05/2022 challenged before this Honourable Tribunal, inter alia on the following grounds:-

GROUNDS:-

- A. That final seniority list dated 25/05/2022 issued by respondent No.2, is against law and procedure hence liable to be set aside.
- B. That the respondent No.2 issued final seniority list through impugned notification dated 25/05/2022 and seniority of private respondents have been assigned from the date

continuous officiation which is bluntly violating the rules of KP Civil Service Rules 1989, hence the impugned notification dated 25/05/2022 liable to be rectified to the extent of replacement of the appellant from at Serial No. 100 to 22.

- That it is pertinent to mention here that the C. appellant is not been regularized employee but the respondent No.2 yet been placed under regularized/absorbed employees, the regular appointment of project employees into PBS cadre materialized got project post notification dated 22/03/2019, 09/01/2020 respectively, while 26/05/2021 and appellant had long been regular appointed to BPS cadre through Khyber Pakhtunkhwa Public Service Commission, therefore, the impugned. seniority list dated 25/05/2022 is against the rules/regulations, nullity in the eye of law and liable to be rectified/corrected as prayed for.
- D. That the issuance of final seniority list on the basis of novel principle of "inclusion" and illegally replacing inclusion by "initial recruitment" totally against the principles of law settled by the Supreme Court of Pakistan, therefore the respondents willfully, deliberately violating the reported judgment passed by the August Supreme Court of Pakistan 2013 SCMR 1752 and their office order/notification dated

25/02/2014 circulated by Govt. of Khyber Pakhtunkhwa through Establishment Department, therefore, the final seniority list, impugned notification dated 25/05/2022 amounts to be contempt of court and against the direction issued by the competent authority, hence liable to be rectified/modified to the extent of appellant position i.e. Serial No. 100 to 22.

- E. That through such impugned final seniority list, respondent No.2 wants to promote their blue-eyed i.e. respondent No.5 and 82 by passing settled law about seniority, so such action of the respondent No.1 and 2 are without lawful authority and jurisdiction.
- F. That the impugned final seniority list was issued by respondent No.2 in hasty manner by no mentioning absorption/inclusion dates and not publication the names of regularized and encadre employees in official Gazzette is blatant violation of rules, regulations and law.
- G. That the respondent No.1 rejected the departmental appeal of the appellant without given any cogent reason and also violated the rules/regulations of his own department, hence liable to be set aside.

- H. That the appellant may be placed at Serial No. 22 through modification in notified final seniority list and granted rightful seniority above all employees who have been "Regularized" and subsequently "absorbed" into PPS cadre vide "Inclusion" as their dates of regular appointment to PPS cadre are later than regular appointment of appellant into PPS cadre.
- I. That new corrected seniority list notification to be issued distinctly differentiating method of recruitment i.e. initial appointment and absorption/inclusion along with dates.
- J. That publication of names of regularized and encadre employees in official Gazette.
- K. That any other grounds which are not raised in memo of appeal the appellant may please be allowed to raise at the time of arguments.

It is, therefore, most humbly prayed that on acceptance of this service appeal, to set aside the impugned final seniority list notification dated 25/05/2022, issued by respondent No.2 is against the norms of service rules, liable to be set aside and respondents be directed to rectified/modified and issued the correct seniority list whereby the appellant be placed above regularized and

PRAYER IN APPEAL

The Impugned Notification No.SO(E)P&D/3-4/PPS/SLs/2020 Dated 25-05-2022 is Against the Norms of Service Rules and May Kindly Be Set Aside, Seniority List be rectified and issued And the Appellant Be Placed Above Regularized & Absorbed Employees

The undersigned got inducted as Planning Officer BPS-17 in pursuance of KPPSC Advertisement No.06/2016¹ dated 29-12-2016, interview held on 01-03-2018 and recommendation forwarded vide letter No. PSC/SR/II/08444² dated 27-03-2018. Since Khyber Pakhtunkhwa Provincial Planning Service Rules 2018 had already been notified on 22-02-2018, therefore, pursuant to Section 8 of PPS Rules 2018³, the services of undersigned got placed at the strength of Planning & Development Department KP in Provincial Planning Service cadre. The department issued a tentative seniority list of BS-17 PPS Officers in February 2020 placing the undersigned at S. No 22.4

However, in the wake of Khyber Pakhtunkhwa Regularization of Services Act, 2018 dated 07-03-2018⁵ project employees of Planning & Development Department KP got regularized. Subsequent

to enactment of the Act ibid, project employees as well as regularized employees of erstwhile FATA got encadred into Provincial Planning Service vide various departmental Notifications dated 22-03-2019, 09-01-2020 and 26-05-20216 through absorption/inclusion.

Subsequently, the appellant has received three tentative seniority lists⁷ issued by P&D Department KP in Oct 2020, July 2021 and April 2022 respectively wherein the appellant was moved from S.No.22 and replaced at S.No. 104,102 and 100 respectively. The seniority list issued vide impugned Notification mention that seniority from "S.No.s 28 to 99 have been assigned from date of continuous officiation" blatantly violating following conditions and rules mentioned in Sections 5(i) ,5(iv) and Section 6(2) of Act ibid, and Sub-Rules 2 and 3 of Rule 17 of KP Civil Service Rules 1989⁸.

Section 5(i) the service promotion quota of all service cadres shall not be affected

Section 5(iv) the services of such employees shall be deemed to have been regularized only on the publication of their names in the Official Gazette

Section 6(2) The seniority inter-se of the employees, whose services are regularized under this Act within the same service or cadre, shall be determined on the basis of their continuous officiation in such service or cadre.

Rule 17(2) Seniority in various cadres of civil servants appointed by initial recruitment vis-à-vis those appointed otherwise shall be determined with reference to the dates of their regular appointment to a post in that <u>cadre</u>; provided that if two dates are the same, the person appointed otherwise shall rank senior to the person appointed by initial recruitment.

<u>Rule 17(3)</u> In the event of merger/restructuring of the Departments, Attached Departments or Subordinate Offices, the inter se seniority of civil servants affected by the merger/restructuring as aforesaid shall be determined in accordance with the date of their regular appointment to a <u>cadre</u> or post.

The KP Provincial Planning Service Rules 2018 do not mention 'inclusion/absorption' anywhere as a mode of recruitment and neither does it mention grant of seniority or promotion on the basis of absorption/inclusion." The Appellant isn't a regularized employee and yet been placed under regularized employees falsely interpreting inter-se seniority of Section 6(2) of Act ibid. Precisely, regular appointment of project employees into PPS cadre and inclusion of project posts into

Schedule I of PPS Rules got materialized vide notifications dated 22-03-2019, 09-01-2020 and 26-05-2021 respectively while the undersigned had long been regularly appointed to PPS cadre through KPPSC recommendation on 27-03-2018 followed by an appointment order issued vide Notification No. SO(ESTT.) P&D/6-1/Req./2018 dated 29-10-2018. 9

Despite conveying observations/comments to Planning and Development Department, KP in August 2021 and April 2022¹⁰ regarding tentative seniority lists, the department issued the contested list titled; 'Final Seniority List of PPS BS-17 Officers' vide Notification No.SO(E)P&D/3-4/PPS/SLs/2020 on 25-05-2022 wherein backdated cadre seniority has been granted to 'regularized' and 'absorbed through inclusion' employees retrospectively and 'inclusion' has been replaced by 'initial recruitment 'in the column titled; 'Method of Recruitment/Appointment'.

The issuance of final seniority list through novel principle of "inclusion" and illegally replacing inclusion by 'initial recruitment' are steps which in their totality go in direct conflict with the principles settled by Honorable Supreme Court of Pakistan in an aptly relevant judgment of Petition No. 89/2011/(2013/SCMR/1752) that was formally endorsed and circulated vide Office Memorandum of Cabinet Secretariat, Establishment Division, Government of Pakistan vide No. 1/59/2013-Lit-IV dated 31-01-2014 and further disseminated by Establishment Department, Govt. of Khyber Pakhtunkhwa vide Notification No. SOR-VI/E&AD/1-13/2009 to all administrative Secretaries of the province on 25-02-2014 for compliance.¹¹

Vital features of the judgment reproduced below support appellant's stance regarding consideration of regularization and cadre absorption separately as it causes extreme violation of merit and justice.

i. A civil servant, who after passing the competitive exam in terms of recruitment rules, is appointed on merit, loses his right to be considered for promotion, when an employee from any other organization is absorbed without competition or undertaking competitive process with back dated seniority and is conferred the status of a civil servant in complete disregard of recruitment rules.

- ii. Absorption of a non-civil servant conferring on him status of a Civil Servant and likewise absorption of Civil Servant from non-Cadre post to a cadre post without undertaking the competitive process under the recruitment rules.
- iii. Introduction of any validation law in the nature of multiple or parallel legislation on the subject of service law.
- iv. Benefit of 'absorption' extended since 1994, with or without back dated seniority, is declared ultravires of the Constitution.
- v. The re-employment / rehiring of the retired Civil Government Servants being violative of the constitution are declared nullity.

The apex court further held that:

- (a) No non civil servant can be transferred and appointed by way of deputation to any cadre, the procedure provided under Esta Code has been approved by this court in the case of Muhammad Arshad Sultan.
- (b) No Civil servant of non-Cadre post can be transferred out of cadre to be absorbed to a cadre post which is meant for recruitment through competitive process.
- (c) The procedure provided under ESTA CODE requires that a person who is transferred and appointed on deputation must be a govt servant and such transfer should be made through the process of selection. The borrowing government has to establish the exigency in the first place and then the person who is being transferred/placed on Deputation in Govt must have matching qualifications/expertise in the field with required experience.
- (d) An employee holding a post under any authority or corporation, body or organization established by or under Provincial Government has controlling share or interest, could not be conferred with the status of a civil servant.
- (e) It is a settled principle of law that if the right of promotion is not blocked by the reemployment then such powers can be exercised, then too in exceptional cases for a definite period, besides it violates the fundamental rights of the serving civil servant, on account of such rehiring on contract are deprived for their legitimate expectancy of promotion to a higher cadre, which is violative of the provision of Articles 4, 19 and 25 of the constitution of Pakistan.
- (f) The absorption and out of turn promotion will also impinge on the self-respect and dignity of the civil servant, who will be forced to work under their rapidly and unduly promoted fellow officers, those who have been included from other service/cadre regardless of their (inductees) merits and results in the competitive exams (if they have appeared for all exam at all), hence are violative of Art 14 of the constitution.
- (g) principle of locus poenitentiae is the power of receding till a decisive step is taken but it is not a principle of law that order once passed become irrevocable and past and closed transaction, it the order is illegal then perpetual rights cannot be gained on the basis of an illegal order.





(h) Any backdated seniority cannot be granted to any absorbee and his inter se seniority, an absorption in the cadre shall be maintained at the bottom as provided under the rules regulating the seniority.

Also, the Supreme Court of Pakistan, in a renowned judgment of Anita Turab case (PLD 2013 SC 195) clearly laid down that merit was to be followed while in the instant case merit has been clearly set aside through discriminatory attitude towards the Appellant in violation of specific decisions circulated vide letter dated 25-02-2014, Office Memorandum dated 31-01-2014 and Rule 17 of KP Civil Servants (Appointment, Promotion and Transfer) Rules 1989.

PRAYER:

In view of above-mentioned facts, the undesigned appeals for grant of immediate relief measures as follows:

- i. The impugned Notification NO.SO(E)P&D/3-4/PPS/SLs/2020_dated 25-05-2022 may be set aside and declared null and void.
- ii. All seniority list operations to be frozen with immediate effect along with 45 cases of PPS-BS 17 officials under process for promotion for forthcoming PSB in June 2022.
- iii. The appellant may be placed at S.No.22 through modification in notified final seniority list and granted rightful seniority above all employees who have been 'regularized' and subsequently 'absorbed' into PPS cadre vide 'inclusion' as their dates of regular appointment to PPS cadre are later than regular appointment of appellant into PPS cadre
- iv. New corrected Seniority List Notification to be issued distinctly differentiating method of recruitment i.e., initial appointment and absorption/inclusion along with dates.
- v. Publication of names of regularized and encadred employees in Official Gazette.

The undersigned is directed to say that the Honorable Supreme Court of Pakistan ad passed judgment on 12-6-2013 on the subject petitions clubbed with a number of other petitions and had ordered that a copy of this judgment be sent to all the Chief Secretaries of the Provinces as well as the Establishment Secretary with the direction to streamline the service structure of civil servants in line with principles laid down in this judgment.

2. It was expected that afore-mentioned judgment was downloaded by all Ministries/ Divisions for compliance. However, for the sake of convenience, the following guideli." s/ principles are highlighted:

The Honourable Court has declared the following practices as illegal:

A civil servant, who after passing the competitive exam in terms of the recruitment rules, is appointed on merits, loses his right to be considered for promotion, when an employee from any other organization is absorbed without competing or undertaking competitive process with the backdated seniority and is conferred the status of a civil servant in complete disregard of recruitment rules.

- (ii) Absorption of a non Civil Servant conferring on him status of a Civil Servant and likewise absorption of a Civil Servant from non cadre post to cadre post without undertaking the competitive process under the recruitment rules.
- (iii) Introduction of any validation law in the nature of multiple or parallel legislation on the subject of service law.
- (iv) Benefit of 'absorptions' extended since 1994, with or without backdated seniority, are declared ultra vires of the constitution.

(v) The re-employment / rehiring of the retired Civil / Government Servants being violative of the constitution are declared nullity.

The Apex Court has further held that: -

- (a) No non-civil servant can be transferred and appointed by way of deputation to any cadre. The procedure provided under Esta Code has been approved by this Court in the case of Mohammad Arshad Sultan.
- (b) No civil servant of a non-cadre post can be transferred out of cadre to be absorbed to a cadre post which is meant for recruitment through competitive process.
- (c) The procedure provided under ESTACODE requires that a person who is transferred and appointed on deputation must be a govt servant and such transfer establish the exigency in the first place and then the person who is being expertise in the field with required experience.
- (d) An employee holding a post under any authority or corporation, body or organization established by or under any Provincial or Federal law or which is owned or controlled by Federal or Provincial Government or in which Federal Government or Provincial Government has controlling share or interest, could not conferred status of a civil servant.
- (e) It is settled principle of law that if the right of promotion is not blocked by reemployment then such powers can be exercised, then too in exceptional cases for
 a definite period. Besides it violates the fundamental rights of the serving civil
 servants, on account of such rehiring on contract are deprived of their legitimate
 expectancy of promotion to a higher cadre, which is violative of the provisions of
 Articles 4, 9 and 25 of the Constitution.
- (f) The absorption and out of turn promotion will also impinge on the self respect and dignity of the civil servants, who will be forced to work under their rapidly and unduly promoted fellow officers, those who have been inducted from other services / cadres regardless of their (inductees) merit and results in the competitive exams (if they have appeared for exam at all), hence are violative of Article 14 of the Constitution.
- Principle of locus poenitentiae is the power of receding till a decisive step is taken but it is not a principle of law that order once passed becomes irrevocable and past and closed transaction. If the order is illegal then perpetual rights cannot be gained on the basis of an illegal order.

- (h) Any backdated seniority cannot be granted to any absorbee and his inter-seseniority, on absorption in the cadre shall be maintained at the bottom as provided under the Rules regulating the seniority.
- 3. All Ministries / Divisions and Departments / Organizations under them are requested to comply with the judgment of the Apex Court in letter and spirit.
