Any other remedy which this august tribunal deems fit may also be awarded in favor of the appellant.

ON FACTS:

- 1- That appellant was inducted in the respondent Department as Senior English Teacher (BPS-16) vide order dated 8.11.1994. That after appointment the appellant performing her duty quite efficiently and up to the entire satisfaction of her superiors. Copy of the appointment order is attached as annexure.....**A.**

- 2- That later on the appellant was adjusted as Subject specialist (BPS-17) from the post of SET (BPS-16) on the recommendation of Proper Departmental Selection Committee vide Notification dated 31.8.2000. That after appointment as Subject Specialist (BPS-17) the appellant started performing her duty quite efficiently and up to the entire satisfaction of her superiors. Copy of the appointment/adjustment order is attached as annexure....**B.**

- 3- That appellant while working as Subject Specialist BPS-17 a seniority list was issued by the respondent Department vide Notification dated 8.8.2012 communicated to the appellant on 24.3.2014 whereby the appellant has wrongly been enlisted at serial No. 250 instead of 240. Copy of the Seniority list is attached as annexure.....**C.**

- 4- That feeling aggrieved from the impugned Notification the appellant preferred Departmental appeal but no reply has been received so far. Hence the present appeal on the following grounds amongst the others. (Copy of the Departmental appeal is attached as Annexure **D.**

GROUND:

- A- That the impugned Notification dated 8.8.2012 communicate to the appellant on 24.3.2014 is against the law, facts, norms of natural justice.

- B- That the appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondent violated article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.

- C- That it is very much clear from the adjustment order of the appellant in private respondents that appellant is senior according her date of birth and date of first appointment as Senior English Teacher but inspite of that the appellant has been superseded by placing the private respondents senior to the appellant in the impugned seniority list dated 8.8.2012.

- D- That the respondent department acted in an arbitrary and malafide manner by placing the appellant junior to private respondents.
- E- That the respondent Department discriminated the appellant by placing the appellant at serial No. 250 instead of 240.
- F- That appellant seeks permission to advance other grounds and appears at the time of hearing.

It is therefore humbly prayed that the appeal of the appellant may be accepted as prayed for.

The Respondents submit as under:-

FACTS:

1. Para-1 needs no comments being relates to the Service record of the appellant.
2. Para-2 is incorrect and mis-leading on the grounds that the appellant was adjusted against the S.S (Economic) Post vide Notification dated 31-08-2000 in her own pay and scale of SET Female subject to terms and conditions in vogue or ones to framed in future with immediate effect vide S.No-4/4 of the said Notification. Hence the plea of the appellant regarding her promotion against the S.S in Economics Post is without any legal justification.
3. Para-3 is incorrect and denied, The Appellant has been treated as per Law & her correct seniority position in the said seniority list issued by the

Respondents vide Notification dated 08-08-2012 against the subject specialist post wherein the appellant has been placed at S.No 250 on the basis of her service record and data/particulars submitted by the Appellant to the Respondent Department, hence the Notification dated 21-03-2014 is not only legal but is also liable to be maintained in favour of the replying Respondents in the interest of justice. Copy of the said Seniority list and adjustment Notification are attached as (Annex-A & B)


4. Para 4 is Incorrect and denied. Neither departmental appeal has been filed by the appellant against the impugned Notification dated 08-08-2012 nor any such recorded is available in the Office of the Respondent till date, therefore, this Para is also liable to be dismissed in favour of the Respondents. However the Respondent No. 1 further submits on the following grounds inter-alia.

GROUND.

- A. Incorrect, hence denied, The Notification dated 08-08-2012 is legally competent and is liable to be maintained in favour of the Respondents being legal and in the interest of justice.
- B. Incorrect and denied, The appellant has been treated as per Law, Rules & her sonority position in light of her service record vide Notification dated 08-08-2012 issued by the Respondent No.2 in the interest of public service, therefore, the plea of violating Articles-4 & 25 of 1973 constitution of Islamic Republic of Pakistan is without any solid justification.
- C. Incorrect and denied. The plea of the appellant is baseless and against the factual position, hence is liable to be dismissed in favour of the Respondents because the Notification dated 08-08-2012 is legally competent duly issued by the competent authority under the relevant provisions of law by keeping in view the facts and circumstances of the case.
- D. Incorrect hence denied. The Respondents have acted as per Law, Rules & Seniority Policy vide Notification dated 08-08-2012 vide which the appellant has been placed at S.No. 250 of the impugned sonority list pertaining to the subject specialist in the Respondent Department.
- E. Incorrect and denied. The Appellant has been treated in accordance with the rules and policy having no question of discrimination with regard to the impugned Notification dated 08-08-2012 by placing the appellant on her due sonority position at S.No. 250 as per available record in the Respondent Department.

F. Legal, However, the Respondents seek leave of this Hon'able Tribunal to advance additional grounds and case law at the time of arguments.

In view of the above made submissions, it is, therefore, most humbly prayed that this Honourable Tribunal may very graciously be pleased to dismiss the appeal in hand with cost in favour of the Respondent.
