ON ACCEPTANCE OF THIS APPEAL THE ORDER NO. KMU(E)-9 253/2011/2055 DATED 20/05/2013 WHEREBY THE APPELLANT WAS DISPENSED FROM SERVICE w.e.f 26-4-2013 MAY GRACIOUSLY BE SET ASIDE AND THE APPELLANT MAY KINDLY BE RE-INSTATED IN SERVICE WITH ALL BACK BENEFITS.

#### Respectfully Sheweth,

That the appellant appointment was made as Driver in (BPS-4) in Khyber, Medical University Peshawar (KMU) on regular basis vide office order No.KMU/Regis/2010/3847 dated 02-11-2011. (Copy of office order dated 2-11-2011 is attached as annexure A).

That the appellant has performed his duties with entire satisfaction of superiors and there are no adverse remarks or entries have been seen on his part.

- 3- That during the entire service no absentee has ever been seen on the part of the appellant.
- That on 17-4-2013 the appellant informed his superior officer that due to some emergency he was going to his home whereby he was allowed so. On the next date he(Appellant) came to know that he was marked absent and in this regard the show cause Notice dated 06-05-2013 was served upon the appellant of which the satisfactory reply was given by the appellant (copy of show Notice and reply are attached as annexure B and C).

That instead of issuing 2nd and 3rd show cause notices the appellant on 26-04-2013 was relieved from service with the remarks that he was no more desired to be government employee. (Copy of order dated 26-4-2013 is annexure D).

- 6- That without giving any opportunity of personal hearing or defense the appellant was dispensed from service w.e.f 26-04-2013. (vide order dated 20-5-2013. (Copy of office order is attached as annexure E).
- 7- That against the said impugned order departmental appeal was moved on 23-5-2013 but till date no response has been received (copy of departmental appeal is attached as annexure F).
- 8- That a grievance notice was also sent to the respondents but in no vain (copy of

grievance notice is attached as annexure G).

- 9-That against the impugned dismissal order a civil suit was filed before the senior civil judge Peshawar but the learned civil judge V Peshawar on 11-01-2014 on the point of jurisdiction returned the plaint for presentation before the proper forum, hence this appeal. (Copy of plaint and order of C.J.V Peshawar dated 11-01-2014 are attached as annexure H and I respectively).
- That appellant invokes the jurisdiction of this honorable court inter-alia on the 10following reasons and grounds.

#### **GROUNDS**

- That the impugned order whereby the service of the appellant was dispensed is against the law and facts hence liable to be set aside.
- B-That the impugned order is a harsh one whereby on one day absentee the appellant service has been strucked off.
- That the impugned order is against the terms and conditions of service law C÷ because no chance of personal hearing has been given to the appellant.
- That 2nd and 3rd show cause notices was not served upon the appellant even it is very much astonishing that before the final order or proper inquiry (vide office order dated 26-04-2013) the appellant was relieved from the service with the remarks that appellant is no more desired to be government employee, showing the ill well and malafide of the respondents for the appellant.
- That the appellant had filed the departmental appeal but till date no response of Edepartmental appeal has been given by the respondents.
- F-That impugned order passed by the respondents is in violation of service law and caused a grave mis-carriage of justice to appellant.

It is therefore most humbly prayed that on acceptance of this service appeal the appellant may kindly be re instated in his service with all back benefits and any other relief deem fit may kindly be awarded.

stopped his salary and they be asked not only to pay the salary but also to reinstate the plaintiff on his job. No doubt the plaintiff was a driver with the defendants medical college, which owned by the state, and is governed by its own rules and the plaintiff being civil servant, his rights are also covered by the Service Act and Rules. The suit of the plaintiff is not competent in this forum and the proper course for the plaintiff is to approach the service tribunal for redressal of his grievances. There is nothing in this case for this court to interfere as the jurisdiction of this court is barred by the law.

Accordingly the plaint is hereby returned to be presented. in the proper forum. Original plaint and documents be returned to the plaintiff and attested copies be placed on file. Thereafter file be consigned to the record room after its necessary completion.


