JUDGMENT

ROZINA REHMAN, MEMBER (J): The appellant has invoked the jurisdiction of this Tribunal through above titled appeal with the prayer as copied below:

"That on acceptance of the appeal, order dated 04.08.2020 of R.No.01 and 07.03.2020 be set aside and appellant be restored/posted at GGPS Nar Abu Samand Begu Khel Lakki Marwat with further request to release the withheld monthly salaries".

2. Brief facts of the case are that appellant alongwith respondent No.4 was appointed as Chowkidar on 24.10.2019 and was posted at

GGPS Nai Abo Samand Begu Khel against vacant post while private respondent No.4 was posted in GGPS Abullah Khan Betani against vacant post. It was on 04.03.2020 when respondent No.1 adjusted respondent No.4 in her office due to the merger of schools but the said School is, still functioning at GGPS. Later on, respondent No.4 was transferred to GGPS Nar Abu Samand Begu Khel on 07.03.2020 while appellant was transferred to the office of respondent No.1 by placing his services at the disposal of respondent No.1. He submitted representation for cancellation of order dated 07.03.2020 being based on the recommendation of political vendetta and in this record, proper inquiry was conducted. Despite recommendation of the Inquiry Officer, pay of the appellant was stopped, he therefore, filed writ petition and the Hon'ble Peshawar High Court was pleased to direct respondents to treat the same as departmental appeal and to decide the same within 30 days, hence, the instant service appeal.

- 3. We have heard Arbab Saiful Kamal, Advocate learned counsel for the appellant and Naseer Ud Din Shah, learned Assistant Advocate General for respondents and have gone through the record and the proceedings of the case in minute particulars.
- 4. Arbab Saiful Kamal Advocate, learned counsel for the appellant inter-alia contended that the impugned orders are not as per mandate of law as neither the appellant nor respondent No.4 had completed normal tenure at their respective schools. He contended that proper inquiry was conducted to unearth the hidden facts and that the inquiry officer submitted his report but the same was not honored by the respondents. That the respondent No.1 did not show any heed to the



recommendation of the Inquiry Officer and the appellant suffered due to the harsh attitude of the respondents by stopping his salary for no fault of the appellant which act of the respondents is illegal, against law and facts. That the appellant was never dealt in accordance with law nor was treated equally before law in violation of Articles-4 & 25 of the Constitution of Islamic Republic of Pakistan, 1973. He, therefore, requested for acceptance of the instant service appeal.

- 5. Conversely, learned AAG submitted that the appellant took charge of his duty but from the very first day he became problematic for the administration of school and was not willing to perform his duty. He was, therefore, transferred and posted in the office of respondent No.1 while respondent No.4 was transferred to GPS Nar Abu Samand for smooth working.
- 6. After hearing the learned counsel for the parties and going through the record of the case with their assistance and after perusing the precedent cases cited before us we are of the opinion that vide office order dated 24.10.2019 upon the recommendation of departmental selection committee appellant was appointed as Chowkidar on merit against vacant post at CPS Nar Abu Samand Begu Khel while respondent No.4 Abdul Wahid was appointed as Chowkidar against Medical Board quota and was posted at GGPS Abdullah Khan Betani. Appellant assumed charge of his post on 26.10.2019. It was on 04.03.2020, when respondent No.4 was temporary adjusted at the office of District Education Officer (Female) Lakki Marwat due to the merger of school and vide order dated 07.03.2020 respondent No.4 was transferred to his native village GGPS Nar Abu Samand Begu Khel

while the appellant was placed at the disposal of DEO (F) and order in respect of temporary adjustment of respondent No. 4 was withdrawn. The appellant filed departmental appeal on 16.03.2020 and one Ikram Ullah Deputy DEO (Male) Bannu was appointed as Inquiry officer to conduct proper inquiry in view of appeal filed by the present appellant. Inquiry report is available on file which favors the appellant. The recommendations of the Inquiry Officer are hereby reproduced for ready reference:

- 1. Competent authority should be directed as to why the pension case of Ex-chowkidar Abdul Rashid was perused on Medical grounds though he was fit for premature pension rather on medical board basis as after lapse of 54 days he could be proceeded on 60 years (superannuation pension).
- 2. Transfer of Muhammad Ishaq chowkidar from GGPS Nar Abusamand Begu Khel to office without any post & stoppage of his pay is against the service laws, hence needs immediate cancellation.
- 3. Competent authority should be penalized with "CENSURE" under E&D proceedings so that such kind of mal practices could be discouraged which could become basis for unnecessary litigation against government."

The inquiry report was submitted before the authority on 10.07.2020 and the District Education officer Female Lakki Marwat was directed to adjust appellant properly and his salary may be released. Despite inquiry report and order by the Assistant Director (Admin) Directorate



of Elementary & Secondary Education Peshawar dated 04.08.2020 appellant was neither adjusted nor his salary was released. He, therefore, knocked at the door of Peshawar High Court, Bannu Bench by filing Writ Petition No.89-B which was sent to the respondents with direction to treat the same as representation and decide within a period of 30 days. Again, no step was taken by the authorities with the result that present service appeal was filed. It is crystal clear from the record that Abdur Rasheed Ex-Chowkidar who was father of respondent No.4 was serving in the Department. He had gone through Medical Board though he was not entitled for the same. As per inquiry report, his age at the relevant time was 59 years, 10 month and 06 days. Thus 54 days were less than 60 years and was proceeded through Medical Board which was against rules because in case of fulfillment of 60 years service, he could enjoy 25% quota of the retired employees son but he manipulated and Abdur Rasheed was proceeded through Medical Board where 100% quota is specified and which was availed. Appointing authority had fully supported the respondent No.4 and the appellant was deprived of his posting as well as salary. The present respondent was benefitted being the son of ex-employee Abdur Rasheed. The present appellant was transferred to the office of District Education Officer Lakki Marwat without post and stoppage of pay is against the service laws. There is no departmental proceedings initiated against the appellant in order to show any misconduct on the part of appellant rather the inquiry Officer submitted report which goes against the District Education Officer (Female). A letter No.4828 dated 16.12.2020 was submitted during arguments which shows that Sub

Divisional Education Officer (Female) Serai Naurang was directed to adjust appellant against any vacant post of Chowkidar in the respective Sub Division for purpose of pay with further direction to release his pay. It is astonishing that this letter was not annexed with the comments nor it was brought before this Bench. This letter was not acted upon because Assistant Director Admin directed the District Education Officer Female on 04.08.2020 to release her salary but fiasco. The appellant submitted an application before the Director in the light of the inquiry report on 25.08.2020 but to no avail. He, then filed writ petition on 14.09.2020 which was disposed of on 29.09.2020 but even then, no step was taken by the respondents. This letter dated 16.12.2020 in respect of transfer and release of salary was produced today but it was never acted upon.

7. In view of the above discussion, instant service appeal is allowed as prayed for. Parties are left to bear their own costs. File be consigned to the record room.

- That on 24-10-2019, appellant along with R. No. 04 was appointed as Chowkidar and he was posted at GGPS Nar Abu Samad Begu Khel against vacant post and R. No. 04 was posted at GGPS Abdullah Khan Bettani against vacant post by R. No. 01. (Copy as Annex "A")
- That in pursuance of the aforesaid order, appellant assumed the change of the said assignment on 26-10-2019. (Copy as Annex "B")
- That on 04-03-2020, R. No. 01 adjusted R. No. 04 in her office due to the merger of schools till further orders, but the said school is functioning till date at GGPS Abdullah Khan Bettani. (Copy as Annex "C")
- 4. That on 07-03-2020, R. No. 04 was transferred to GGPS Nar Abu Samad Begu Khel and appellant was transferred to the office of R. No. 01 by placing his services at the disposal of R. No. 01.
 - Here it would be not out of place to mention that neither appellant nor R. No. 04 has completed normal tenure of posting and transfer at their respective Stations/Schools. (Copy as Annex "D")
- 5. That on 16-03-2020, appellant submitted representation before R. No. 02 to cancel order dated 07-03-2020, being illegal and based on the recommendation of Political vendetta, as services of appellant were placed at the disposal of R. No. 01. (Copy as Annex "E")
- 6. That on 02-06-2020, Ikramullah Khan, Deputy DEO (M) Bannu was nominated to conduct enquiry in to the appeal of appellant and to submit recommendations within fortnight. (Copy as annex "F")
- 7. That regarding the posting transfer order of R. No. 01 and in pursuance of the representation of appellant enquiry was conducted by Ikramullah Khan DEO (M) Bannu and made recommendations on 10-07-2020 to the effect:-

- i. Competent Authority should be directed as to why pension case of ex-chowkidar Abdur Rasheed (father of R. No. 04) was perused on medical grounds though he was fit for premature pension rather on Medical Board basis as after lapse of 54 days, he could be proceeded on 60 years. (superannuation pension)
- Transfer of Muhammad Chowkidar from GGPS Nar Abu Samand Begu Khel to office of R. No. 01 without any post and stoppage of his pay is against the service laws, hence needs immediate cancellation.
- iii. Competent authority (R. No. 01) should penalized with "CENSURE" under E & D Rules so that such kind of malpractices could be discouraged which would become basis for unnecessary litigation against government. (Copy as annex "G")
- 8. That on 04-08-2020, R. No. 02 wrote letter to R. No. 01, stating there in that no question, whatsoever, arose to stop pay of appellant appointed on merit, the same be released and he be adjusted properly. (GGPS Nar Abu Samad Begu Khel) against the recommendation of the Inquiry Officer. (Copy as Annex "H")
- That on 25-08-2020, appellant submitted application before R. No.
 to honor the recommendation of the Inquiry Officer but in-vain.
 (Copy as annex "I")
- 10. That on 14-09-2020, appellant filled Writ Petition before Peshawar High Court Peshawar, Circuit Bench Bannu for cancellation of the impugned order and to release withheld monthly salaries, which came up for hearing on 29-09-2020 and then the Hon'ble Court was pleased to direct respondents to treat the same as departmental appeal and to decide the same written 30 days or if appellant is still aggrieved of the decisions of the respondent, he may approach to proper forum for relief. (Copies as annex "J" & "K")

Hence this appeal, Inter Alia, on the following grounds;

GROUNDS

- a. That the impugned orders are not per the mandate of law as neither appellant nor R. No. 04 has completed normal tenure at their respective schools.
- b. That the enquiry was conducted to dig-out the misshape in the matter and has submitted its recommendation which was binding upon on R. No. 01 but the same were not honored due to personal interest by R. No. 01 to favor R. No. 04.
- c. That even R. No. 01 was recommended for penalty in the matter.
- d. That R. No. 01 did not show any heed either to the recommendation of the Inquiry Officer or to the direction of the judgment of the hon'ble court, so is required to be dealt with under the law.
- e. That no one can stop salary of a servant but R. No. 01 showed her high handedness and appellant is serving the department till date without any salary.
- f. That the impugned orders are based on favoritism, malafide and political vendetta so is liable to set aside.

It is, therefore, most humbly prayed that on acceptance of the appeal, order dated 04-08-2020 of R. No. 01 and 07-03-2020 be set aside and appellant be restored / posted at GGPS Nar Abu Samand Begu Khel Lakki Marwat with further request to release the withheld monthly salaries.



ILLEGAL TRANSFER & STOPPAGE PAY OF MUHAMMAD ISHAQ CHOWKIDAR GGPS NAR ABU SAMAND BEGU KHEL DISTRICT LAKKI MARWAT.

PROCEEDINGS OF INQUIRY.

As per grievances mentioned in the appeal by Muhammad Ishaq chowkidar, submitted to Director Elementary & Secondary Education Khyber Pakhtunkhwa, served questionnaire on DEO (F) District Lakki Marwat, reproduced again here for further proceedings.

As per budget book there exist one post of chowkidar at GGPS Nar Abu Sagnand Begu Khel, against which, complainant Mr, Muhammad Ishaq was appointed as chowkidar against vacant post vide your Endst NO. #781-89 Dated 24.10.2019, whether you endorse the said information? Whether recommendation of Mr. Muhammad Ishaq were on open merit basis , keeping in view free of cost mutation etc?

What were the circumstances when the services of the said chowkidar Q.NO.3. 🔌 have been placed at the disposal of DEO(F) office, where there exist no vacant post of chowkidar?.

Can the Medical board of Ex-chowkidar Abdur Rasheed be justified who was proceeded after acquiring age (59:10:06 YY,MM,DD)?, whether he was not fit to be proceeded through pre-mature pension? If Abdul Waheed S/OAbdur Rasheed was fit for appointment against 0.NO.5 MB son quota then why he was not appointed as junior clerk etc , whether office was reluctant or candidate ? Whether office is bound to go through whims & whishes of any candidate or through procedure? In MB & deceased son quota appointment, adjustment is made any

where in the district as was made in case of Abdul Waheed chowkidar but why a unilateral decision has been taken by transferring him to the school from where his father had gone through

Medical Board? Whether his initial appointment at GGPS Ahmad Khan

Battani was wrongly made, duly approved in DSC?, or there were other reasons?

Muhammad Ishaq chowkidar duly recommended in DSC on 23.10.2019 against the vacant post of chowkidar at GGPS Nar Abu Samand Begu Khel, pay release order issued on the said school & even pay bill passed on the said school then why lapses of law, rules & violation of policy seems obvious in his case?

Brief of the case is that there exist one sanctioned post of chowkidar at GGPS Nar Abu Samand Begu Khel District Lakki., where Mr. Muhammad Ishaq was appointed against open merit vide DEO (F) NO. 4781-89 Dated 24-10-2019, through DSC. On further scrutiny it became clear that father of Mr. Ishaq chowkidar i.e Mr. Kbar Zaman S/O Mehrullah Khan had mutated one Kanal (1--0 K--M) piece of land in Khasra NO. 30 Khata NO. 13 Mutation NO. on 26.02.1987 free of cost, in favour of Education 557 confirmed Department, which was the basic determining factor for consideration of Mr. Ishaq Khan chowkidar on open merit basis against the said post of chowkidar at GGPS Nar Abu Samand Begu Khel. It is added that vide NO. 860 Dated 19-02-2019 29 candidates were called on for interview scheduled to be held on 25.02.2019 where Mr. Muhammad Ishaq was at S. NO.07. When the appellant informed that his right was going to be jeopardized by someone else then he approached to the court of civil judge NO.V Lakki Marwat where the learned court emphasized the matter to continue as per schedule on 24.04.2019. Appointment order of three (03) candidates issued against retired son quota of 25% ,one against Medical Board son quota & five(05) against open merit quota including the appellant at s.no.04 of the appointment/order issued under Endst NO. 4781-89 Dated 24.10.2019. On going in détail pay was yeleased vide DEO(F) NO. 6436 Dated 05/12/2019 against the said post of chowkidar at GGPS Nar AbuSamand Begu Khel Lakki Marwat.

After lapse of few months Mr. Abdul Waheed s/o Abdur Rasheed who was appointed as chowkidar under the same Endst: NO. 4781-89 Dated 24.10.2019. at GGPS Abdullah khan Bhattani, was transferred to GGPS Nar Abu Samand Begu Khel & services of Muhammad Ishaq chowkidar were placed on the disposal of DEO (F) where there exist no vacant post & his pay was stopped vide office order NO.782-85 Dated 07.03.2020.

When the case of Abdul waheed was further scrutinized, it became clear that his father Abdul Rasheed had gone through Medical Board though he was not entitled for the same. As per CNIC, Mr Abdul Rasheed Ex-chowkidar was born on 18-12-1958 & as per Sanction of MB retirement on 24.10.2018, the acquired age was (yy,mm,dd 59,10,06). Thus 54 days less than 60 years, Abdul Rasheed chowkidar was proceeded through medical board which is quite against the rules & astonishing case. In case he fulfilled 60 years service

Minds

then he could enjoy 25% quota retired son but he manipulated the game with assistance of appointing authority & proceeded Abdul Rasheed through medical board where 100% quota is specified which he availed.

Another malafide is obvious where abdul waheed S/O Abdul Rasheed is/was qualified for appointment up to BPS 11 but he preferred the post of chowkidar at GGPS Nar Abu Samand Begu Khel from where his father had retired because as per local customs he has ambitious designs of occupation of school building for personal usage after school hours.

Appointing authority had fully supported & pleased Abdul waheed in fulfilling his ambitious whims by transferring him from GGPS Ahmadullah khan Bhattani to GGPS Nar Abu Samand Begu Khel & expelling the real land donor.

CROSS EXAMINATION OF EVIDENCES.

During the proceedings, the documentary evidences produced by appellant were cross examined with official documents produced by Mr.Shafqatullah khan Superintendent of the office of DEO(F). After after having authentication, made exhibition, statements were recorded & perused all evidences present in documentary form accordingly.

RECOMMENDATIONS.

After hearing the defence & examining evidences, following preliminary recommendations are hereby submitted.

Competent authority should be directed as to why the pension case of Ex-chowkidar Abdul Rashid was perused on Medical grounds though he was fit for premature pension rather on medical board basis as after lapse of 54 days he could be proceeded on 60 years (superannuation pension).

Transfer of Muhammad Ishaq chowkidar from GGPS Nar Abusamand
Begu Khel to office with out any post & stoppage of his pay is against
the service laws, hence needs immediate cancellation.

3. Competent authority should be penalized with "CENSURE" under E&D proceedings so that such kind of mal practices could be discouraged which could become basis for unnecessary litigation against government.



That, when the petitioner approached the District Education Officer (F), Lakki Marwat for cancellation of his transfer order and release of his pay, in the light of directions of the Director Education, Peshawar contained in letter No. No.29317/F.No./A-20/C-IV/Eakki Marwat Dated Peshawar the 04.08.2020, she flatly refused
- 13. - F. That, the petitioner has neither been dealt with in accordance with law nor has been treated equally before the law, in violation of Articles-4 and 25 of the Constitution of Republic of Pakistan.
- G. That, the above referred order of the Respondent No.3 is the result of malfeasance and misfeasance.
- H. That, the very act of Respondents regarding non-payment of monthly salaries to the petitioner, is unjust, unlawful and discriminatory.
- I. That, due to non-payment of monthly salaries by the respondents No.1 to 6, the petitioner is facing great inconvenience and hardships in daily life.
- J. That, learned counsel for the petitioner may kindly be allowed to submit further grounds during the hearing of instant writ petition.



Respectfully Sheweth,

The Respondents humbly submits as under:

PRELIMINARY OBJECTIONS:

- i. That the appeal is badly time barred.
- ii. That the appellant has got no locus-standi to file the instant appeal.
- iii. That the appellant has not come to this tribunal with clean hands.
- iv. That the appeal is not maintainable in the present from and also in the present circumstances.
- v. That the appellant has filed the instant appeal just to pressurize the respondents.
- vi. That the appeal is against the facts, rules and laws.
- vii. That the appellant is precluded and estopped from filing the instant appeal due to his own conduct.
- viii. That the appellant has concealed some material facts from this Hon'ble Tribunal. That after the appellant appointment, he only took charge but was not willing to perform his duty and from the very first day he became problematic for the school administration. Therefore the respondent No.4 was transferred to the said school just for public interest and for the GPS Nar Abu Samand's smooth working, while the appellant was posted in office of respondent No.1 (by previous D.E.O) but till date the appellant didn't take charge and is not ready to be adjusted at any other school.
 - ix. That the appointing authority is competent to transfer employee from one place to another. It is pertinent to mention that appellant's only wish and demand is posting at GPS Nar Abu Samand from which he was transferred due to his non-performance of duty.
 - x. That due to non-performance of duty, appellant is not entitled to pay.

FACTS:

- 1. That Para No-1 is correct, hence needs no reply.
- 2. That Para No-2 is correct. The appellant took charge of his duty but from the first day he became problematic for the administration of school. He interferes in the school's administrative matters.

- 3. That Para No-3 is incorrect. The respondent NO.4 was adjusted in respondent No.1's office due to merging of schools.
- 4. Para No-4. That as mentioned above the appellant became troublemaker for the school administration therefore in the best interest of the school, appellant was transferred from the said school to office of respondent No.1 and respondent No.4 was transferred to GPS Nar Abu Samand Begu Khel.

Here it is pertinent to mention that due to non-performance of duty the case of appellant became special and the appointing authority has the competency to transfer employee in special circumstances.

- 5. Para No-5. That the appellant agitated matter before respondent No.2.
- 6. That Para-6 was correct. Hence need no reply.
- 7. Para-7. That it is evident from the enquiry report that the matter was not properly addressed, all the questions were not answered, no opportunity was given to the respondent No1 & 4, as well as respondent No.4's father to defend their case. Recommendations were based on ex-parte enquiry.
- 8. That Para No.8 is correct. The respondent No.2 directed the respondent No.1 to adjust the appellant and release his pay but after the said directions the appellant again filed civil suit and verbally demanded (literally ordered) his posting at GPS Nar Abu Samand Begu Khel. He was neither accepting the adjustment at any other place of duty nor was he joining the duty in the office of respondent No.1, therefore, his pay was not released.
- 9. Para No.9. That from the application it is evident that the appellant's only demand is posting at the disputed school from which he was transferred due to his non-performance of duty and undue interference.
- 10. Para No.10. That without giving proper notice to the respondents, the appellant's counsel requested the Hon'ble High Court to convert the writ petition to representative appeal, which was done by the Hon'ble Court without touching the merits of the case.
- 11. That the present appeal is filed just to pressurize the department, therefore liable to be dismissed on the following grounds interalia:-

GROUNDS:

- A. That Para No. A is incorrect, hence expressly denied. The appellant is troublemaker / problematic and due to his rude behaviour with the school administration and interference in school matters, he was transferred from the said school.
- B. Para No.B. That the enquiry report was conducted ex-parte wherein irrelevant issues were addressed, therefore, enquiry was not honored by the competent authority. The appellant's main issue is not stoppage of salary but his transfer from the GPS Nar Abu Samand Begue Khel.
- C. Para No.C. That the said enquiry was conducted without giving opportunity to all parties i.e (previous D.E.O) respondent No.1, 4 and father of respondent No.4.
- D. Para No.D. That the respondent No.1 was not competent to act on the recommendation of enquiry. Moreover the respondent No.2 on the recommendation of enquiry, directed the respondent No.1 to adjust the appellant and release his pay, whereupon the respondent No.1 was ready and is ready to adjust him and release his salary but the appellant only demand is his posting on GPS Nar Abu Samand Begu Khel and dismissal of respondent No.4 which is based on personal grudge.
- E. Para No.E is incorrect. In special circumstances when the employee refused to perform duty, the appointing authority / department is not bound to pay the salary. Moreover till date the appellant never reported / appeared before respondent No.1 for joining of duty but every time he came to the office with demand of his posting at GPS Nar Abu Samand Begu Khel and dismissal of respondent No.4. He neither performed his duty nor willing to perform at any other place of duty.
- F. Para F is incorrect. The transfer order of appellant was legally correct due to his problematic behavour and non-performance of duty. The respondents / department is ready to release the pay of appellant after joining the duty in respondent No.1 office and after that on availability of post he will be adjusted at any other school.

G. That the respondents may be allowed to raise / advance additional ground at the time of arguments.

It is therefore most humbly prayed that this Hon'ble Tribunal may very graciously be pleased to dismiss the instant appeal with cost.
