- 1. That the Appellant is a naturally born bonafide citizen of Islamic Republic of Pakistan and hails from a respectable family.
- 2. That the Appellant was initially appointed as I.T Lab Incharge on 14/10/2014, in pursuance to advertisement & fulfilling the eligibility as having intermediate and six months certificate, which the appellant fulfilled. (Copy of Appointment Order is annexed as Annexure "A")

- 3. That it was on 24 April 2017 that service structure was approved and the post of lab in-charge were redesignated as Certified Teacher-IT & eligibility criteria is now being changed to intermediate plus Diploma in Information Technology & Associate Degree of Education/ Certified Teacher. (Copy of Rules are annexed as Annexure "B")
- 4. That on 16/03/2019 the services of the appellant was regularized from date of initial appointment and was re-designated as CT-IT. (Copy of Regularization Order is annexed as Annexure "C")
- 5. That on 28/05/2019 department promoted some of Certified Teacher IT to Secondary School Teacher. IT following service structure notified on 24/04/2017. But refused to promote the Appellant for the post. (Copy of Promotion order is annexed as Annexure "D")
- 6. That later on again D.P.C held its meeting on 24/09/2020 regarding promotion of Certified Teacher-IT to Secondary School Teacher-IT (from BPS-12 to PBS-16) and even the department recommended the appellant for the existing post, but even then no promotion order was issued. (Copy of DPC Meeting dated: 24/09/2020 is annexed as Annexure "E")
- 7. That the Directorate thereafter asked for guidance in the matter for promotion of Certified Teacher-IT to

Secondary School Teacher-IT. (Copy of Letter of Guidance is annexed as Annexure "F")

- 8. That in response to the letter issued from Directorate, the same was intimated back as "the Director may proceed & decide their promotion case being Competent Authority up to BPS-16 at their own level". (Copy of Directions is annexed as Annexure "G")
- 9. That thereafter DPC held its meeting on 11/06/2021, in which the appellant was rejected for the promotion due to lack of Certified Teacher/Associate Degree of Education, which is not the requirement for the post on which the appellant going to be promoted. (Copy of DPC meeting dated 11/06/2021 annexed as Annexure "H")
- 10. That after the above mention order the department withdraw all appointment order who has no Certified Teacher/Associate Degree of Education. (Copy of Withdrawal Order is annexed as Annexure "I")
- which have been issued regarding termination or withdrawal of appointment of Certified Teacher-IT due to Certified Teacher/Associate Degree of Education & the department again sent draft regarding elimination of professional degree Certified Teacher/Associate Degree of Education to Secretariat, which is clear discrimination, as the

same yardstick is not applied to the case of the appellant. (Copy of Restoration Order is annexed as Annexure "J")

- 12. That feeling aggrieved the Appellant preferred a Departmental Appeal, but futile. (Copy of Departmental Appeal is annexed herewith as Annexure "K")
- 13. That after feeling exhausted the Appellant prefer the instant service appeal for promotion to the post of Secondary School Teacher-IT (BPS-16) with all back benefits upon the following grounds inter-alia:-

Grounds:

- A. That the appellant is naturally born bonafide citizen of the Islamic Republic of Pakistan & is fully & equally, on equality basis entitled to all basic & fundamental rights as enshrined in the fundamental law of the land, interpreted, guaranteed & enforced by the laws & law courts of the land.
- B. That as per the prevailing rules & law governing the subject, the Appellant is fully eligible in all aspects and is fully and equally entitled to be promoted on regular basis as Secondary School Teacher IT from the date of vacancy or date of 1st DPC meeting.
- C. That it is cherished principle of law that where a law requires a thing to be done in particular manner, then that has to be done in that very manner & not otherwise.

- D. That as per minutes of the 1st meeting of DPC posts of Secondary School Teacher- IT available for promoting from PBS-12 to PBS-16, but the respondent department have illegally & unlawfully deferred the promotion & that too without mentioning any reasons which is illegal, unlawful & against the regulations.
- E. That according to Article 4 of the Constitution, no one should be treated otherwise than accordance with law, while Article 25 postulates alike are to be treated alike, but here the case is volta-facie & totally different yardstick has been taken to that appellant.
- F. That discrimination in any form is highly abominable & bête-noire & always checked by the Superior Courts in a derisorious manner, the reason behind checking it down & chucking it away is to remove any sense of discrimination & to ensure equality & equal treatment.
- G. That from every angle, the appellant is entitled to be promoted as Secondary School Teacher -IT (from BPS-12 to BPS-16) on regular basis, w.e.f date of vacancy or at least from date of 1st DPC meeting i.e. 24/09/2020
- H. That deferment of the subject promotion for the subject post in the impugned DPC is based on malafide & liable to be struck down.
- I. That any other ground not raised here may graciously be allowed to be raised at the time of arguments.

It is, therefore, most humbly prayed that on acceptance of the instant Service Appeal, the Appellant may graciously be declared to be entitled to be promoted from the post of Certified Teacher-IT (BPS-12) to the post of Secondary School Teacher-IT (BPS-16) & be promoted as Secondary School Teacher-IT (BPS-16) with all back benefits in terms of arrears & seniority w.e.f the date of vacancy or at least from date of 1st D.P.C meeting i.e. 24/09/2020.
