In pursuance to the directions given on previous date, copy of order dated 26.11.2020 passed in Writ Petition No. 4949-P/2020 has been produced. Accordingly, notice for interim relief was given and was directed that till the date fixed, no adverse action shall be taken against the petitioners who were promoted prior to the promulgation of the Khyber Pakhtunkhwa Validation of Standing Order Act, 2005. Direction for production of this order was given on previous date so as to ascertain the impact of such order on execution of the judgment at credit of the petitioner. The order of the Hon'ble Peshawar High Court Peshawar relating to interim relief as produced today is specific to the petitioners in the relevant Writ Petition who were promoted prior to the promulgation of the K.P Validation of Standing Order Act, 2005. 1. That the appellant qualified KPK Public Service Commission Examination held for the post of ASI. Thereafter, he was appointed as ASI on probation on 29/07/1998 alongwith other ASIs of Hazara Range.

2. That the appellant completed the probation period successfully. Whereupon, he was confirmed as ASI with effect from his date of appointment on probation.

3. That the appellant was subsequently promoted as officiating sub inspector with effect from 17/11/2001. He qualified the upper class training in March, 2003. Seniority of the appellant remained intact, while entering him in list "E" from list "D". Similarly, his seniority remained same while promoted to the rank of officiating sub inspector alongwith his other batch fellows ASIs. Copy of order dated 17/11/2001 is attached as Annexure "A".

4. That the batch fellows of the appellant were promoted to the substantive rank of Sub Inspector on 17/05/2004. However, appellant was not promoted and confirmed on the pretext that he had not served as SIO for a period of one year. Although, it was not in the control of appellant to appoint

himself as SIO. The authority penalized the appellant for, apparently, their own fault.

5. That it is surprising that batch fellow of the appellant, namely, then ASIs Nazir Khan, Ayaz Khan, Jameel Akhtar Khan and Saeed Akhtar Khan were not kept on two years probation like the appellant for no stated or known reasons. Since, they were confirmed as Sub Inspector with effect from 11/05/2004, they were promoted as officiating Inspector in the year 2005 and now stand confirmed according to the same seniority. Copy of order dated 29/02/2008 is attached as Annexure "C".

6. That the appellant did not challenge the order of promotion to substantive rank of SI dated 06/04/2006 under the impression that seniority would be certainly adjusted on publication of seniority list. The appellant was also made to believe it as per view of the staff working in the set up of IG Police.

Nevertheless, on the publication of list of seniority, to the horror of the appellant, he found his name at S. No. 156, whereas, according to his original seniority he should have been at S. No. 79. Copy of Seniority list is attached as Annexure "D".

7. That the appellant has been promoted to the officiating rank of Inspector alongwith his colleagues through notification dated 31/05/2008 issued by the IG Police Peshawar. Name of appellant is included in list "F" as per recommendation of DPC. Copy of notification dated 31/05/2008 is attached as Annexure "E".

8. That the seniority list of Inspector on list "F" as it stood on 10/02/2011 was circulated towards the end of February, 2011. Objection of aggrieved Inspectors with respect to their seniority were invited. The appellant on becoming aware of new seniority list, made representation before the IG Police within the stipulated period in law,

9. That respondent No. 2 forwarded representation of appellant to respondent No. 1 alongwith his comments for decision. The representation of the appellant was dismissed by respondent No. 1. Copy of comments of respondent No. 2 are annexed as Annexures "G"

10. That the order of the respondent No. 1, IGP though passed on 01/10/2011, was communicated to the appellant on 14/11/2011 through proper channel. Copies of the said order and the letter conveying the letter is attached as annexure "H".

11. That the appellant seeks to impugn all the orders aforementioned adversely effecting the seniority of the appellant, as unwarranted at law and facts, inter-alia, on the following grounds:-

GROUND

- a. That the appellant as per settled principles is entitled to seniority from the date of his initial appointment as ASI on 29/07/1998. The promotion of the appellant not having been delayed due to his own fault, he cannot be penalized therefor.
- b. That after the appellant completed one year of appointment as SIO, he should have been confirmed as Sub-Inspector with effect from 11/05/2004 being the date of confirmation of his batch fellows. Mere mention of confirmation date as 06/04/2006 cannot deprive the appellant of his original seniority by any stretch of imaginations. Hence, he should have been promoted to the rank of Inspector and confirmed as such, alongwith his colleagues.
- c. That the appellant was kept on probation for two years without any

lawful justification presuming without conceding, the DIG has discretion to keep any officer on probation, such discretion must be judicially exercised according to the laid down principle of law.

d. That the appellant was never communicated the reasons for keeping him on probation and allowing his colleagues to bypass him. The orders are not only mala fide at law but discriminatory as well, falling within the fold of Article 25 of the Constitution of 1973. As such, adverse action against the appellant, militating against his entitled seniority are illegal, unlawful, without jurisdiction, unilateral, arbitrary, perverse and of no legal effect on the rights of appellant.

e. That pushing back the seniority of the appellant in view of foregoing background is simply misconceived




Thus, the impugned orders are liable to be set-aside and original seniority of appellant restored.

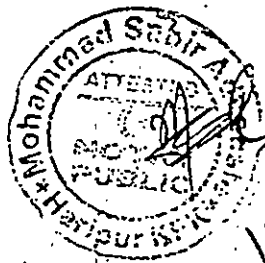

FACTS

2. The appellant was promoted as officiating Sub Inspector in the year, 2001.

The appellant was then deferred from promotion on 31.05.2004 on the ground that one year testing period as SHO in out district under rule 13.10(2) of the Police Rules, 1934 was not fulfilled. Subsequently the appellant was confirmed as Sub Inspectors on 03.05.2006 w.e.f 06.04.2006. Against this order the appellant filed the departmental appeal on 14.03.2011 which was dismissed on 01.10.2011. Thereafter, a seniority list was circulated on 10.02.2011 against which the appellant filed departmental appeal on 14.03.2011 which was rejected on 01.10.2011 and communicated to him on 14.11.2011. Thereafter he filed the present service appeal on 13.12.2011.

ARGUMENTS

3. Learned counsel for the appellant argued that this Tribunal in a number of cases has held that the confirmation of the officiating Sub Inspectors shall be from the date when the concerned official was promoted on officiating basis. In this regard he referred to judgment dated 21.02.2018 in service appeal No. 736/2016 entitled "*Amjad Ali Vs. Government of Khyber Pakhtunkhwa through Secretary, Home and Tribal Affairs Department, Peshawar and others.*"

4. On the other hand learned DDA argued that the appellant did not implead those officers/officials who would be declared junior to him through anticipated judgment. That the departmental authority rightly ordered the confirmation of the appellant from 04.06.2006 because he was to undergo certain pre-conditions like testing for one year and passing certain courses. He next contended that the present appeal was time barred.

CONCLUSION

5. Since this Tribunal has already decided this issue in case referred to above, the case of the appellant is also similar to that appeal. This Tribunal in the case of *Amjad Ali* above has already directed that all the similarly placed officials be extended the benefits of the judgment.

6. In view thereof this appeal is also disposed of in the same terms and with the direction to the department to extend the benefit of the judgment of *Amjad Ali* to all similarly placed officials, so that the original seniority of the seniors may not be disturbed. Parties are left to bear their own costs. File be consigned to the record room.

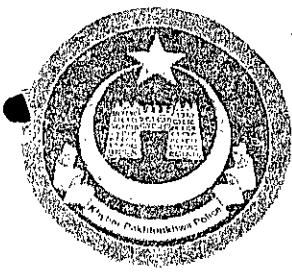
