PRAYER: -

On acceptance of the instant appeal, the impugned acts of the respondents regarding non-promotion of the appellant from BPS-7 to BPS-9 w.e.f 2005, BPS-9 to BPS-15 w.e.f 2012 and retirement of the appellant in BPS-14 may please be declared as wrong, illegal, against the law and facts, arbitrary, fanciful, against the service rules applicable on the lis, against the fundamental rights of the appellant and the respondents may please be directed to consider and promote the petitioner from BPS-7 to BPS-9 w.e.f 2005, from BPS-9 to BPS-15 w.e.f. 2012 and ultimately the appellant may please be ordered to be retired in BPS-15 and all the benefits in this regard may also be ordered to be issued in favour of the appellant or any other order or relief as this Honourable Tribunal deems fit and

appropriate in the circumstances of the case, may also be issued/passed.

Respectfully Sheweth!

1. That, the appellant hails from Village Mehran P.O New Darband, Tehsil Darband/Oghi District Mansehra who was inducted in Education Department as PTC Teacher on 25.11.1987 who joined his service in GPS Garhi Hassan Zai Kala Dhaka presently District Torghar which was the then part of District Mansehra.

(Copy of the appointment order is annexed as annexure "A").

2. That, during the service, appellant got his Intermediate examination in the year 2005.

(Copy of the Intermediate certificate is annexed as annexure "B").

3. That, later on, as per the policy of Education Department, the teacher who increased his education upto Intermediate will be promoted to higher rank/scale and be considered from BPS-07 to BPS-09 forthwith.

(Copies of the service book are annexed as annexure "C").

4. That, after obtaining the Intermediate Certificate, the appellant produced the same for his promotion and it was assured to the appellant that he will be promoted as per rules, law and policy on the subject.
5. That, later on, the appellant time and again got information regarding his promotion from the respondents but only lame excuses were made by the respondents in this regard for reason best known to them.
6. That, during the service, the scales were upgraded and BPS-07 was changed into BPS-14 whereas BPS-09 was changed into BPS-15 and ultimately the name of the appellant was put in Grade/BPS-14 in the year 2012.

(Copy of the notification of promotion is annexed as annexure "D").

7. That, the appellant served the department with great Zeal and zest and later on retired in BPS-14 after attaining the age of superannuation i.e. 60 years on 31.12.2018.

(Copy of the retirement order is annexed as annexure "E").

8. That, after his retirement, the appellant after submitted a departmental appeal before the respondent No.3 but the same has till unattended to.

(Copy of the departmental appeal is annexed as annexure "F").

9. That, the appellant being aggrieved from the impugned acts of the respondents having no other efficacious remedy except to invoke the jurisdiction of this Honourable Court by way of instant appeal, inter alia, on the following grounds: -

GROUND

- a. That, the impugned acts of the respondents regarding non-promotion of the appellant from BPS-7 to BPS-9 w.e.f 2005, BPS-9 to BPS-15 w.e.f 2012 and retirement of the appellant in BPS-14 may please be declared as wrong, illegal, against the law and facts, arbitrary, fanciful, against the service rules applicable on the lis, against the

fundamental rights of the appellant hence liable to be struck down/set aside.

- b. That, the rules on the subject are very much clear that any teacher who would increase his education, would be entitled for promotion. The appellant got his Intermediate in the year 2005 whereas at that time the appellant was working in BPS-07 hence after the Intermediate, the appellant should have been promoted to BPS-09 but very strangely, the respondents while sheer violation of the relevant law, rules and regulations did not promoted the appellant in BPS-09.
- c. That, the appellant left no stone unturned for redressal of his grievances but of no avail and the respondents on one or other pretext lingering on the matter on one or other pretext and the same is still unattended to and the grievances of the appellant have not been redressed so far.
- d. That, it is worthy to note here that same like teachers who are at par with the appellant rather some are juniors were promoted to BPS-15 whereas in case of

the petitioner, clear cut discrimination has been done and malafidely on the part of the respondents is floating on the surface of record and such act of the respondents being against the constitutional guaranteed rights of the appellant is deplorable and condemnable.

- e. That, injustice has been done with the appellant and the appellant has been deprived from his legal, valid and legitimate right by the respondents for no fault at his part.
- f. That, the appellant had unblemished service record and there is not even a single negative entry against the appellant could be made basis for depriving him from his legal right of promotion.
- g. That, the respondents have treated the case of the appellant with deaf ear and never paid any heed to safeguard the rights of the appellant for the reasons best known to them.
- h. That, under the law a thing is to be done in a particular manner then the same must be done in that very manner otherwise, it would be abused of process.


- i. That, prima facie, the appeal of the appellant is very strong as the law, rules and regulations on the subject clearly supports the version of the appellant.

promoted to BPS-15 and I was deprived for the same. It is very important that not only the teachers but other staff were also given their due right as per their qualification and the petitioner was deprived.


