- c. The complaint tee teachers be strictly warned, even be proceeded under rules, to be careful in future and not to use social media for such matters against their transfer under policy or other Departmental administrative action, which is clear-cut violation of use of Social Media by Govt. servant.
- d. The DEO (F) Haripur be advised to guide her teachers time to time and keep sympathetic attitude with her teachers in future.

4. Findings

Following facts are found after discussing the matter during meetings with DEO (F) Haripur and others concerned staff/teacher (Listed above) as well as going through the replies to questionnaire and discussing the grounds of complaints with concerned officers, PTC members, Patents and intervening project members i.e. AAR Japan.

- j. The teachers submitted the complaints agains: DEO (F) due to their transfer from the school, which was on administrative grounds in the best interest of public service as well betterment of the schooling.
- ii. GGPS /GGMS TIP Haripur is the one of the best school of the District Hairpur.
- iii. The International NGO i.e. AAR Japan has supporting / facilitating the school for inclusive education in the school and provided furniture, laptops, speakers and other equipments along with construction of ramps, etc.
- iv. The concerned complaint tee teachers are found guilty of misconfluct as well avoiding the protocol of Social Media, notified for the Govt. servant by conducting press conference against the District Admin as well Govt. and publishing the aggressive messages / posts on Face book etc against the District Admin. (Anx-IX-02 pages)
- v. The Head Teachress Mst. Nazli Banu PSHT GGPS TIP Ex-Head Teachress, who is transferred to GGPS Model Town, was found very aggressive as well using un-civilized language against her transfer during the meeting with enquiry officer and again and again tried to prove herself as a hardworking and honest teacher but in the light of the school visit as well meeting with PTC members / Parents / HM GGMS TIP she was not taking interest in the school matters as well quality education.
- vi. All of the teachers are transferred on administrative grounds near to their home stations within a radius not more than 01 KM i.e. no one is transferred far-flung.
- vii. It is worth to mention here that the newly posted staff / teachers are working with professional spirit and trying their best to prove themselves best teachers working for the improvement of schooling in the school under question.
- viii. The Mst. Khatbain Bibi HM GGMS TIP, which is running in same building, stated in her reply to the questionnaire that the previous teachers, who are transferred remained
