Respectfully Sheweth,

FACTS:-

1. That, petitioner was appointed respondents
department on 12-06-2009 through
Notification No.14667-96/E-III/Order, dated 12-
06-2009. *(Copy of appointment order is
annexed as Annexure "A")*.
2. That respondent No.3/ department issued
seniority list vide Notification No.13053/E-III dated
31-12-2011 wherein petitioner was placed at

serial No.283. ***(Copy of seniority list is as Annexure as Annexure "B").***

3. That, respondent No.6 to 11 who were placed at Sr.298,302,304,305,306, and 307 of seniority list were promoted to the post of senior Clerk (BPS-09 now BPS-14) by respondent No.3 vide impugned Notification No.14779-99/E-III, dated 22-07-2013. While the petitioner was not considered for the purpose of promotion in sheer violation of law and against the principles of natural justice. ***(Copy of Impugned Notification is Annexure as Annexure "C").***
4. That, petitioner filed departmental appeal/representation before the respondent No.1 for promotion but so far no re-dressal has been made. ***(Copy of representation is Annexure as Annexure "D").***
5. That, in similar case against the impugned notification a writ petition No. 474-D/2013 was filed before Honorable Peshawar High Court, D.I Khan Bench, where in the respondent makes a commitment before the Honorable Court for promotion of petitioner and the said commitment was honored by respondent in Contempt of Court 103-D-/2018. ***(Copy of writ petition along with***

order and COC are Annexure as Annexure "E").

6. That, feeling aggrieved from the impugned Order No.17479-99/E-III Dated 22/07/2013, of respondent No. 3 the appellant approaches this honorable tribunal for redressal of his grievances on the following amongst the other grounds.

GROUND:-

- a. That, Impugned Order/Notification of respondent No.3 not to consider the petitioner for promotion is highly illegal against the law and norms of natural justice.
- b. That impugned order against the law and facts hence liable to be set-aside.
- c. That the Impugned order dated 22/07/2013 is illegal, void ab-initio having no legal effects hence, liable to be set aside.
- d. That petitioner is duly qualified, as per his due seniority as well as professional skills to have been to the post of Senior Clerk by the respondent, while processing promotion of Junior Clerk through impugned notification denial on part of respondents, amounts to discrimination in term of constitutional provisions.

- e. That while processing the promotion the petitioner was destitute from his lawful right and promotion order of the respondents No,6 to 11, (who were juniors to the petitioner) is highly condemned able and liable to be set-aside.
- f. That respondent No.3 issued the impugned Notification dated 22/07/2013 accommodated their blue eyed i.e. respondent No.6 to 11 and while ignoring the petitioner is against the law and the same is not sustainable in the eye of law.
- g. That other ground may be agitated during the course of arguments with the kind permission of this Honorable Court.



Respectfully Sheweth:-

BRIEF FACTS:

- 1- That petitioners were appointed as Junior Clerks in Khyber Pakhtunkhwa Police Department in years 12-6-2009.
- 2- That the respondents illegally and in violation of the seniority list, issued the seniority list by way of which Junior employees were given promotion as against petitioners.
- 3- That petitioners challenged the illegal acts of the respondents by way of Writ Petition No. 474-D/2013. During the proceeding of the above said Writ Petition Mr. DSP Legal Mr. Imtaiz Ali appeared before Honourable Court and made commitment that petitioners will be promoted as per their seniority. And the Honourable Court was pleased to allow the Writ Petition in the light of commitment made at the bar. Copy of the Writ Petition along with judgment dated 20/04/2017 is enclosed as Annexure "A".



4.

That on the request of respondents Honourable Court was pleased to grant 60 days time from the date of judgment to grant promotion to the petitioners but respondents despite repeated requests have not given promotion to the petitioners.

5.

That respondents are bent upon frustrating order of this Honourable Court by not promoting petitioners quite willfully which amounts to disobedience and non-compliance of the order of this Honourable Court. Hence petitioners approaches this Honourable Court for initiating contempt of Court proceeding against respondents, inter alia, on the following grounds:-

GROUNDS:-

a)

That the impugned action / inaction of the respondents of non-compliance and disobedience of this Honourable Court is against the law and is deliberate attempt on the part of the respondents simply to deprive the petitioner of remedy granted by this Honourable Court.

b)

That the modus operandi and conduct of the respondents is in no way to be condoned as they have no regard and respect for this Honourable as is evident of their attitudinal behavior, which amounts to lowering dignity of the Honourable Court that's why respondents be proceeded against.

c)

That modus operandi displayed by respondents for willful defying order of this Honourable Court has left the petitioner to seek indulgence of this Honourable Court to get its order implemented by initiating contempt of Court proceeding now through awarding punishment to respondents Under Sections 3, 4 the Act read with Article 204 of Constitution of Pakistan.

d) That counsel for the petitioners may also be allowed to raise any additional grounds during the Course of arguments.

In view of the submissions made above, it is therefore humbly prayed that on acceptance this petition, this Honourable Court may very graciously be pleased to initiate contempt proceeding against the respondents under relevant laws, and they - be punished for commission of contempt of this Honourable Court so that ends of justice and fair play be met in letter and spirit.

PETITION UNDER ARTICLE 199, CONSTITUTION OF I.R.P. 1973.

PRAYER:-

To kindly direct and require the respondents to act in accordance with law, desist from acting contrary to law, desist from discriminating the petitioners by ignoring them and promoting juniors instead in violation of law, rules and seniority.

To declare Order/Notification No: 17479-99/111 dated 22.7.13 as illegal, ultra vires, Null and Void ab-initio, issued wrongly to the detriment of petitioners, and thereby direct and require respondents to desist from giving effect to the said Notification.

To direct and require the respondents to consider the petitioners for promotion in accordance with law, rules and above all their due seniority. With grant of any other remedy that this Hon'ble Court may consider appropriate in the circumstances.

Respectfully Stated,

The petitioners prefer instant petition on, inter-alia, the grounds hereinafter submitted apropos the following facts.

BRIEF FACTS:-

1. That the petitioners, sane, adult citizens are residing within a territorial jurisdiction of this Hon'ble court and are rightfully eligible for the purpose of relief sought here.

2. That during the years 2008-2009, the petitioners, besides a number of other candidates, being duly qualified, were appointed as Junior Clerks in CPK Police Department by Respondent No.1 and have been posted last as per address given in the title.
3. That during the course of employment of the petitioners a Seniority List was devised and issued at the strength of Notification No:13053/E-III dated 28.6.2012, wherein petitioner No.1 is placed at serial No.228, Petitioner No. 2 at serial No.217, petitioner No.3, at serial No.229, petitioner No.4 at serial No.292, petitioner No.5 is at serial No. 293, petitioner No.6 at serial No. 295 and petitioner No.7 is placed at serial No.297 of the said list. Copy of Seniority List is placed at Annex-A.
4. That to the dismay of petitioners those junior to the petitioners i.e. respondents placed at serial numbers 12 to 28 in the title, have recently been promoted to the post of Senior Clerk (BPS-9) by respondents at the strength of Notification No. 11479-99/E-III dated 22.7.2015 while the petitioners were not even considered for the purpose of promotion in sheer derogation, violation and disregard to law, rules and principles of natural justice. Copy of Notification impugned hereby is placed at Annex-B.
5. That aggrieved of the high-handedness and illegality on part of respondents departmental appeals/representations were moved by all the petitioners with respondent No. 1 but were apparently thrown to trash-bin without any action and consideration since till date no response has been received by the petitioners from the office of respondent No.1 or rest. Copies of appeals/representations are placed at Annex-C.
6. That aggrieved by the discriminatory action and omission on part of the respondents, in their failure to abide by the Law & Rules in vogue and left with no other remedy available to him, the petitioners approach this Hon'ble court seeking redressal of their grievance on the grounds mentioned hereibelow.

GROUND:

- a. That the petitioners are duly qualified, as per their due seniority as well professional skills and academics to have been considered for promotion to the post of Senior Clerk by the respondents while processing promotion of Junior Clerks through impugned notification. Denial on part of respondents not to consider the petitioners amounts to discriminatory in terms of constitutional provisions.
- b. That the act and omission on part of respondents while processing and making promotions through impugned order / Notification is against the spirit or principles governing public / civil service and thereby has caused grave miscarriage of justice provoking interference by this Hon'ble Court in its constitutional jurisdiction to correct, rectify and undo the wrong.
- c. That the petitioners have been discriminated and victimized apparently due to extraneous and political interference and without any lawful justification. Withholding and ignoring Law, Rules & merit in making promotions, by respondents appears to be an effort not only to appease political bosses but to frustrate the rights of the petitioners accredited day by law and precedents, thus calling for interference by this Hon'ble court.



RESPECTIVELY SHEWETH:

PRELIMINARY OBJECTIONS:-

- a) The appeal is not based on facts.
- b) The appeal is not maintainable in the present form.
- c) The appeal is bad for miss-joinder and non-joinder of necessary parties.
- d) The appellant is estopped to file the appeal by his own conduct.
- e) Appeal is bad by law and limitation.
- f) The appellant has not come to this Honorable Tribunal with clean hands.
- g) The appellant has got no cause or locus standi of action to file present Service Appeal.

FACTS

1. Para No. 1 pertains to record.
2. Correct.
3. Para No. 3 is incorrect hence, rebutted. In fact 69 vacancies of Senior Clerks (BPS-09) were available for promotion of Junior Clerks to the rank of Senior Clerk. As per minutes of DPC held on 05.07.2013, a total 217 names of Junior Clerks were included in the agenda of meeting. The name of appellant was placed at S. No. 193 and was discussed in the DPC meeting wherein, the committee deferred him due to incomplete ACRs for the period from 01.01.2010 to 15.09.2010, 01.01.2011 to 31.12.2011 & 01.01.2012 to 31.12.2012, vide Notification No. 17477/ E-III dated 22.07.2013. (Copy of the DPC minutes & Notification No. 17477/ E-III is annexed as "A" & "B" respectively).
4. Pertains to record.
5. Para No. 5 to the extent of commitment before the Honorable Court for promotion of petitioner in Writ Petition No. 474-D/2013, is illogical and not prudent. The promotion and seniority of officials of Police are being regulated in accordance with the prescribed criteria/ rules. Unless and

until these criteria are not fulfilled no one, can be promoted to the next higher rank.


6. That the act of answering respondents by not recommending/ considering the name of appellant in the DPC held on 05.07.2013, were quite legal and in accordance with law/ rules. The ACRs of appellant for the period mentioned above were missing so he was not recommended by the committee to be promoted to the rank of Senior Clerk. No illegality has been committed by the respondents while dealing the instant appellant. As discussed above, the instant Service Appeal may be dismissed on the following Grounds.


GROUND:-

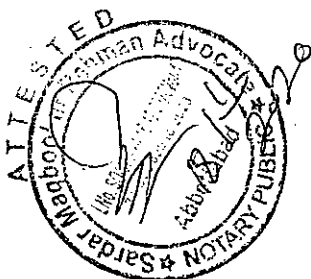

remain present in the office or to perform any duty. Elaborating his point further, Learned Counsel maintains that suspended official could not be expected to sustain himself and his family without doing some other work. The respondents had no moral or legal authority to demand his presence in office except when he might be required to attend office in connection with the departmental proceedings. Learned Counsel vehemently maintains that the impugned orders were fit to be set aside.

8. Appearing on behalf of the respondents, Learned District Attorney relies on the written objections filed by them. He particularly referred to the fact that the appellant had even earlier been censured twice on account of his absence from duty for two days in May, 1988 and 13 days in March, 1988 apart from the penalty of censure on account of his failure in disposal of important papers, in addition to the reduction in pay by two stages on account of his substance from duty from 15-8-1988 to 26-8-1988. Learned District Attorney maintained that the work and conduct of the appellant had remained unsatisfactory. He, therefore, urged that the appeal should be set aside.

9. I have heard the learned counsel for the appellant and have taken note of the points raised by the Learned District Attorney. I am afraid the scope of the efficiency & Discipline Rules does not include consideration of the entire past of a civil servant in a given case of misconduct on his part. A such an exercise could alone be conducted while considering the case of a civil servant for retirement under Section 12(i) of the Punjab Civil Servants Act, 1974.

10. The appellant concedes that he had regretted his inability to perform duty during the period of his suspension. Such conduct was not in fact worthy of a conscientious civil servant. He is indeed fit to be censured again on this account. However, I am of the view that the penalty of removal from services imposed on him was apparently disproportionate to the ungratifying stance taken by the appellant when he refused to perform duties while he was under suspension. A suspended official could not legally be asked to perform duty unless he was re-instated in service. Punishing him with removal from service cannot, therefore, be sustained in law.

11. In view of the foregoing, I accept the appeal, set aside the impugned orders whereby the appellant was removed from service, re-instate him in service and impose upon him the penalty of censure on account of the indiscretion shown by him as a civil servant. The period of his absence from duty from the date he was removed from service till he resumes duty shall be treated as leave of the kind due.

12. The parties are left to bear their own costs.

JUDGMENT

Roshan Ali Mangi, Member.--The facts leading to this case are that the appellant Mr. Amin Jan joined the T&T Department in the year 1973. He was promoted to the post of A.D.E (B-17) w.e.f. 26.12.1983 on 5.7.1988. A seniority list of A.D.E. was circulated in which the name of the appellant was placed at Sl. No. 25. The name of his junior Mr. Muhammad Afzal, respondent No. 4 on the other hand appeared at Sl. No. 26. At such the appellant was shown senior to respondents No. 4.

2. The D.P.C. was convened in the year 1988, in which promotion to the post of regular D.Es (B-18) was considered. Out of them 15 were promoted, vide order dated 19.10.1988. But the appellant alongwith some other officers, were deferred. Respondents No. 4 to 8 although being junior to the appellant were among those who were promoted.

15. As regards limitation, the learned counsel for the respondents stated that it had two aspects - one legal and other factual. As regards factual, there was neither original order, nor the appellate order in the field. As regards the former, the appellant was deferred in 1988 and promoted to B-18 on 15.6.1991. He did not agitate for the antidation of his promotion. In other words, he had accepted that position at that time. As such he cannot now agitate at this belated time. He further argued that the appellant submitted his representation for antidation of his promotion and seniority on 11 Oct' 1995, which was replied on 8 July, 1996. As a matter of fact he should have come to the Tribunal after expiry of mandatory period of 90 days. But chose to wait and that period was over. And approached the Tribunal much later. In other words he had accepted the position. Now it was too late to agitate. As such his appeal was clearly time barred.

16. The learned counsel for the respondents raised yet another objection i.e. the impugned order dated 3rd July, 1996 was not addressed to the appellant. Besides, he also objected that departmental appeal was not addressed to Board of Directors, who constituted the appellate authority. Concluding his arguments, the learned counsel contended that if the case judged on the legal ground, it has no legal base. It was time barred, as the cause arose in 1991, when the appellant got promotion, however, he made an appeal although not to proper authority in 1995 and approached the Tribunal in 1996, as such the appellant's appeal was patently time barred, hence liable to be dismissed.

17. The learned counsel for the appellant, on the other hand took position that the appeal can not be dismissed merely on the grounds of limitation if the facts of the case have merit. In this regard he quoted the following judgments of the Supreme Court in support of his stand :-

- (ii) 1987 SCMR 367
- (iii) 1990 SCMR 1356
- (iv) 1970 SCMR 170
- (v) 1991 SCMR 640
- (vi) 1995 SCMR P. 16
- (vii) 1996 SCMR 850 (854).

18. As regards, the objection of the learned counsel of the respondents pertaining to non addressing of the impugned order to the appellant, the learned counsel for the appellant pleaded that the said impugned order contained in para 3, which mentions as: "The officer may please be informed accordingly". From this he contended that the appellant was informed and accordingly he took the action of filing appeal before the Tribunal. As such the learned counsel for the respondents' objection was not tenable.

19. We have heard the parties at length and perused the relevant record.

20. The main issue to resolve is whether or not the appellant is entitled to his original seniority on promotion i.e. with effect from the date of promotion of his juniors, under the law when he was deferred, but not superseded. As a matter of fact if the appellant was considered to be at fault as learned counsel for the respondents contended, when he did not agitate on his promotion to reckon his original seniority the department cannot be absolved from its duties to have given the appellant his original seniority on his own either.

21. We find that the appellant was deferred, due to whatever reason, during the consideration of promotion of the appellant alongwith others in 1986 by the DPC. However, later on he was promoted to B-18 during the meeting of DPC held in 1991. It is a settled law that has also been quoted by the learned counsel for the appellant above in para 5, that when an employee is deferred on promotion, he gets seniority from the date his juniors are promoted. It was, therefore, incumbent upon the department to have allowed the appellant his seniority on promotion to next higher grade, from the date his juniors were promoted. He was not superseded, but deferred due to reasons beyond his control. That does not forfeit his right to reckon his seniority from the date his juniors were promoted.

22. The learned counsel's objection *prima facie* appears justified when he contended as to why the appellant did not agitate at that time. We at the moment agree with him. But at the same time we are of the opinion that the department too had erred not to have given the original seniority to the appellant, as he was deferred not superseded, hence on his promotion he was entitled to his original seniority in accordance with law automatically. We asked the respondent department, was it not supposed to assign the seniority to the appellant on their own, on his promotion from the date his juniors were promoted? The learned counsel for the respondents replied that Tribunal was supposed to decide such issues. Any how if he did agitate at that time, it does not forfeit his right to reckon his original seniority. It is against the principles of natural justice and fairplay to kill the vested right of civil servant on the alter of limitation. In this regard the learned counsel for the appellant has quoted number of judgments of the Supreme Court in which it has been held that appeals be not dismissed on the ground of limitation, when the facts of the case have merits. And we subscribe to that law and condone the delay if at all caused under the circumstances.

23. For the reasons recorded above, we accept the appeal and direct the department, that the appellant shall reckon his seniority from the date his juniors were promoted, with all consequential benefits.

24. No order as to costs.

25. Parties be informed.

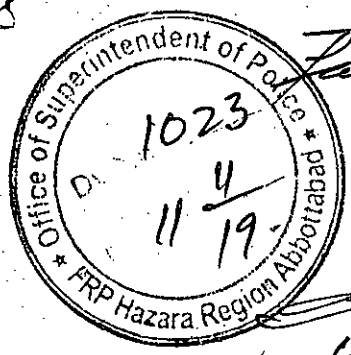
