

IT IS VERY RESPECTFULLY PRAYED THAT, ON ACCEPTANCE OF THE INSTANT APPEAL, THE IMPUGNED ORDER DATED 15-11-2018, AND NOTIFICATION DATED 09-07-2018 AND ANY SENIORITY LIST PREPARED PREJUDICIAL TO THE INTEREST OF THE APPELLANT MAY KINDLY BE SET ASIDE, AND RESPONDENTS MAY BE DIRECTED TO PLACE THE APPELLANT ON ITS ORIGINAL POSITION IN SENIORITY LIST AS OF SENIORITY LIST OF 2013, AND BE PROMOTED AS REGULAR TEHSILDAR WITH ALL CONSEQUENTIAL BENEFITS AND PRIVATE RESPONDENTS MAY KINDLY BE DECLARED AS JUNIOR TO THE APPELLANT.

Respectfully Sheweth:

The appellant submits as under:-

1. That the appellant was appointed directly as Assistant BPS-11 vide order No.5078/Estt:/8, dated 22-02-2006 was posted in the office of

Deputy Commissioner, Buner and, later-on, the post of Assistant was upgraded to BPS-16 vide Notification No. ED/SO/SCM/FR 10-22/2014 dated 20-05-2014. (Annexure "A")

 That, then the appellant was posted as Naib Tehsildar land Reform SWAT Dated: 14-03-2013 on own pay and scale, by the then Commissioner, Malakand vide office order No <u>1938</u> / 2/18/VOI-N/Estt.

Copy of office order is (Annexure "B")

- 3. That, then the Appellant was posted on current charge basis (CCB) as Tehsildar, **DARGAI**, vide order No Estt:I/PF/Qutab Khan Dated 12-11-2014 . (Annexure "C")
- That, then the appellant was posted as regular Political Tehsildar on the Disposal of Commissioner Bannu Division for further posting in North Waziristan Agency, vide office order No. FS/L&O/37/540-41Dated: 11-02-2016. (Annexure "D").
- 5. That, then the appellant was posted as regular Political Tehsildar, MIRALI, vide office order No 716 -21-/AG-1/F.90. Dated: 22-02-2016. (Annexure "E").
- 6. Then, the appellant was posted as regular Political Tehsildar and transferred to Tehsil DOSSALI vide office order No. 3819-24/AG-1/F-90. Dated: 26-12-2016 and also given additional charge of Political Teshildar Garyum vide office order No. 411-13/ APA /RZK Dated: 07-04-2014.(Annexure "F")
- That then appellant was lastly posted as Political Tehsildar, FR-BANNU vide office order No. 680-89-/AGI/F.9 Dated: 02-02-2018. (Annexure "G")
- 8. That, Government of Khyber Pakhtunkhwa, Board of Revenue & Estate Department, vide No. ESTT.1/34/S.I/17106-19 circulated tentative seniority list of regular Assistants PBS-16 as stood on 31-12-2013, which was further circulated. According to that list, the appellant has been shown at S. No. 192. (Annexure ''H'')
- 9. That, Government of Khyber Pakhtunkhwa, Board of Revenue & Estate Department, vide Notification No. 1942/Estt:/135/SSRC, Dated Peshawar 23-01-2015, laid down the method of recruitment, qualification and other conditions to the various posts. According to which at Sr. No. 1 for the post of Tehsildar (BPS-16), in column 7, amongst others, at "(c) Twenty percent by promotion on the basis

of joint seniority-cum-fitness from amongst Assistant of the office of Board of Revenue, offices of Commissioners, Deputy Commissioners and Political Agents having five years service as such" quota was fixed pertaining to the cadre of the appellant. (Annexure ''I'')

- 10. That, in view of the seniority of the appellant, postings on such posts and services rendered at the position of Tehsildar the appellant had a legitimate expectations to be promoted on merit to the post of Tehsildar in due course.
- 11. That on 17-08-2018, Government of Khyber Pakhtunkhwa, Board of issued Department, Notification No. Revenue & Estate Estt:/P.T/30393-430 showing the name of the appellant at Sr. No. 8, and as mentioned that on completion of settlement / Revenue training of newly promoted Tehsildar / Naib Tehsildar the incumbents were repatriated to his parent department. But another order of the same date Notification No. 30367 (Annex-J), whereby contrary to the notification No. Estt:/P.T/30393-430, mentioned above, no newly promoted Tehsildar / Naib Tehsildar was appointed to the posts vacated by the appellant and others rather BPS-14 personals were appointed. Consequent upon these notifications the Commissioner of Bannu vide OFFICE ORDER No. 3672-95/Estab./DT/18 dated August 31, 2018 at Sr. No. 6, Mr. Tanzil-ur.-Rehman, Naib Tehsildar (BPS-14) was posted against the post occupied by the appellant (Annex-K). It was surprising for the appellant. The appellant immediately submitted the department appeal to the competent Authority on 18-08-2018, which was rejected through a two line order, vide letter dated 25-09-2018, without any stating reasons and speaking order.
- 12. That appellant impugned the order dated 25-09-2018 through Service Appeal No. 1185/2018, in which the learned KP Service Tribunal, passed an order of status quo, on 01-10-2018. (Annex-L)
- 13. That, due to these notifications, the appellant faced mental torture and agony also loss of career to the appellant and was searching for the reason, and finally found few juniors to the appellant has been promoted but no latest seniority list has been circulated. The appellant also requests for provision of latest seniority lists of year 2017.
- 14. This act of discrimination is causing recurring loss to the appellant in term of financial benefits as well as career.

15. That after rejection of earlier departmental appeal, the appellant found a *Notification No. Estt: 1/P/27057 dated 09/07/2018*, whereby in the impugned notification mentioned above, at Sr. No.6 Mr. Imran Zaman, Sr. No. 13 Mr. Khalid Mansoor, and Sr. No. 71 Mr. Muhammad Ayaz, are shown as Tehsildar upon completion of training. These incumbents are most junior in the seniority list as on 31-12-2013 circulated by the Board of Revenue mentioned above as at Sr. No. 235, Sr. No. 253 and Sr. No. 312 respectively while the appellant is at Sr. No. 192). (Notification dated 09-07-2018 is Annexure ''M").

- 16. That *Notification No. Estt: I/P/27057 dated 09/07/2018* caused me a recurring loss to my career and the appellant is *aggrieved* of these orders and also other orders, which are not in the knowledge of the appellant, wherein any junior to the appellant has been promoted and the appellant has not been considered for any such Departmental Promotion Committee (DPC) or training, without any due cause and the appellant is deprived of his legal right to the promotion.
- 17. That the appellant submitted an application for provision of the fresh / last prepared seniority list to the respondents but response is still awaited (copy of the application is **Annexure "N"**).
- 18. That the appellant preferred department appeal through proper channel on 22-10-2018 (Annexure "O"), which is filed / declined vide letter / order No. Estt:I/PF/Saraf Ali/37067 dated 15-11-2018.
- 19.That the impugned order dated 15-11-2018, above mentioned notifications and notification dated 09-07-2018 are discrimination and prejudice to the rights of the appellant and caused huge loss to the appellant of expectations for consideration to promotion and , inter-alia, challenges the same on the following grounds.

GROUNDS.

- A. That the impugned order dated 15-11-2018 and notification dated 09-07-2018 mentioned above, are against the law, facts and material available on record.
- B. That the private respondents were junior to the appellant and are promoted against the law and Rules.
- C. That appellant is the senior most employee of the cadre and is eligible for promotion as regular Tehsildar according to the Rules, but the respondents promoted the junior employees against the rights of the appellants.

D. That the respondents have not circulated the seniority list of the employees and changed the seniority position of the appellant against the rights of the appellant.

- E. That the above mentioned orders of the respondents are against the fundamental rights of the appellant as provided by the Constitution of the Islamic Republic of Pakistan.
- F. That the above mentioned acts of the respondents are discrimination against the rights of the appellant.
- G. That the respondents acted in an arbitrary manner against the rights of the appellant which is clear example of mala fide.
- H. That the appellant has not been provided chance of personal hearing to clarify his position which is against the law and natural justice.
- I. That any other ground which this honorable court may deems fit may kindly be allowed to the appellant during the proceeding and at the time of final arguments.

It is very humbly requested that, in view of the above fact, the appeal of the appellant may kindly be accepted and allowed as prayed for.

Any other relief which this Hon'ble Tribunal may deem just and proper in the circumstances of the case may kindly be granted in favour of the appellant.

It was further contended that he was transferred from the post of Political Tehsildar, Dossali North Waziristan to the post of Political Tehsildar FR Bannu vide order dated 21.02.2018 but just after six months he has been again transferred from Tehsildar (CCB) FR Bannu and repatriated to his parent office vide impugned order dated 17.08.2018 before completing his normal tenure therefore, the impugned order is illegal and liable to be set-aside.

The appellant submits as under:-

- 1. That the appellant was appointed directly as Assistant BPS-11 vide order No.5078/Estt:/8, dated 22-02-2006 was posted in the office of Deputy Commissioner, Buner and, later-on, the post of Assistant was upgraded to BPS-16 vide Notification No. ED/SO/SCM/FR 10-22/2014 dated 20-05-2014. (Annexure ("A")
- That, then the appellant was posted as Naib Tehsildar land Reform SWAT Dated: 14-03-2013 on own pay and scale, by the then Commissioner, Malakand vide office order No <u>1938</u> / 2/18/VOI-N/Estt.
   Copy of office order is Annexure ("B")
- 3. That, then the Appellant was posted on current charge basis (CCB) as Tehsildar, **DARGAI**, vide order No Estt:I/PF/Qutab Khan Dated 12-11-2014. (Annexure "C")
- 4. That, then the appellant was posted as regular Political Tehsildar on the Disposal of Commissioner Bannu Division for further posting in North Waziristan Agency, vide office order No. FS/L&O/37/540-41Dated: 11-02-2016. (Annexure "D").
- 5. That, then the appellant was posted as regular Political Tehsildar, **MIRALI**, vide office order No 716 -21-/AG-1/F.90. Dated: 22-02-2016. (Annexure "E").

- 6. Then, the appellant was posted as regular Political Tehsildar and transferred to Tehsil **DOSSALI** vide office order No. 3819-24/AG-1/F-90. Dated: 26-12-2016 and also given additional charge of Political Teshildar Garyum vide office order No. 411-13/ APA /RZK Dated: 07-04-2014.(Annexure "F")
- That then appellant was lastly posted as Political Tehsildar, FR-BANNU vide office order No. 680-89-/AGI/F.9 Dated: 02-02-2018. (Annexure "G")
- 8. That, Government of Khyber Pakhtunkhwa, Board of Revenue & Estate Department, vide No. ESTT.1/34/S.I/17106-19 circulated tentative seniority list of regular Assistants PBS-16 as stood on 31-12-2013, which was further circulated. According to that list, the appellant has been shown at S. No. 192. (Annexure "H")
- 9. That, Government of Khyber Pakhtunkhwa, Board of Revenue & Estate Department, vide Notification No. 1942/Estt:/135/SSRC, Dated Peshawar 23-01-2015, laid down the method of recruitment, qualification and other conditions to the various posts. According to which at Sr. No. 1 for the post of Tehsildar (BPS-16), in column 7, amongst others, at "(c) Twenty percent by promotion on the basis of joint seniority-cum-fitness from amongst Assistant of the office of Board of Revenue, offices of Commissioners, Deputy Commissioners and Political Agents having five years service as such" quota was fixed pertaining to the cadre of the appellant. (AMNITURE-I)
- 10. That, in view of the seniority of the appellant, postings on such posts and services rendered at the position of Tehsildar the appellant had a legitimate expectations to be promoted on merit to the post of Tehsildar in due course.



That on 17-08-2018, Government of Khyber Pakhtunkhwa, 11. Board of Revenue & Estate Department, issued Notification No. Estt:/P.T/30393-430 showing the name of the appellant at Sr. No. 8, and as mentioned that on completion of settlement / Revenue training of newly promoted Tehsildar / Naib Tehsildar the incumbents were repatriated to his parent department. But another order of the same date Notification No. 30367 (Annex J), whereby contrary to the notification No. Estt:/P.T/30393-430, mentioned above, no newly promoted Tehsildar / Naib Tehsildar was appointed to the posts vacated by the appellant and others rather BPS-14 personals were appointed. Consequent upon these notifications the Commissioner of Bannu vide OFFICE ORDER No. 3672-95/Estab./DT/18 dated August 31, 2018 at Sr. No. 6, Mr. Tanzilur.-Rehman, Naib Tehsildar (BPS-14) was posted against the post occupied by the appellant (Annex-K). It was surprising for the appellant. The appellant immediately submitted the department appeal to the competent Authority on 18-08-2018, which was rejected through a two line order, vide letter dated 25-09-2018, without any stating reasons and speaking order.

12. That appellant impugned the order dated 25-09-2018 through Service Appeal No. 1185/2018, in which the learned KP Service Tribunal, passed an order of status quo, on 01-10-2018. (Annex-M)

13. That, due to these notifications, the appellant faced mental torture and agony also loss of career to the appellant and was searching for the reason, and finally found few juniors to the appellant has been promoted but, no latest seniority list has been circulated. The appellant also requests for provision of latest seniority lists of year 2017.



14. This act of discrimination is causing recurring loss to the appellant in term of financial benefits as well as career.

- 15. That after rejection of departmental appeal, the appellant found a *Notification No. Estt: 1/P/27057 dated 09/07/2018*, yesterday, whereby at Sr. No.6 Mr. Imran Zaman, Sr. No. 13 Mr. Khalid Mansoor, and Sr. No. 71 Mr. Muhammad Ayaz, are shown as Tehsildar upon completion of training. These incumbents are **most junior** in the seniority list as on 31-12-2013 circulated by the Board of Revenue mentioned above as at Sr. No. 235, Sr. No. 253 and Sr. No. 312 respectively while the appellant is at Sr. No. 192). (the Notification dated 09-07-2018 is **Annexure** "**X**].
- 16. That *Notification No. Estt: I/P/27057 dated 09/07/2018* caused me a recurring loss to my career and the appellant is *aggrieved* of these orders and also other orders, which are not in the knowledge of the appellant, wherein any junior to the appellant has been promoted and the appellant has not been considered for any such Departmental Promotion Committee (DPC) or training, without any due cause and the appellant is deprived of his legal right to the promotion.
- 17. That the above mentioned notifications and notification dated 09-07-2018 are discrimination and prejudice to the rights of the appellant and caused huge loss to the appellant of expectations for consideration to promotion.
- 18. That the appellant request for a chance of personal hearing to explain my case.

It is very humbly requested that, in view of the above fact, the appellant may kindly be considered for promotion to the regular post of Tehsildar and the officers junior to me be declared as juniors to the appellant.
