With great veneration the instant appeal is preferred by the appellant on the following grounds:-

Facts:

1:- Briefly facts of the case are that the appellant had preferred and departmental representation to respondent No: 2 regarding the correction of seniority list on the basis that the appellant seniority may be corrected on the basis that the junior who were appointed and confirmed prior to the appellant

That the appellant representation was not entertained within the prescribed period hence appellant feeling aggrieved approach to the Hon'able Khyber Pakhtunkhwa service tribunal for the redressal of the grievances regarding of the promotion in which the Hon'able Tribunal on dated 09.04.2019 issue direction for the respondents above to considered the departmental representation and within the sixty days issued a speaking order upon the gracious order of the tribunal the respondent above pronounced a impugned order on 19.11.2019 which was communicated/issued/received by the appellant on 22.01.2020 (Copy of impugned order along with judgment of the hon'able service tribunal as annexed as annexture A)

3:- That the appellant has been serving in District Hangu and appellant has long standing service at his credit with unblemished good service record.

4:- That the respondent No: 2 circulated a final seniority list as stood on 09.05.2014 of inspectors and sub inspectors vide Memo: No: 370-90 /E-11 dated 09.05.2014 wherein the appellant has wrongly been placed at serial No: 343 instead of S.No: 278 (Copy of the seniority list is annexed as Annexture B)

5:- That the appellant has not been promoted in the DPC and differed the status of the appellant on the basis that the appellant has not completed his mandatory period as SHO although it is worth mentioning here that the other junior officials who were not completed the SHO period they were confirmed and promoted while the appellant who have completed all the mandatory courses as well as successfully qualified SHO period according to Police Rules 13.10(2) of police rules 1934

6:- That till to date being aggrieved from the impugned order the appellant had preferred instant service appeal before the Hon'able Service Tribunal Khyber Pakhtunkhwa regarding the promotion on the basis of following grounds:-

Grounds:

- a. That the respondent No: 1 has not treated the appellant seniority/ promotion in accordance with the law/rules and policy and acted in violation of the article 4 of the constitution as per rule 17(1)(b) of the Khyber Pakhtunkhwa Civil servant appointment promotion transfer rules 1989 seniority in case of promotion shall be recon from the date of regular promotion to a post and that a civil servant selected for promotion to a higher post in one batch shall, on their promotion to the higher post retained their inter se seniority as in the lower post the appellant is established senior from the other officials from S.No: 278 and onwards of the impugned seniority list in reference to his regular promotion to the post of sub inspector.
- b. That the appellant has been confirmed against the post of sub inspector w.e.f. 06.02.2013 where as all other from senior No: 283 to 242 have been confirmed much later then appellant similarly the appellant is senior from others laying from senior No: 278 to 282 on the score of his retaining his inter-se-seniority in the lower post as all of them are batch mate of the appellant
- c. That as per police rules 12-2(3) seniority of the upper subordinate shall be finally settled from the date of confirmation and this fact has also been adopted by the Appx Court of Pakistan and also by the various judgment of the Tribunal . Appellant has been confirmed w.e.f. 06.02.2013 whereas all other at S.No: 278 and onward have been confirmed later on in view of the speaking rules appellant is entitled to be placed at his due position in the seniority list.
- d. That there are already the respondent No: 1 has issued a special guide line regarding the seniority and promotions in the year 2018 that the seniority and promotion shall be recon from the date of appointment/ confirmation copy annexed as Annexure C
- e. That all the public powers are in the nature of trust and public functionaries must act as repository of such trust. In the instant case of

appellant for no good reasons the appellant has been deprived from his due seniority/ senior position without keeping the rules ibid and the appellant tender all the requisite necessary documents which enable the appellant for promotion to a higher post but in vain and the appellant who is senior most in his batch has not been promoted while the other officials who were later on confirmed were promoted to the higher post without completion of their necessary period and other requirement but this fact has been ignored by the respondent No: 1 while blessing the appellant with impugned order which is totally not consonance with the existing police rules as well as against to the service rules.

- f. That it is worth mentioning here that the service appeal No: 1117/2014 in reply to the appeal the respondents submitted their comments in which the main contention of the appellant has not been discussed and ignored the material facts with bias intention which clearly speaks the mala fide intention as well as personal biasness.
- g. That the appellant is honest and dedicated one and leave no stone unturned to discharge his duties.
- h. That as per universal declaration of human rights 1948 prohibits the arbitral / discretion.
- i. That the Respondent No-1 has acted whimsically and arbitrary, which is apparent from the impugned order.
- j. That the impugned order is not based on sound reasons and same is not sustainable in the eyes of law. The same is based on wrong assumption of facts.
- k. That the biasness of the respondent No: 1 is clearly shown by not giving ample opportunity of personal hearing for the redressal of grievance of the appellant and were not in mode to issue/ deliver the impugned order within stipulated time/ period on the basis that the appellant may suffer and indulged in technicalities
- l. That the impugned order is outcome of surmises and conjecture.

Pray:

In the view of above circumstances it is humbly prayed that the impugned order of Respondent No-1 dated 19-11-2019 may graciously be set aside for the end of justice and the appellant may please be graciously award due seniority/ promotion to the next higher post in accordance with the law or bless with and other suitable remedy as deemed proper.

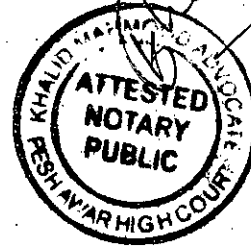





Brief facts of the case are that the Regional Police Officer, Kohat Region forwarded recommendation roll of Sub-Inspectors of his region to bring their names on list-"F" and for promotion as officiating Inspector.

The promotion cases of Sub Inspectors of various regions were discussed in the DPC held on 25.07.2013 to bring their names on list "F" and officiating promotion as Inspector. The name of Mr. Shafiq ur Rehman No.K/17 was deferred from promotion due to not completion of SHO period because he has not served as SHO according to Rule 13.10(2) of Police Rules 1934.

The promotion case of Shafiq ur Rehman was again discussed in the DPC held 07.02.2014 and his name was brought on list-"F" and promoted as Officiating Inspector.

Later on, Mr. Shafiq ur Rehman No.K/17 submitted a representation for revised seniority that all the confirmed Sub-Inspector i.e batch mates of appellant were promoted to promotion list-"F" vide CPO No.19653/E-II, dated 13.08.2013 whereas, the appellant was ignored and deferred without any plausible reason and whereas other batch mates junior to him were promoted. He also appeared before the Committee and explained his position.

The representation of Mr. Shafiq ur Rehman No.K/17 was discussed in DPC held on 16.02.2015. The Committee recommended which was approved by the Competent Authority that the representation of appellant is not maintainable.

Mr. Shafiq ur Rehman No.K/17 filed a service appeal No.1117/2014 before the Khyber Pakhtunkhwa Service Tribunal Peshawar which was decided on 09.04.2019. The operating para of judgment is reproduced as under:-

"In view of the above discussion this Tribunal reached to the conclusion to dispose off the appeal with the direction to the respondent department to consider the departmental appeal of the appellant through a speaking order within a period of sixty (60) days positively at the receipt of the copy of this judgment".

Having perused all relevant record and other documents, the representation of Mr. Shafiq ur Rehman is devoid of any substance/merit, hence not maintainable.

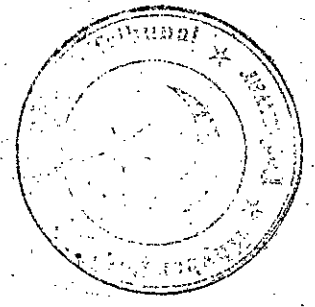



The appellant was aggrieved from the impugned seniority list of Inspectors and Sub-inspectors, issued by respondents No.2; vide memo No. 370-90/E 11 dated 09.05.2014; due to the reason that he had been placed, allegedly at wrong position at serial No.343 instead of serial No.278. He preferred departmental representation on 31.05.2014 which is still pending with the appellate authority hence the instant service appeal preferred on 08.09.2014 before this Tribunal.</p>

3. The learned counsel for the appellant argued that the appellant was confirmed in the rank of Sub Inspector w.e.f 06.02.2013 while the incumbents at serial no. 283 to serial No.242 have been confirmed much later than the appellant. As regarding the seniority for the incumbents to serial no. 278 to 282 the learned counsel for the appellant contended that the due seniority position of the appellant in the list is based on the grounds of the principle of Inter se seniority. In addition to rules 17 (1) (b) Khyber Pakhtunkhwa Civil Servant (Appointment, Promotion & Transfer) Rules, 1989 the learned counsel for the appellant referred to rule 12-2 (3) of Police Rules. According to these statutory provisions the seniority of the civil servant recon from the date of regular promotion or confirmation in the concerned list. He further argued that on promotion to the higher post the inter se seniority of the junior level is not affected adversely. It has been prayed that the appeal may be allowed (accepted) and his due seniority position viz serial No.278 instead of serial No.343 be orderd.

4. The learned Deputy District Attorney contested the facts, grounds of the appeal and arguments of the learned counsel for the appellant on the basis of Para wise comments of the respondent department and stated that the seniority list as stood on 09.05.2014 of Inspector and Sub Inspector was prepared from the dated of confirmation as ASI in accordance with the law and in the light of judgments passed by Hon'ble Service Tribunal and Hon'ble Supreme Court of Pakistan. The seniority of appellant was correctly

reckoned from the date of his confirmation as Inspector in 2014, while the private respondents were confirmed as Inspector from the DPC held in 2013. He further argued that the seniority of the Police subordinate are governed under the provision of Police Rules. He further stated that the service appeal does not carry any merit and may be dismissed.

5. Arguments heard. File Perused.

6. The Tribunal examined the record on file, arguments and counter arguments of the learned counsel for both the parties. The examination of seniority list reveals that the appellant joined service on 02.10.1986. He was confirmed as SI on 06.02.2013 and admitted to list F on 11.02.2014. While the private respondent No. 4 joined the service on 28.09.1995. The date of his confirmation as SI is 06.02.2013 and the date of enlistment in list F is 13.08.2013. Their respective position at seniority list is 343 and 278. The appellant challenged the seniority list of the Inspectors & Sub Inspectors in the list F as notified on 09.05.2014 on the ground of the provision of the Khyber Pakhtunkhwa Civil Servant (Appointment, Promotion Rules) pertaining to the inter se seniority. The respondent department defended the seniority list on the basis of provision in the Police Rules. Where the seniority is reckoned on the basis of enlistment in a particular list. It has been noted during the trial that the appellant was not enlisted in the list F on the ground of non completion of the requisite experience as independent SIO of Police station. However the respondent





Memo:- Please refer to your letter No. 4879/EC, dated 24.04.2016 on the subject cited above.

Sahib Rehman, Rahat Gul, Ali Rehman, Amir Hamza, Manzoor-ur-Rehman, Javed Hussain, Muhammad Waqas Khan, Muhammad Hanif Khan and Saeed Khan, of Kohat Region have challenged the Notification No. 4051-61/EC dated 03.06.2015 issued by Regional Police Officer, Kohat vide which the confirmation of ASIs of Kohat Region was revised.

The former five (5) officers posted at PTC Hangu have submitted joint representation and the latter four (4) have submitted individual representations. The former five have contended that they have availed the incentives of Cadet Law Instructor as contained in Standing Order No. 11/87 and 03/2007. All the nine (09) Police officers are aggrieved of one and the same notification passed by Regional Police Officer, Kohat therefore, the representation were consolidated for decision.

The crux of arguments of the appellants was that initially the seniority of ASIs of Kohat Region was correctly fixed and the same was wrongly revised vide impugned notification. Appellant have contended that 52 ASIs were confirmed from the date of officiating promotion and no reasons were advanced for antedating the confirmation of the officers and counting their officiating period as confirmation period. One of the appellants namely Muhammad Waqas ASI, further pointed out that the seniority was granted to those ASIs who were promoted on acting charge basis.

As per recommendation of DPC dated 16.11.2016, the committee examined the impugned Notification No. 4051-61/EC dated 03.06.2015, which revealed that the RPO, Kohat has confirmed the probationer ASIs from the date of appointment and have also confirmed the Police Officers promoted from the rank of head constable from the date of officiating promotion while according to Police Rules 13.18 an officers promoted from junior rank shall be confirmed after probation period of two years and the authority is further competent to count the officiating period as probation period while confirming in the rank. RPO/Kohat has based the revised notification on letter No. 267/E-III dated 28.01.2015 issued by CPO. The Rules do not allow confirmation from the date of officiating promotion rather it says that on promotion confirmation in the rank could only be done on completion of probation period.





Due to certain deficiency the name of the appellant was not brought on promotion list F which was caused soon. Thankfully the names of colleague officers were brought on promotion list despite their case was at par with appellant, Thus appellant was discriminated.

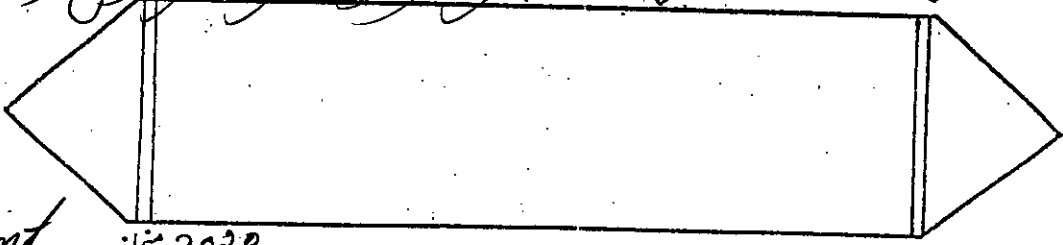
7. That under the law and rules as provided in Police Rules 12-2(3) and pronounced by the Honorable Courts in various Judgments, appellant seniority is worth restoration.

PRELIMINARY OBJECTIONS:-

- i. That the appeal is not based on facts.
- ii. That the appeal is barred by law and limitation.
- iii. That the appeal is not maintainable in the present form.
- iv. That the appeal is bad for mis-joinder and non-joinder of necessary and proper parties.
- v. That the appellant is estopped to file the instant appeal by his own conduct.
- vi. That the appellant has not come to this Honorable Tribunal with clean hands.
- vii. That the appellant has got no cause of action and locus standi to file the instant service appeal.

FACTS:-

1. Pertains to representation of the appellant needs no comments.
2. Incorrect, in compliance with the judgment dated 09.04.2019, of the Honorable Khyber Pakhtunkhwa, Service Tribunal, Peshawar the representation of the appellant being devoid of any substance/ merit rejected vide order dated 19.11.2019. (Copy annexed as "A").
3. Pertains to service record of the appellant needs no comments.
4. Incorrect, the appellant name was exist at right place in Seniority list as stood on 09.05.2014.

5. Incorrect, the promotion cases of Sub-Inspectors of various regions were discussed in the DPC meeting held on 25.07.2013, to bring their names on list 'F' and officiating promotion as Inspector. The name of the appellant was deferred from promotion due to not completion of mandatory SHO Period in accordance with Rule 13.10(2) of Police Rules, 1934. (Copy annexed as "B"). The promotion case of the appellant was again discussed in the DPC meeting held on 07.02.2014, wherein the name of the appellant was brought on list 'F' and he was promoted as Officiating Inspector. Later on, the appellant filed representation for revised seniority which was discussed and rejected in DPC meeting held on 16.02.2015, being non-maintainable.
6. Incorrect, the instant Service Appeal of the appellant being not maintainable and is liable to be dismissed on following Grounds.


GROUND:-


- A. Incorrect, the appellant has been treated in accordance with law/ rules and policy and appellant has not been discriminated by the answering respondents.
- B. Incorrect, as already explained that the appellant was not considered for promotion because of not completion of SHO Period in accordance with Rule 13.10 (2) of Police Rules, 1934.
- C. First part of this Para pertains to Apex Court while in remaining part it is submitted that representation of the appellant was rejected being not maintainable.
- D. Correct to the extent that seniority shall reckon from the date of appointment.
- E. Incorrect, as already explained in Para No. 5 of Facts.
- F. Incorrect, the respondents replied in comments of earlier Service Appeal of the appellant on basis of material facts in comments and no malafide has been committed on part of answering respondents.
- G. Pertains to service record of the appellant needs no comments.
- H. Incorrect, no discrimination has been done by the answering respondents.
- I. Incorrect, respondent No. 1 acted in accordance with law/ rules.
- J. Incorrect, the order passed by the competent authority is quite in accordance with law and is sustainable in eyes of law/ rules.


- K. Incorrect, as already explained in Para No. 5 of Facts.
- L. Incorrect, the order passed is based in accordance with law/ rules.

PRAYER:-

Keeping in view the above stated facts and rules, it is therefore humbly prayed that the appeal is not maintainable, being devoid of merits, hence; may kindly be dismissed with costs, please.

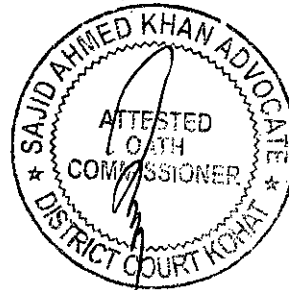

ORDER

Brief facts of the case are that the Regional Police Officer, Kohat Region forwarded promotion roll of Sub-Inspectors of his region to bring their names on list-"F" and for promotion as Inspecting Inspector.

The promotion cases of Sub Inspectors of various regions were discussed in the DPC held on 07.07.2013 to bring their names on list "F" and officiating promotion as Inspector. The name of Mr. Shafiq ur Rehman No.K/17 was deferred from promotion due to not completion of SHO period because he was not served as SHO according to Rule 13.10(2) of Police Rules 1934.

The promotion case of Shafiq ur Rehman was again discussed in the DPC held 07.02.2014 and his name was brought on list-"F" and promoted as Officiating Inspector.

Later on, Mr. Shafiq ur Rehman No.K/17 submitted a representation for revised seniority that all the confirmed Sub-Inspector i.e batch mates of appellant were promoted to promotion list-"F" vide DPC No. 19653/E-II, dated 13.08.2013 whereas, the appellant was ignored and deferred without any plausible reason and whereas other batch mates junior to him were promoted. He also appeared before the Committee and explained his position.

The representation of Mr. Shafiq ur Rehman No.K/17 was discussed in DPC held on 16.02.2015. The Committee recommended which was approved by the Competent Authority that the representation of appellant is not maintainable.

Mr. Shafiq ur Rehman No.K/17 filed a service appeal No.1117/2014 before the Khyber Pakhtunkhwa Service Tribunal Peshawar which was decided on 09.04.2019. The operating para of judgment is reproduced as under:-

"In view of the above discussion this Tribunal reached to the conclusion to dispose off the appeal with the direction to the respondent department to consider the departmental appeal of the appellant through a speaking order within a period of sixty (60) days positively at the receipt of the copy of this judgment".

Having perused all relevant record and other documents, the representation of Mr. Shafiq ur Rehman is devoid of any substance/merit, hence not maintainable.

10. In rule 13.10 for sub-rule (2) the following shall be substituted namely:

“(2) No Sub-Inspector shall be confirmed in a substantive vacancy unless he has been tested for at least a year as an officiating Sub-Inspector in independent charge of a Police Station, a notified Police Post, or as in-charge Investigation of a Police Station or in Counter Terrorism Department:

Provided further that he shall also have to spend one year in any other Unit excluding the period spent on long leave, deputation or promotional training course i.e. upper college course”.

11. After rule 13.16, the following new rule shall be added, namely:

“13.16A. One year mandatory tenure for promotion to Deputy Superintendent of Police.--An Inspector shall be promoted to the post of Deputy Superintendent of Police after successful completion of mandatory training i.e. Advance Course and completion of one year tenure as Inspector in the Investigation Branch, or Counter Terrorism Department, or Special Branch, or any police training institution.”.

12. After Form No. 13.7, the following new Appendices shall be added, namely:
