APPEAL UNDER SECTION 4 OF THE KPK SERVICES TRIBUNAL ACT, 1974, AGAINST THE IMPUGNED ORDER OF STOPPAGE OF SALARY ISSUED BY RESPONDENT NO.3 WHEREBY APPELLANT WAS NOT GIVEN THE MONTHLY SALARY FROM THE DATE OF APPOINTMENT AND THEREAFTER AGAINST THE OMISSION ON THE PART OF RESPONDENT NO. 2 FOR INDICISION OF THE DEPARTMENTAL APPEAL WHICH IS AGAINST THE LAW AND IN VIOLATION OF SERVICES LAWS AND RULES AND THE APPELLANT WAS CONDEMNED UNHEARD WITH MALAFIDES.

PRAYER

On acceptance of this appeal, impugned order regarding stoppage of salary of the appellant (the same order has not been

communicated to the appellant) issued by respondent No.3 may please be reversed and set-aside and the respondents be directed to release salaries of the appellant with all back benefits.

Note: Addresses given above shall suffice the object of service. All necessary and proper parties have been arrayed in the panel of respondents.

Respectfully Sheweth;

1. That the petitioner is law abiding citizen of Pakistan and is enjoying well reputation in the society and is educated person having domicile of District Tank. Copy of domicile is enclosed herewith.
2. That on 24/02/2012 an advertisement for the post of Naib Qasid was published in Daily Mashriq by the respondents.
3. That petitioner being fully qualified for the post as per the advertisement published, applied in accordance with the advertisement, and was appointed on 16-06-2014 Vide Letter No.1492-45 Dated 16-06-2014 as Naib Qasid by the Respondent No.3. Copies of appointment order dated 16-06-2014/Medical Certificate, Arrival Report are enclosed herewith.
4. That after appointment the appellant served the department with full zeal and zest and performed the duties by marking attendance in the attendance register of the office. Copies of daily attendance register till August 2016 are enclosed herewith.
5. That post of appellant was budgetary post. Copy of budget book is enclosed herewith.
6. That the appellant has made his attendance through Biometric system. It is in the record of respondents that the appellant biometric data speaks that the appellant attended the office and served. Copy of Biometric Employee Data is enclosed herewith.
7. That the appellant also performed his job to the entire satisfaction of superiors and also dispatched the letters and also received the same. Copies of dispatch and received letter register are enclosed.

8. That the appellant's salary was stopped by the respondent No.3 despite of his appointment and daily attendance in the office. The appellant made several oral requests to release the salaries but the same was not honoured. Thereafter the appellant filed a Writ Petition in the Peshawar High Court against the respondents which was decided on 21-04-2021. Copy of Writ petition along with its order is enclosed.
9. That on 01-06-2022 the appellant made a departmental representation to the Respondent No.2 which was not decided in statutory period provided under the law. Feeling aggrieved from the stoppage order of salary, the appellant made instant service appeal in this Honorable Tribunal inter-alia on the following grounds.

GROUNDS

- a. That the impugned act and omission on the part of respondents is illegal, unjustified and indecision of appellant's departmental appeal is illegal, against services Law and rules, without jurisdiction, in violation of the precedents of Honourable apex courts of the country and is not justifiable for any reason whatsoever.
- b. That appellant was appointed against vacant post of Naib Qasid (BPS-I) and posted at DHQ Hospital Tank, after submission of all formalities, Since then, Appellant has been serving health department and invested his full skill, energy and honesty in performance of his duties. But, act of respondents is injustice to with appellant and stoppage of salary order is against Law.
- c. That in this regard at a number of occasions, it has been held by Supreme Court that if department feels certain prior appointments as illegal then instead of penalizing petty employees like Chowkidar, Naib Qasid, Junior Clerks etc, who have to earn livelihood to support their families, action should be taken against the authority who had mis-exercised its powers. Reliance are placed on 2012 SCJ 780, 1996 SCMR 8413, 2004 SCMR 303+1662, PLD 2003 SC 724, 2006 SCMR 1818+678 for ready reference.

- d. The act/refusal/omission on the part of respondents is not grounded in reason nor does it smack of sensible or sane approach which is bad in law and circumstances in the present case.
- e. That appellant was appointed by the approval accorded by the District Selection Committee under the Chairmanship of the then EDO, against a cadre post and respondent no. 3 has no authority whatsoever to stop the salary of the appellant.
- f. That the respondent No. 3 discriminated the appellants because other employees who were appointed with appellant but still not removed from service and are still getting salaries from the department.
- g. That the appellant is still in service and the respondents are not treating in accordance with law under section 10 of the KPK Service Tribunal Act. This Honorable Tribunal has vast and ample power to direct the official respondents to release the salaries of the appellant with all back benefits.
- h. That appellant being citizen of Pakistan deserves to be dealt in accordance with law and the treatment meted out to him is in violation of Article 4 of our Constitution.

On acceptance of this appeal, impugned order regarding stoppage of salary of the appellant (the same order has not been communicated to the appellant) issued by respondent No.3 may please be reversed and set-aside and the respondents be directed to release salaries of the appellant with all back benefits.

Copies of the medical fitness certificate and arrival report of the petitioner are enclosed as **Annexure C & D** respectively.
- 4. That the petitioner since the date of his arrival has been performing his official duties as Naib Qasid in the office of respondent No.4; but respondent No.4, for the reasons best known to him, did not make any effort to enter the salary of petitioner in the computer system of respondent No.5.
- 5. That thereafter the petitioner time and again requested respondent No.4 to release his monthly salaries but he has been delaying the matter on one pretext or the other due to which the petitioner & his family are suffering from starvations.

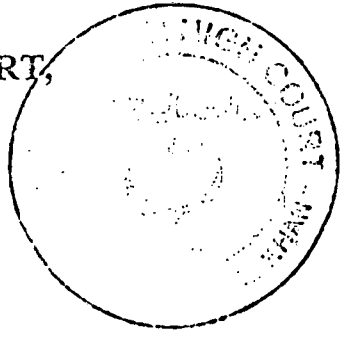

ABDUL SHAKOOR, J.- Through the instant petition filed under Article 199 of the Constitution of Islamic Republic of Pakistan, 1973, the petitioner seeks issuance of writ directing the respondents to provide him proper place of posting and release all his salaries w.e.f. 24.6.2014.

2. In essence, petitioner was appointed as Naib Qasid (EPS-1) in the office of District Health Officer, Tank vide letter No.1492-95 dated 16.6.2014. On 24.6.2014, he submitted his arrival report and since then performing his official duties. He time and again requested respondent No.4 to release his monthly

salaries but he has been delaying the matter on one pretext or the other, therefore, he filed the instant constitution petition.

3. In view of facts and grounds urged in the instant petition, respondent No.4 submitted his para-wise comments. According to the comments, no codal formalities were adopted by the petitioner as no post of Naib Qasid was lying vacant and the arrival report annexed with the instant petition is fake one because no record was found in the office in this respect. Respondent No.4 also annexed copies of attendance register, budget book, biometric attendance certificate, dispatch register and diary register with the comments.

4. Arguments heard and record perused.

5. The averment of the petitioner is that he was appointed as Naib Qasid (BPS-1) in the office of District Health Officer, Tank. He submitted his arrival report on 24.6.2014 and since then performing his official duties and the respondents are not paying his salaries. Whereas the stance of the respondents is that as no post of Naib Qasid was lying vacant with them and the arrival report annexed with the instant petition is fake one because no record was found in their office and he is not performing his official duties. The questions so raised in this petition cannot be decided on the basis of

available record. The matter in hand requires resolution of factual controversy and that will be possible only after allowing the parties to adduce pro and contra evidence which surely is not advisable while hearing constitutional petition.

6. Moreover, the petitioner claims that he was appointed as Naib Qasid, he is performing his official duties since 24.6.2014 but the respondents are not paying his salaries. This issue relates to term and condition of civil servant in view of Section 10 of the Khyber Pakhtunkhwa Service Tribunal Act, 1973 and Article 212 of the Constitution of Islamic Republic of Pakistan, 1973 ousts the jurisdiction of this Court in all matters relating to the terms and conditions of a civil servant.

7. For the reasons stated above, this writ petition stands dismissed. However, the petitioner is at liberty to approach the proper forum for redressal of his grievance.

**DEPARTMENTAL APPEAL/REPRESENTATION AGAINST THE
IMPUGNED ORDER OF STOPPAGE OF SALARY ISSUED BY
THE DISTRICT HEALTH OFFICER TANK.**

The appellant humbly submits as under;

1. That the appellant is bona-fide resident of District Tank and is eligible for the purpose of relief sought hereby.
2. That the appellant was appointed as "Naib Qasid" (BPS-01) by the district health officer Tank in the health department Tank vide appointment order #1492-95 dated 16/06/2014, since then the appellant performing his duty with due diligence, dedication and to the utter satisfaction of his superiors. During the entire stretch of service the conduct of appellant remained unblemished. Service record of the appellant is evident. Copy of appointment order is enclosed.
3. That after his appointment and obtaining medical fitness certificate the appellant submitted his arrival report on 24/06/2014 in District health office Tank and then he started to perform his official duties there. Copies of the medical fitness certificate and arrival report are enclosed.
4. That the appellant since the date of his arrival has been performing his official duties as Naib Qasid in District Health Office, but the District Health Officer Tank for the reason best known to him, stop the salary of the appellant.

5. That the appellant has wrongfully been denied his due right of employment and other ancillary benefits by the authorities, thus having discriminated the appellant the authorities have acted in violation of the constitutional guarantees.
6. That the appellant has more than 08 years of service to his credit and a large family to feed but the authorities while stopping the salary of the appellant and thereby inflicting financial loss, ignored these aspects blatantly.

In view of the above given facts, it is humbly prayed that on acceptance of the present departmental appeal , and directed the District Health Officer Tank to release all the salaries to the appellant w.e.f 24/06/2014 in the larger interest of justice and equity.

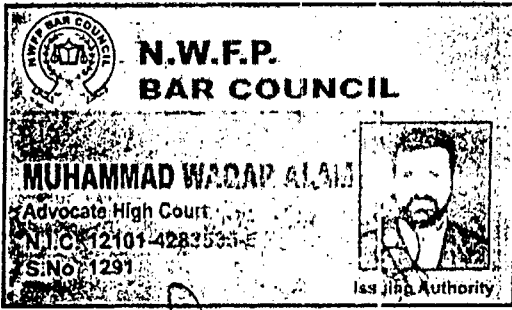
