APPEAL US 4 SERVICE TRIBUNAL ACT 1973 AGAINST THE IMPUGNED PROMOTION ORDER DATED. 07/12/2021 ISSUED BY RESPONDENT NO.2 & 3 VIDE WHICH THE RESPONDENTS NO. 6 TO 8 WERE PROMOTED TO THE POST OF SST (GENERAL) AGAINST THE BPS-16 AND EXCLUDED THE NAME OF APPELLANT ALTHOUGH THE APPELLANT IS SENIOR TO RESPONDENTS NO.6 TO 8 AND ALIGIBLE FOR PROMOTION TO THE POST OF SST AGAINST THE BPS-16 BEING SENIOR CT TEACHER ACCORDING TO SENIORITY LIST, WHICH IS ILLEGAL, AGAINST LAW, VOID AB-INITO AND APPELLANT

BEING SENIOR TO THE RESPONDENTS NO.6 TO 9. AND ALSO ENTITLED FOR PROMOTION IN BPS 16 TO THE POST OF SST WITH EFFECT FROM 07/12/2021.

PRAYER:

ON ACCEPTANCE OF INSTANT SERVICE APPEAL, THIS HONOURABLE TRIBUNAL MAY SET ASIDE THE IMPUGNED PROMOTION ORDER DATED 07/12/2021 ISSUED BY RESPONDENTS NO. 2 & 3 AND APPELLANT MAY GRACIOUSLY BE PROMOTED IN BPS 16 TO THE POST OF SST (GENERAL) FROM THE DATED. 07/12/2021. ANY OTHER RELIEF WHICH THIS HONOURABLE TRIBUNAL MAY DEEM FIT AND PROPER IN THE CIRCUMSTANCES OF THE CASE MAY ALSO BE GRANTED TO THE APPELLANT

Respectfully Sheweth:

Following are the facts, giving rise to the instant services appeal.

1. That Appellant was initially appointed as PTC Teacher (PST) on 24. 10. 1995 in BPS 7 and appointed as CT teacher on 06/05/1999. Thereafter the appellant was promoted to the post of Senior ST teacher in BPS 16 on 21/11/2014. Copies of appointment letters and promotion order are attached as annexure "A" "B" & "C" respectively.
2. That appellant throughout her professional carrier performed her duty with zeal and zest, and never give

any opportunity to her superiors to question her conduct or job.

3. That, appellant is serving in the education department since 22 years approximately.
4. That the appellant is senior to Respondents No. 6 to 8, and her name is placed at senior part/serial number than respondents No. 6 to 8 in seniority list. **Copy of seniority list is attached as annexure "D"**
5. That with malafide intention the impugned promotion order issued by respondents in which the name of appellant was wrongly excluded and junior teachers (respondents No.6 to 8) were promoted to the post of SST against the BPS-16. The impugned promotion order is attached as annexure "E"
6. That departmental appeal was filed by appellant against said impugned promotion order before competent authority but the same was not decided by the authority with in due time and verbally it was told to appellant that her name was included erroneously in CT list which would be rectified and appellant would be promoted in BPS 16 .copy of appeal is attached as annexure "F"

7. That an enquiry was started against Mst Asma Ghaffar regarding irregularities in seniority list and promotion issue of appellant, and appellant also appeared before inquiry officer for recording of her statement, but the appellant is still waiting for result/findings of inquiry. Copy is attached as annexure "G"
8. That a reminder was also filed by appellant before competent authority 13/07/2022. Copy of reminder is annexed as annexure "H".
9. That, respondents neither decided the appeal nor completed the inquiry. And never pay any consideration to reminder of appellant.
10. That, petitioner left with no other option but to assails the act of respondents before this Honourable tribunal, inter-alia, on the following grounds:-

GROUND:

- A. That the act of respondents is against the fundamental right of the appellant, which is guaranteed under constitution of Islamic republic of Pakistan 1973.
- B. That the act of respondents is illegal, unlawful, against law, against facts and circumstances of the case and against the principle of natural justice.

C. That the respondents did all the proceedings without touching the legal requirements of the law and procedure hence the impugned order is liable to be set aside.

D. That appellant filed an appeal to respondents against their such illegal act, on which respondents kept deaf ear and without giving opportunity to appellant, promoted the respondent No.6 to 8, who were junior to appellant as per law, and wrongly promoted to deprive the appellant from the right of promotion, in this way the said act of respondents is unlawful, against the norms of justice, service law and rules, one sided and harsh, as well as grave misuse of power and law, so, liable to be struck down and set aside.

E. That the other points would be urged at the time of arguments.

F. The appeal is well within time even then application for condonation of delay is also moved by the appellant.


