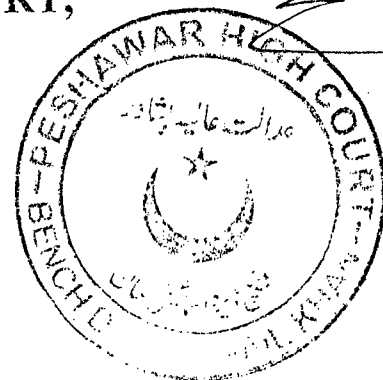

Reference to your letter No. 5319-23 dated 8-04-2016 undersigned conducted the enquiry by serving a questionnaire to Mst Maria Bashir. The questionnaire and her responses are hereby attached.

**Findings**

1) It is evident that Maria was appointed by D.C.O on 29-07-2008, therein with copies of information to the following officers / officials.

1. The Secretary to Govt: of KPK E&SE Department Peshawar.
2. The District Nazim Khan.
3. The EdO (Finance & Planning) D.I.Khan.
4. The EDO (School & Literacy) D.I.Khan.
5. The Principal GGHSS Chah Said Munawar D.I.Khan.
6. The District Accounts Officer, D.I.Khan.
7. Official Concerned.

The record of advertisement of the Post and Test Interview are not available in the office or from the Maria Bashir.

- 2) That Mst Maira's orders were cancelled on 10-10-2010. But she was taking salary regularly upto 22-6-2012 (as evident from application by the Maria Bashir).
- 3) On 22-6-2012 the then EDO Mr. Feroz Shah through his letter No. 22612 declares the appointment orders of Mst Maria Bashir as bogus without legal authority, being issued by the D.C.O.
- 4) She submits appeal before honourable High Court on 17-09-2013.
- 5) That the honourable Peshawar High Court D.I.Khan Bench passed an esteemed order which is reproduced IBID below.



"In view of the above concurrence, this petition is disposed of the impugned order dated 10-10-2010 is set aside and the respondent No.5 is directed to pass an appropriate order on the petitioner's case after giving her the opportunity of hearing. It means there was lack of co-ordination / correspondence amongst the different quarters of the department no one has raised objection against this order issued by the D.C.O.


**Recommendations**


