Counsel for the appellant present.

Learned counsel for the appellant argued that the appellant was appointed as ASI in the respondent-department on 01.09.2009. However, there is no copy of appointment order in service of the appellant dated 01.09.2009, found with index of service appeal. It was contended that the appellant had been on Tableegh for four months and on return, his services were terminated, but he was not provided any formal order of termination of his services. There is neither any original impugned order nor appellate order to have been issued by the respondents the appellant is aggrieved of. As such the basic requirement specified under Section-4 of the Khyber Pakhtunkhwa Service Tribunal Act 1974 does not meet. Therefore, the instant service appeal being not maintainable is hereby dismissed in limine. Consign.


