CONSEQUENCE, WHATEVER, AND SAME MAY BE ORDERED TO BE CORRECTED RESPONDENT BE DIRECTED TO ENLIST THE APPELLANT NAME EXACT PLACE IN SERIAL NO IN DISPUTED SENIORITY LIST AND ALSO BE DIRECTED TO CONSIDER THE CASE OF APPELLANT FOR PROMOTION TO (BPS-18) FROM THE DATE OF HIS ACTUAL BATCH MATES.

Respectfully Sheweth,

1. That, the petitioner was appointed as Naib Tehsildar (BPS-14) in 1995 through public Service Commission.
2. That, the respondent No.3 has issued final seniority list of Naib Tehsildar in the year 2005 in which petitioner name was at serial No.2 of the said list. **(Copy of the list is annexed as Annexure "A")**
3. That, the respondent No.3 conduct departmental examination of Naib Tehsildar, in which petitioner appeared and passed the exam the result was announced on 2006 through notification dated

10.10.2006. **(Copy of result notification is attached as annexure "B")**

4. That, on 02.07.2009 respondent No.3 issued tentative seniority list of Tehsildar (BPS-16). Being aggrieved petitioner objected the tentative seniority list. **(The copies of tentative seniority list and objection petition are annexed as annexure "C")**

5. That, in DPC meeting held on 01.09.2008 appellant was deferred with malafide intention which was apparent on face of record. **(Copy of DPC meeting and record of petitioner service at that time are annexed as Annexures "D" & "D-1")**

6. That, in the subsequent meeting of DPC Petitioner was promoted to the post of Tehsildar (BPS-16) w.e.f 17.07.2009. **(The copy of promotion order BPS-16 alongwith working paper is attached as Annexures "E" & "E-1" respectively)**

7. That in the meanwhile respondent No.2 establishment department as per rule call a list from respondent No. for recommendation for promotion to post of PM

(BPS-17). Again with ulterior motive with malafide intention respondent No.1 deprived the appellant and concealed his name in seniority list which was grass miscarriage of justice. On which appellant again submitted his objections to competent forums. **(Copies of list and objection are annexed as Annexures "F", "FI" & "F-II" respectively)**

8. That consequence of above mentioned recommendation of respondent No.1. The respondent No.2 issued the disputed notification of promotion in which petitioner was deliberately deprived from promotion. Being aggrieved appellant again requested/ objected for the correction of said notice. **(Copies of objection / application are annexed as Annexures "G-1" & "G-II" respectively)**

9. That, inspite of many applications / reminders to concerned authorities for the correction of disputed seniority list but no proper response has been received so far. **(Copies of applications are annexed as Annexure "H")**

10. That in March 2014 respondent No.2 issued a seniority list for (BPS-17) in which appellant's name was at serial No.419 instead being at serial No.101 alongwith the batch fellows of appellant. The respondent No.2 referred the case to respondent No.1 for the correction of said anomaly. **(Copy of objection and recommendation of respondent No.2 are annexed as Annexures "I", "I-I" & I-II" respectively)**

 11. That on the sequence of previous seniority list the respondent No.2 issued fresh seniority of (BPS-18) again the appellant name is missing and the names of junior batch fellows of appellant are included. **(Copy of PMS (PBS-18) for March 2019 are annexed as Annexure "J")**.

 12. That, inspite of crystal clear record of petition's service, the right of petitioner is badly suffered and petitioner is facing irreparable loss due to the illegal, malafide act of respondents.

 13. That, appellant preferred an appeal before worthy Chief Secretary KPK on 30.05.2019 but still no

decision is taken, hence this appeal is being filed, inter-alia, on the following legal grounds:-

GROUNDS:-

- a. That, the acts of respondents are not only malafide, illegal, without jurisdiction, and against the principle of promotion policy of Government of Khyber Pakhtunkhwa, that appellant was senior to other names in the disputed seniority list which demonstrate malafide on the part of respondent, hence the intervention of this Honourable Tribunal is utmost warranted in the instant appeal.
- b. That appellant has to his credit about 24 years of unblemished service record, in all 24 ACRs, the petitioner was evaluated as "fit for promotion" and for this reason alone the appellant is entitled for scaled upto BPS-18.
- c. That besides qualifying mandatory training courses the appellant successfully completed various

capacity building training courses etc appellant is entitled for natural, legal promotion.

- d. That respondent exercised his discretion, arbitrarily while preparing the seniority list, definitely a consequence of malafide intension and erroneous consideration, even on the face of it. Supersession of appellant is arbitrary, unjustified and result of colourful exercise of power, hence not sustainable in the eye of law.
- e. That, respondents how and why the officers junior to appellant and having less experience and exposure have been enlisted in the disputed seniority list while without showing any reason missed the name of appellant in disputed seniority list.
- f. That, the appeal is within time.
- g. That, Honourable Tribunal has jurisdiction to entertain it for what has been submitted above.

It is humbly prayed that Honourable Tribunal may graciously be pleased to accept this appeal and declare that impugned seniority list is malafide, arbitrary, unjustified, illegal and of no legal consequence, whatever, and same may be ordered to be corrected, respondents be directed to enlist the appellant at the exact serial number in the disputed seniority list and the appellant be promoted to BPS-18 from the date of his other batch fellows. Any other relief which this Honourable Court deems fit and proper in the circumstances of the case may also be granted to the appellant.

2. The case regarding promotion of Naib Tehsildars (working as Tehsildars on Acting Charge Basis) to the post of Tehsildar (BS-16) on regular basis was placed before the Committee. The committee was informed that there were 75 regular posts of Tehsildars which had become vacant due to promotion of Tehsildar as PMS (BS-17) officer on 19.02.2008. Out of these 75 vacant posts, 42 Naib Tehsildars and Ministerial / Subordinate staff (Acting Charge Tehsildars) were promoted to the post of Tehsildar (BS-16) on regular basis duly Notified on 20.03.2008 leaving a balance of 33 posts.

3. In view of the observation made by Deputy Secretary Regulation, two post of Reader to SMBR / MBR and one post of Tehsildar Anti-Corruption Establishment were excluded from the sanctioned posts of Tehsildars (BS-16) leaving a balance of 30

sts. He further informed that 36 regular Tehsildars were promoted to the post of PMS (BS - 17) on 27.05.2008. Hence, the total vacant post 30 + 36 becomes 66.

4. Out of 88 regular Sanctioned posts, 44 posts of Tehsildars @ 50%, falls to the share of Naib Tehsildars. In this respect, (12) Naib Tehsildars have already been promoted as Tehsildars (BS-16) from amongst the Naib Tehsildars working on regular basis while (32) posts are required to be filled from amongst the Naib Tehsildars (Acting Charge Tehsildar) to the post of Tehsildar (BS-16) on regular basis.

5. Similarly, out of 88 regular sanctioned posts of Tehsildars, (26) posts @ 30% falls to the share of Ministerial/Subordinate staff. Ten (10) Officials are already working as Tehsildars (BS-16) on regular basis while (16) posts of Tehsildars are required to be filled from amongst the Ministerial staff. However, their case will be considered as and when new rules approved by SSRC on 28.05.2008 are notified
