



APPEAL UNDER SECTION 4 OF THE KP SERVICE TRIBUNALS ACT, 1974 AGAINST THE ORDER DATED 29.11.2021 WHEREBY THE DEPARTMENTAL APPEAL DATED 18.06.2021 AGAINST THE FINAL SENIORITY LIST DATED 16.03.2021 ISSUED BY THE RESPONDENT DEPARTMENT HAS BEEN REJECTED FOR NO GOOD GROUNDS.

PRAYER:

THAT ON THE ACCEPTANCE OF THIS APPEAL THE REJECTION ORDER DATED 29.11.2021 & FINAL SENIORITY LIST DATED 16.03.2021 MAY PLEASE BE SET ASIDE AND THE RESPONDENTS MAY BE DIRECTED TO PLACE THE APPELLANT'S NAME AT SERIAL NO. 26 INSTEAD OF SERIAL NO. 218 BY MODIFYING THE FINAL SENIORITY LIST . ANY OTHER REMEDY WHICH THIS AUGUST TRIBUNAL DEEMS FIT AND APPROPRIATE THAT MAY ALSO BE AWARDED IN FAVOUR OF THE APPELLANT.

RESPECTFULLY SHEWETH:

FACTS:

1. That the appellant is a permanent resident of Muhalla Garhi Khel Ahmad Khel, Tehsil and District Peshawar and is a law abiding citizen of Pakistan.
2. That the respondent department advertised the post of Village Secretary (BPS - 07) and the appellant being eligible, applied, and qualified for the said post through a written test duly conducted through NTS by the respondent department. The appellant was declared a successful candidate in merit list in Union Council 49, Bazid Khel, Village Council 144, Ahmad Khel. Copy of Advertisement & Relevant Documents are attached as Annexures - A & B.
3. That the Union Council Bazid Khel 49 consists of four village councils namely: i) Village Council 142 known as Kande Malakanan, ii) Village Council 143 known as Scheme Chowk, iii) Village Council 144 known as Ahmad Khel, & iv) Village Council 145 known as Marozai. That the

appellant belongs to Village Council 144 known as Ahmad Khel and was declared a successful candidate for the said Village Council, but astonishingly another person named Manzoor Khan belonging to another Village Council was illegally appointed/ transferred in the said Village Council. Copy of Documents are attached as Annexure - C.

4. That the appellant feeling aggrieved approached the honourable Peshawar High Court, Peshawar through W.P. No. 4362-P/2016 and the honourable Peshawar High Court, Peshawar through judgment dated 22.05.2018 directed the respondents to appoint the petitioner(now appellant) on the vacant post of Village Council No. 144 as soon as possible but not later than 30 days. Copy of W.P. No. 4362-P/2016 and PHC Judgment dated 22.05.2018 are attached as Annexures - D & E.

5. That the appellant was finally appointed through office order dated 30.11.2018 after a delay of several months and continuous requests and applications by the appellant. Copy of Applications, Appointment Order dated 30.11.2018, Arrival Report & Medical Certificate are attached as Annexures - F, G, H & I.

6. That a Tentative Seniority List dated 10.08.2020 was issued by the department against which the appellant filed his objection. The appellant kept on inquiring about the Final Seniority List from the department but the department kept on informing him that it will be notified soon. The department then secretly issued a Final Seniority List dated 16.03.2021 without even notifying it on the Notice Board/ Circulation, as in normal course in such matters. The appellant when came to know of the Final Seniority List immediately filed an application for provision of Final Seniority List dated 16.03.2021, which was communicated to him 07.06.2021. The appellant was shocked to find his name placed at Serial No. 218 instead of Serial No. 26. Copy of Tentative Seniority List dated 10.08.2020, Application & Final Seniority List dated 16.03.2021 are attached as Annexures - J, K & L.

7. That the appellant then filed departmental appeal dated 18.06.2021 against the Final Seniority List dated 16.03.2021 which was rejected through Order (Letter) dated 29.11.2021 by the respondent department. Copy of Departmental Appeal dated 18.06.2021 & Rejection Order dated 29.11.2021 are attached as Annexures - M & N.

8. That now the appellant comes to this august Tribunal for the redressal of his grievances on the following grounds amongst others.

GROUND:

- A) That the appellant has not been treated according to rules, law, norms of justice and material on record.
- B) That the appellant will suffer great loss due to inaction, mala fide, arbitrary and illegal conduct of the respondent department.
- C) That the appellant has been condemned unheard and has not been treated according to law and rules.
- D) That the appellant applied for the post in pursuant to same dated advertisement, appeared in test and interview on same date as the other respondents did, but the appellant was deprived from his due right of appointment which was granted later on by the Hon'able Peshawar High Court. Thus seeing the selectee of the one and same process, the appellant is to be treated as per Rule-17 of the KP Civil Servants APT Rules, 1989.
- E) That being the selectee of the same selection process, the appellant's name is required to be place at Serial No. 26 (On the basis of date of birth), because the respondents have not maintained the list on the basis of merit list.
- F) That the appellant has been discriminated by not treating on the principles as treated the other selectees despite the fact that the appellant was also a candidate of the same selection process.
- G) That the respondents have violated the Law and Rules governing the issue of seniority amongst the civil servants.
- H) That the appellant has been deprived from his due right of seniority in an arbitrary manner by the respondents which is not sustainable legally.
- I) That the appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly requested that the appeal of the appellants may be accepted as prayed for.

(Copy of relevant documents are attached as annexure "B").

4. That Union Council Bazid Khel 49 consists of four village councils (i). Village Council 142 known as Kande Malakanan, (ii). Village Council 143 known as Scheme Chowk, (iii). Village Council 144 known as Ahmad Khel, (iv). Village Council 145 known as Marozai.
5. That petitioner belong to Village Council 144 known as Ahmad KHel where as Manzoor Khan Secretary belong to Village Council 142 known as Kande Malakanan.
6. That Manzoor Khan Secretary is appointed as successor Secretary of Village Council 142 known as Kande Malakanan instead of the petitioner who is permanent resident of Village Council 144 known as Ahmad Khel. (Copy of CNIC, Birth Certificate, Residential Certificate are attached as annexure "C", "D" & "E" respectively).
7. That appointment order of Manzoor Khan/ Respondent No. 5 is contrary to advertisement.

6/ 8. That petitioner time and again approached to respondents for appointment of the petitioner on the vacant post of Secretary Village Council, but in vain.

9. That petitioner being aggrieved from the impugned appointment of one Manzoor Khan/ Respondent No. 5 as Secretary which is illegally appoint in Village Council 144 Ahmad Khel instead of peitiotenr, there being no other adequate remedy available is constrained to approach this Hon'ble Court inter-alia on the following grounds:

GROUNDS:

A. That appointment of respondent No. 5 namely Manzoor Khan is illegal, contrary to the advertisement and based on malafide of the appointing authority.

02. In essence, on 27.06.2015, respondent/department advertised some post of Village Secretary Council. Petitioner being eligible and qualified, applied for the same post. Written test was conducted by the NTS, which was declared by the petitioner. After conducting test and interview by the respondent/department, respondent No.5 namely Manzoor Khan was appointed as Secretary at Village Council 142 known as Kande Malakanah instead of the petitioner who is permanent resident of Village Council 144 known as Ahmad Khel. Feeling aggrieved by the appointment of respondent No.5, petitioner time and again approached the respondent/department but in vain. Hence, the instant Writ Petition.

03. Learned counsel for the petitioner contended that petitioner had successfully qualified the required test and interview for the post of Village Secretary but he was not appointed by the respondents without any feasible explanation.

04. Further stated that no one shall be discriminated, insofar as appointment to public posts are concerned, if anyone is otherwise eligible and qualified for the public post.

05. On the other hand, learned counsel for respondent admitted that although petitioner had qualified the required test and interview but was not appointed as there was no any vacant post of Village Secretary in the concerned Village Council as private respondent was already adjusted on the only vacant post of Village Council No.144 Ahmad Khel, according to surplus policy of the government.


06. We have heard learned counsel for the parties in light of the available record.

07. The record reveals that according to Memo dated 26.06.2015, issued by the Director General, Local Government Rural Development Khyber Pakhtunkhwa it has been directed that all the surplus staff of District Council and Municipal Committees shall be first adjusted on all vacant post without the respective Union Councils and thereafter, if any vacancy was still existed, fresh candidates shall be appointed on the respective vacant post, which reads as: -

08. Record further reveals that test and interview for the post under consideration was held much after the target date mentioned in the directives/memo dated 26.06.2015.

09. No any first appointment order of the private respondent had been placed on record in order to determine that when and how the private respondent was previously appointed while the

adjustment order of the private respondent is also not available on record to determine the veracity of the comments submitted by the respondents, which itself reveals that material facts were concealed purposely by the respondent by filing vague kind of comments.

10. The required test had conducted on 01.01.2016, while the target date, for adjustment of surplus employees was 01.07.2015, meaning thereby that on the day of test for the post under consideration, it was vacant but despite the fact that petitioner had qualified for the post was not appointed which clearly shows the factum of nepotism and other consideration, which had suffered the petitioner and had illegally deprived him of his vested legal right of appointment.

11. Insofar as the adjustment of private respondent on the post of Village Secretary Village Council No.144 namely Ahmad Khel is concerned, respondent had not denied that he was not resident of Village Council No.142 namely Kandi Malakanan. So in accordance with the directives dated 26.06.2015, at most he would have been adjusted on the vacant post of Village Council No.142 but his
