

Appeal Under Section 4 of Khyber Pakhtunkhwa Services Tribunal Act 1974 for promotion to the post of Secondary School Teacher –IT (BPS-16) with all back benefits.

Respectfully Sheweth,

1. That the Appellant is a naturally born bonafide citizen of Islamic Republic of Pakistan and hails from a respectable family.
2. That the Appellant was initially appointed as I.T Lab Incharge on 15/04/2005 vide office order dated 15-04-2004. (Copy of Appointment Order is annexed as Annexure "A")

3. That it was on 24 April 2017 that service structure was approved and the post of lab in-charge were re-designated as Certified Teacher-IT & eligibility criteria is now being changed to intermediate plus Diploma in Information Technology & Associate Degree of Education/ Certified Teacher. **(Copy of Rules are annexed as Annexure "B")**

4. That on 28/05/2019 department promoted some of Certified Teacher IT to Secondary School Teacher. IT following service structure notified on 24/04/2017. But refused to promote the Appellant for the post. **(Copy of Promotion order is annexed as Annexure "D")**

5. That later on again D.P.C held its meeting on 24/09/2020 regarding promotion of Certified Teacher-IT to Secondary School Teacher-IT (from BPS-12 to PBS-16) and even the department recommended the appellant for the existing post, but even then no promotion order was issued. **(Copy of DPC Meeting dated: 24/09/2020 is annexed as Annexure "E")**

6. That the Directorate thereafter asked for guidance in the matter for promotion of Certified Teacher-IT to Secondary School Teacher-IT. **(Copy of Letter of Guidance is annexed as Annexure "F")**

7. That in response to the letter issued from Directorate, the same was intimated back as "the



Director may proceed & decide their promotion case being Competent Authority up to BPS-16 at their own level". **(Copy of Directions is annexed as Annexure "G")**

8. That thereafter DPC held its meeting on 11/06/2021, in which the appellant was rejected for the promotion due to lack of Certified Teacher/Associate Degree of Education, which is not the requirement for the post on which the appellant going to be promoted. **(Copy of DPC meeting dated 11/06/2021 annexed as Annexure "H")**
9. That after the above mention order the department withdraw all appointment order who has no Certified Teacher/Associate Degree of Education. **(Copy of Withdrawal Order is annexed as Annexure "I")**
10. The department again withdrawn the notification which have been issued regarding termination or withdrawal of appointment of Certified Teacher-IT due to Certified Teacher/Associate Degree of Education & the department again sent draft regarding elimination of professional degree Certified Teacher/Associate Degree of Education to Secretariat, which is clear discrimination, as the same yardstick is not applied to the case of the appellant. **(Copy of Restoration Order is annexed as Annexure "J")**

11. That feeling aggrieved the Appellant preferred a Departmental Appeal, but futile. (Copy of Departmental Appeal is annexed herewith as Annexure "K")
12. That after feeling exhausted the Appellant prefer the instant service appeal for promotion to the post of Secondary School Teacher-IT (BPS-16) with all back benefits upon the following grounds inter-alia:-

Grounds:

- A. That the appellant is naturally born bonafide citizen of the Islamic Republic of Pakistan & is fully & equally, on equality basis entitled to all basic & fundamental rights as enshrined in the fundamental law of the land, interpreted, guaranteed & enforced by the laws & law courts of the land.
- B. That as per the prevailing rules & law governing the subject, the Appellant is fully eligible in all aspects and is fully and equally entitled to be promoted on regular basis as Secondary School Teacher IT from the date of vacancy or date of 1st DPC meeting.
- C. That it is cherished principle of law that where a law requires a thing to be done in particular manner, then that has to be done in that very manner & not otherwise.
- D. That as per minutes of the 1st meeting of DPC posts of Secondary School Teacher- IT available for promoting from PBS-12 to PBS-16, but the respondent department have illegally & unlawfully deferred the promotion & that too without

mentioning any reasons which is illegal, unlawful & against the regulations.

- E. That according to Article 4 of the Constitution, no one should be treated otherwise than accordance with law, while Article 25 postulates alike are to be treated alike, but here the case is volta-facie & totally different yardstick has been taken to that appellant.
- F. That discrimination in any form is highly abominable & bête-noire & always checked by the Superior Courts in a derisorous manner, the reason behind checking it down & chucking it away is to remove any sense of discrimination & to ensure equality & equal treatment.
- G. That from every angle, the appellant is entitled to be promoted as Secondary School Teacher -IT (from BPS-12 to BPS-16) on regular basis, w.e.f date of vacancy or at least from date of 1st DPC meeting i.e. 24/09/2020.
- H. That deferment of the subject promotion for the subject post in the impugned DPC is based on malafide & liable to be struck down.
- I. That any other ground not raised here may graciously be allowed to be raised at the time of arguments.

It is, therefore, most humbly prayed that on acceptance of the instant Service Appeal, the Appellant may graciously be declared to be entitled to be promoted from the post of Certified Teacher-IT

(BPS-12) to the post of Secondary School Teacher-IT (BPS-16) & be promoted as Secondary School Teacher-IT (BPS-16) with all back benefits in terms of arrears & seniority w.e.f the date of vacancy or at least from date of 1st D.P.C meeting i.e. 24/09/2020.

Any other relief not specifically asked for may also graciously be extended in favor of the appellant in the circumstances of the case.



Terms and Conditions of their appointments: -

1. Their Services will be considered regular but without pension or gratuity and terms that section 19 of the NWFP Civil Servant Act 1973 as amended vide NWFP Civil Servant (amendment act 2005). They will however be entitled to Contributory provided fund in such manner and in such rates as may described by the Government.
2. They will governed by such rules & regulation as may be prescribed by the Govt. from time to time for category of the Govt. servants to which they belong
3. In case of resignation without prior notice their one month pay plus usual allowances will be forfeited in lieu thereof.
4. Their seniority will be determined in accordance with the merit of Departmental Selection Board/Committee.

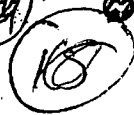

Subject Departmental Representation/Appeal against Notification No.5631-4 dated: 30.06.2021 promotion from the post of C.T (I.T) (BPS-12) to the post of SST (IT) (BPS-16).

Respected Sir

The appellant humbly submits as under:-

1. The appellant is possessing the qualification of B.Sc (Computer Science) as well as B.Ed, acquired from the HEC recognized Institutions.
2. The Education Department Khyber Pakhtunkhwa had advertised the post of Computer Lab: In-charge (BPS-7). Appellant being eligible in terms of the advertisement applied for the said post. He went through the selection process successfully qualified the same and consequently appointed against the subject post on 16-04-2005 on contract basis after observing all the codal formalities. It is pertinent to mention here that on the basis satisfactory service, the contract period of appellant was extended from time to time.
3. The Provincial Government of Khyber Pakhtunkhwa enacted Regularization of Services Act, 2018 wherein as many as 58 projects including the project of appellant were converted to regular side. It worth mentioning to aver here that the Department re-designated the post of Computer Lab: In-charge (BPS-7) to C.T (I.T) (BPS-12) with the date of initial appointment. Since then appellant has been discharging duty with full zeal and zest.
4. The pursuant to above the appellant was placed at Serial No 07 of the Final Seniority List of C.T (I.T) (BPS-12). It is important to mention here that the seniority list of the seniority is promote a civil servant against the next higher grade.
5. The in the year 2020 applications were invited departmentally from CT (I.T) (BPS-12) working in District Chitral for promotion to the post of SST (I.T) (BPS-16). Appellant also applied for the same through proper channel. The cases of eligible candidates including appellant were duly processed. Working Paper was prepared and placed before the Departmental Promotion Committee held on 24.09.2020 for consideration. Appellant was hopeful for his promotion, but to his utter dismay and bewilderment, the recommendations were unlawfully cancelled without any reasonable basis lawful.

That it is submitted that after almost 9 months fresh recommendations were processed for promotion to the post of SST (I.T) (BPS-16) wherein CT(I.T) were promoted vice impugned Notification dated 30.06.2021 while appellant was ignored on the ground of lacking Professional qualification of C.T, hence the appellant has departmental appeal on the following grounds:-

GROUND 1:-

A The appellant has not been treated in accordance with law, rules on subject and the Department has unlawfully deprived the appellant from his due right of promotion on a misplaced ground of C.T qualification which unlawful, unjust and not sustainable in the eye of law.

B The post of the appellant was re-designated as C.T (I.T) (BPS-12) in violation of law, therefore, the same left no room to the Department to deprive the appellant from the subject post. It is relevant to mention here that by means of a notification dated 30.05.2019, the Department has used different yardstick by promoting as many as 14 C.Ts (I.T) (BPS-12) to the post of SSTs (I.T) (BPS-16); the appellant was also to be treated on the same footing under the law of consistency and equality before law. Reliance is placed on 2019 SCMR 1.

C Article-25 of the Constitution of Islamic Republic of Pakistan, 1973 stipulates equal treatment amongst the citizens of the Pakistan as it was held in *Shafiq Ahmad v. Islamic case that under Article-9 of the Constitution a civil servant has constitutional rights to be treated as per law*. Reliance is placed on 2019 SCMR 1 and CSJ Note 23 which is as under:-

"Article-25: Discrimination Similar treatment Scope Alike should be treated Alike."

Section-9 of Civil Servants Act-1973 provides:-

"A civil servant possessing such minimum qualification as may be prescribed shall be eligible for promotion to a higher post for the time being reserved under the Rule for Departmental Promotion in the service or cadre to which he belongs."

Further Rule-7(3) Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989 narrates that:-

"Persons possessing such qualifications and fulfilling such conditions as laid down for the purpose of promotion or transfer to a post shall be considered by the Departmental Promotion Committee or Provincial Selection Board for promotion."

4. The prescribed criteria for promotion to the post of SST (I.T) (BPS-16) is as under:-

- i. **At least Second Class Master Degree in Computer Science or Information Technology or Bachelor Degree in Computer Science (BCS/BSCS Honours 4 Years) or Bachelor's Degree with a subject of Computer Sciences or equivalent qualification from recognized University; and**
- ii. **Bachelor Degree in Education (B.Ed.) or equivalent qualification from recognized University.**

5. In view of the above criteria, the appellant is very much eligible for the promotion to the subject post but he has unlawfully been deprived on the misplaced ground of lacking prescribed qualification.

6. That appellant deserves to be promoted against the post of SST (I.T) as per prescribed qualification but was unlawfully deprived. It is valuable to aver here that decided in 2021 PLC (CS) 365:-

..... When law required a thing to be done in a particular manner then it must be done accordingly."

7. Likewise, 2020 PLC (CS) 331 provides that "if law had required a particular thing to be done in a particular manner then same must be done in the prescribed manner only". Therefore, it is visible from the Notification dated 30.05.2019 wherein persons were promoted against the said post who had the same qualification as appellant possesses but clear discrimination has been made against him and he has unlawfully been deprived of his right of promotion.

8. G. Appellant is eligible for the post of SST (I.T) (BPS-16) because he having the prescribed qualification but on the basis of misplaced reasons, he was debarred from promotion.

9. In light of the above, it is, therefore, humbly prayed that on acceptance of this Departmental Appeal, the appellant may kindly be promoted to the post of SST (I.T) (BPS-16) in view of the Notification dated 30.05.2019 with effect from the due date with all back benefits.
