



AND FOLLOW THE SENIORITY LISTS
PRIVIOUSLY ENLISTED FROM 2007 TO 2018 BY
THE RESPONDENTS DEPARTMENT FOR DISTRICT
CHARSADDA.

RESPECTFULLY SEWETH;

The appellant humbly submitted as under;

REIF FACTS:

- a) **That** the appellant serving as Patwari Halqa Sariekh (BPS-9) Tehsil Shabqadar and my appointment order as patwari on 13/02/2004.
- b) **That** the appellant performing his duties with full devotion and am having a clear and transparent record.
- c) **That** on 21/08/2007 fist Final seniority was issued by District Officer Revenue (DOR) in which the Appellant was on Serial Number 62.**(Copy is attached as "A")**.
- d) **That** the respondent #1 issued another Final seniority bearing number 78-81/DC/DK/Sonority List/ DPC on 29/01/2014 in which Appellant is on Serial Number 55.**(copy of which is attached as "B")**.
- e) **That** on 30/06/2015 another Final seniority list was issued by Deputy commissioner (DC) Charsadda (Respondant#1) in which Appellant was on Serial Number 35.**(copy of which is attached as "C")**.
- f) **That** on 31/12/2016 Tentative seniority List was issued by Deputy commissioner (DC) Charsadda (Respondent#1) in which Appellant was on Serial Number 24.**(copy of which is attached as "D")**.
- g) **That** on 31/12/2017 Tentative seniority list was issued by Deputy commissioner (DC) Charsadda (Respondent#1) in which Appellant was on Serial Number 12.**(copy of which is attached as "E")**.

- h) **That** on 31/12/2018 another Final seniority list was issued by Deputy commissioner (DC) Charsadda (Respondent #1) in which Appellant was on Serial Number 11.(copy of which is attached as “F”).
- i) **That** on 27/12/2021 another Final seniority list bearing number DC(CHD)/DK/1293-97 was issued by Deputy commissioner (DC) Charsadda in which Appellant Serial Number is astonishingly mentioned at serial number 17 from serial number 11.(Copy of List is attached as “G”).
- j) **That** feeling aggrieved the appellant submitted departmental appeal before commissioner Peshawar division on 20/01/2022 which was dismissed on 16/03/2022.(Copy is attached as annexure “H”).
- k) **That** during pendency of departmental appeal the respondent made a DPC in district Charsadda and the petitioner were not allowed to take a copy of order and proceeding of the committee.(Copy of Other documents annexure “I”)
- l) **That** feeling aggrieved the Appellant having no other remedy come to this honorable Tribunal on the following grounds enter-alia.

ROUNDS:

1. **That** the impugned seniority list dated 27/12/2021 was against the rules prescribe under the law and the serial number of appellant was mentioned in wrong place which is evident from

the record of previous seniority list published from 2007 to 2018.

2. That the appellant explained his position to the Deputy Commissioner Charsadda (respondent #2) through written application and went to his office for correction of the final seniority list but in vain.
3. That the impugned order dated 16/03/2022 passed by the respondent #1 is illegal, unjust, arbitrary, whimsical and based on malafide, therefore, is liable to be cancelled / set aside and a seniority list may kindly be made in according to the law.
4. That the impugned seniority list order is whimsical, arbitrary and passed without observing the coddle formalities.
5. That appellant has been condemned unheard, which law, rules and regulations does not permit, beside the facts, that it is against the rules of natural justice and the matter has been conducted one sided which is not permissible under the law.
6. That the Respondents resorted for their own whims and wishes and making seniority list of their favorites for gaining monetary benefits. In this view of the matter the whole process of making seniority list needs a close look and check through a judicial scrutiny by this Honorable Tribunal.
7. That Respondents No: 01 & 02 are custodians of the public rights and interests and under the command of the constitution they are obliged to carry out a fair and transparent process of appointment but in the case of the appellant they have succumbed to their own wishes and have made pick and choose.

8. That the appellant has been treated against the law and has also been deprived of protection of law.
9. That the appellant having no other forum available for redressal of his grievances hence knocked the door of this honorable Tribunal through the instant appeal.





I have the honour to submit the following few lines for your kind and sympathetic consideration:-

- a) That I am serving as Patwari Halqa Sariekh (BPS-9) Tehsil Shabqadar and my appointment order as patari is on 13/02/2004.
- b) That I have been performing my duties with full devotion and am having a clear and transparent record.
- c) That on 21/08/2007 first Final seniority was issued by District Officer Revenue (DOR) in which my Serial Number 62. (copy of which is attached as "A").
- d) That on 29/01/2014 another Final seniority bearing number 78-81/DC/DK/Sonority List/ DPC was issued by Deputy commissioner (DC) Charsadda in which my Serial Number 55. (copy of which is attached as "B").
- e) That on 30/06/2015 another Final seniority list was issued by Deputy commissioner (DC) Charsadda in

which my Serial Number 35.(copy of which is attached as "C").

- f) That on 31/12/2016 Tentative seniority List was issued by Deputy commissioner (DC) Charsadda in which my Serial Number 24.(copy of which is attached as "D").
- g) That on 31/12/2017 Tentative seniority list was issued by Deputy commissioner (DC) Charsadda in which my Serial Number 12.(copy of which is attached as "E").
- h) That on 31/12/2018 another Final seniority list was issued by Deputy commissioner (DC) Charsadda in which my Serial Number 11.(copy of which is attached as "F").
- i) That on 27/12/2021 another Final seniority list bearing number DC(CHD)/DK/1293-97 was issued by Deputy commissioner (DC) Charsadda in which my Serial Number is astonishingly mentioned at serial number 17 from serial number 11.(copy of which is attached as "G").
- j) That feeling aggrieved the appellant submit the following grounds enter-alia.

Grounds:

1. That the impugned seniority list dated 27/12/2021 was against the rules prescribe under the law and the serial number of appellant was mentioned in wrong place which is evident from the record of previous seniority list published from 2007 to 2018.
2. That, I explained my position to the Deputy Commissioner Charsadda through written application and went to his office for correction of the final seniority list but in vain.
3. That the impugned order is illegal, unjust, arbitrary, whimsical and based on malafide, therefore, is liable to be cancelled / set aside and a seniority list may kindly be made in according to the order of Peshawar High Court Peshawar I Writ Petition # 2048-P/ 2021, dated: 07/07/2021.(Copy of order is attached As Annexure "H").
4. That the impugned seniority list order is whimsical, arbitrary and passed without observing the coddle formalities.
5. That I have been condemned unheard, which law, rules and regulations does not permit, beside the facts, that it is against the rules of natural justice and the matter has been conducted one sided which is not permissible under the law.

It is, therefore, most humbly prayed that the impugned order dated 10/11/2021 may be canceled /set aside/ varied according to the previous seniority lists issued from 2007 to 2018.

ORDER

By this order I will dispose of the departmental appeals filed by the above named appellants against the seniority list of Patwaris dated 27.12.2021 issued by the Deputy Commissioner Charsadda vide no. DC(CHD)/DK/1293-17, praying for assigning them their due seniority in the list.

Brief facts are that back in 2004, Respondent at S.No.2 preferred an appeal before this office praying for correction of seniority and assigning him due seniority whose appointment as Patwari alongwith 08 others was made in one joint order on 13.02.2004 where his name was placed at S.No.5 but afterward when joint seniority list in 2006 was issued, his name appeared at S.No.71 (placing him at 2nd position amongst those appointed with him in one joint order i.e (13.02.2004), however in seniority lists issued later-on in 2014, & afterward name of Respondent no 2 was placed below the names of his colleagues. On the basis above he prayed for placing his name at proper position as per seniority list of 2006 as during this period (2004-2006) neither any objection was raised by any candidate against the seniority list of 2006. Stance of the Department was that appointment order dated 13.02.2004 was not in order (though mentioned in the order that it was in order of merit) but unfortunately, no corrigendum issued or correction made in time by the District Collector until it matured. Though later one correction was made in Seniority lists of 2014, & afterwards name of Respondent No.2 and his colleagues were placed in order as per their dates of birth, wherein position in seniority of the Respondent no.2 came below the names of his colleagues. His court vide letter dated 17.03.2020 directed the District Collector to dispose of the appeal-cum-application of Respondent No. 2 as per ground merit of the case.

Petitioner at S.No.1 (Mr. Sher Bahader) filed the instant petition against the Seniority list dated 27.12.2021 issued by the District Collector Charsadda notified in light of the Hon'ble Peshawar High Court Judgment dated 09.07.2021 in a writ Petition no. 2048-F/2021

and advice of the Director Land Records dated 10.11.2022. Worth to mention here that the said writ petition was filed before the Hon'ble High Court Peshawar by the Respondent No.2 for assigning him due seniority as per Seniority list 2006 and in light of the directions of the Commissioner Peshawar Division contained in letter dated 17.03.2020 and reflected in meeting minutes of the District Collector Charsadda dated 21.04.2020. None of the petitioners have filed writ in any court of law for seniority.

The petitioner aggrieved by the above seniority list has submitted that he was appointed in 2004 as Patwari and obtained highest score of 437 marks from the Revenue Academy Karak in 2003 and also got 1st position in the written test/interview during appointment as Patwari and also confirmed 1st of the list of his colleagues. He has further submitted in his appeal that the scrutiny committee headed by the ADC Charsadda has also recommended him for selection at S.No.1 of the list and that he was entitled for assigning him due senior over his colleagues in light of Para 3.6 of the Land Record Manual and under Rule-9 of the Patwar Subordinate Service Rules-1963. That no tentative list was issued prior to the instant seniority list of dated 27.12.2021 as admissible under the rules so that objections can be filed. Keeping the above in view, the petitioner has prayed that he may be assigned due seniority by placing his name at S.No.11 of the ibid list instead of S.No.15.

Regarding claim of the petitioner that he got 1st position in test/interview, it is cleared that prior to the year 2016 there was no criteria for appointment or selection of a patwari on the basis of test/interview. Furthermore, the recommendations of the Scrutiny Committee were not exceeded to after advice received from the Director Land Record, hence this aversion of the appellant is also contrary to facts.


Petitioners at S.No. 2 & 3 have also the same pray for assigning them due seniority and setting aside the impugned seniority list dated 27.12.2021 being illegal and based on malafide and also prayed that it may be corrected as per previous seniority lists from 2007 to 2018 as it is contrary to the orders of the Hon'ble Peshawar High Court and advice of the Director Land Record. As per pray of the appellant at S.No.2, his name appeared at S.No. 11 of the seniority list of 2018 while it appeared at S.No.17 of the impugned seniority list dated 27.12.2021. Similarly, Appellant at S.No. 3 has the same grievance as his name was placed at S.No.12 in the Seniority list of 2018 and now at S.No. 13 of the impugned seniority list below the name of Respondent No.2.

Record perused and comments furnished by the District Collector Charsadda also examined. Hon'ble Peshawar High Court in WP No. 2048-P/2021 while disposing of the petitions of the appellants vide judgment dated 07.07, directed that Respondent No.1 (District Collector Charsadda) shall by all means issue a fresh seniority list of the Patwaris of District Charsadda within one month positively. If the petitioners are agreed of the fresh seniority list,

may file a fresh petition for his grievances, if so desired. In compliance thereof fresh seniority list was prepared and issued by the District Collector on 29.12.2021 determining the seniority position of the Patwaris of the district.

The Director Land Records Khyber Pakhtunkhwa in an advice dated 10.11.2021 sought by the District Collector Charsadda advised that seniority may be determined as per Para 3.6 of the Land Record Manual, if appointment is made prior to amendment in Service Rules (2016) and in case of appointment is made after 2016, the order in enlistment register becomes irrelevant and seniority is to be determined on the basis of test/interview. It is pertinent to mention here that the impugned seniority list was issued subject to advice of the Director Land Records, orders of the Hon'ble High Court Peshawar dated 07.07.2021 and directions of the Commissioner Office dated 17.03.2020, on the basis of Patwar Candidate Register according to which Respondent No.2 stands prior to the appellants as his name appears at S.No 52 of the Register while names of the petitioners falls later than him. As per Para 3.6 of the Patwar Candidate Register, candidates shall be entered in the order in which their applications (rather than marks obtained) are accepted but priority of entry shall give no priority of claim to appointment. The position of the candidates/Patwaris appointed prior to 2016 were reflected in the impugned Seniority list on the basis of Patwar Candidate Register as per provision contained in Para 3.6 of the Land Record Manual. Patwar Candidate Register maintained at District level carries name of Respondent No.2 on proper place and accordingly seniority list of 2006 was also issued in this context. Above all this seniority list was neither challenged nor objected to by any concerned which ultimately got matured.

Keeping the above in view, the appeals in hand stands dismissed. The seniority list of Patwaris dated 27.12.2021 issued by the District Collector Charsadda is upheld and shall remain intact. Files be consigned to GRR after necessary completion.

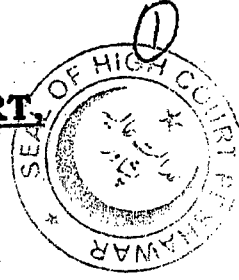

C. That even otherwise, a candidate like petitioner who has an unblemished service career hence delaying the issuance of seniority list is the result of injustice and discrimination.

D. That the Respondents have deliberately and mala fiddly not issuing the seniority list to stop the promotion of eligible persons like petitioner and the respondents believed that they could not be asked for their injustice by any authority.

E. That even otherwise, as per record produced by the petitioner regarding his previous seniority the respondents are duty bound to made correction in the record and to issue fresh seniority. The delaying tactics on part of Respondent No.1 is against the rule of Equality, hence, Respondent No.1 is duty bound to issue the seniority.

F. That the seniority is the vested right of the petitioner has been infringed, thus the constitutional remedy is available to the petitioner to the extent to issue direction to Respondent No.1 to issue Seniority list.

G. That the petitioner has been gone through a long and painful exercise of the departmental proceedings and he would be on top position in his colleagues, however a conspiracy is made to deprive the petitioner from his right.

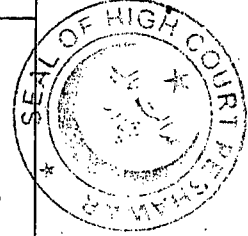
