



**SERVICE APPEAL:** UNDER SECTION 4 OF THE KPK SERVICE TRIBUNAL ACT, 1974, SEEKING DECLARATION/DIRECTION TO THE EFFECT THAT NOTIFICATION NO. SO(SM) E&SED/7-1/2021/PT/G/MC Dated 7/10/2021 ISSUED BY RESPONDENT NO. 2 WHEREBY APPELLANT WAS TRANSFERRED TO SDEO(MALE) DARBAND, DISTRICT MANSEHRA IS ILLEGAL, UNLAWFUL, WITHOUT LAWFUL AUTHORITY, ARBITRARY, PERVERSE, DISCRIMINATORY MALAFIDE AND CONSEQUENTLY OF NO EFFECT UPON THE RIGHTS OF APPELLANT AND LIABLE TO BE SET ASIDE TO THE EXTENT OF SERIAL NO. 40 OF THE SAID NOTIFICATION.

**PRAYER:** ON THE ACCEPTANCE OF THE INSTANT SERVICE APPEAL, THE IMPUNGED NOTIFICATION NO. (SM) E&SED/7-1/2021/PT/G/MC Dated 7/10/2021 ISSUED BY RESPONDENT NO. 2 MAY KINDLY BE SET ASIDE TO THE EXTENT OF SERIAL NO. 40 AND RESPONDENTS MAY GRACIOUSLY BE DIRECTED TO TRANSFER/ADJUST AGAINST THE VACANT POST OF DEPUTY DEO (M), ABBOTTABAD ON OPS. AND ANY OTHER RELIEF WHICH THIS HONORABLE TRIBUNAL DEEMS FIT AND PROPER IN THE CIRCUMSTANCES OF THE CASE BE GRANTED.

Respectfully Sheweth:-

The facts giving rise to instant appeal are arrayed as under:-

1. That the appellant was serving as SDEO (M) Tehsil Lower Tanawal, District Abbottabad.
2. That on 07/10/2021 appellant was transferred from SDEO (M) Lower Tanawal, Abbottabad to SDEO (M) Tehsil Darband District Mansehra vide Notification No. SM) E&SED/7-1/2021/PT/G/MC and appellant took over the charge on

15/10/2021 (under protest) against vacant post. Copies of Notification No. SM) E&SED/7-1/2021/PT/G/MC Dated 07/10/2021 are annexed herewith as Annexure "A" and "B" respectively.


- 3. That the appellant filed departmental appeal against the impugned Notification No. SM) E&SED/7-1/2021/PT/G/MC Dated 07/10/2021 before the respondent No. 1 which is still pending and the statutory period has been elapsed. Copy of departmental appeal is annexed as Annexure "C".
- 4. That feeling aggrieved appellant assails the impugned Notification dated 07/10/2021 being illegal, unlawful, against law and is liable to be set aside inter-alia amongst many other grounds:

**GROUNDS:-**

- a) That the impugned Notification Dated 07/10/2021 has been issued by respondent No. 2 to the extent of the appellant is illegal, unlawful, without lawful authority, arbitrary, perverse, discriminatory, malafide and consequently of no legal effects upon the rights of appellant.
- b) That the impugned Notification dated 07/10/2021 is liable to be set aside to the extent of appellant on the ground that as per final seniority list of SDEO MC BPS-17 duly notified vide Notification dated 04/03/2021 the name of appellant falls at serial No. 19 whereas, Mr. Raja Babu Jahangir falls at serial No. 79 of the said list who is presently working against the post of Deputy DEO(M) Mansehra BPS-18 on OPS basis. As appellant is senior than Mr. Raja Babu Jahangir and how <sup>appellant</sup> can perform his duty under the subordination of his junior. Copy of seniority list is annexed as Annexure "D".
- c) That appellant also submitted an application to respondent No. 2 vide diary No. 2942 dated 07/10/2021 regarding adjustment on acting charge basis.
- d) That consequent upon the departmental appeal appellant was called for personal hearing on 21/10/2021 vide letter dated 18/10/2021 and appellant appeared accordingly but in vain. Copy of letter regarding personal hearing is annexed herewith as Annexure "E".
- e) That the impugned Notification dated 07/10/2021 to the extent of appellant if seen from any angle, both factually and legally is not maintainable hence, liable to be set aside.
- f) That the impugned Notification dated 07/10/2021 to the extent of appellant is totally against the posting transfer policy and liable to be set aside.
- g) That the respondents have not treated the appellant in accordance with law, rules and policy on the subject and acted in violation of Article-4 of the

Constitution of Islamic Republic of Pakistan 1973 and unlawfully posted under the subordination of junior which is unjust, unfair, illegal hence not sustainable in the eye of law.


It is therefore, humbly prayed that on acceptance of the instant service appeal, the impugned Notification No. SO(SM) E&SED/7-1/2021/PT/G/MC Dated 07/10/2021 may kindly be modified/ set aside to the extent of appellant and respondents may graciously be directed to transfer/adjust the appellant against the vacant post of Deputy DEO (M), Abbottabad on OPS. And any other relief which this Honorable Tribunal deems fit and proper in the circumstances of the case be granted.
