Prayer:

On acceptance of this appeal, it is, therefore, earnestly prayed to allow this service appeal with directions to the official respondents to forthwith award proforma promotion to the appellant from the post of Clinical Technologist (Anesthesia) BPS-17 to Senior Clinical Technologist PBS-18 with all consequential back benefits/ perks and pensionary benefits attached to the post of BPS-18 w.e.f. 15.04.2019. Any other relief which this Hon'ble Tribunal deems appropriate in the circumstances of this service appeal and to whom the appellant found entitled may kindly also be granted.

Respectfully Sheweth;

Brief facts giving rise to the instant appeal are as under:-

- That the appellant was appointed as Anesthesia Assistant in (BPS 06) on 01.08.1978 and later on was promoted to the post of Anesthesia Technician (BPS-09) w.e.f. 21.04.1985.
- 2) That vide notification dated 08.08.2019, final joint seniority list of technologists (BPS-17) in various cadres in health department Khyber Pakhtunkhwa as stood on 15.04.2019 was issued for information of all the concerns.

(Copy of notification dated 08.08.2019 along with final joint seniority list of technologist BPS-17 of various cadres in the health department as stood on 15.04.2019 are enclosed as Annexures "A and B").

- 3) That the appellant is appearing at <u>Sr.No.23</u> of the Joint Final Seniority List, which indicates that the appellant was appointed on 01.08.1978 as Anesthesia Assistant who was promoted to the post of Anesthesia Technician (BPS-09) on 21.04.1985. He was further promoted as Chief Anesthesia Technician on 12.05.1991 in BPS-16, likewise, the appellant was further promoted as Clinical Technologist (Anesthesia) on 02.08.2012 in BPS-17.
- 4) That the appellant having almost 42 years service at his credit at the time of his retirement on 31.12.2019.

It is pertinent to mention that the appellant having almost 8 years service in BPS-17 while serving as Clinical Technologist Anesthesia.

5) That the appellant's case along with others was referred to Provincial Selection Board for promotion from the post of Clinical/ PHC Technologist BPS-17 to Senior Clinical/ PHC Technologist BPS-18 vide letter dated 07.10.2019 issued by section officer Govt. of Khyber Pakhtunkhwa Establishment and Admin. Department Regulation Wing.

(Copy of letter dated 07.10.2019 is enclosed as Annexure "C" while relevant list/ panel of officers for promotion from BPS-17 to 18 is also enclosed as Annexure "D").

6) That according to the working paper which was sent to the Provincial Selection Board indicates that 284 sanctioned post of the cadre of PHC technologist BS-18 was available in which 50% were reserved for promotion while 50% supposed to be filled by initial/ direct recruitment. According to the working paper required length of service for promotion from BPS-17 to 18 is five (05) years.

(Copy of working paper along with relevant service rules are enclosed as Annexure "E and F").

- 7) That though the case of appellant was referred to Provincial Selection Board on 17.10.2019, however, the case was returned due to irrelevant observations not related to the appellant.
- 8) That the appellant filed various representations to the concerned quarters that the case should be take up with the concerned stakeholders on priority basis for promotion from

BPS-17 to 18, however, due to inaction of the department the case could not be managed expeditiously and in the meanwhile the appellant reached to the age superannuation on 31.12.2019.

- 9) That the appellant filed departmental appeal on dated 01.01.2020 for promotion from BPS-17 to 18 but the same was not responded till date. (Copy of Departmental appeal is Annexure F/1).
- 10) That the appellant also approached the Hon'ble Peshawar High Court, Peshawar through W.P.No.1333-P/2021 for promotion to BPS-18 but the same was declined vide order dated 29.09.2022 with the observation that the proper forum for the redressal of appellant's grievance is the Provincial Services Tribunal, Khyber Pakhtunkhwa, Peshawar.

(Copy of writ petition along with order dated 29.09.2022 are enclosed as Annexure "G and H").

11) That the appellant feeling aggrieved and dissatisfied with the inaction of the department in the matter of his promotion from BPS-17 to 18, hence constrained to approach this Hon'ble Services Tribunal, for redressal of his grievance and seeking proforma promotion, on the following amongst other grounds:

Grounds of appeal:

a) That the appellant was eligible for promotion during his service from the post of Clinical/ PHC Technologist PBS-17 to Senior Clinical Technologist PBS-18 but due to inaction of the department the same could not be materialized. b) That the appellant was having more than five years service in BPS-17 which was required for onward promotion to BPS-18, therefore, the appellant's right cannot be denied within the fore-corners of law and to this effect relevant rules and working paper of the parent department has already been enclosed with the instant service appeal.

- c) That a retired civil servant can be considered for grant of proforma promotion in view of the recent judgment delivered by the Hon'ble Supreme Court of Pakistan reported in <u>2022</u> <u>SCMR 1546</u>.
- d) That the appellant having unblemished service record and earned excellent ACRs and also awarded performance shield awards throughout his career and was also found eligible for promotion in the working paper, therefore, he has every right to be considered for promotion BPS-17 to 18.
- e) That it is settled principle of law that the appellant cannot be suffered for the inaction of the department, therefore, he is entitled for proforma promotion.
- f) That additional grounds will be raised at the time of arguments with the kind permission of this Hon'ble Tribunal.

Keeping in view, what has been stated above, it is, therefore, earnestly prayed to allow this service appeal with directions to the official respondents to forthwith award proforma promotion to the appellant from the post of Clinical Technologist (Anesthesia) BPS-17 to Senior Clinical Technologist PBS-18 with all consequential back benefits/ perks and pensionary benefits attached to the post of BPS-18 w.e.f. 15.04.2019. Any other relief which this Hon'ble Tribunal deems appropriate in the circumstances of this service appeal and to whom the appellant found entitled may kindly also be granted.







- That the Health Department has finalized the joint seniority list of technologists BPS-17 in various cadres in the health department Khhyber Pakhtunkha Peshawar vide Notification No SOH-III/10-4/2019 on 8.8.2019 as per the said seniority list, 116 eligible health technologist were held liable for promotion by the Health Depepartment. copy annex as A.
- 3. That the names of petitioners have mentioned in the joint seniority list at S.No. 2,9,15,16,23,26,27 & 51 who is finalized on 15.4.2019 for promotion to BPS-18.
 - That the case of promotion of clinical technologist/Primary Health Care technologist BPS-17 to the post of senior clinical technologist/senior Primary Health Care technologist BPS-18 was sent to Health Department on 28.8.2019.
- 5. That the Govt: of Khyber Pakhtunkhwa Establishment Department PSB Section returned the said promotion case to Secretary Health Department Govt: of Khyber Pakhtunkhwa with the observations on 11.9.2019,where by Health Department cleared up all the observations. copy annex as B.
- 6. That in the mean time the petitioners retired from service in the year of 2019/2020, when the promotion case was under process under the said both departments.
- 7. That during this process period, the health department prepared the new joint seniority list on July 2020 and issued vide Notification No. 6683-783, dated 2.9.2020.it is worth mentioning here that the names of petitioners were excluded from the said new joint seniority list / promotion case which is against law and rules prescribed in as when a case of a Govt Servant's is under process/pending for promotion, they are entitle for promotion and benefits (all) for even after superannuation/retirement.

That once a seniority list is finalized & issued for promotions, it can not be changed until the promotion order is not issued.

- 9. That as per Govt policy,284 seats are reserved for grade 18 officers/technologists out of which 142 seats are reserved for seniority basis /promoted servants.further that in current 134, saeats are lying vacant for which the petitioners are eligible.
- 10. That as per decision of august Supreme Court, if latest amendment for retirement rules reconsidered, then the petitioners will have right to be rejoined on their previous posting and promotion subject to orders by this Honorable Court.
- 11. That it is pertinent to mention here that as per rules, a technologist will be eligible for promotion to 18 scale after completion of 5 years on the existing post and in this regard, all the petitioners have completed this period since 2012 till 2017/18.but this aspect also ignored by Respondents.
- 12. That petitioner no 1 particularly dropped for 3 times from promotion as he is the most senior of his other colleagues.
- 13. That all the petitioners have not been awarded with their right of promotion for the reason of malafidy, Discrimination and Political interference.

So under these circumstances it is humbly prayed that on acceptance, writs/orders magraciously be passed to join petitioners in seniority list and be promoted to Grade 18 since their period of eligibility with benefits.
