Preliminary Objections:

- 1. The appellant has no locus standi and cause of action.
- 2. The appellant has not come with clean hands.
- 3. The appeal is time barred.
- 4. The appeal is not maintainable.
- 5. The appeal is bad for non-joinder and misjoinder of parties.
- 6. That according to Section-10 of the Civil Servant Act 1973 the appellant is bound to do his duty anywhere in the Province.
- 7. That the appellant was transferred for the reason smooth running of the deptt: it is pertinent to mentioned here but only the appellant agitate the transfer order for their ulterior motives.
- 8. That the appellant not facing any hardship on that transferred because retained in same district, so the appellant failed to make out any hardship case which is necessary in case of transferred. This principal is also held in case 2005 SCMR 442 and appeal no 379/2018.

FACTS:.

- 1. Denied for want of knowledge.
- 2. Correct to the extent of posting as SDA but by dislocating the replying respondent and replying respondent was posted in OPS which is against the law and rules.
- 3. Denied. On noticing the mistake the deptt issued order dated 15/09/2022 wherein the replying respondent was posted as SDA in the office of PHE Bannu.

- 4. Correct. The posting order was issued according to law and rules. Moreover the appellant was transfer in same district but from one office to other office, which not caused any hardship to appellant, the principal held in appeal no 379/2018.
- 5. Denied for want of knowledge.
- 6. Denied for want of knowledge.
- 7. That the appeal of the appellant was not on legal footing may be dismissed on the following grounds.

GROUNDS:

- A. Incorrect. The impugned order is according to law, facts, norms of justice and material on the record, hence not liable to be set aside.
- B. Incorrect and misconceived. The appellant has been treated according to law and rules by the respondent Department on the subject. Moreover, the appellant uses political influence for his posting time and time again.
- C. Incorrect and misconceived. The appellant also served at PHE Division Bannu more than normal tenure from 2016. According Section-10 of the Civil Servant Act 1973 the appellant is bound to serve anywhere in Province in public interest. Copy of arrival report is attached as annexure-A.
- D. Incorrect. Hence denied. Already explained. Moreover the appellant was posted within district but from one office to other office which did not create hurdle for the appellant.
- E. Incorrect. The order has been issued in public interest. Moreover according Section-10 of the Civil Servant Act 1973 the appellant is bound to serve anywhere in Province.
- F. The respondent also requested to furnished any other ground at the time of arguments.

It is, therefore, most humbly prayed that the appeal in hand may be dismissed with cost through out merit less and devoid of any legal footing.
