

*The appellant submits as under:-*

1. *That the appellant joined the respondent department as PST Teacher on 17/03/1984.*
2. *That the appellant remained in active service for sufficient time and at some point of time, he was in need of long leave without pay as he was intended to construct residential house and he applied for the same, which was allowed and thereafter on completion of the leave, the appellant again send a request for further leave and the same was also allowed and it was extended. Thereafter, when the appellant's leave expired, the appellant joined his duties and continued the same and was re-adjusted at the place of MPS Sokai on 30/03/1998 and the appellant remained in active service. Thereafter again due to some family matter the appellant was in need of long leave and so again he applied for the same , which was granted and the appellant was allowed to go on long leave without pay. The appellant performed duties for about 24 months in the breakup and no salary/remuneration was paid at all.*
3. *That after the long leave and its extension at different points of time the appellant desired to assume duty.*
4. *That the appellant thereafter during the leave, proceeded abroad due to certain emergency, where he was incarcerated*

by law enforcement agency, showing the reason that there is some defect in the documents and the appellant was kept in fake allegation and was kept in confinement for long long time and when the appellant was release and deport, he immediately rushed to the authority concern for his posting and assuming charge.

5. That the appellant approached to the respondent for joining and posting, but the respondent made a Dilly dally and was proroguing the matter on one pretext or the other.
6. That thereafter the appellant was informed verbally that his service has been terminated vide entry in the pay bill dated 30/08/2003 and the appellant has seized to be in service.
7. That the appellant thereafter examined the record and asked through written appeal/application to the authority and submitted the same to the competent authority. The appeal/application was duly processed and forwarded to respondent No 1, who passed the impugned order dated 19/05/2022.
8. That the appellant approached this Honourable Tribunal for setting aside the order dated 19/05/2022 on the following grounds inter alia:-

**Grounds:-**

- A. *That the impugned order dated 19/05/2022 is against the law and facts on the file, hence the same is not sustainable.*
- B. *That the respondents have not issued any Show Cause Notice to the appellant nor any charge sheet was given nor any inquiry was conducted and the matter was also not reported in the newspapers and a unilateral proceedings without observance legal requirements and codel formalities and as such the respondents have blatantly violated the law and rules on the subject, which need rectification and correction by this Honourable Tribunal to set aside the same.*
- C. *That the respondents have sanctioned long leave without pay of the appellant and as such once the leave was allowed and sanctioned, the respondent could not take a somersault without recalling leave and putting the appellant on Show Cause Notice and explanation etc.*
- D. *That once the leave was granted and sanctioned and the same was acted upon then under the principle of locus ponentian, the respondents should have been passed a speaking order and ought to have been put the appellant on notice and there should have been inquiry and the matter ought to have been reported in the newspapers as per rules.*

- E. *That the subsequent absence of the appellant beyond the leave period was not intentional and willful rather it was under compulsion and reasons beyond the control of the appellant as the appellant was held up and incarcerated in the foreign country due to some problem in the dossier and some kind of fight/scuffling with the law enforcement authority and as such the non return was due to the reasons beyond control of the appellant, hence the one sided action taken in violation of the law and rules on the subject need to be set aside by this Honourable Tribunal.*
- F. *That the appellant through members of the family have informed the respondents about the incarceration and non availability for duty due to the reason beyond his control, but the said information was not seriously taken and was not considered and looked into by the respondents and as such committed grave illegality, which needs the indulgence of this Honourable Tribunal to be corrected.*
- G. *That the respondents if were adamant to take any punitive action, they ought to have put appellant on notice or should have been complied with law and rules on the subject, but by not obeying the law and rules governing the situation, the respondents have committed grave illegality, which is liable*

*to be rectified and the impugned order is liable to be set at naught.*

H. *That any other grounds inter alia not raised in this appeal may graciously be allowed at the time of arguments.*

*It is, therefore, most humbly prayed that on acceptance of the instant Service Appeal, the impugned order dated 19/05/2022 and the other proceedings under the fundamental rules may kindly be set aside and the appellant may be ordered to be reinstated in service with all back benefits.*

*Any other relief as deemed appropriate in the circumstances of the case not specifically asked for may also be granted to the appellant.*
