APPEAL UNDER SECTION 4 OF THE SERVICE TRIBUNAL ACT 1974 AGAINST OFFICE ORDER NO. DIRECTOR (LG) 3-1 / ESTB / 2022 / 1675-81 DATED 04-10-2022 OF R. NO. 01 WHEREBY REPRESENTATION OF R. NO. 04 WAS ACCEPTED WITH DIRECTION TO PLACE HIM AT THE TOP OF THE SENIORITY LIST OF THAT CADRE.

Respectfully Sheweth;

- That appellant was initially appointed on 30-04-1988 as Secretary Union Council and was posted as such at Village Council Kachi Kamar District Lakki Marwat.
- That R. No. 04 was appointed as Junior Clerk in Revenue Department on 21-10-1992 and due to re-structuring his services were placed at the disposal of Assistant Director Local Government Department, on 03-02-2002.
- 3. That on 23-12-2014, Establishment Department tendered opinion to Secretary Local Government, that surplus employees adjusted in other departments they shall be given back dating seniority over the incumbents of parent department / cadre. (Copy as annex "A").
- 4. That one Hidayat Ullah was also serving the department as Secretary Union Council since 01-09-1979. The department issued Seniority List and one Gul Zaman was placed senior to him, so he filed S. A. No. 733/16 before the hon'ble Tribunal to place him senior which came up for hearing on 01-03-2017 and then the hon'ble Tribunal feeling some mishap remitted the case to respondents with direction to prepare proper seniority list in accordance with law and then make up promotion against the vacant posts after observing the due codel formalities. (Copy as annex "B")
- 5. That in pursuance of the said direction respondents circulated Final Seniority List on 15-05-2017, wherein appellant was placed at S. No. 09, while R. No. 04 was placed at S. No. 25 being correct position. (Copy as annex "C")
 - That in the subsequent Seniority List dated 01-12-2019, covering letter dated 02-01-2020, appellant was placed at S. No. 08 while R. No. 04 at S. No. 24, being the correct position. (Copy as annex "D")

- That on 16-03-2021, in the Final Seniority List, appellant was placed at S. No. 06, while R. No. 04 at S. No. 20, being correct position. (Copy as annex "E")
- That on 01-02-2022, R. No. 04 submitted representation before Director General to re-cast Seniority List and he be placed at S. No. 01. Appellant also submitted representation on 08-03-2022 for issuing direction to Assistant Director, Local Government Department, to follow the Seniority List dated 16-03-2021. (Copies as annex "F" & "G")
- That on 29-03-2022, Director General decided both representations of appellant viz-a-viz R. No. 04, wherein claim of R. No. 04, regarding re-casting of Seniority List was turned down being time barred as well. (Copy as annex "H")
- 10. That on 09-05-2022, Deputy Director (Admin) Local Govt. & Rural Development Department wrote letter to Assistant Director Local Govt. & Rural Development Department, Lakki Marwat that R. No. 04 has approached appellate authority after lapse of more than three (03) years, the appeal being time barred could not be considered. (Copy as annex "I")
- That on 12-05-2022, Tentative Seniority List was issued, wherein R. No. 04 was placed at S. No. 01 while appellant at S. No. 04. This seniority list was of no legal effect as the matter was already dealt with by the respondents. (Copy as annex "J")

- 12. That the said Tentative Seniority List was objected by appellant as well by Khalid Hayat and Jameel Khan submitted representations on 18-05-2022 to Assistant Director Local Govt. to kindly place them at proper position which appeals were accepted on 07-06-2022. (Copies as annex "K")
- That in pursuance of the said direction Final Seniority List was circulated on 09-06-2022 by placing appellant at S. No. 02, while R. No. 04 at S. No. 15. (Copy as annex "L")

- 14. That the said Seniority List was again objected by R. No. 04 on 16-06-2022, submitting representation before Director General to place him on top of Seniority List. (Copy as annex "M")
- 15. That on 22-06-2022, Assistant Director (Admin), LG & RDD wrote letter to all Directors of the respective quarters to remit cases for promotion of senior Village Secretaries B-11 to the post of Supervisors B-14 and for the purpose meeting was scheduled on 05-07-2022 wherein others were promoted and no decision was made in respect of appellant. (Copy as annex "N")
- 16. That on 25-07-2022, appellant also submitted the representation before Director General for determination of seniority list of the Secretaries at Lakki Marwat. (Copy as annex "O")
- 17. That on 20-09-2022, Assistant Director (Admin) wrote letter to appellant viz-a-viz R. No. 04 to attend meeting to be held on 22-09-2022 in respect of seniority list of Senior Village Secretaries which directions were complied with and thereafter Director General LG & RDD Peshawar issued office order on 04-10-2022 wherein appeal of R. No. 04 was accepted to be placed at the top of list of that cadre. (Copies as annex "P" & "Q")

Hence this appeal, inter alia, on the following grounds.

<u>GROUNDS:</u>

- a. That since 30-04-1988, appellant was serving the department to the best of his ability and without any complaint.
- b. That R. No. 04 was initially appointed as Junior Clerk in Revenue Department in the year 1992 and was adjusted in Local Govt. Department on 03-02-2002. How he could be placed senior over appellant who was appointed in parent department as Secretary Union Council on 30-04-1988 and R. No. 04 was initially appointed as Junior Clerk in Revenue Department on 21-10-1992 and was adjusted in Local Govt. Department on 03-02-2002.
- c. That numerous seniority lists were circulated wherein appellant was not only placed senior to R. No. 04 but also at correct position.

- d. That request for seniority of R. No. 04 was turned down on 09-05-2022 and later on too, he should have challenge that order and thereafter the matter of seniority was closed once for all.
- e. That cadre of appellant viz-a-viz R. No. 04 was altogether different. Appellant was hailing in parent department while R. No. 04 was to Revenue Department.
- f. That R. No. 01 misinterpreted the law and those who were adjusted in other departments were to be placed at the bottom and not over the incumbents of the parent departments.
- g. That R. No. 04 cannot compete with appellant being of parent department, while he of alien to Local Govt. Department.
- h. That seniority list dated 15-05-2017 was made in pursuance of the direction of the hon'ble Peshawar High Court, Peshawar which cannot be interpreted by any authority of any department to issue direction to place him senior over the incumbents of parent department.
- i. That the impugned order dated 04-10-2022 of R. No. 01 is not per the mandate of Law. Policy cannot overrule settled law in respect of any terms and conditions of service of any individual.
- j. That the impugned order is not only against the law and rules but is also based on favoritism and malafide.

It is, therefore, most humbly prayed that on acceptance of the appeal, the impugned Order dated 04-10-2022 of R. No. 01 be set aside and Final Seniority List dated 09-06-2022 be restored with all consequential benefits, with such other relief as may be deemed proper and just in the circumstances of the case.

As regards the contention of the judgment of the Supreme Court of Pakistan, forbidding backdating seniority, it covers the absorption of employees of another departments/cadres. JUDGMENT

ASHFAQUE TAJ MEMBER: Hidayat Ullha, Secretary Union Council, Lakki Marwat, hereinafter called the appellant has preferred instant service appeal in terms of section-4 of Khyber Pakhtunkhwa Service Tribunal Act, 1974 against the the appellant was ignored.

Facts in brief are that appellant joined the respondent-department as Secretary 2. Union Council vide order dated 01.09,1979. That the appellant was adjusted as Supervisor vide orders dated 18.04.1998 and 10.06.2014. That according to rules, the post of Supervisor is to be filled in as 25% by initial recruitment and 75% by selection on merit with due regard to the seniority from amongst the holders of the post of the Village Secretary/Union Council Secretary with at least five years service as such. The appellant according to these rules was fully eligible for promotion to the post of Supervisor in the year 1996 when two posts were available at the time and the appellant was also holding the post of Supervisor by virtue of order dated 18,04.1998. That on 26.05.2015 the respondent-department in utter violation of rules and seniority promoted the junior most officer (Private Respondent No. 3) to the post of Supervisor by ignoring the appellant. That the appellant agitated the matter before the Hon'ble Peshawar High Court, Peshawar but the said Writ Petition was dismissed on basis of jurisdiction with observation that the appellant has not filed departmental appeal. That then the appellant in light of observations of the Hon'ble Peshawar High Court preferred a departmental appeal on 15.03.2016 which was not responded within the stipulated period and hence the instant service appeal.

3. Learned counsel for appellant argued that the impugned order dated 26.05.2015 is against the law, rules, norms of justice and material on record therefore, not tenable. He further argued that the appellant has not been treated according to law and rules and has been kept deprived from his legal right of promotion in an arbitrary manner. He contended that the appellant was senior most official and at serial No. 1 of the seniority list while the private respondent No. 3 was at serial No. 18/19 of the seniority list and thus the respondents have violated the basic principle of with due regard to seniority as mentioned in the rules. He further contended that the appellant has more than 36 years

service and in year 1998 when the post of Supervisor was available the appellant was eligible being senior most for the post at that time. Learned counsel for appellant in last argued that the Hon'hle Supreme Court of Pakistan held in many cases that promotion in a quota will always to be made from the date when the post was available for an official in his quota and the official cannot be deprived from his rights merely because the concerned department did not carry out the process of promotion in time and in last prayed that the impugned order dated 26.05.2015 might be set-aside and appellant may be promoted to the post of supervisor from the date 18.04.1998 when the vacancy was available for promotion quota.

4. On the other hand, learned Government Pleader for respondents resisted the appellant counsel arguments by submitting that the appellant joined the department on 01.09.1979 in BPS-6 while the private respondent No. 3 who was Senior Clerk in BPS-07 was surplus and was adjusted in the Department on 23.08.2001. According to the provisions of Esta Code when a government servant having higher scale is adjusted in a lower scale of pay he shall be given seniority and finally seniority list was prepared where the private respondent No. 3 was at scrial No. 3 while the appellant was at scrial No. 7. He further argued that the appellant was entrusted with the additional charge of a vacant post of Supervisor in 1998 and 2014 but was not adjusted or promoted to the post of Supervisor. In last he prayed that the instant appeal being devoid of any merits liable to be dismissed with costs.

5. From perusal of the record it transpires that the appellant joined the department as Secretary Union Council/Village Secretary vide order dated 01.09.1979 while private respondent No. 3 (Mr. Gul Zaman) Senior Clerk in BPS-07 who was in surplus pool and adjusted in the department on 23.08.2001. On record there are two seniority lists available one annexed by the appellant with his appeal and other by respondents with their reply as annexure-A. Both seniority lists were issued in year 2015, in first seniority list Mr. Hidayatullah (appellant) who joined service in year 1979 was shown

at serial No. 1 while Mr. Gul Zaman (private respondent No. 3) was shown at serial No. 7 in the later seniority list Mr. Gul Zaman (Private respondent No. 3) was placed on serial No. 1 and Mr. Hidayatullah (appellant) at serial No. 7. Record is completely silent to the effect that whether these seniority lists were ever circulated amongst all the officials for inviting any legal objections. Needlessto mention that it was informed during the course of arguments that private respondent No. 3 Mr. Gul Zaman got retirement from service be that as it may the appellant according to the later seniority list is at serial No. 7-despite the lact that he had joined service on 01:09-1979 and in derms of service hears senior most. Without giving any other findings on the seniority lists at this stage this service appeal is remitted with direction to respondents to prepare a proper seniority list in accordance to rules and procedure and circulate it amongsi all the officials and provide them appropriate opportunity for objections and accordingly to make promotion on the vacant post after doing all the afore-said legal formulities. This service appeal in hand stands disposed of accordingly. Parties and left to bear their own costs. File be consigned to the record room. Most respectfully it is submitted that the Assistant Director, LGRDD, Lakki Marwat has circulated Final Seniority List of VCs/NCs Secretaries on 09.06.2022. The said list is quite incorrect, unlawful. Hence the present appeal under the Khyber Pakhtunkhwa Civil Servants (Appeal) Rules, 1973 with the following facts and grounds:-

That, the competent authority of the appellant issued no seniority list of VCs/NCs Secretaries as required under Section-8(5) of the Khyber Pakhtunkhwa Civil Servants Act, 1973. So he lodged an appeal for the same. But his appeal was considered to be against the seniority lists of previous years. Therefore the said appeal was filed being time barred vide your office letter dated 13.05.2022 <u>but without prejudice and merit of the case and the competent authority was directed to regularly issue seniority list every vent as per law/rules in future (copy of letter dated 13.05.2022 is as Annexure-A).</u>

That, in pursuance of the said letter dated 13.05.2022 the AD, LGRDD Lakki Marwat circulated a tentative list on 12.05.2022 where in the appellant appeared at Sr. No.1. The appellant having rightful position did not file any objection or suggestion. But in the final seniority list the appellant name appeared at Sr.No.15. (Copies of both the lists are at Annexure-B & C respectively).

That, the appellant was surplus from Revenue Deptt. as Senior Clerk in BPS-7 and was adjusted as Village Secretary in BPS-6 on 03.02.2002. He was rightful to be placed at the top of the Seniority List in pursuance of Adjustment Policy vide Para-6(d) which provides that "In case of adjustment against a post lower than his original scale, he shall be placed at the top of seniority list of that cadre, so as to save him from being rendered surplus again & becoming junior to his juniors."

That, the Department adopted the said policy vide circular letter dated 12.02.2015 (copy of circular letter dated 12.02.2015 is as Annexure-D).

That, the above said policy was also adopted by the Department while implementing judgment dated 19.03.2019 of PHC Bannu Bench in Writ Petition No.873-B/2017 titled Mai Khan VS.Govt. (Copy of implementation is as Annexure-E).

Keeping in view the above facts and grounds it is earnestly requested that the appellant may be placed at the top of the seniority list of VCs/NCs Secretaries as required under the rules and obliged.

REVIEW PETITION/REPRESENTATION UNDER RULE 4 OF THE SERVICE TRIBUNAL ACT, 1974, REGARDING DETERMINATION OF SENIORITY OF SECRETARIES VCS/NC LAKKI MARWAT.

Respected Sir,

I have the honour to submit that I am the bonifide resident of Village Marmandi Multan District Lakki Marwat and hereby submit my review petition/representation in the light of Rule 4 of the Service Tribunal Act, 1974 as under:-

FACTS.

1.

That basically, I was appointed as a Secretary Union Council on 30.04.1988 and presently is serving as a Secretary BPS-11 uptil now under the control of Assistant Director, LG & RDD Lakki Marwat.

(Attested copy of my service book showing all required particulars prescribed for promotion to the next higher pay scale has already been submitted to your good offices for DPC).

That keeping in view my seniority, I was upgraded from the post of Secretary BPS-09 to the post of Senior Secretary BPS-11 on 01.02.2018.

- Now some dispute over seniority raised an illegally by one Mr. Allah Nor Secretary claimed his seniority then me and the whole process of further promotion distubred thus depriving me from my fundamental rights in violation of Rule 8 and 11A of the Civil Servant Act, 1973.
- 4. In this respect, I hereby clarified that Mr. Allah Noor was basically a senior clerk in Commissioner Office Bannu and his 1st appointment as shown in the seniority list is 21.10.1992 and due to devolution after declaring him as a surplus in 2001, he was adjusted in LG & RDD on 03.02.2002.

Assistant Director LG & RDD Lakki Marwat being Competent Authority shall caused inter-se seniority of the Secretaries of parent department and adjusted from other department strictly as per prescribed rules 8 & 11A of the Civil Servant Act, 1973 and Rule 17 of Civil Servant (Appointment, Promotions and Transfer Rules, 1989).

It is evident from all the available service record of both the officials, and rules on subject. I am clearly senior to him from the date of 1st appointment and rendered my services in my parent department since 30.04.1988 and Mr. Allah Noor Secretary appointed on 21.10.1992.

It is further clarified and justified that the Provincial Government has also made addition in the rules as provided in Rule 17 b (3) as under:-

"In the event of merger/restructuring of the departments, attached departments or subordinate offices, the inter se seniority of civil servants affected by the merger/restructuring as aforesaid shall be determined in according with the date of their regular appointment to a cadre post.

The above rules itself clarified that seniority of all the officials may be determined in accordance with the date of their regular appointment but some of the departments wrongly consider interpretations of the aid amendments as officials declared surplus whereas the above named respondent officials neither affected from merger/restricting nor having any vested rights of the seniority in LG & RDD and his objection, petition is totally malafide, against the rules and regulations and wasting time and energy of other officials.

Rule 11A of the Civil Servant Act, 1973 has only protected his pay and allowances and not any vested rights provided for seniority which is also clarified and circulated by Establishment Department Khyber Pakhtunkhwa vide letter No. SOR-IV/ED/G-1/2014 dated 23.12.2014 (Photostat copy enclosed for ready reference).

To this effect one of the official Mr. Hidayat Ullah the then seniority of V/Cs/NC no retired as Supervisor knocked at the door of Service Tribunal in this respect of seniority of the official. The Services Tribunal decided the case of afore mentioned official on dated 01.03.2017 vide order No. 733/2016 whereby a direction were issued through order dated 01.063.2017 to the Department LG & RDD to prepare seniority list of Secretaries VCs/NC according to law and rules. Which was prepared in 2017 accordingly. Whereby Mr. Hidayat Ullah was placed at serial No. 1 while the petition i.e. Naqib Ullah was placed at serial No 9 while placing respondent Allah Noor at serial No. 25 and the same was mentioned without any objection till 2019 and than 2021. Which is quite evident that Allah Noor is just wasting the precious time of the competent authority the judgment of worthy Service Tribunal is attached for worth perusal and on the basis of seniority in 2017 Mr. Hidayat Ullah was promoted and than one Abdul Majeed also promoted in the light of judgment of Service Tribunal dated 01.03.2017. (Photostat of Judgment, Service Tribunal & Order of Mr. Hidayat Ullah is attached)

- 10. Moreover, departmental appeal of the respondent official regretted by the Competent Authority with consultation of a prescribed committee in its meeting held on 29.03.2022 and circulated vide DG LG & RDD Khyber Pakhtunkhwa letter No. Director (LG)/3-1/Estab:/2021/20338 dated 09.05.2022 (Photostat copy enclosed).
- 11. As regards to Para 10 and on the directions of Competent Authority, the original seniority as per 1st and regular appointment has been determined by Assistant Director LG &RDD Lakki Marwat on 09.06.2022 wherein I along with other officials basically appointed in LG & RDD have been placed at S/No. 2 and Mr. Allah Noor placed at his appropriate place at Serial No. 15, circulated vide letter No. 969/AD/LG/RD dated 09.06.2022 (Photostat copy enclosed).

It is pointed out that the respondent official is submitting lame excuses to all concerned, disturbing the whole process of promotions and my vested rights due to which delay in my promotion is occurred wasting our time and energy showing mis-appropriation and interpretation of rules.

It is further highlighted that this issued has also been agitated and litigated by other officials but in vain rules/regulations quoted in this respect is very clear as per adjustment policy/notified by the Provincial Government of Khyber Pakhtunkhwa for the officials of surplus pool caused due to devolution in 2001.
