

Prayer

On acceptance of the instant appeal and by setting aside the impugned orders dated 21/11/2019 and 18/06/2019 issued by respondent # 1 & 2 respectively with the directions to the respondents to reinstate the appellant at his previous job as constable in the District Dera Ismail Khan being the eligible candidate with all back benefits.

Note: The Appellant had already filed a service appeal on 04/12/2019 in this honourable Kp, Service Tribunal Peshawar on the same issue (subject Controvery) which was by this honourable Kp, Service Tribunal Peshawar treated as Departmental representation vide Judgment/order dated 28/06/2022 and sent to the IGP, KPK for deciding it in accordance with law within three months.

### Respectfully Sheweth;

- 1. That the appellant was initially inducted in the Police Department in the year 2006 and w.e.f 2006 to 2015 the appellant served in the Police Department as constable # 115.
- 2. That in the year 2015, **PESCO** announced the various posts for which the appellant applied and in this respect the appellant obtained the NOC from respondent # 2 which was duly allowed upon the application of the appellant. Copies of the documents for obtaining NOC from respondent #2 is annexed as <u>Annexure-A.</u>
- 3. That on 14/12/2016, the appellant was appointed as Meter Reader in PESCO after fulfilling all the codal formalities. Copy of the appointment order dated 14/12/2016 is annexed as **Annexure-B.**



- 4. That the respondents were pleased to relieve the services of the appellant while allowing him lien and resultantly the appellant was relieved from his services and joined PESCO. Copies of relieving order and lien order are annexed as **Annexure-C.**
- 5. That during the services in PESCO and in lien period, the appellant submitted an application to the respondent # 2 for his reinstatement in the services but the respondent # 2 unfortunately vide impugned order dated 18/06/2019 without communication to appellant rejected the plea of the appellant and later on this order was issued to the appellant on 19/08/2019. Copies of the application along with impugned order dated 18/06/2019 passed by respondent # 2 are annexed as **Annexure-D&F.**
- 6. That feeling aggrieved with the order of the respondent # 2 the appellant submitted an appeal to the respondent # 1 which also met with the same fate i.e rejection. Copies of the application to respondent # 1 along with impugned order dated 21/11/2019 passed by the respondent # 1 are annexed as Annexure-G
- 7. That feeling aggrieved with the impugned orders dated 21/11/2019 and 18/06/2019 passed by respondent # 1 & 2 respectively, the appellant filed/preferred an appeal to this Honourable Service Tribunal on 04/12/2019 which was later on by this Honourable Service Tribunal treated as Departmental Representation vide judgment/order dated 28/06/2022 and sent to the IGP, KPK with the directions/order of this Honourable Service Tribunal to decide it in accordance with law within three months. Copies of the service appeal/departmental representation & order dated 28.06.2022 are annexed as Annexure-H & I.
- 8. That the appellant also made a departmental appeal to the respondent # 1 on 20/07/2022. Copy of the departmental appeal is annexed as **Annexure-J.**
- 9. That the appellant was called upon by the office of the IGP, KPK through order dated 29/08/2022 for the inquiry which was attended by the appellant on date given in the oder i.e



06/09/2022 at 11:00 hours in Central Police Office, Peshawar. Copy of the order dated 29/08/2022 is annexed as **Annexure-K**.

10. That feeling aggrieved with the impugned orders dated 21/11/2019 & 18/06/2019 passed by the respondent # 1 & 2 respectively and after the lapse of three months of the directions/order made in vide order dated 28/06/2022 of this Honourable Service Tribunal to the IGP, KPK to decide the matter within three months, the same has yet very unfortunately not been decided by the respondent no 1, therefore, the appellant has no other remedy but to knock the door of this honourable forum on the following grounds.

## GROUNDS

- a. That it is an admitted fact that the appellant is an Ex-old employee of the Police Department who joined his service as "Constable" BPS-05 in the year 2006.
- b. That the impugned orders passed by the respondent# 1 &2 are against law and against the norms of justice.
- c. That the respondent# 1 & 2 refused the rights of the appellant for which he was entitled for his reinstatement in services during the lien period.
- d. That the impugned orders of respondent # 1 & 2 are not sustainable in the eyes of law because the same are also against the dictum laid down by the August Supreme Court of Pakistan in case citation, 1996 SCMR 284 wherein it has categorically been directed that if any Ex employee wants his reinstatement in his previous services, he cannot be denied but respondent # 1 & 2 totally by passed the verdict of the said Judgment.
- not sustainable in the eyes of law and are liable to be set aside and the appellant deserves to be reinstated in the department.
  - f. That the appellant requests for his reinstatement in the services on the ground that the PESCO officials were not



regularizing the services of the appellant despite the fact that appellant was a regular employee of the respondents' department and refusal on the part of PESCO by not regularizing the services of the appellant rather by directing the appellant to resign from his services resultantly the appellant had to submit the application for his reinstatement in the respondents' department but the respondents failed to consider the plea of the appellant. Copy of the letter dated 03/04/2018 is annexed as **Annexure-L.** 

- g. That the respondent # 1 in the impugned order dated 21/11/2019 mentioned as "it is submitted that lien was granted to the appellant for 02 years period which was applicable from 10/01/2017 to 10/01/2019 as per DPO Order Book NO. 94 dated 10/01/2019 but it is must to communicate this honourable tribunal regarding the fact that the appellant during the days of getting his lien period extended was in jail in a false and fake FIR. (Copies of FIR and Acquittal order would be provided at the time of arguments).
- involved and if the services of the appellant are very much involved and if the services of the appellant are not reinstated the appellant shall become unemployed and the appellant now is about 37 years of age and is not eligible for any other job in any department being over aged.
- i. That the appellant is medically fit and is able to perform his duties in respondents' department.
- j. That the appeal of the appellant is after the lapse of three months of the directions made in the judgment/order dated 28/6/2022 of this honourable tribunal to the IGP, KPK which is well within time and this forum is the only competent forum to adjudicate and hear the matter of appellant.

It is therefore, on acceptance of the instant appeal and by setting aside the impugned orders dated

## **JUDGMENT**

KALIM ARSHAD KHAN CHAIRMAN. According averments made in the appeal are that the appellant was initially appointed in the Police Department in the year 2006 and w.e.f 2006 to 2015 the appellant served in the department as Constable; that in 2015, PESCO announced various posts for which the appellant applied and in this respect the appellant obtained NOC from respondent No.2 which was duly allowed upon the application of the appellant; that on 14.12.2016, the appellant was appointed as Meter Reader in PESCO after fulfilling all the codal formalities; that the respondents were pleased to relieve the appellant while allowing him lien and resultantly the appellant was relieved from his services and joined PESCO; that during the services in PESCO and in lien period, the appellant submitted an application to the respondent No.2 for his reinstatement in police services but respondent No.2 unfortunately vide impugned order dated 18.06.2019 without communication to appellant rejected plea of the appellant and later on this order was issued to the appellant on 19.08.20149; that feeling aggrieved, the appellant filed departmental representation which was rejected, hence, this appeal.

2. On receipt of the appeal and its admission to full hearing, the respondents were summoned, who on putting appearance contested the appeal by filing written reply raising therein numerous legal and factual objections. The defence setup was a total denial of the claim of the appellant.

- 4. Learned counsel for the appellant reiterated the facts and grounds detailed in the memo and grounds of the appeal while the learned AAG controverted the same by supporting the impugned order(s).
- According to the impugned order dated 21.11.2019, the department had granted lien to the appellant for a period of two years from 10.01.2017 to 10.01.2019 as per DPO order book No. 94 dated 10.01.2019. It was further stated that from 0.01.2019 the appellant did not apply for extension in lien, period which was his fault and thus his lien ended on 10.01.2019 from the Police Department and, therefore, his request was not held maintainable and was accordingly filed. Instead of preferring departmental representation against the impugned order dated 21.11.2019, the appellant has preferred this appeal before this Tribunal on 04.12.2019 that is within thirty days of the impugned order. Filing of departmental appeal against an impugned order before the next higher forum is not only the requirement of Section-4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 but also a step towards filing appeal before the Tribunal. The appellant has not filed departmental appeal within thirty days of the impugned order as required under Section-4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 and has rather preferred this appeal within thirty days of the impugned order, therefore, while deriving wisdom from the judgment of august Supreme Court of Pakistan reported as PLD 1994 Supreme

- the appellant submitted an appeal to the respondent#1 which also met with the same fate i.e rejection. Copies of the application to respondent#1 along with impugned order dated 18/11/2019 passed by respondent#1 are annexed as Annexure-E.
- 7. That feeling aggrieved with the impugned orders dated 21/11/2019 and 18/06/2019 passed by respondents#1 & 2 respectively, the appellant is having no other remedy except to knock at the door of this honorable forum on the following grounds.

#### GROUNDS

- a. That it is an admitted fact that the appellant is an Ex-old employee of the police Department who joined his service
   as "Constable" BPS-05 in the year 2006.
- b. That the impugned orders passed by respondent#1 & 2 are against law and against the norms of justice.

- c. That the impugned orders of respondents#1 & 2 are not sustainable in the eyes of law and are liable to be set aside






and the appellant deserves to be reinstated in the department.


