Appeal under Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974, against the inaction of the respondents by not adjusting the appellant on her due post of Subject Specialist BPS-18, against which the appellant filed departmental appeal before the competent authority which is not yet responded even after the lapse of Statutory period of 90 days.

Prayer in Appeal;

On acceptance of this appeal the appellant may kindly be adjusted/transfer on her due Post i.e. Senior Subject Specialist Statistics BPS-18 at GGHSS University Town Peshawar or any other School at Peshawar, the inaction of the respondent by adjusting the respondent no 4 i.e. Humaira Nasim BPS-17 on the post of SSS Statistic BPS-18 vide order dated 04.07.2022 may kindly be declare illegal unlawful and lawful authority and violative upon the rights of the appellant necessary direction may kindly be issued to the respondent to adjust the

appellant on the Post of SSS Statistics BPS-18 at GGHSS University Town Peshawar Or any other relief which is not specifically asked for may also be awarded to the appellant.

Respectfully Submitted:

- 1. That the appellant is the citizen of Pakistan and permanent resident of Kareem Pura, House No 2560, Mohallah Malik Shahdad Peshawar and having every right secured and guaranteed by constitution of Pakistan. (Copy of the CNIC and Domicile are attached as annexure A & B).
- 2. That the appellant was initially appointed on the recommendation of the Khyber Pakhtunkhwa Public Service Commission Peshawar on the post of Subject Specialist BPS-17 on 09.12.2009 and was adjusted against the vacant post at GGHSS Harichand Charsadda. (Copy of the appointment order dated 09.12.2009 is attached as annexure C.)
- 3. That since her appointment the appellant is performing her duties with great zeal and devotion and to the entire satisfaction of her superiors without any complaint whatsoever regarding her performance.
- 4. That the appellant was transferred/posted as SSS Statistic (BPS-17) at GGHSS Umarzai District Charsadda vide office order dated 24.09.2011, the appellant was against transferred to the post of SS Statistics BPS-17 at GGHSS Taru Jabba Nowshera vide office order dated 20.06.2014, the appellant was further transferred from GGHSS Taru Jabba Nowshera to GGHSS Khyber colony Peshawar vide order dated 24.11.2015. (Copy of the transfer orders are attached as annexure D, E & F).
- 5. That the appellant was promoted from the SS Statistics BPS-17 to the post of SSS Statistic BPS-18 but due to non-availability of the post of SSS Statistics BPS-18 at Peshawar the appellant was posted/adjusted on the post of SS Maths BPS-18 at GGHSS Shabqadar Charsadda against the vacant post as stop gap arrangement. (Copy of the notification dated 07.05.2020 is attached as annexure G).

- 6. That in the meanwhile through the impugned notification dated 04.07.2022, respondent no 4 i.e. Humaira Nasim SS Statistic BPS-17 was illegally Posted/adjusted against the post of SSS Statistics BPS-18 at GGHSS University Town Peshawar and in remarks it clearly written "that she will assume charge after vacation of the said position of Mst Shehla Nouman on account of her promotion to Principal BPS-19 in due course of time" and thereafter through notification dated 14.09.2022 the said Mst Shehla Nouman was promoted to the post of Principal BPS-19. (Copy of the impugned notification dated 04.07.2022 and notification dated 14.09.2022 are attached as annexure H & I)
- 7. That being aggrieved from the impugned office order/notification dated 04.07.2022, the appellant filed a departmental appeal before the competent authority on 05.07.2022, which is not yet responded even after the laps of statutory period of 90 days. (Copy of the departmental appeal dated 05.07.2022 is attached as annexure J).
- 8. That the appellant being aggrieved from the acts and omission of the respondents filed this service appeal on the following grounds inter alia.

GROUNDS OF SERVICE APPEAL

- A. That the Appellant has not been treated in accordance with law, and thus her rights secured and guaranteed under the law are badly violated.
- B. That the appellant since her appointment performed her duties with great zeal and devotion and to the entire satisfaction of her superiors without any complaint whatsoever regarding her performance till date.
- C. That the appellant was transferred/posted as SSS Statistic (BPS-17) at GGHSS Umarzai District Charsadda vide office order dated 24.09.2011, the appellant was against transferred to the post of SS Statistics BPS-17 at GGHSS Taru Jabba Nowshera vide office order dated 20.06.2014, the appellant was further transferred from GGHSS Taru Jabba Nowshera to GGHSS Khyber colony Peshawar vide order dated 24.11.2015.

- D. That the appellant was promoted from the SS Statistics BPS-17 to the post of SSS Statistic BPS-18 but due to non-availability of the post of SSS Statistics BPS-18 at Peshawar the appellant was posted/adjusted on the post of SS Maths BPS-18 at GGHSS Shabqadar Charsadda against the vacant post as stop gap arrangement.
- E. That the respondents malafidely and through the impugned notification dated 04.07.2022, the respondent no 4 i.e. Humaira Nasim SS Statistic BPS-17 was illegally Posted/adjusted against the post of SSS Statistics BPS-18 at GGHSS University Town Peshawar, which is illegal, unlawful and without lawful authority and also violative upon the rights of the appellant.
- F. That in the impugned notification in remarks column, it clearly written "that she will assume charge after vacation of the said position of Mst Shehla Nouman on account of her promotion to Principal BPS-19 in due course of time" and thereafter through notification dated 14.09.2022 the said Mst Shehla Nouman was promoted to the post of Principal BPS-19
- G. That in fact there exist no exigencies of service nor the order of posting/adjusting of BPS-17 on the post of Bps-18 as termed as in the public interest it is a result of political pressure at the cost of the Appellant, and thus not tenable in the eyes of law.
- H. That the impugned transfer/adjustment of respondent no 4 BPs-17 on the post of BPS-18 is illegal, unlawful, without lawful authority and passed without jurisdiction, not in the prescribed manner, in violation of transfer and posting policy, thus nullity in the eyes of law and not tenable.
- I. That according to the posting and transfer policy of the Provincial Govt, all the posting transfer shall be strictly in public interest and shall not be abused/misused to victimise the Govt, servant.
- J. That the appellant has prior right to be transfer to the post of SSS Statistic BPS-18 at GGHSS University Town Peshawar as the appellant is BPS-18 instead of adjusting the respondent no 4 BPS-17 on the post of BPS-18.

- K. That the appellant was adjusted on the post of SS Maths BPS-18 at GGHSS Shabqadar Charsadda due to the non-availability of the post of SSS Statistics BPS-18 at Peshawar in the meanwhile due to the promotion of Mst *Shehla Nouman* to BPs-19 the post of the SSS Statistics BPS-18 become vacant therefore the appellant has the prior right to be transfer to the post of SSS Statistic BPS-18 at GGHSS University Town Peshawar.
- L. That the Appellant seeks the permission of this Honourable Tribunal to rely on additional grounds at the hearing of this petition.

It is therefore respectfully prayed that On acceptance of this appeal the appellant may kindly be adjusted/transfer on her due Post i.e. Senior Subject Specialist Statistics BPS-18 at GGHSS University Town Peshawar or any other School at Peshawar, the inaction of the respondent by adjusting the respondent no 4 i.e. Humaira Nasim BPS-17 on the post of SSS Statistic BPS-18 vide order dated 04.07.2022 may kindly be declare illegal unlawful and lawful authority and violative upon the rights of the appellant necessary direction may kindly be issued to the respondent to adjust the appellant on the Post of SSS Statistics BPS-18 at GGHSS University Town Peshawar Or any other relief which is not specifically asked for may also be awarded to the appellant.




