







ORDER

Ex-Lady Constable Haleema Zareef No.4096 was awarded major punishment of dismissal from service by the then SP HQrs vide OB No.3355 dated 01.11.2018 on the charges of absence from duty w.e.f 10.04.20218 till date.

She was filed an appeal before CCPO, Peshawar against the above mentioned orders which was rejected/filed by the then CCPO, Peshawar vide order No.65-7/PA dated 07.01.2019.

Ex-Lady Constable Haleema Zareef No.4096 has submitted an application along-with court Judgment, wherein the Hon'able Service Tribunal ordered that **"the appeal is accepted. The appellant is reinstated in service and the impugned order of removal from service is converted into Minor penalty of stoppage of two annual increments for two years without cumulative effect."**

In light of the Tribunal Judgment, DSP Legal opinion & kind approval of W/CCPO, dismissal order of Ex-Lady Constable Haleema Zareef No.4096 is conditionally & provisionally converted into minor penalty of stoppage of two annual increments for two years without cumulative effect subject to the decision of CPLA which is still subjudice in the Apex Court.


