Respectfully Sheweth;-

May it please your lordship, the brief fact of the instant  
appeal are as under:-

1. That in order to make good the illegal order, the  
respondents issued a transfer order on 15/10/2021  
which is all together illegal and unlawful . Copy of

order dated 15/10/2021 is annexed herewith as Annexure "A"

2. That to the utter surprise of appellant, respondent No. 1 issued notification bearing Endst: No SO(SM)/E&SE/7-1/2020/Posting/Transfer/General dated 09/06/2021, whereby, he transferred respondent No. 4 from GHSS Serai Niamat Khan, District Haripur to GHSS No. 3 Abbottabad on the vacant post which was neither vacant nor in existence at the time of issuance of impugned notification, rather, after the issuance of impugned Notification has been created on 02/09/2021, whereas the respondent No. 4 was posted against the said post on 09/06/2021 i.e. more three months prior to sanction of post, surely, for the respondent No. 4 due to political motivation or sinister motives. Copy of impugned notification bearing Endst: No SO(SM)/E&SE/7-1/2020/ Posting / Transfer/General dated 09/06/2021 and letter whereby the post was sanctioned are annexed herewith as Annexures "B", "C" & "D"
3. That another application was also filed to Provincial Ombudsman vide

No. PO/Complaint/0114/02/2019/8750, where the respondents did not appear, however, the Honourable Provincial Ombudsman directed the appellant to approach the proper forum i.e. this Honourable Tribunal. Copy of complaint and order of Provincial Ombudsman dated 04/10/2021 are annexed herewith as Annexure "E"

4. That appellant preferred appeal before respondent No. 2 against the impugned notification before respondent No. 1 but to no avail and till date respondent No. 1 did not pass any order on departmental appeal and similarly not given any response on the said appeal, hence instant appeal on the following grounds inter-alia among many other. Copy of appeal and complaint history dated 23/01/2021 is annexed herewith as Annexure "F"
5. That as the appellant is performing his duties from last 10 years in hard/hilly area of Abbottabad, therefore, initially, the appellant submitted application to the respondent No. 2 through department No. 6735/EB-I/F. No. 38-Voll-II dated 17/11/2020 for his transfer from GHSS Tajwal to newly upgraded High School Kokal Barseen, the

appeal is also preferred on said application. Copy of application dated 17/11/2021 and alongwith appeal are annexed herewith as Annexure "G"

6. That secondly, the appellant again filed an application before respondent No. 2 on 26/01/2019 through No. SO(SM)2-1/2019 dated 25/01/2019, which was also not entertained and the appellant filed appeal. Copy of application and appeal are annexed herewith are attached herewith as Annexures "H" & "I".

7. That on many time appellant requested and submitted applications to respondents for his transfer but no action has so far been taken. Copies of applications dated 26/12/2018 and 12/11/2018 are annexed herewith as Annexures "J" & "K".

8. That the respondents also issued another transfer order dated 15/11/2018 wherein the appellant has also been ignored. Copy of order dated 15/11/2018 is attached as Annexure "L"

9. That the appellant also preferred appeal against order dated 26/12/2015 bearing No. SO(SM)E&SED/2-1/2018 regarding



posting/transfer. Copies of order dated 26/12/2015 is attached as Annexure "M".

10. That appellant has been performing his duties SS Physics at GHSS, Tajwal Abbottabad since, 24/09/2009. Copy of appointment order of appellant is annexed as Annexure "N".
11. That the appellant is a chronic patient of Aphthous Ulcerations with loss of vascular pattern and is suffering great hardship while performing his duties in hard/hilly area. Besides, the appellant met with an accident and has lost his two legs and has become disabled. Copies of medical treatment record is annexed herewith as Annexure "O"

That the appellant has now come to this Honourable Tribunal with the instant appeal in hand inter-alia, on the following grounds:-

**GROUND:-**

- a. That impugned notification bearing Endst: No SO(SM)/E&SE/7-1/2020/ Posting / Transfer/General dated 09/06/2021 is

against the law, fact and policy of the Govt.

Hence, is liable to be set aside.

- b. That the impugned Notification as issued by respondent No. 1 is illegal, unlawful and is against the fundamental rights of the appellant guaranteed under the Constitution of Islamic Republic of Pakistan, 1973.
- c. That impugned Notification dated 09/06/2021 is against the principle of transfer and posting policy, hence ineffective upon the right of appellant.
- d. That the appellant has served more than the prescribed period of tenure at one station and is otherwise eligible for transfer to any nearest station especially in view of his health condition.
- e. That the respondents have not treated the appellant in accordance with law, rather acted discriminately with the appellant for the reasons best known to them.
- f. That there is no criteria in the department with respect to transfer/posting. All the

transfers/postings are being made on political basis and personal whims notwithstanding the law on the subject, if there is any criteria, same is only approach to the highups of the department and the political figures, however, the appellant has neither any approach to the high ups of department nor to any political figures, that is why, the appellant with the serious health condition is compelled to serve in the hard area, rather, a corner of District Abbottabad.

- g. That there are many examples where an employee has been transferred for more than three times in a year.
- h. That the appeal is well within time.
- i. That other points would be argue at the time of arguments with the kind permission of this Honourable Court.



**THE COMPLAINT**

**REPORT OF THE AGENCY**

Notices under Section 10 (4) of the Khyber Pakhtunkhwa Provincial Ombudsman Act 2010 were issued to Secretary E&SE, Director E&SE and DEO (M) Abbottabad to meet the allegations and submit reply including rebuttal, if any. In response, DEO (M) Abbottabad submitted comments stating that complainant has submitted an application against the transfer orders dated 25/01/2019, which was forwarded to Director E&SE Peshawar, being the competent forum. However, no response was received from the Directorate of E&SE Department, hence parties were called for hearing, to clarify the matter.

**HEARING**

To clarify the matter the case was fixed for hearing. Mr. Adnan Shah (SO-General) and Mr. Muhammad Asad (Asstt) attended as representative of the Agency and contended that complainant is a Civil Servant and complainant should approach the Service Tribunal, which is the proper Forum for such like grievances.
