

Ex-Constable Shahab Alam No.3899 was awarded major punishment of dismissal from service by the then SP HQrs vide OB No.3368 dated 01.11.2018 on the charges of absence from duty w.e.f 26.09.2017 to 01.10.2017, 02.10.2017 to 07.11.2017, 17.03.2018 to 28.04.2018, 01.05.2018 to 17.05.2018, 27.05.2018 to 23.07.2018 and 09.08.2018 to 01.11.2018 (07-months & 26-days).

In this regard he was filed departmental appeal before W/CCPO against above punishment orders which was rejected/filed by the then CCPO, Peshawar vide order No.665-71/PA dated 25.04.2019.

Now, Ex-Constable Shahaab Alam No.3899 has submitted an application along-with court Judgment, wherein the Hon'able Service Tribunal ordered that **"the appeal is accepted. The impugned order of dismissal of the appellant from service is set aside and he is re-instated into service. The intervening period shall be treated as leave of the kind due."**
