Respectfully Sheweth:-

The Respondents No.1 to 3 submit as under:-

Preliminary Objections.

- 1) That the appellant has got no cause of action/locus standi.
- 2) *That* the appellant is not an aggrieved person within the meaning of Article 212 of the constitution of Islamic Republic of Pakistan 1973.
- 3) *That* the appellant has concealed material facts from this Honorable Court in the instant case.
- 4) *That* the case in hand is bad for mis-joinder and non-joinder of necessary to the appeal.
- 5) *That* the instant case is barred by Law under the relevant provision of Law of limitation Act 1908.
- 6) *That* the appellant has been treated as per Law & rules vide order & Notification dated 23-05-2018 by the competent authority.
- 7) *That* the Appellant is not entitled for promotion as DPE w.e.f. 15-05-1999 in BPS-16, 19-05-2009 in BPS-17 w.e.f. 25-05-2018 in BPS-18 in the Respondent Department under the rules.
- 8) *That* the Appellant is estopped by her own conduct to file the instant against the Respondent Department.
- 9) *That* the Appellant is not entitled for the relief she was sought from this Honorable Court.

ON FACTS.

- **1**. *That* Para-1 is relates to the service record of the appellant against the PET in BPS-9 post in the Department, hence, needs no comments.
- 2. *That* Para-2 is also needs no comments being pertains to the academic and professional qualification of the appellant.

That Para-3 is correct that vide Notification dated 13-11-2012, the Respondent Department has notified service structure/Rules vide S No.9 which is hereby re-produced for ready reference as under:-

SPET BPS-16 "By promotion on the basis seniority cum fitness from amongst the PET with at least 05 years' service as such and having qualification as prescribed for initial recruitment of PET". Wherein, the appellant has not been considered for promotion as SPET in BPS-16 on the grounds that she could qualify the required criteria for promotion in the Department for her promotion a SPET BPS-16 w.e.f. 11-05-1999, hence, the plea of the appellant is without any legal grounds and legal justification copy of the service rules dated 13-11-2012 is attached as **(Annexure-A)".**

- **4.** That Para-4 is correct that vide order and Notification dated 28-02-2013, the appellant was promoted against the SPET in BPS-16 post after due process of Law and Rules by the competent authority (Copy of the Notification dated 28-02-2013 is attached as **(Annexure-B)**.
- 5. That Para-5 is also correct to the extent of promotion of the appellant in BPS-17 against the DPE post vide Notification dated 11-05-2017 on the basis of seniority cum fitness and by the competent authority with immediate effect under the relevant provision of APT Rules 1989. Therefore, the claim for her promotion as DPE in BPS-17 w.e.f. 19-05-2009 is illegal and liable to be rejected and a copy of the Notification dated 11-05-2017 is **(Annexure-C).**
- 6. That Para-6 is correct to the extent of promotion order of the private Respondents issued on dated 23-05-2018 which is in accordance with law, rules and criteria in field, hence, the plea of the appellant is liable to be rejected and a copy of the Notification is (Annexure-D).
- 7. That Para-7 is also incorrect, hence, denied on the grounds that the act of the Respondent Department with regard to the seniority list as stood in 'the year 2020 relating to the SIP in BPS-18 is within legal para meter and liable to be maintained and a copy of the said seniority list is **(Annexure-E)**.
- 8. That Para-8 is incorrect as no Departmental Appeal against the aforesaid seniority as stood in the year 2020 of the SIPs BPS-18 has been filed by the appellants, hence, got final under the Law of limitation Act 1908 against the appellant.

- 59. That Para-9 is incorrect as the appellant is not an aggrieved person within the meaning of Article 212 of the constitution of Islamic Republic of Pakistan 1973,
- therefore, the appeal in hand is liable to be dismissed on the following grounds inter alia:-

<u>ON GROUNDS.</u>

- A. <u>Incorrect & not admitted</u>. The act of the Department to the extent of seniority of the year 2020 of SIPs BPS-18 is legal on the strength of the appellant has been promoted in the upper scale on the basis of his service record in the Department.
- **B.** <u>Incorrect & not admitted</u>. The stand of the appellant is illegal as she has been treated as per Law, Rules and policy by the Department and have not violated the provision of Articles 04 & 25 of the constitution of 1973.
- C. **Incorrect & not admitted**. The appellant has been treated as per law, rules and policy by the Department in the instant case.
- D. <u>Incorrect & not admitted</u>. The act of the Department is legal and liable to be maintained having no question of violating the provision of sections 8 & 9 of Civil Servant Act 1973 as well as Rule 7 & 17 of APT Rules 1989 by the Department.
- E. Incorrect & not admitted. The plea of the appellant is illegal and liable to be rejected.
- F. <u>Incorrect & not admitted</u>. As the appellant is not an aggrieved person within the meaning of Article 212 of the constitution of Islamic Republic of Pakistan 1973. Therefore, the Respondents are also seek leave of this Honorable Court to submit additional grounds, record and case law at the time of arguments on the date fixed.

In view of the above made submissions, it is most humbly requested that this Honorable Tribunal may very graciously be pleased to dismiss the instant appeal in favor of the Respondents in the interest of justice.


