That even after petitioner's increscent approaches and receipt of attested copies of the judgment/decision dated 22-09-2021 of this Honourable Service Tribunal the respondents are reluctant to implement the same on one or other pretext and using delaying tactics while petitioner is badly suffering his promotion and seniority in the rank of Naib Tehsildar.

 That consequent upon the recommendations of the Departmental Selection Committee, the

appellant was initially inducted in the Revenue Department as Junior Clerk on 13-01-1992 and elevated to the rank of Senior Clerk on 29-06-2010. The appellant has since rendered more than 27 years unblemished service.

- 2. That almost during his entire service the appellant remained posted in the Revenue Branch of the Commissioner's Office and gained tremendous experience in his field. Since his appointment the appellant always performed his assigned duties to the entire satisfaction of his superiors and there is no complaint against him.
- 3. That since the beginning of his service the appellant enjoyed 20% reserved quota of Ministerial Staff being feeding cadre of promotion to the post of Naib Tehsildar in the Revenue Department of KPK according to Tehsildari/Naib Tehsildari Service Rules -1962 (Land Revenue Act-1967) with the legitimate expectation of his promotion as Naib Tehsildar.
- 4. That in the year 2000, the appellant became eligible for promotion to the post of Naib Tehsildar and on the basis of aforementioned promotion rules his case for promotion as Naib Tehsildar was recommended and placed before the Departmental Promotion Committee's meeting held on 29-06-2000. (Copy of the working papers alongwith list of candidates to the post of N/Tehsildar is attached as Annex-"A").



- 5. That due to inaction, delayed and lethargic attitude, of the departmental authorities the aforesaid promotion process could not be completed till the time when in the year 2001 devolution process of Government Departments, Divisional & District Administration took place which resulted into further delay in appellant's promotion.
- 6. That in the year 2015, the method of recruitment, qualification and other conditions for the post of Tehsildar/Naib Tehsildar etc were laid down by the Government of KPK, Revenue Department, vide its Notification dated 23-01-2015 whereby reserved quota for promotion of Ministerial Staff to the post of Naib Tehsildar was reduced from 20% to 15%. (Copy of Notification dated 23-01-2015 is as Annex-"B").
  - 7. That in the year 2015, some posts of Naib Tehsildar became vacant in Hazara Division and the appellant fulfilling the requisite qualifications applied for his promotion as Naib Tehsildar vide application dated 09-03-2015 forwarded to the Board of Revenue by the Commissioner Hazara Division Abbottabad vide letter No. 4/9/Estb/1585 dated 25-03-2015. (Copies of application dated 09-03-2015 and covering letter dated 25-03-2015 are attached as Annex-"C&D").
  - 8. That in the light of above application, the Board of Revenue Peshawar vide letter No. Estt/V/Munir Akhtar/ Abbottabad/9500 dated 22-04-2015

Alleded

directed the Commissioner, Hazara Division, Abbottabad to prepare and submit the working papers under the provisions of reserved quota of Ministerial staff for promotion of appellant as Naib Tehsildar which were also furnished. But promotion process could not take place due to inaction and malafide of the concerned departmental

authorities. (Copy of letter dated 22-04-2015 is

attached as Annex-"E").

- 9. That in the year 2019 some posts of Naib Tehsildar became vacant and the Commissioner Hazara Division Abbottabad vide letter No. CHD/Estb/ 2/ 3/ 2027-28 dated 27-02-2019 requested the Board of Revenue Peshawar for convening Departmental Promotion Committee meeting in order to fill-in the vacant posts of Naib Tehsildars through promotion of Ministerial staff against 15% reserved quota under rules 2015. The copy of a Final Seniority list of Senior Clerks of Hazara Division for the year 2018 was also attached there with the letter. The name of appellant stands at Serial No. 2 of the seniority list. (Copies of the letter dated 27-02-2019 and Seniority List are attached as Annex-"F&G").
- 10. That on **04-03-2019** the appellant through a joint application applied for his promotion as Naib Tehsildar under the provisions of Tehsildari/Naib Tehsildari Rules 2015 reserving 15% quota for Ministerial Staff whereupon Board of Revenue Peshawar vide letter No. Estt. V/PF/Seniority

Modhi



List/2018/9588 dated 19-03-2019 demanded working papers alongwith seniority list & ACRs etc for constitution of DPC for said promotion and the Commissioner Hazara Division Abbottabad with his recommendation submitted the required documents vide letter No. 2//3/Estb/ACR/CHD/3824-25 dated 25-03-2019. (Copies of application dated 04-03-2019, letter dated 19-03-2019 and letter dated 25-03-2019 are as Annex"H, I & J").

- 11. That even in the aforesaid situation the concerned departmental authorities as usual once again adopted the lethargic attitude toward the finalization of appellant's promotion case which could not be completed till further amendment in Tehsildari/Naib Tehsildari Rules was introduced by the department vide impugned Notification dated 13-05-2019 by deleting the reserved quota of 15% of the Ministerial Staff to the post of Naib Tehsildar. (Copy of the Notification dated 13-05-2019 is attached as Annex-"K").
- 12. That appellant vide his departmental appeal dated 17-06-2019 applied for his promotion as Naib Tehsildar against 15% reserved quota of Ministerial Staff according to Tehsildari/Naib Tehsildari Rules-2015 where under the terms and condition of appellant's promotion are governed and appellant also assailed the Notification dated 13-05-2019, for deletion of 15% reserved quota of Ministerial Staff to the post of Naib Tehsildar, being



illegal, unlawful, without lawful authority, perverse, whimsical, arbitrary and inapplicable to the terms and condition/rights of promotion of appellant. The said departmental appeal of the appellant was filed without any consideration by the Board of Revenue Peshawar vide letter dated 11-07-2019. (Copies of departmental appeal dated 17-06-2019 and letter dated 11-07-2019 are as Annex-"L & M").

13. That by virtue of issuance of impugned Notification, the amendment has been made in Rules 2008, whereas after issuance of Rules-2015 in supersession of all previous rules, the Rules-2008 stand non-existence, therefore has no legal impact on the already accrued rights of promotion of appellant nor on the basis of such amendment in the non-existence rules any reserved quota for promotion of ministerial staff can be deleted. Hence instant service appeal, inter-alia, on the following:-

#### **GROUNDS:**

- A) That order dated 11-07-2019 is illegal, without lawful authority, void-an-initio, passed in slipshod, perfunctory and arbitrary manner, against the law, rules & regulations, facts & circumstances of the matter, hence is liable to be set aside.
- B) That Notifications dated 13-05-2019 of the Board of Revenue Peshawar whereby 15%



reserved quota of Ministerial Staff of promotion to the post of Naib Tehsildar has been deleted, is illegal, unlawful, perverse, arbitrary against the law and principle of natural justice and ineffective to the extent of appellant's rights of promotion's terms and conditions which were/are governed under Tehsildari/Naib Tehsildari Rules 2015.

- C) That on issuance of promotion rules 2015 in supersession of all previous rules, the rules 2008 stand non-existence, therefore the impugned amendment of 2019 has no legal impact on the already accrued rights of appellant nor on the basis of such amendment in the non-existence rules any reserved quoted for promotion of ministerial staff to the post of Naib Tehsildar can be deleted.
- D) That since the year 2000 by fulfilling the all the requirement, appellant had become entitled for promotion as Naib Tehsildar against 20 % quota reserved for Ministerial Staff for promotion to the post of Naib Tehsildar under the provisions of Tehsildari/Naib Tehsildari Rules-1962 and the posts of Naib Tehsildar were also fallen vacant in Hazara Division. Working papers were prepared according to seniority list of candidates and promotion cases of ministerial staff including appellant were placed before Departmental Promotion



Committee constituted and headed by the then Commissioner Hazara.

- E) That similarly in the year 2015, the appellant again became eligible for promotion as Naib Tehsildar against the said 15% reserved quota of Ministerial Staff and the posts had also fallen vacant and his working papers were submitted to the Board of Revenue KPK Peshawar but of no use due to lethargic and protracted attitude of the departmental authorities.
- That early in the year 2019 the Commissioner F) Hazara Division Abbottabad vide his letter dated 27-02-2019 by explaining position vacant of posts requested the Board of Revenue KPK Peshawar for promotion of Senior Clerks to the post of Naid Tehsildar and asked for convening of DPC meeting for the purpose. In response the Board of Revenue KPK Peshawar vide its letter dated 19-03-2019 demanded the required documents of the Senior Clerks for promotion through special messenger within no time which were also furnished vide letter dated 25-3-2019 but once again there was no action like past on the departmental of authorities. The Appellant has been deprived of his legitimate right of promotion by departmental authorities

and caused tremendous loss to his future service career without any fault on his part.

- That in the light of judgments of the superior G) courts of the country any change in the terms and conditions of service of the civil servant with retrospective effect by depriving him of his vested right cannot be made while the appellant remained eligible for promotion for considerable period of 20 years but through impugned notification his right of promotion has been taken away which is not sustainable in the eyes of law but the departmental authority has ignored this aspect of the case while filing departmental appeal of the appellant vide impugned notification dated 11-07-2019, without giving opportunity of fersonal hearing.
- H) respondents have That the not treated appellant in accordance with departmental rules, regulations and policy on the subject and have acted in violation of Article-4 of the constitution of Islamic Republic of Pakistan 1973 & unlawfully issued the impugned orders and notifications, which are unjust, unfair hence, are liable to be set aside/treated as ineffective to the extent appellant's promotion as Naib Tehsildar.
- That the respondents have failed to abide by the law and even did not take into

consideration the grounds advance appellant in the memo of departmental appeal for his promotion as Naib Tehsildar against the 15# quota reserved for Ministerial Staff under rules 2015. Thus the impugned notification dated 13-05-2019 and order dated 11-07-2019 of respondents are contrary to the law as laid down in Tehsildari/Naib Tehsildari Rules 2015. other departmental rules regulations read with section 24-A of General Clause Act 1897 & Article 10-A of Constitution of Islamic Republic of Pakistan 1973.

- J) That the appellant being qualified and fulfilling all requirements was eligible for promotion as Naib Tehsildar since 2000 but has been deliberately deprived of his leaitimate promotion despite of availability of posts without any reason, justification against the law, departmental rules and regulation. He deserves to be promoted as Naib Tehsildar since the date he became eligible and the post was available in Hazara Division with all consequential service back benefits.
- K) That instant appeal is well within time and this honorable. Service Tribunal has got every jurisdiction to entertain and adjudication upon the same.

#### **JUDGMENT**

ATIQ-UR-REHMAN WAZIR MEMBER (E):- This single judgment shall dispose of the instant service appeal as well as the connected Service Appeal No 1022/2019 titled "Munir Akhtar Versus Government of Khyber Pakhtunkhwa through Chief Secretary, Civil Secretariat, Feshawar and two others", as common question of law and facts are involved therein.

Brief facts of the case are that the appellants namely Abdul Qayyum Tahir and Munir Akhtar initially joined the Revenue Department as Junior Clerks and subsequently were elevated to the post of Senior Clerks on 02-02-1983 and

29-06-2010 respectively. As per service rules, notified on 23-01-2015, 15% quota was reserved for promotion on the basis of joint seniority cum fitness from amongst the Senior Clerks of the office of Board of Revenue, Commissioners and Deputy Commissioners offices, for their further promotion to the post of Naib Tehsildar. Cases of promotion of the appellants were under process for quite some time, but could not materialize well in time and in the meanwhile, the respondents vide another notification dated 13-05-2019 amended the service rules and deleted the reserved quota of 15% for promotion of ministerial staff to the post of Naib Tehsildar. Feeling aggrieved, the appellants filed departmental appeals, which were filed without any consideration vide order dated 11-07-2019, hence the instant service appeals with prayers that the impugned order dated 11-07-2019 may be set aside and notification dated 13-05-2109, may be declared as illegal, void ab-initio and ineffective upon the appellants promotion rights and the appellants may be promoted to the post of Naib Tehsildar against the 15% quota reserved for ministerial staff, from the date when the appellants became eligible for such promotion and posts had fallen vacant in Hazara Division with all consequential benefits.

Learned counsel for the appellant has contended that the appellants were fully eligible for promotion to the post of Naib Tehsildar based on seniority cum fitness, but it was due to the lethargic and reckless attitude of the respondents that cases of promotion of the appellants lingered for years in the offices of respondents, which finally were refused under the pretext that the respondents has brought amendments in service rules vide notification dated 13-05-2019, thereby deleting the 15% quota reserved for ministerial staff; that by virtue of issuance of impugned notification dated 13-05-2019, the amendments has been made in Rules, 2008, whereas after issuance of Rules, 2015 in supersession of all previous rules, the rules, 2008 stands non-existent, therefore has no legal impact on the aiready accrued rights of promotion of appellants nor on the basis of such amendments in the non-existent rules, any reserved quota for promotion of ministerial staff can be deleted; that posts of Naib Tehsildar were lying vacant in Hazara Division, working paper for which were also submitted and cases of promotion in respect of the appellants were also included, which were also placed before the Departmental Promotion Committee(DPC); that again in 2015 cases of promotion in respect of the appellants came under consideration of the DPC, but were again ignored by the respondents due to their lethargic






behaviour; that in 2019, the Commissioner Hazara Division vide letter dated 27-02-2019, requested the board of revenue for promotion of the senior clerks to the post of Naib Tehsildar and in response, the board of revenue demanded for requisite documents of the senior clerks concerned, which were also provided, but in the meanwhile rules were amended and the appellant were not promoted, which was illegal unlawful and contrary to the norms of natural justice; that in the light of judgments of the superior courts, any change in the terms and condition of service of the civil servant with retrospective effect by depriving them of their vested rights cannot be done while the appellants remained eligible for considerable period of 20 years, but through impugned notification dated 13-05-2019, their right of promotion has been taken away which is not sustainable in the eye of law; that the respondents have not treated the appellants in accordance with law, departmental rules, regulation and policy on the subject and have acted in violation of Article-4 of the constitution and unlawfully issued the impugned order and notifications, which are unjust, unfair and are liable to be set at naught.

- 4. Learned counsel for respondents has contended that in 2015, under 15% quota reserved for senior clerks, cases of the appellants were placed before the DPC, but their cases were not considered for such promotion due to non-availability of post of Naib Tehsildar in their share at that time; that it is correct that the appellants were otherwise eligible for promotion on the basis of seniority cum fitness for promotion to the post of Naib Tehsildar, but in the meanwhile amendments were brought in the service rules and 15% quota reserved for their promotion was deleted.
- 5. We have heard learned counsel for the parties and have perused the record.
- 6. Record reveals that the appellants were otherwise fit for promotion based on seniority cum fitness and their cases were submitted for promotion more than once, but were not considered. Stance of the respondents to the effect that the appellants were not considered due to non-availability of posts is not correct, as record reveals that Commissioner Hazara vide letter dated 27-02-2019 had submitted cases of the appellants for convening meeting of DPC as well as mentioned that there are many vacancies available in the division to be filled in through promotion from amongst the senior clerks at the ratio of 15%, but the





respondents as usual lingered the cases and finally refused on the grounds of amendments in service rules, which was not warranted. We are of the considered opinion that the appellants were fit for promotion in every respect and vacancies to that effect were also available, but it was due to malafide of the respondents that the appellants were kept deprived of their right of promotion. The amendments in service rules at a later stage, cannot deprive the appellants of their right of promotion already accrued to them as making the relevant amended rules applicable to the appellants would be against the law and natural justice.

7. In view of the foregoing discussion, the instant appeals are accepted. The appellants are held entitled for promotion to the post of Naib Tehsildar from the dates, when they became eligible for promotion. Parties are left to bear their own costs. File be consigned to record room.



During the discussion it was observed that as per service rules notified vide Notification dated 25.01.2016. 12% quota was reserved for promotion to the post of Naib Tehsildar on the basis of joint seniority cum fitness from amongst the Senior Clerks and Junior Scale Stenographer of the offices of Commissioners and Deputy Commissioners of the province. In the year 2019, there were total 20 sanctioned posts of Naib Tehsildar in Hazara Division (Flag-A) out of which 2.4 posts comes under promotion quota of Senior Clerks/Junior Scale Stenographers, offices of the Deputy Commissioners and Commissioner Hazara. The appellant was at Serial N. 9 of the Joint Seniority List of the Hazara Division (Flag-B). Suppose the Departmental Promotion Committee Meeting was convened even then the appellant could not be promoted to the post of Naib Tehsildar being at Serial No. 09 of the Joint Seniority List. The appellant has concealed the facts from the court as he was not in promotion zone in the year 2019. Besides, the officials at Serial No. 02 to 08 did not challenge the rules ibid, except official at Serial No. 1, who during proceeding of the appeal has retired from Government Service.

After detailed discussion it was unanimously decided that the official was not eligible for the appointment of Naib Tehsildar as he was at serial No. 09 on the Joint Seniority list of Junior Scale Stenographers and Senior Clerks for the year 2018 provided by Commissioner Hazara Division.

During the discussion it was observed that as per service rules notified vide Notification dated 25.01.2016. 12% quota was reserved for promotion to the post of Naib Tehsildar on the basis of joint seniority cum fitness from amongst the Senior Clerks and Junior Seale Stenographer of the offices of Commissioners and Deputy Commissioners of the province. In the year 2019, there were total 20 sanctioned posts of Naib Tehsildar in Hazara Division (Flag-A) out of which 2.4 posts comes underpromotion quota of Senior Clerks/Junior Scale Stenographers, offices of the Deputy Commissioners and Commissioner Hazara. The appellant was at Serial N. 9 of the Joint Seniority List of the Hazara Division (Flag-B). Suppose the Departmental Promotion Committee Meeting was convened even then the appellant could not be promoted to the post of Naib Tehsildar being at Serial No. 09 of the Joint Seniority List. The appellant has concealed the facts from the court as he was not in promotion zone in the year 2019. Besides, the officials at Serial No. 02 to 08 did not challenge the rules ibid, except official at Serial No. 1, who during proceeding of the appeal has retired from Government Service.

- Whether the impugned judgment and order of the Honble Khyber Pakhtunkhwa Service Tribunal, Camp Court Abbottabad does suffer from 1. material illegality, factually incorrect and require interference by this august Court?
  - Whether the Hon'ble Khyber Pakhtunkhwa Service Tribunal, Camp Court Abbottabad has properly and legally exercised its jurisdiction in the matter in hand?

- 3. Whether promotion is not a vested right and no person could same the same as right?
- 4. Whether promotion did not fall/come under the policy decision in which Courts normally did not interfere but the Khyber Pakhtunkhwa Service Tribunal, Camp Court, Abbottabad has not taken into consideration this aspect of the case?
- 5. Whether the petitioners has not tried to promote the respondent but there was no clear vacancy of the post of Naib Tehsidlar to the share of respondent to which respondent could be promoted?
- Whether the Service Rules of 2008 as amended vide Notification dated 23/1/2015 was not further amended vide Notification dated 13/5/2019 whereby promotion of the Senior Clerk to the post of Naib Tehsidlar was deleted/omitted from the rules?

- 8. Whether it does not fall/come under the prerogative of the Government to change the Service and Promotion Rules at any time in the best interest of government service?

- 10. Whether the Notification dated 13/5/2019 is not in accordance with law?
- 11. Whether the Khyber Pakhtunkhwa Service Tribunal, Camp Court, Abbottabad has struck down the amending Notification dated 13/5/2019?

- 3. That the respondent alleged that his case for promotion was in process for quite some time but could not be materialized and the service rules were further amended whereby the reserved quota of 15% for promotion of ministerial staff to the post of Naib Tehdidar was deleted.
- 4. That the respondent being aggrieved filed departmental appeal but the same being merit less was filed vide letter dated 11/7/2019 by the appellate authority.
- 5. That the respondent then filed service appeal No.1021/2019 before the Hon'ble Khyber Pakhtunkhwa Service Tribunal, Peshawar wherein Para-wise reply was asked from the petitioners which was filed and the stance of respondent was denied.
- 6. That the Hon'ble Khyber Pakhtunkhwa Service Tribunal, Camp Court Abbottabad was pleased to allow the Service Appeal No.1021/2019 of the respondent vide impugned judgment dated 22/9/2021.
- 7. That the petitioners being aggrieved from the impugned judgment/order of the Hon'ble Khyber Pakhtunkhwa Service Tribunal, Camp Court Abbottabad dated 22/09/2021 in Service Appeal No.1021/2019 prefers this CPLA before this august Court.
