It was contended by learned counsel for the appellant that the official respondent-department published advertisement for recruitment of Junior Clerk in Police Department. It was further contended that the appellant applied for the same but the official respondents appointed the private respondents and ignored the appellant. It was further contended that the appellant alongwith others filed Writ Petition before the worthy High Court wherein he prayed for issuance of direction to respondent-department to appoint the appellant as Junior Clerk, the Writ Petition of the appellant was accepted by the worthy High Court vide detailed judgment dated 31.07.2012 and the respondent-department was directed to appoint the appellant alongwith other petitioners within one month. It was further contended that the respondent-department on the basis of aforesaid judgment of the worthy High Court appointed the appellant vide order dated 29.08.2012. It was further contended that the official respondent issued seniority list dated 31.12.2017 but the appellant was placed more junior to the private respondents therefore, the appellant filed departmental appeal on 25.04.2018 but the same was not decided hence, the present service appeal. It was further contended that since the respondent-department was required to appoint the appellant alongwith other private respondents therefore, the seniority list dated 31.12.2017 is liable to be rectified.

The contentions raised by the learned counsel for the appellant need consideration. The appeal is admitted for regular hearing. The appellant is directed to deposit security and process fee within 10 days, thereafter, notice be issued to the respondents for written reply/comments for 15.10.2019 before S.B.

APPEAL UNDER SECTION 4 OF THE SERVICE TRIBUNALS ACT, 1974 AGAINST THE IMPUGNED SENIORITY LIST DATED 31.12.2017 ISSUED ON 30.03.2018, WHEREBY, THE APPELLANT HAS NOT BEEN ASSIGNED HIS PROPER POSITION IN THE IMPUGNED SENIORITY LIST ALONG WITH HIS BATCH MATES SELECTEE OF ADVERTISEMENT DATED 16.08.2008 AND NOT TAKING ACTION ON THE DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS.

PRAYER:

THAT THE ACCEPTANCE OF THIS APPEAL, THE RESPONDENT MAY BE DIRECTED TO MODIFY THE IMPUGNED SENIORITY LIST BY PLACING THE

APPELLANT NAME AS PER HIS MERIT POSITION ALONG WITH BATCH MATE OF SELECTEE OF ADVERTISEMENT DATED 16.08.2008 AND IN LIGHT OF RULE-17 OF KPK APT. RULES 1989 WITH ALL BACK AND CONSEQUENTIAL BENEFITS. ANY OTHER REMEDY WHICH THIS AUGUST TRIBUNAL DEEMS FIT AND APPROPRIATE THAT MAY ALSO BE AWARDED IN FAVOUR OF APPELLANT.

RESPECTFULLY SHEWETH:

FACTS:

1. That some post of junior clerks were advertised in the police department in 2009, the appellant being eligible applied for the said post on which the appellant was called for test and interview through parwana. **Copies of advertisement and parwana are attached as Annexure-A&B)**
2. The appellant appeared in test and interview and on the basis of that test and interview the name of the appellant was mentioned in the merit list issued 2009, but the appellant was not appointed and his name was not mentioned in the appointment order of different official issued on 11.06.2009. **(copies of merit list 2009 order dated 11.06.2009 are attached as Annexure-C&D)**
3. That the appellant along with two other filed writ petition No. 1808/2009 in Peshawar High Court, Peshawar for his appointment along with his batch mate as low merit candidates than the appellant were appointed. The said writ petition was decide on 31.07.2012 which was allowed and directed the respondents to consider the appointment of appellant with two others by issuing to that effect within period of one month and on the basis of direction the Honorable High Court Peshawar the appellant was appointed on 29.08.2012 instead of 11.06.2009 along with batch mate as the appellant was appointed on the advertisement, test and interview conducted for appointment of the candidate who were appointed on 11.06.2009. **(Copies of judgment dated 31.07.2012 and order dated 29.08.2012 are attached as annexure-E&F)**
4. That the respondent department issued final seniority list on 30.03.2018 stood on 31.07.2018, whereby the private respondents were shown senior to the appellant and the appellant was wrongly placed at S. No. 370. That as the appellant aggrieved from the final

seniority list, therefore, he filed departmental appeal on 25.04.2018 which was not responded in the stipulated period of ninety days. **(Copies of seniority list and departmental appeal are attached as Annexure-G&H)**

5. That now the appellant come to this august Tribunal on the following grounds amongst others.


GROUNDS:

- A) That the impugned seniority list dated 31.07.2018 issued on 30.3.2018 and not taking action on the departmental appeal of the appellant within a stipulated period are against the law, facts, norms of justice and material on record, therefore not tenable and liable to be set aside.
- B) That the appellant applied for the said post advertised in 2009 and on the basis of that advertisement the appellant was appear in the test and interview and on the basis that advertisement, test and interview the private respondents were appointed on 11.06.2009, therefore legally the appellant is entitle to be considered with his batch mate appointed in 2009 and also be entitled for the correct seniority position in the impugned seniority list.
- C) That the name of the appellant was mentioned in the merit list of appointment of 2009 and not appointing him in 2009 is the malafide of the respondent department, therefore the appellant should not be punished for the fault of the others.
- D) That the name of the appellant was mentioned in the merit list of 2009 but not appointed him by the respondent in 2009 on which he filed Writ Petition in the Honourable Peshawar High Court which was allowed and directed to the respondent to consider the appointment of the appellant along with two others petitioners by issuing order to that effect which shows that the appellant was also entitle for appointment in 2009 as per decision of the Honourable High Court Peshawar, but despite that the appellant was appointed 29.08.2012 instead of his due date 11.06.2009 due to which his seniority is also effect due to the malafide and lethargic attitude of the respondents.
- E) That wrongly placed the name of the appellant in the final seniority list will effect the appellant's promotion which will deprive from his legal right of promotion in future.

F) That the appellant was has been condemned unheard and has not been treated according to law and rules.

G) That the appellant seeks permission to advance others grounds and proofs at the time of hearing.

It is, therefore most humbly prayed that the appeal of the appellant may be accepted as prayed for.

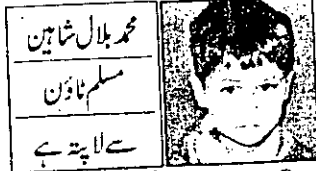



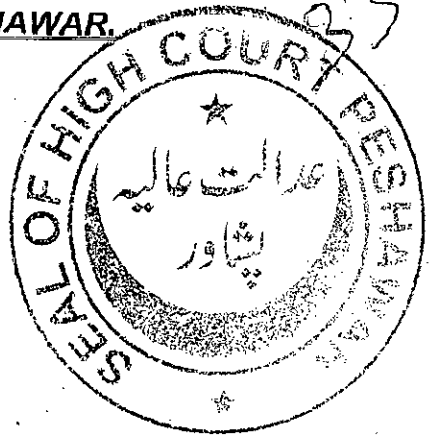

The duly notified merit list was communicated to the CPO Peshawar by the DIG Mardan Range, however, here at Peshawar, it is alleged that in fact the computer / MS Word test was carried out but all the three (03) petitioners could not succeed to secure the required marks to be declared successful candidates.

3. Neither with the comments the replying respondents have annexed any document to show that any computer / MS Word test was conducted at Peshawar nor despite of repeated queries of the Court, Mian Imtiaz Gul, DSP Legal, and the learned AAG (Mr. Fazal-ur-Rehman Khan) were in a position to show to the Court a single paper with regard to the second test of computer conducted at Peshawar albeit, the DSP Legal is in possession of complete record of the entire process, as he

is carrying in his hand a huge file with regard to the process of interview & test. The Court again asked them as to whether they could produce any such document to show that indeed computer test was carried out at Peshawar, both were found evasive and indeed avoided to take such responsibilities.

4. In the initial merit list, prepared by the DIG Mardan Range and forwarded to the CPO, all the three (03) petitioners have scored high marks as compared to many those who were appointed albeit, they scored much low merit marks than the petitioners, however, we failed to understand that when the competent authority under the law to conduct test & interview including that of computer test was DIG Mardan Range and in this modern day of the world where computer is part & parcel of every office more particularly, the police setup, then why the computer test allegedly conducted at Peshawar was not

taken at Mardan, is the most intriguing aspect of the case.

There is also no written order or communication to show that initially it was arranged and decided that the written test & interview shall be carried out at Mardan while computer test would be conducted at Peshawar by Central Police Office because not a single document in this regard has been annexed with this petition albeit, sufficient time was given to the replying respondents.

5. It was in this background that on 01.03.2011 both the learned AAG (Mr. Fazal-ur-Rehman Khan) and DSP legal (Mian Imtiaz Gul) made favourable statements, reproduced in the order-sheet of the day, which was read over to them today and they were found unable to controvert the same.

6. Keeping in view the law & order situation of this Province, it is the utmost requirement of the day that appointment in the police force be made strictly according

to merits and political consideration must be avoided because anyone, who is appointed otherwise, would be unable to render service of the nature required of him in the prevailing law & order situation. The police, the most disciplined force, which is meant to prevent and investigate into crimes, must be clean & clear and shall consist of all those, who are appointed purely on merits otherwise, it would be a crude imagination think over to maintain proper law & order situation in the Province.

7. In the case of "*Chief Secretary Punjab & others Vs. Abdul Raoof Dasti*" (2006 SCMR 1876) the Hon'ble Apex Court has held that appointment of a person to any post, as a public functionary, must be carried out in a transparent manner and best amongst the best qualified be selected for a particular post, who is capable to deliver service in a befitting manner because public servants are paid from public exchequer and not from personal kitty of

the Appointing Authority. The Appointing Authority shall clearly understand that exercising power of appointment is a sacred trust reposed in it by the law and it must be discharged faithfully and in the best interest of the public at large.

This principle appears to have been violated in this case and the three (03) petitioners were dropped from final appointment at the final stage for which the replying respondents could not offer any plausible explanation nor their stance is supported by a single document much less computer test result, allegedly conducted at Peshawar, and in particular the concession made on 01.03.2011 bespeaks volumes that how the replying respondents wanted to retain their own men and also to accommodate the three (03) petitioners, however, today they made U-turn and contested the case but with no fair defence to offer.

1. That the vacancies of Junior Clerks were announced in the Police Department. Therefore, the applicant submitted application for the post of Junior clerks on 16.08.2008.
2. That for the aforesaid post written examination was conducted at Mardan Police Lines dated 29.03.2009 which was passed by the applicant. Similarly, computer test was also on 30.03.2009 at held at Police Lines Mardan and the applicant also passed the same.
3. That the then DIG Mardan issued a list of 56 candidates and send the same to CPO Peshawar and in the said list, the applicant was included, thereafter the CPO Peshawar sent the applicant to Police club Peshawar on 28.05.2009 for scrutiny.
4. That when the order of selected candidates was issued, it included such like candidates who had never appeared in both the examination nor submitted their respective applications.
5. That the candidate serial No.56 was also appointed but the name of applicant was missing.
6. That the applicant exhausted departmental remedies but in vain, thereafter the applicant resorted to the Peshawar high court which passed the order of the applicant appointment and the applicant was thus appointed.
7. That an order No.2321-70/EV dated 07.04.2015 has been issued regarding the seniority of junior clerks in which the applicant is placed in serial No.446 while illegitimate appointees mentioned at Para No.4 are placed at serial No.97, 99, 108, 109, 114 and 118.
8. The applicant run from post of pillar and filed different application to competent authority No.3431/EC dated 24.03.2014 and 3320/EC dated 30.04.2015 but of no avail and the competent authority turn deaf ear on the applications of the applicant.
9. That the competent authority issued final seniority list of junior clerks of BPS-11 is stood on 30.12.2017 No.1592-1630/EV dated 30.03.2018 and placed on serial No.367 while many juniors were placed seniors to the applicant which is illegal without fairs and have no effect on the rights of the applicants.

It is therefore, requested that the name of applicant may please be put in the seniority list and obliged.



RESPECTIVELY SHEWETH:

PRELIMINARY OBJECTIONS:-

- a) That the appeal is not based on facts.
- b) That the appeal is not maintainable in the present form.
- c) That the appeal is bad for miss-joinder and non-joinder of necessary parties.
- d) That the appellant is estopped to file the appeal by his own conduct.
- e) That the Appeal is bad by law and limitation.
- f) That the appellant has not come to this Honorable Tribunal with clean hands.
- g) That the appellant has got no cause or locus standi of action to file present Service Appeal.

FACTS:-

1. Correct to the extent that some posts of Junior clerks have been advertised in Police Department in the year 2008 (**Annexure-A, Advertisement**) and not in the year 2009 against which test and interview was conducted and selection was made of successful candidates.
2. Correct to the extent that appellant appeared in the selection process on 29/30-3-2009 and obtained 34 marks in written test and 25 marks in computer test, as a result got 59 marks in total and placed at S. No. 49 of merit list which was sent by the RPO Mardan Region to the Worthy Provincial Police Officer for further necessary action. However, the appellant was not appointed/ selected as Junior Clerk by the Departmental Selection Committee vide Notification No. 14531/ E-III dated 11.06.2009 (**Annexure-B**).
3. First Portion of this Para pertains to record however, with respect to remaining Para it is submitted that the appellant was appointed on the

directions of Honorable Peshawar High Court, Peshawar vide judgment dated 31.07.2012 & placed at S. No. 69 of Notification No. 16426/ E-III dated 29.08.2012, (**Annexure-C**) hence, the appellant was rightly appointed on 29.08.2012, in accordance with the judgment of Honorable Peshawar High Court, Peshawar.

4. Para No. 4 is incorrect hence, rebutted. In-fact the appointment of appellant was made in compliance of judgment dated 31.07.2012, and placed at S. No. 69 of Notification No. 16426/ E-III dated 29.08.2012, whereby, the private respondent from S. No. 4 to 9 in instant Service Appeal have been appointed vide Notification No. 14531/ E-III dated 11.06.2009, which is crystal clear that the private respondents mentioned in the Service Appeal have been appointed as Junior Clerks in the year 2009 while the appellant has been appointed as Junior Clerk in the year 2012 therefore, the private respondents stood senior to the instant appellant. It is further added that the instant appellant stood at S. No. 370 in light of seniority list No. 1591/ E-V dated 30.03.2018, (**Annexure-D**). In-fact the appellant stood at S. No. ~~370~~ in the said Seniority List, therefore, the private respondents have automatically senior to instant appellant who being appointed in the year 2009. Hence, the seniority list issued on 30.03.2018, is quite legal and in accordance with law/ rules.
5. That the instant Service Appeal being infructuous hence, may kindly be dismissed on the following Grounds.


GROUND:-


- A. Incorrect. That the Seniority list No. 1591/ E-V dated 30.03.2018, issued by Competent Authority is quite legal and as per law/ rules. Therefore, no norms of natural justice have been violated by the answering respondents.
- B. Incorrect. That the appellant was not appointed/ selected as Junior Clerk by the Departmental Selection Committee vide Notification No. 14531/ E-III dated 11.06.2009, who later on, filed Writ Petition No. 1808/ 2009 in the Honorable Peshawar High Court, Peshawar which was decided on 31.07.2012, therefore, in light of judgment of Honorable Court he was appointed as Junior Clerk vide Notification No. 16426/ E-III dated 29.08.2012.


- C. Incorrect. That the name of appellant was not considered/ approved by the Departmental Selection Committee therefore, he was appointed as Junior Clerk in response to advertisement in the year 2008.
- D. This Para is already explained in preceding Paras.
- E. Incorrect. That the name of petitioner has rightly been placed at S. No. 370 on seniority list No. 1591/ E-V dated 30.03.2018 and appellant has not been deprived from his legal right of promotion by the answering respondents.
- F. Incorrect. That the appellant has been treated in accordance with law/ rules.
- G. That the respondent may also be allowed to raise additional grounds at the time of arguments.

PRAYER:-

In view of the above, it is humbly prayed that on acceptance of Para-wise comments, the instant Service Appeal may kindly be dismissed being meritless.
