2. That the appellant should have been promoted as confirmed SI w.e.f 19-11-2003, Inspector w.e.f 03-05-2005 and DSP w.e.f 31-03-2012 and the same has rightly been impugned in the captioned case, but inadvertently the date of and mentioned about the rank of Inspector is not mentioned in the prayer of the main appeal.



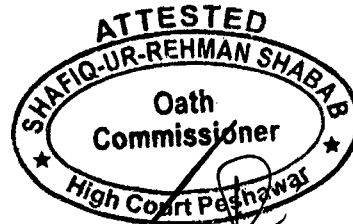



**AMENDED SERVICE APPEAL U/S 4 OF THE
KHYBER PAKHTUNKHWA SERVICE
TRIBUNAL ACT 1974 R/W RELEVANT
PROVISIONS OF THE POLICE RULES AGAINST
THE IMPUGNED OFFICE ORDER NO.16/CPB,
DATED 09/01/2019 OF THE OFFICE OF THE
RESPONDENT NO.4, WHEREBY THE
DEPARTMENTAL REPRESENTATION FOR
ANTE DATED PROMOTION AND DUE
PLACEMENT IN THE SENIORITY LIST WAS
DISMISSED IN A CLASSICALLY CURSORY AND
WHIMSICAL MANNER**

Respectfully Sheweth

1. That the Appellant is naturally born bonafide citizen of the Islamic Republic of

Pakistan, and hails from a respectable family of district Peshawar.

2. That after going through the mandatorily required competitive examination and interviews, the appellant was enrolled in the prestigious Police Force of Khyber Pakhtunkhwa Peshawar on 12/12/1994 as Assistant Sub Inspector (A.S.I) and after getting onto the rolls of Khyber Pakhtunkhwa police the appellant was posted vide office order, dated 11/01/1995. **(Copy of the office order dated 11/01/1995 is annexed as annexure "A").**
3. That after getting onto the rolls of this prestigious Force, the appellant not only rendered meritorious service, but as well as excelled throughout his professional career and has remained as exemplary police officer of tremendous repute, and throughout kept and maintained good ACR's and always won appreciations and admirations of public, colleagues and high ups.
4. That inspite of this aforementioned background when the promotion/ selection board, held its meeting under the chairmanship of S.S.P/ operations,

Peshawar, on 28/02/2005 for promotions to the rank of sub-inspectors, the appellant was deferred for the reason that the appellant had allegedly incomplete S.H.O period. **(Copy of the deferment order, dated 07/03/2005 is annexed as annexure "B")**

5. That vide the aforementioned impugned office order, 07/03/2005 many colleagues and juniors of the appellant promoted to the rank of confirmed sub-Inspectors, while the appellant was deferred, but was subsequently promoted to the rank of confirmed sub-Inspector vide office order dated 05/07/2008, but with effect from 30/06/2008. **(Copy of the office order dated 05/06/2008 is annexed as annexure "C")**

6. That thereafter the appellant was promoted and enlisted in list-F vide office order, dated. 05/03/2009. **(Copy office order, dated 05/03/2009 is annexed as annexure "D")**

7. That thereafter the appellant was promoted as confirmed Inspector vide notification dated 27/08/2018. **(Copy of the notification dated 27/08/2018 is annexed as annexure "E")**

8. That after the promotion of the appellant to the list-F on 05/03/2009, the appellant was promoted as confirmed Inspector after more than 9 years on 27/08/2018, and thereafter just after three months i.e. on 29/11/2018, the appellant was promoted as D.S.P (Deputy Superintendant of Police). **(Copy of the notification dated 29/11/2018 is annexed as annexure "F")**

9. That as the appellant had only been deferred on the alleged ground of incomplete SHO period, which notion and reason for deferment has already been struck down in plethora of judgments, even by this Hon'ble tribunal so after notifying and promoting the appellant, the appellant should have been promoted with ante-dated effect and should have been placed at his due placement in the seniority list along with his colleagues namely Tariq Habib, Nisar Ahmad, Aslam Nawaz and Tariq Iqbal , who had been confirmed in the rank of S.I in 2004 with effect from 19/11/2003. It is interesting to note that the appellant had been senior to aforementioned Nisar Ahmad, Tariq Iqbal and Tariq Habib as per the Seniority list issued as per Public Service Commission Rules and stood at serial No.3, while Nisar

Ahmad Khan at Serial No.4, Tariq Iqbal at serial No.6 and Tariq Habib at Serial No.8. Now under the law the appellant should have been promoted w.e.f 19/11/2003 and should have been placed ahead of his colleagues after getting promotion to the rank of confirmed S.I, but was denied. This deprivation of his due rights was continued and resulted in belated promotions to the rank of inspector as well as to the rank of D.S.P. In order to get his rights back and due promotions along with due placement in the seniority list the appellant moved departmental appeal but that ended in fiasco and turned down vide the impugned office order, No.16/CPB, dated, 09/01/2019, of the office of Additional Inspector General /Establishment Khyber Pakhtunkhwa police. (Copies of the Departmental appeal and impugned office order, dated 09/01/2019 are annexed as annexure "G and "H" respectively)

10. That feeling aggrieved the appellant prefers the instant appeal before this Hon'ble Tribunal for setting aside the impugned office order No.16/CPB, dated

09/01/2019, upon the following grounds
inter alia:-

GROUND:

A. That the impugned order of filing of departmental representation of the appellant as well impugned office order dated 05/07/2008, whereby the appellant was promoted as confirmed SI with immediate effect instead with retrospective effect are wrong, illegal, unlawful, void and ineffective upon the rights of the appellant.

B. That where reason for deferment is either ceased or declared illegal, then getting promotion, the promotee Civil Servant is entitled to be given ante dated promotions with all back benefits and due placement in the seniority list.

C. That the reasons of not promoting the appellant alongwith his colleagues i.e. incomplete period of SHO has already been declared as illegal and void by this Hon'ble Tribunal in plethora of its judgments and thus the appellant is certainly entitled for his ante-dated promotion in rank of SI w.e.f 19/11/2003 and due placement in the seniority list of SI as stood on 31/01/2010 at serial No.94 i.e. ahead of Tariq Habib and

below Muhammad Arif. **(Copy of list of SI is annexed as annexure "I")**

D. That like-wise the appellant was duly entitled to be placed at S.No53 i.e. ahead of Mr. tariq Habib and below of Mr. Muhammad Arif in the seniority list of D.S.Ps as it stood on dated 06/02/2017, and not doing so, by the Respondents, the appellant has been deprived of his due right and was promoted on 29/11/2018, instead w.e.f 31/03/2012. **(Copy of Seniority list of D.S.Ps is annexed as annexure "J").**

E. That one another colleague namely Iftikhar Shah, who had been standing on same footing was extended the ante-dated promotion, by placing his name at his due placement, but the appellant is still kept at abbey from the same. **(Copies of departmental appeal and notification of ante dated promotion of the Iftikhar Shah D.S.P are annexed as annexure "K" and "L" respectively)**

F. That even this question came up again and again before this Hon'ble Tribunal in many cases and same was adjudicated by the Hon'ble Tribunal and under the principle laid down by the Hon'ble Apex Court in 2009 SCMR 01, the appellant is entitled for equal

treatment, which is the cherished principle of this Hon'ble Tribunal as well. Some of the cases are annexed herewith and others will be produced as and when directed by the Hon'ble Tribunal. **(Copies of precedents are annexed as annexure "M" to "O" respectively)**

G. That even the departmental appeal was simply shelved without any opportunity of hearing and even without any speaking order.

H. That from every angle the appellant is entitled to be given anti-dated promotion to the rank of D.S.P w.e.f 31/03/2012 with all back benefits and his due placement in seniority list.


I. That any other ground not raised here may graciously be allowed to be raised at the time of arguments.

It is, therefore, most humbly prayed that on acceptance of the instant service appeal, the impugned office order NO. 16/CPB, dated 09/01/2019 of the office of Additional Inspector General (Establishment) police Khyber Pakhtunkhwa, whereby the departmental representation of the appellant was dismissed and filed, may graciously be

set aside and by doing so the appellant be given his ante dated promotion to the rank of confirmed SI w.e.f from 19/11/2003, inspector w.e.f 03/05/2005 and thereafter to the rank of D.S.P w.e.f 31/03/2012 instead 29/11/2018, with all back benefits.

Any other relief not specifically asked for may also graciously be extended in favour of the Appellant in the circumstances of the case.

It is therefore, requested that my promotion as Offg: may be revised with effect from 27.03.2007 and confirmation as Inspector with my colleagues.



after promoted as Inspector in the year 2013. That he was promoted as Offg. Sub Inspector vide notification dated 21.04.2008 however he was confirmed as S.I on 13.09.2012 while his colleagues including junior to him were confirmed on 30.07.2010 and were assigned seniority in the List "F" accordingly. That the appellant was not confirmed as Sub Inspector as he has not served as SHO. That the appellant submitted written application/departmental appeal but in vain and hence the instant service appeal.

4. Learned counsel for the appellant has argued that the appellant was not assigned the duty to serve as Incharge of Police Station. That the said omission is not attributable to the appellant as he was not afforded opportunity to serve as SHO by the high ups. In support of his claim reliance was placed on judgment of this Tribunal passed in service appeal No. 407/2011, titled "Mr. Nasir Khan Versus Provincial Police Officer, Khyber Pakhtunkhwa, Peshawar and others" wherein it was observed that it is the authority to give assignment of SHO to the appellant and when the authority fails to give such an opportunity then the rule of serving as independent SHO for one year would hold no ground. Similar view taken by this Tribunal in service appeal No. 1264/2012 decided on 31.01.2013 as well as appeal No. 37/2011 decided on 03.4.2013.

5. Learned Government Pleader has argued that the appeal

was not maintainable as the same was not within time. In support of his arguments he has placed reliance on judgment of august Supreme Court of Pakistan passed in Civil Petition No. 566/2012 titled "Tariq Habib Khan and others versus the Provincial Police Officer, Khyber Pakhtunkhwa Peshawar and others"


6. We have heard arguments of learned counsel for the parties and perused the record.

7. The impugned final order was passed on 10.08.2015 while the appeal in hand was preferred on 28.08.2015 as such we hold that the appeal is within time. So far as the issue relating to confirmation of the appellant as Sub Inspector w.e.f. 30.07.2010 is concerned the same hold ground as it was not within the authority of the appellant to post himself as SHO of an independent Police Station. Had the relevant authority posted the appellant as SHO and had the appellant failed to perform as SHO despite such posting then the appellant would have not been found entitled to the relief claimed. Since the omission is on the part of the respondents as such the appellant cannot be deprived of his right to ante-date confirmation as Sub Inspector w.e.f. 30.07.2010 i.e. the date on which his colleagues were confirmed.



JUDGMENT

NOOR ALI KHAN, MEMBER. - This appeal has been filed by Younas Javed Mirza, the appellant, under Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 against the impugned order dated 1.7.2011, communicated to the appellant on 4.7.2011 whereby the departmental representation of the appellant for confirmation from date, of joining his service as Temporary ASI dated 28.3.1975 was turned down and probation service period rendered by him from 28.3.1975 to 1.1.1978 was not considered. It has been prayed that on acceptance of the appeal, the respondents be directed to ensure the confirmation of the appellant in service from the date of joining his service as Temporary ASI w.e.f. 28.3.1975 and the probation period rendered by the appellant from 28.3.1975 to 1.1.1978 be considered as active service.

2. Brief facts of the case as averred in the memo: of appeal are that the appellant had joined police department as Temporary Assistant Sub-Inspector on 28.3.1975 and on 1.1.1978 his services as ASI were confirmed. He was gradually promoted to the rank of DSP on 24.8.2006 and presently posted as acting Superintendent of Police, FRP, Peshawar Range. Some of the officers namely Shafiullah Khan and nine others approached this Tribunal and vide consolidated judgment dated 12.3.2005, in service appeal No. 192/2004, titled "Shafiullah Khan Versus Provincial Police Officer and others", the appeals were accepted as prayed and their respective services of probation period was considered as active service and they were confirmed in their respective services from the date of joint their services. The respondents have not challenged the aforementioned judgment, which attained finality and implemented by confirming the appellants in the above mentioned services appeals from the date of joining their service and also assigned them revised seniority in the seniority list. In the circumstances, the appellant also approached respondent No.1 through proper channel and filed the departmental representation for the redressal of his grievances on the analogy of the judgment mentioned above in the light of judgment of august Supreme Court of Pakistan reported in 1996-SCMR-1185. Vide impugned order dated 1.7.2011, his representation has been rejected, hence this appeal.

3. After admission of the appeal, notices were issued to the respondents for submission of written replies. They have filed their joint written reply and contested the appeal. The appellant also filed rejoinder, in rebuttal. Arguments heard and record perused.


4. The learned counsel for the appellant argued that the appellant was initially appointed as temporary Assistant Sub Inspector on 28.3.1975. After probation period, the appellant should have been confirmed w.e.f. the date of appointment as per Rule 19.25(5) of Police Rules, 1934 but he had been confirmed on 1.1.1978 with immediate effect, which is against the law/rules. Confirmation can be made w.e.f. the date of appointment. The learned counsel for the appellant relied on 1971-PLC-47 (CST), 1971-PLC-114(CST), 1997-PLCC(CS)687. He further argued that on initial appointment, probation period will be considered and treated as part of regular service and seniority of such employees to be reckoned from their initial appointments. He referred to 1988-PLC(CS) 916. On the point of limitation, the learned counsel for the appellant argued that the departmental appeal of the appellant has been rejected on merit and from the date of communication of final order, the appellant filed the instant appeal within thirty days, which is well within time. He referred to PLJ 1996 Tr.C (Services) 899, PLJ-1996, Tr.C(Services)-640, PLJ 1997-Tr.C(Services) 496. The learned counsel for


the appellant also stated vested rights have been taken back from him, and no limitation runs in such like matters. PLJ-1997-Tr.C(Services)-139. He further stated that if the department given the benefits of confirmation and seniority from the date of appointment, to come employees could not be denied to others. In such cases technicalities including limitation, even if established, could not be over-ride equity and justice. The learned counsel for the appellant further stated that case of Shafiullah etc. mentioned above is totally similar and identical as all of them were appointed as Temporary ASIs like the appellant, thus the principle of consistency fully supports the case of the appellant. He requested that the appeal may be accepted as prayed for.

5. The learned AAG argued that the appeal is barred and bad for non-joinder/mis-joinder of necessary parties and that this Tribunal has no jurisdiction to entertain the present appeal. He further argued that the case of appellant is totally different from the case of Shafiullah and others and not applicable to the case of present appellant. The appellant was appointed as Temporary ASI against temporary vacancy on 28.3.1975. Confirmation is always made against a permanent vacancy and on occurrence of such vacancy he had rightly been confirmed as ASI on 1.1.1978. He requested that the appeal may be dismissed.

✓ 6. The Tribunal observes that the appellant filed departmental appeal on 9.4.2011, the same has been rejected on 1.7.2011, and the present appeal filed on 20.7.2011, which is well within time. The appellant was appointed as ASI on temporary basis on 28.3.1975 and on his confirmation he will be confirmed from the date of appointment as per ruling of the august Supreme Court of Pakistan referred to above. The matter in issue has already been decided by this Tribunal in consolidated judgment in Service Appeals No. 192 to 200 and 241 of 2004, titled Shafiullah and others who were confirmed from the date of appointment with seniority benefits. The appellants in those appeals were also appointed as Temporary ASI in Malakand Range on 1.4.1977. Para-7 of the judgment is reproduced as under:-

“.....In our opinion the probation period of a prospective civil servant is always counted as active service, and while fixing seniority the probation period is duly into account, as is done in case of other services like C.S.S etc where the two years probation period of the appointee is considered to be active service, and seniority fixation is done accordingly. Regards the sanctioning or otherwise of the posts of ASIs in Malakand Range from 1.4.1977 we feel that it was the primary responsibility of the department to have ensure that budgeted posts did exist before making appointment of the appellant and his batch-mates. If the department lapsed on that score, the appellant and his batch-mates should not be made to suffer for the failings of others. With these remarks, the appeal is accepted as prayed for, and the decision of the

earlier DPC meeting dated 14.5.2002 wherein the services of the appellant and his batch-mates were regularized w.e.f. 1.4.1977 is hereby restored. No order as to costs. File be consigned to the record."

The appellant is also entitled to the same treatment meted out with other similar employees as per judgment of august Supreme Court of Pakistan reported as 1996-SCMR-1185.

7. In view of the above, the appeal is accepted, the impugned order dated 4.7.2011 is set aside and the appellant is confirmed from the date of appointment i.e. 28.3.1975, with seniority and other consequential benefits. Parties are left to bear their own costs. File be consigned to the record.

8. This order will also dispose of connected Service Appeal No. 1370/2011, "Muhammad Idrees Versus Provincial Police Officer, Khyber Pakhtunkhwa, Peshawar and others", in the same manner.

JUDGMENT

AHMAD HASSAN, MEMBER.- Arguments of the learned counsel for the parties heard and record perused.

FACTS

2. The brief facts are that the appellant and private respondent no.5 and 6 were appointed as Prosecuting Sub-Inspector Legal (BPS-14) on 17.04.1993. The appellant was senior to the aforementioned respondents. That vide impugned seniority list dated 20.11.2013 he was placed junior to respondent no. 5 and 6 by wrong interpretation of judgment of this Tribunal dated 12.01.2010. Feeling

aggrieved he filed an appeal on 27.11.2013 against the said seniority list but was not accepted. Thereafter he filed departmental representation which was considered by the Departmental Promotion Committee in its meeting held on 16.02.2015 but was "not entertained", hence, the instant service appeal on 14.04.2015.

ARGUMENTS

3. Learned counsel for the appellant argued that he and private respondent no. 5 and 6 were appointed as Prosecuting Sub-Inspector Legal (BPS-14) on 17.04.1993. That the appellant's date of appointment and confirmation as S.I Legal is same i.e 17.04.1993. He was promoted to the rank of Inspector on 19.11.2007, while private respondent no.5 on 08.10.2009 and respondent no. 6 on 15.02.2008. In addition to this appellant was shown senior to private respondent no. 5 and 6 in the seniority lists stood on 31.12.2006, 31.12.2007, 31.12.2008, 15.07.2009, 31.10.2010 and 31.12.2011. That vide notification dated 20.01.1997 seniority of Prosecuting Sub-Inspectors Legal as per list "F" prepared under Rule- 13-15(4) of Police Rules 1934 the name of the appellant sr. no. 17, while private respondent no. 5 and 6 are at sr. no.19 and 20 respectively. However, vide impugned seniority list dated 20.11.2013 issued by the competent authority he has been shown junior to them due misinterpretation of judgment of this Tribunal dated 12.01.2010. He preferred appeal against the said seniority list for placing his name at an appropriate place but was not entertained. It goes against the spirit of Rule 12.2(3) of Police Rules 1934 because he is older in age than the private respondents and deserves to be placed senior to private respondents. Furthermore, the appellant was not made a party in that service appeal and no adverse order was passed against him. Hence, the principle of *audi-alterum partem* is also attracted in this case. Private respondents


no. 5 and 6 were entitled for seniority but not at the cost of the appellant. Thereafter, he preferred another departmental appeal which was considered by the competent authority and vide order dated 15.01.2014 followed by addendum 17.01.2014, confirmed him as PSI from the date of appointment i.e. 17.04.1993 instead of 01.10.1997. As proper effect was not given so it was followed by another representation dated 14.07.2014. It was considered by the DPC "but not entertained" in its meeting held on 16.02.2015, hence, instant service appeal. This decision of DPC is not in tandem with law/rules governing the aforementioned issue.

4. In response to objections raised by learned counsel for private respondent no. 5 and 6 that Police Rules 1934 have not adopted by the Khyber Pakhtunkhwa, Police, learned counsel for the appellant produced Police Order 2002 and Police Act 2017 etc. and established about adoption of the above rules by the Khyber Pakhtunkhwa Police. Reliance was also placed on case law reported as PLJ 2009 SC 125, 2007 SCMR 818, 2007 SCMR 135, PLD 2008, Peshawar 121 and 2008 SCMR 1148.

5. On the other hand learned counsel for private respondents no. 5 and 6 argued that appellant submitted a representation against seniority list notified on 20.11.2013. His prayer included antedating his date of confirmation in the rank of PSI Legal from the date of appointment. Seniority of junior ranks of police officials is regulated by Rule 12.2 of Police Rules and confirmation is a basic factor for determination of seniority. The impugned seniority was prepared strictly in accordance with rules and there is hardly any force in the plea of the appellant. Vide order dated 15.01.2014 he was confirmed as PSI Legal from the date of appointment

i.e. 17.04.1993. He failed to file service appeal against the above decision, so his appeal is time barred. The appellant filed another representation for antedating of his confirmation as Inspector, which was regretted by the Departmental Promotion Committee in its meeting held on 16.02.2015. He has been correctly confirmed as Inspector from 13.10.2013. He further contended that Police Rules 1934 have not been adopted by the Khyber Pakhtunkhwa Police, so his case should be dealt with under Khyber Pakhtunkhwa Civil Servants Act 1973 and Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules 1989.

6. Learned Additional Advocate General adopted the arguments advanced by the learned counsel for respondent no. 5 and 6.

CONCLUSION

7. Careful perusal of record would reveal that the appellant and private respondents no. 5 and 6 were appointed as PSI Legal in Police Department on 17.04.1993. The appellant was promoted as Inspector on 19.11.2007, while respondent no.5 on 08.10.2009 and respondent no.6 on 15.02.2008. That vide notification dated 20.01.1993 relating to the seniority of PSI's Legal as per list "F" firmed up under Rule 13-15(4) of Police Rules names of appellant and respondent no. 5 and 6 are appearing at sr. no. 17,19 and 20 respectively. Seniority lists as stood on 31.12.2006, 31.12.2007,31.12.2008,15.07.2009,31.10.2010 and 31.12.2011 notified by the respondents the appellant stood senior to private respondents no. 5 and 6. These seniority lists were never challenged by private respondents. Official respondents deliberately misinterpreted the judgment of this Tribunal dated 12.01.2010 and placed private respondents no. 5 and 6 senior to the appellant in the impugned seniority list notified on 20.11.2013. The said seniority list is hit by Rule 12.2 (3) of Police Rules 1934. The appellant being older in age should be placed



senior to private respondents. Case law reported as PLJ 2009 SC 125 refers. He filed departmental appeal but was not considered by the competent authority. Furthermore, the appellant was not arrayed as a necessary party in the service appeals filed in this Tribunal by private respondents. That no adverse order was passed against the appellant in those judgments. Operative part of judgment is reproduced below:-




"The Tribunal accepts the appeal to the extent that in case juniors to the appellant have been promoted/confirmed, in region, on the basis of seniority, maintained on provincial level or regional level, the appellant shall also be considered at par with his colleagues as per seniority and rules".

No doubt private respondents were entitled to be assigned due place in the seniority list but not to the detriment of the appellant. On preference of departmental appeal the competent authority vide order dated 15.01.2014 followed by addendum date 17.01.2014 confirmed him as PSI Legal from the date of his appointment i.e 17.04.1993 instead of 01.10.1997. As proper effect was not given to the aforementioned decision so he filed another representation on 14.07.2014, which was "not entertained" by the Departmental Promotion Committee in its meeting held on 16.02.2015. Aforementioned decision of Departmental Promotion Committee is not in line with law/rules governing seniority.

8. Learned counsel for private respondents was beating around the bush and referring to instances which are least relevant in the instant appeal. However, he candidly conceded that the appellant was correctly confirmed as S.I w.e.f 17.04.1993. So far the issue of adoption of Police Rules is concerned those have been adopted by the Khyber Pakhtunkhwa Police as is evident from police order 2002 and Police Act 2017 etc. Learned counsel was repeatedly confronted through the aforementioned evidence but failed to come up with convincing arguments. He was also confronted that in the presence of Police Rules 1934, why Civil Servant Act, 1973 and APT Rules 1989 be followed, but did not have

plausible explanation?. He has failed to made out a case having support of law/rules. We are of considered view that grievances of the appellatant contained in the prayer of the appeal are genuine and should be addressed strictly according to law/rules.

9. As a sequel to above, the appeal is accepted the impugned seniority list dated 20.11.2013 is set aside, order dated 16.02.2015 and ancillary matters be brought in conformity with law/rules. Parties are left to bear their own costs. File be consigned to the record room.
