SERVICE APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNALS ACT, 1974 AGAINST THE IMPUGNED FINAL SENIORITY LIST OF AETO BS-17 DATED 16/06/2022 BEING ILLEGAL AND WRONG. WHEREIN THE APPELLANT WAS DROPPED FROM SENIORITY NO. 15 TO SENIORITY NO. 23, AND AGAINST NOT TAKING ACTION

## ON THE DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN THE STATUTORY PERIOD OF THE NINETY DAYS.

#### **PRAYER**

ON THE ACCEPTANCE OF THIS APPEAL, THE APPELLANT MAY BE DECLARED SENIOR FROM RESPONDENT NO.4 TO 10 AND THE RESPONDENTS MAY PLEASE BE DIRECTED TO CORRECT THE IMPUGNED FINAL SENIORITY LIST of AETO BS-17 DATED 16/06/2022 AND PLACE THE NAME OF APPELLANT AT PROPER POSITION IN SENIORITY LIST ACCORDING TO SENIORITY RULES. ANY OTHER REMEDY WITH THIS AUGUST TRIBUNAL DEEMS FIT AND PROPER MAY ALSO BE AWARDED THE FAVOR OF THE APPELLANT.

#### RESPECTFULLY SHEWETH

#### **FACTS**

- 1. That the appellant is law abiding citizen of Pakistan and have every legal right protect under Constitution of Islamic Republic of Pakistan.
- 2. That the appellant was promoted as Superintendent BPS-16 and latter on the post of Superintendent upgraded to BS-17 since that the appellant has been performing his duty up to the entire satisfaction of his superior and no complaint has ever been filed against him.
- 3. That the department amended rules in 2018 wherein the promotion channel was provided to appellant as superintendent BPS-17 to AETO BPS-17 in same scale. Which was also challenged by the appellant through service appeal. During pendency of that appeal the appellant was promoted to AETO BS-17 on 22/01/2021, which is accepted by the appellant under protest.
- 4. That thereafter the deptt: issued tentative seniority list, which was according to law and rules but now the deptt Issued the final Seniority of AETO BS-17 in June 2022 but not according to law, the junior official showing senior to the appellant, which is injustice with the appellant. The appellant being aggrieve filled departmental appeal but

after lapse of considerable time there is no outcome of the appeal /representation all went in vain. Hence, the appellant constrained to file this service appeal before this August Tribunal on the following grounds amongst others. Copy of tentative seniority list and Final seniority list and appeal on final seniority list is attached as annexure-A, B & C.

#### **GROUNDS**

- A. That the impugned actions/inaction on the part of the respondents vide which the appellant has been deprived of due right is smacked with malafied, illegal wrong, unlawful against vested right of the petitioners, unauthorized and unconstitutional.
- B. That no notice was given before disturbing the seniority position of the appellant which is against the natural Justice.
- C. That not responding on Departmental appeal with in statutory period of 90 days and the impugned seniority list is against the law, illegal, unlawful, without and lawful authority, thus calling interference of this learned tribunal.
- D. That the private respondent were promoted on 22/12/2021 and the appellant was promoted on 22/01/2021 but despite that the private respondent shown seniors which is against the law and rules.
- E. That the appellant was promoted from BS-17 to BS17, so the seniority must be reckoned from the date of regular promotion to the post of AETO BS-17.
- F. That the impugned seniority list is against the norms of service law and principles of natural justice and dictums of the apex courts.
- G. That the impugned seniority list is the worst example of favoritism, nepotism and colorful exercise of powers which is not warranted under law.
- H. That All person placed in similar circumstances must be treated alike and the reasonable classification must be based on reasonable ground in a particular set of circumstances but the same in any case must not offend the spirit of Article 25 of the constitution. Person equally placed must be treated alike in the matter of rights, privileges and liabilities under the rules of equal protection of law.

I. That In Dr. Munir Ahmad and 37 others Vs Govt of Pakistan Finance Division, Islamabad and 4 others (2007 PLC(CS) 285) the Honorable Supreme court of Pakistan held as:

"Concept of equal protection and equality before law is hallmark of the constitutional scheme recognized by not only the preamble, objective resolution, Article 4, 25 and 27 of the constitution but also the principle of policy contained in Article 37 of the constitution. Equal protection and equal treatment of citizen similarly placed is universally accepted and recognized principle which has been explained by many others in text books and judges in precedents, statutory function in a democratic setup cannot make any individual distinction for any extraneous reason in exercise of discretion must be free of arbitrariness and caprice."

- J. That according to Section-8 of the Civil Servant Act 1973and section-17 of APT Rules 1989, it is the legal right of every civil servant to properly placed in seniority list according to his seniority position, but the same benefits was not extended to the appellant which is the violation of law and rules.
- K. That the appellant was not treated according to the law and rules and has been deprived from his legal right of seniority in arbitrary manner without fault on his part.
- L. That the appellant craves permission of this honorable tribunal to rely on other grounds at the time of arguments and produce any additional document if required in support of instant service appeal.

It is therefore most humbly prayed that the appeal of the appellant may be accepted as prayed for.

DEPARTMENTAL REPRESENTATION / APPEAL AGAINST THE FINAL SENIORITY LIST OF ASSISTANT EXCISE AND TAXATION OFFICERS BPS-17.

With all the due respects kind attention is invited to Section Officer Dear Sir, No. SO(Admn)/E&T/1-6/;2021/8153-56/W/E, dated. 28.12.2021 regarding issuance of tentative seniority lists of various service cadres including that of the Assistant Excise No. SO(Admn)/E&1/1-6/;2022/4286-88/W/E dated, 17.06.2022, regarding issuance of final seniority lists of various service cadres including that of the Assistant Excise and Taxation Officers BPS-17 (Annex "B").

It is submitted that seven (07) inspectors (BPS-16) having newly been promoted on 22.12.2021 as Assistant Excise and Taxation Officers BPS-17 have been granted seniority and reflected at S. # 1, 3, 7, 12, 13, 17 and 18 in the impugned seniority list which is irregular as under the provisio to Explanation-II of Rule 17 of the Khyher Pakhtunkhwa Civil Servants (APT Rules) 1989, it is laid down that a junior person shall not be deemed to have superseded a senior person if the case of the senior person is deferred for the time being for want of certain information or for incomplete record or for any other reason not attributing to his fault or demerit. (Copy attached Annex "C").

That according to section -8 of Civil Servant Act 1973 and section-17 of APT Rules, 1989, it is the legal right of every Civil Servant to properly placed in Seniority list according to his seniority position, but the same benefits was not extended to the appellant which is the violation of law and rules, according to APT Rules, 1989, the seniority must be counted from the date of appointment wherein the employee promoted from different cadre so there seniority must be counted from the appointment.

In this connection it is to be noted that all the above persons were not promoted in time just because they could not pass the departmental examination in the required time frame/standard. It was by reason purely attributing to their fault and demerit. As such they were not deferred rather superseded and the grant of seniority to them is not covered under the rules and ultravires, thereby causing me irreparable loss in terms of seniority. By that reason my seniority position in the impugned seniority list has been pushed downwards by seven locations and hence this departmental representation.

It is further submitted that the post of AETO is in basic pay scale 17 and under the Excise and Taxation Service Rules, 2018 a superintendent of BPS-17 is promoted (encadred) as AETO BPS-17 in the same scale. I was declared a superintendent BPS-17 with all back benefits w.c.f. 06.08.2013 and subsequently promoted as AETO BPS-17 on 22.01.2021. Therefore, technically I have been in BPS-17 since 06.08.2013. Whereas, all the said inspectors (now AETOs) remained in BPS-16 till their promotion on 22.12.2021. As such the grant of seniority to them over me is not only unfair but against the spirit of the rules.

In view of the above it is requested that the grant of seniority to all the above seven (07) officers having been irregular may be withdrawn and reflected at the bottom of the seniority list of AETOs in accordance with the date of their regular
