

Respectfully Sheweth:-

1. That after recommendation of provincial Public Service Commission KPK appellant was appointed as Lecturer computer Science (BPS-17) vide office order <u>dated:13.12.2012</u>, and during his entire service he has got no adverse remarks or any other charge and as such having an excellent record and spot less service.

(Copy annexed as A)

- That during his service the appellant submitted an application to respondent No.2, through respondent No.2 for Two Years leave without pay on 14-02-2015 vide endsit No. 1135. (Copy of application is annexed as B)
- 3. That vide endsit No.1166, dated:24.02.2015 respondent No.\$ forwarded the application of the appellant to district account officer for report and as such the district account officer reported that appellant is having 730 days of extraordinary leave in his leave account. (Copy of leave promforma is annexed C)
- 4. That thereafter the appellant was relieved by respondent No. A on 27-02-2015 under the endstt No: 1181-84and respondent No. (principal), on 02.03.2015, issued clearance certificate to the appellant, hence leave of the appellant was started with effect from 01-03-2015, and as such the salary of the appellant was closed. (Copies are annexed as D&E)
- 5. That after relivingfrom the college the appellant was under the impression that the leave of the appellant has been sanctioned by the competent authority, as the appellant has properly been relieved by the respondent No. 2 and his salary was also closed by the Respondent No. 3 after fulfillment of all codal formalities, thus he started his leave without any apprehension and dread.
- 6. That at the back of the appellant respondents initiated proceedings against the appellant, after getting knowledge of the above stated proceeding the appellant submitted his arrival report on 18.05.2016 to the respondent No.3, but his arrival report was not considered by the respondent No.3 and as such the appellant was removed from service vide order dated:27.05.2016. (Copy of arrival report and order is annexed as F &G)
- 7. That aggrieved from the impugned order <u>dated:27.05.2016</u>, communicated to appellant on 08.06.2016, the appellant filed a departmental appeal/representation to the chief minister K.P.K which on 28.06.2016, which still pending adjudication.

8. That after lapse of statutory period for disposal appeal, the appellant now approaches this Hon,able court / tribunal for setting aside impugned orders and re-instatement in service on the following grounds amongst others.

<u>GROUNDS.</u>

- A. That the order of the respondent No.**3** from removal of service of appellant is against the law, facts and violation of the procedure as provided under the law, hence the same is liable to be struck down.
- B. That respondent No.3 after satisfying himself about the availability of extra ordinary leave of 730 days in his leave account properly not only properly relieved the appellant from duty but also issued him clearance certificate, similarly, the appellant after getting the knowledge of the proceedings initiated against him instantaneously approached the respondent No. 3 but despite that the respondent No. 4 has not considered the same and issued the impugned order, hence removal of the appellant thereafter on the ground of absence from duty is based on malafide, self-motivation and unreasonable, thus cannot be allowed to remain intact.
- C. That no statement of allegations, were issued to the appellant nor the appellant was given an opportunity of personal hearing was provide to the appellant before the passing the impugned orders, hence on this score too the order of respondents in maintainable.
- D. That neither any show cause notice issued to the appellant nor any show cause notice was served to the appellant nor any inquiry was conducted in accordance with law, rules and procedure, thus the order passed without show cause notice and proper inquiry in the matter is having no sanctity in the eye of law.
- E. That being a regular employee the appellant has served the department honestly and whole heartedly for sufficient time, and perform his duties candidly and unequivocally thus the appellant cannot be removed from his service with a stroke of pen as done by the respondent.
- F. That the appellant totally stand condemned unheard, the impugned orders doesn't provide any reason, and the appellant having long years of service to his credit, being a regular employee could not has been thrown out illegally and without any process of law, such orders being void ab-initio could not be allowed to remain in field.
- G. That the conduct of the respondents clearly suggests that appellant has highly been discriminated which is not permissible under the constitution of Islamic Republic of Pakistan 1973.

- H. That the appellant has been condemned totally unheard and as such the basic principle of natural justice is violated in the case of the appellant.
- I. That as per facts and circumstances of the case the principle of locus poenitentiae is also attracted in the case of the appellant.
- J. The contents of the departmental appeal/representation may be considered as integral part of the instant appeal.
- K. That on the permission of this Hon, able court the appellant may urge other additional ground if any, at the time of arguments.

PRELIMINARY OBJECTIONS. -

Respectfully Sheweth: -

- 1. That the Applicant has got no cause of action/locus standi to file the instant Service appeal.
- 2. That the appellant has concealed material facts from the Hon'able Tribunal.
- 3. That the Hon'able Tribunal lacks jurisdiction to entertain the instant appeal.

4. That the Appellant has not come to the honourable Tribunal with clean hands.

5. That the Appellant is estopped by his own conduct to file the instant appeal.

6. That the appeal is hit by doctrine of laches.

7. That the instant appeal is based on mis-conception/mis-statement of facts, hence, liable to be dismissed.

Facts: -

- Correct to the extent that the appellant was recommended by the Khyber Pakhtunkhwa Public Service Commission and was appointed as Lecturer in Computer Science, while the rest of the para in subject to proof.
- 2. Correct that the appellant submitted an application to respondent No.2 for two years leave (without pay) w.e.f. 01-03-2015 to 27-02-2017 on account of domestic problem.
- 3. Pertains to record.
- 4. Incorrect. The appellant only submitted an application for extra ordinary leave (without pay) for two years and left the College without approval of the competent authority. The Principal, Government Degree College, Garhi Kapora, (Mardan) directed the appellant time and again to resume your duties but to no avail, (Annex-A, B, C, D). Moreover, the respondent No.3 also informed the appellant vide letter No. 15626 dated 17/06/2015 and directed to explain the reason of his wilful absence from duties and assume his duties within a week failing which disciplinary action under E & D Rules, 2011 will be initiated against him (Annex-E).
- 5. Incorrect. The appellant was required to wait for the sanctioning of his extra ordinary leave and only submission of an application does not mean that his leave was sanctioned. The appellant is misleading the honourable Tribunal that all codal formalities were fulfilled before leaving the College.

- 6. Correct that several letters were sent on the home address of the appellant for the resumption of duties, but the appellant failed to resume his duty and he was alleged to proceed to Korea without obtaining permission/leave, which is tantamount to misconduct. The Department Published absence notices in two leading Newspapers, wherein the appellant was directed to report to duty within 15 days, failing which it will be presumed that he is no more interested in his service and ex-parte action will be taken against him culminating in his dismissal from service (Annex-F&G), but the appellant did not bother to reply. Hence, the appellant was removed from service vide Notification dated 27-05-2016 (Annex-H).
- 7. Pertains to the record of Chief Minister, Secretariat.
- 8. Needs no Comments.

Grounds: -

- A. Incorrect. The respondents issued the order of removal of the appellant from service in accordance with law, rules and policy in vogue.
- B. Already explained in Para No. 6 on facts.
- C. Incorrect. The respondent fulfilled all the codal formalities before removing the appellant from service. The appellant was directed to resume duties failing which Exparte proceeding will be initiated against him, but he did not bother to reply.


