


20th Sept 2022 1. Appellant alongwith his counsel present and heard.

PRAER:-

ON ACCEPTANCE OF INSTANT SERVICE APPEAL, RESPONDENTS MAY PLEASE BE DIRECTED TO ISSUE ADJUSTMENT ORDER AS SUPERINTENDENT (ON HIS OWN PAY AND SCALE TILL THE REGULAR PROMOTION) AGAINST THE AVAILABLE VACANT POST ON THE BASIS OF RETIREMENT IN THE OFFICE OF SDEO (FEMALE) ABBOTTABAD AND PRESENT SERVICES OF APPELLANT AS ASSISTANT IN THE OFFICE OF

DEO (F) ABBOTTABAD BE CONTINUED, REMAINED TILL THE ABOVE PROMOTION, IN PURSUANCE OF ACCEPTANCE OF DEPARTMENTAL REPRESENTATION DATED 23/02/2022.

Respectfully Sheweth, **FACTS**

- 1) That appellant joined Elementary & Secondary Education department on 01/01/1985 as junior clerk in BPS 05, and after successful in competition, was promoted as Junior Scale Stenographer on 26/11/1989 in BPS 12 and after that he was promoted (after awarded Selection grade in BPS 15), as a Senior Scale Stenographer in BPS 16 in March 2021, and presently being Senior Scale Stenographer is performing his duty in the capacity of Assistant BPS 16, in the office of DEO (Female) Abbottabad situated in the premises of the office of respondent No 02. Copy of Monthly Salary slip for the month of May 2022 is attached as **Annexure "A"**
- 2) That in the last Tentative Seniority list of Stenographers on provincial level, dated 12/08/2020 the name of appellant was appeared at serial no 01, (later the same was declared final) and promotion of appellant as Superintendent in BPS 17 was confirmed on seniority cum fitness, but before filing of instant service appeal, he got relevant seniority list, wherein it revealed that seniority of Stenographers was merged with assistants and separate seniority list of Stenographers was changed/broken by the respondents, though appellant is filing departmental appeal to higher authority for taking his established rights, due to this reason, instant appeal is filing with some delay and application for condonation of delay is also being filed. Copies of separate seniority list of Stenographers for the year 2020, and joint seniority list of assistants with Stenographers for the year 2021 are annexed as **Annexure "B" & "C"**
- 3) That remaining service of appellant is only three years, as date of his retirement is 03/02/2026, and he served in several hard areas during his service, and now in the end of last three years of his

service, he is entitled to service/perform his duties in the near station of his residence, on the basis of same circumstances, appellant submitted his representation through registered post on 23/02/2022 to respondent No 01. Copy of representation/application along with receipt of computerized registered post, is annexed as Annexure "D"

- 4) That now one Mr: Muhammad Bashir superintendent in the office of SDEO (Female) Abbottabad is retired from his service on 04/06/2022, the same office is also situated in premises of respondent no 02 (appellant's present posting station) and thus the post of superintendent is available and lying vacant.
- 5) That the kind notice of this Honourable Tribunal is drawn to the facts that appellant in his representation, has agreed that if he will be adjusted as superintendent on his own pay and grade or acting charge basis, he will not get or raise any claim of extra more financial benefits till the regular promotion as Superintendent, and in this regard he will give an affidavit when required by the respondents, but there is no response taken by the respondents upon his representation/application dated 23/02/2022 (Annexure C) and in the present scenario of current dispute of Joint seniority list as discussed herein above at para 02, some delay has passed after statutory period of 120 days from the submission of departmental representation, in this regard application for condonation of delay is also filed. Hence this appeal inters-alia on the following ground.

Grounds


- a) That appellant is not only most senior and his name is available on the top of the seniority list of senior scale stenographers for promotion, but due to merging of seniority list, appellant's placement is appeared in disadvantages position, whereupon he filed an other application/departmental representation. Copy of present application/departmental representation is annexed as Annexure "E"

- b) That appellant is entitled for his better posting rights in the final promotion of his service and his service is only last three years is now left in his credit.
- c) That the impugned action of respondent no 1, i.e not issuance of adjustment order of appellant, is apparent activity of illegality, which is also unjust in the circumstances of the case.
- d) That appellant is dragged into litigation, the conduct of the respondents is admittedly arbitrary capricious unjust and against all norms of justice and as such requires indulgence of this Honourable Court by awarding appropriate Cost to the respondents.
- e) That respondents ignored the provisions of Article 4 of the Constitution of Pakistan while exercising their illegal impugned order and their exercising discretionary powers in refusing the relief to the appellant.



