**ALSO BE ALLOWED IN FAVOR OF APPELLANT**

**RESPECTFULLY SHEWETH :**

The appellant very humbly submit the following the few line for your kind and sympathetic consideration :

1. That the appellant was appointed as naib qasid on <sup>21-10-18</sup> ~~21-10-18~~ ever since his appointment , appellant performed his duties as assigned with zeal and devotion and there was no complaint whatsoever regarding his performing.
2. That the appellant pass the SSC examination in the year 2003 from board of intermediate and secondary education Bannu.
3. That the appellant was Senior most in seniority lists from to 2019 issued for naib qasid/chowkidar/sweeper/Mali water carrier, from private respondents which were prepared on the basis of initial appointment. **Copy of the seniority lists are attached as annexure-A.**
4. That the present seniority list dated 01.01.2020 issued on 13.01.2020 of the class IV staff (naib qasid/ chowkidar/sweeper /Mali water carrier) of sessions division Bannu in which the undersign was placed at serial no 07 and after one month another seniority list was issued on 03.02.2020 which was prepared on the basis of regular appointment.. **Copy of seniority list is attached as annexure-B & C.**
5. That the seniority list 2020 is illegally prepared and issued on the basis on acquiring SSC, whereas most of the class 4 employees passed their SSC examination before their appointment in the service and most junior to the appellant which badly effect the promotion right of the appellant and seniority. The appellant being aggrieved filed departmental appeal which was rejected vide order dated 22.02.2020 for no good grounds. **Copy of departmental appeal and rejection order is attached as annexure-D & E.**
6. That the seniority list 2020 issued on the basis of acquiring SSC is illegal unlawful against the law and facts hence liable to be set aside inter alia on the following grounds :

**GROUND OF SERVICE APPEAL**

- A. That the seniority list dated 01.01.2020 issued on 13.01.2020 and rejection order dated 22.02.2020 is against the law, rules and norms of



justice. Which is also against the Section-8 of Civil Servant Act 1973 and Rule 17 of Apt Rules 1989 because the appellant is civil servant and must deal according to civil servant act 1973 but the appellant has not been treated in accordance with law , hence his right secured and guaranteed under the law are badly violated.

- B.** That the impugned seniority list is against the law and rules on the subjects, the department have never taken into consideration the settled principles governing seniority/ promotion before issuance of the final seniority list.
- C.** That the seniority list of 2020 is against the Section-8 of Civil Servant Act 1973 and Rule 17 of Apt Rules 1989 because the appellant is civil servant and must deal according to civil servant act 1973.
- D.** That the seniority list 2020 is illegally prepared and issued on the basis on acquiring SSC, whereas most of the class 4 employees passed their SSC examination before their appointment in the service.
- E.** That the appellant was on top of first seniority list issued for naib qasid / chowkidar/sweeper / Mali water carrier which was prepared on the basis of initial appointment and not on the basis of SSC , hence the seniority list is liable to be corrected in the light of initial / regular appointment.
- F.** that the appellant has been greatly discriminated has his batch mates , even juniors to him were placed on top the seniority list , while I have been discriminated , thus seriously affected his right of seniority.
- G.** that the appellant was senior most , fit and eligible for promotion to the post of junior clerk , however appellant was ignored for no fault on his part, thus as per the rules.
- H.** That the similar nature appeal is already accepted by the Hon'able service tribunal so the appellant may also be treated same being similar placed person.

- I. That not allowing him promotion at per with my batch mates is illegal unlawful violative upon the rights of the appellant and is highly discriminatory.
- J. That the appellant is also senior to his batch mates as per the date of 1<sup>st</sup> entry to service and also discriminated in respect of those candidates who also pass their SSC prior to their appointment , however the respondents have never taken this fact into consideration while finalizing the seniority list.
- K. That the appellant has not treated been in accordance with law and he remained throughout deprived of his promotion due to in action/ slackness of the respondents, thus they are bound to follow the law and to act in accordance with law
- L. That the appellant also seeks permission of this honorable tribunal to rely on additional grounds at the time of hearing of the appeal.

It is therefore, most humbly requested that the appeal of the appellant may be accepted as prayed for.

IKRAMULLAH KHAN, J.- Through the instant Writ

Petition, the petitioners have challenged the  
promotion of private respondents with the  
following prayer: -

"It is therefore, humbly prayed  
that on acceptance of this writ  
petition, this Hon'ble Court may  
graciously be pleased to declare  
the impugned Seniority List  
(Annex:-E), the impugned  
promotion order dated 09.05.2012  
(Annex:-H) as without lawful  
authority and hence of no legal  
effect and this august Court may  
further be pleased to set aside the  
same and direct the Respondents  
to act in the matter in accordance  
with law and to rectify the  
seniority list by placing  
petitioners seniors to  
Respondents No.4-8 and to issue  
the promotion order of petitioners  
to the posts of junior Clerks w.e.f.  
17.01.2011 with all consequential  
back benefits"

02. In essence, some posts of Junior  
Clerks in the respondents/department were fallen  
vacant. Respondent in order to fill up the vacant  
posts on the basis of senior list well circulated

amongst Class-IV employees of the Board of Intermediate & Secondary Education, Mardan, promoted private respondents, out of 33% quota reserved for promotion to Junior Clerk, out of Class-IV employees.

03. The contention of petitioners, as agitated by them in the present petition, is that private respondents were junior to them and were illegally promoted thereby meted out petitioners with discrimination which is against the Constitution.

04. We have heard learned counsel for the parties in light of law and material available on record.

05. As the Board of Intermediate & Secondary Education, Mardan had already adopted the rules, notified by the Government of Khyber Pakhtunkhwa in regard to reservation of 33% quota in promotion to Class-IV etc, therefore, it requires no further explanation and discussion on the same point, however, both the parties have asserted and denied the same through their respective pleadings.

06. In order to resolve the crucial dispute, vehemently agitated by petitioners herein the

instant Writ Petition is the question of their seniority.

07. The provincial government of Khyber Pakhtunkhwa vide its Notification No.SOR-IV(S&GAD)1-1/95(D) dated 13.03.1997, had already formulated criteria for determination of seniority for the purpose of promotion to higher pay scale which reads as: -

- "(a) 33% by promotion from amongst Daftaries, G/Operator, Qasid & Naib Qasid including others equivalent post in the Secretariat with two years service as such who have passed SSC examination.
- (b) 67% by initial recruitment.

For the purpose of promotion there shall be maintained a common seniority list of Daftaries, G/Operator, Qasid & Naib Qasid etc with reference to the dates of their acquiring Secondary School Certificate provided that.

- i. If two are more officials have acquired the SSC in the same session, the official having longer services shall rank senior to other officials.
- ii. Where a senior official does not possess requisite experience at the time of filling up vacancy, the official next junior to him possessing the requisite experience shall be promoted in preference of the senior official(s)".

08. As very much clear from the record, available with us, placed by both the parties that private respondents had acquired their S.S.C. qualification much prior to petitioners and as per

seniority formula, issued by the Government of Khyber Pakhtunkhwa, adopted by the Board of Intermediate & Secondary Education, Mardan, private respondents were placed senior to petitioners irrespective of their length of service

09. Therefore, for the reasons mentioned hereinabove, petitioners were rightly placed junior to private respondents in accordance with Rules *ibid*. This petition is devoid of merit is dismissed accordingly.





**PARAWISE COMMENTS ON BEHALF OF RESPONDENTS.**

**Preliminary Objections:**

- I. That appellant assailed the Tentative Common Seniority lists before this Hon'ble Tribunal which does not meet the requirements of Section-4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974, as it has been held that the Civil servant can invoke the jurisdiction of the Tribunal against the Original and Appellate Order whereas the appellant challenged a provincial common seniority list. The tentative Seniority list does not assign any right amongst the Civil Servant rather it is circulated in order to seek objections from the incumbents with in a prescribe period whereafter a final Seniority List is to be issued.
- II. That Section-4(b) of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 imposes embargo upon viz:- "*No appeal shall lie to a tribunal against an order or decision of a departmental authority determining the fitness or otherwise of a person to be appointed to or hold a particular post or to be promoted against a higher post or grade*". Therefore the instant appeal is defective in its present shape and liable to be dismissed on this score too.
- III. That the seniority list of the appellant has been prepared under the Peshawar High Court (Subordinate Court staff) Recruitment Rules 2003, to which no exception can be taken. Moreover, the Final Seniority List has never been challenged by the appellant as he has filed an application against the Tentative Seniority List.

- IV. That appellant has alleged in para-4 that appellant was placed at serial No.9 at common seniority list which he has considered a final. Respondent Department issued a final seniority list as reflected on page No.33-34 of the main service appeal in which appellant was shown at serial No.10 which has not been called in question.
- V. That the instant appeal is also not maintainable on the ground that promotion against a particular post is not a vested right of a civil servant rather it is the Departmental Promotion Committee which has to determine the fitness and eligibility of an officer for promotion against a higher post.
- VI. That appeal is bad on account of non-joinder of necessary parties.
- VII. That as per Section-22(2) Khyber Pakhtunkhwa Civil Servants Act, 1973 no Representation shall lie on matters relating to the determination of fitness of a person to hold a particular post or to be promoted to a higher post or grade.
- VIII. That the appellant has no locus standi and/or cause of action to file the instant appeal.
- IX. That the appellant has not referred to and/or pointed out the violation of any statutory provision, which has been violated by the answering Respondent. It is the exclusive domain of the Respondents to amend, vary or modify the rules for the sake of smoothly running the judicial work.
- X. That the rules (*Annex:-Reply/1*) are very much clear that "*seniority shall be reckoned with reference to the date of their acquiring Secondary School Certificate.*" Thus the appeal in hand is not maintainable.

**FACTS:**

- 1&2. Needs no reply.
3. Regarding Para No.3 of the appeal it is submitted that the appellant right from the first date of his appointment, appellant was dealt with in accordance with law and no infringement of his right has been made by the Respondents. Moreover, as envisaged in Section-23 of the General Clauses

Act, 1897 it is the prerogative of the rule making authority to vary, amend or modify a law/rule which he deems appropriate in the best public interest.

4&5. Regarding Para No 4&5 of the Appeal it is apprised that appellant was treated in accordance with law and rules and no contravention of his rights muchless fundamental has been made. It is the exclusive prerogative of the Respondent to vary, amend or modify a law/rule which they deemed appropriate for the ends of smooth running of the official assignments. It is the celebrated principle of law laid down by the superior fora that no limitation can be imposed upon a department while exercising rule making power, therefore, Respondents by following the guidelines of Respondent No.1 dated 29.04.2019 (*Annex:-Reply/2*) framed the Service Rules providing that seniority shall be reckoned with reference to the date of the acquiring Secondary School Certificate. The copy of joint Seniority Lists of the Chowkidars/Naib Qasids, Sweepers etc. right from 01.01.2006 to 01.01.2019 is attached as *Annex:-Reply/3* and the seniority list dated 01.01.2020 of Class-iv employees has been prepared from the date of acquiring SSC for promotion to the post Junior Clerk (BPS-11). Moreover, appellant has not pointed out malafide or illegality of Respondents in the instant appeal in formulating the subject rules. It is worth-mentioning to add here that earlier similar question has come up for consideration before the Hon'ble Peshawar High Court, Peshawar in Writ Petition No.3724/2017 which, after extensive arguments, was dismissed vide order dated 07.11.2018 (*Annex:-Reply/4*).

6. Incorrect as contented by the appellant. Detail reply has already been given herein above.

**GROUND:-**

A-C. Not admitted. It is the domain of answering Respondents to frame Rules for smooth running of the official business of the Department. It is submitted that no discrimination has been meted out against the appellant. Seniority List in question has been prepared on the basis of date of acquiring Secondary School Certificate (SSC) which is in accordance with Peshawar High Court (Subordinate Courts Staff) Recruitment Rules-2013. Rest of the para is misconceived

D&F. Not admitted as narrated by the appellant. The Seniority List was prepared in the light of the Rules *ibid*, in order to bring efficiency and Discipline among the employees for the sake of better outcome of the official duty. Moreover identical question was also settled down by the Hon'ble Peshawar High Court, Peshawar in the Writ Petition bearing No. 1729-P/2012 decided on 30.05.2018 (*Annex:-Reply/5*) and it was held:-

08. *“As very much clear from the record available with us, placed by both the parties that private respondents had acquired there SSC qualification much prior to petitioners and as per Seniority formula, issued by the Government of Khyber Pakhtunkhwa, adopted by the Board of Intermediate & Secondary Education, Mardan, private respondents were placed Senior to Petitioner irrespective of their length of service”.*

G-L. Incorrect hence denied. Detail reply has been furnished hereinabove. So far as the acceptance of Service Appeal is concerned it is adduced that appellant is supposed to comply with the requirements of Rule-6 of the Khyber Pakhtunkhwa Service Tribunals Rules, 1974. It is further apprised that promotion to the post of Junior Clerk is meant to be made on the basis of seniority-cum-fitness and the appellant would be promoted in the manner in accordance with rules *ibid*.

It is, therefore, respectfully prayed that on acceptance of these Parawise Comments, the appeal may graciously be dismissed with cost.

1. Needs no reply.
- 2&3. Regarding Paras No.2&3 of the application it is apprised that albeit Order, 39 Rule-1, 2 of the CPC provides the remedy of temporary and/or permanent injunction to a claimant but subject to some limitations which are as under:-
  - (i) The claimant must have a case of prima facie.
  - (ii) There must be a balance of convenience and
  - (iii) Irreparable lost.

None of the above ingredients for seeking interim relief exist in case in hand. Appellant cannot be termed as an "Aggrieved Person" because he has called in question the Tentative Seniority List against which no departmental appeal or Service Appeal would lie. Moreover, as per assertions of the appellant he is dissatisfied from the letter dated 29.04.2019 of the Respondent No.1 whereby combined Seniority List has been prepared from the date of acquiring the SSC for promotion to the post of Junior Clerk (BPS-11), therefore, keeping in view the above circumstances appellant has failed to make out his case against the Respondents and not entitled to be granted interim relief.

4. Incorrect hence vehemently denied. Adequate reply has already been furnished. Moreover, reply as already advanced by the Respondents to the main service appeal may kindly be considered as an integral part of the instant replication.


It is, therefore, humbly prayer that the instant application may kindly be dismissed being devoid of facts and merits.

Subject: **GUIDELINES FOR THE PURPOSE OF PROMOTION TO THE  
POST OF JUNIOR CLERK (BPS-11)**

I am directed to refer to the subject noted above and to say that as a result of different queries from the District Judiciary about method of promotion to the post of Junior Clerk (BPS-11) from the holders of the post of Daftari, Record Lifter, Naib Qasid, Sweeper, Chowkidar, Mali and Water Carrier against the promotion Quota, the Competent Authority has been pleased to approve the guidelines for appointing authority as enumerated herein below:-

1. To avoid the ambiguity having crept due to splitting of the post of Junior Clerk into seven categories in the appendix to Peshawar High Court (Subordinate Courts Staff) Recruitment Rules, 2003, the appointing authorities in District Judiciary are advised to treat the post of Junior Clerk in their establishments as a single category as against its five categories reflected at S. No. 14 to 18 in the said appendix. In turn, a common seniority list of holders of the post of Daftari, Record Lifter, Naib Qasid, Sweeper, Chowkidar, Mali and Water Carrier be maintained with reference to the dates of their acquiring Secondary School Certificate (SSC), for the purpose of promotion against 30% reserved quota in posts of Junior Clerk. In order to avoid any further doubt on account of the expression "dates of acquiring SSC", it would be in the fitness of things to provide that the said expression refers to two different cases. In one case, it refers to those persons who are



appointed in one batch and among them, one who acquired SSC prior in time will stand senior in common seniority list to the other who acquired SSC later in time. In the second case, it will refer to those persons who at the time of appointment did not possess such qualification and acquired it during service. In this case, the person who acquired the SSC prior in time will stand senior to the other in common seniority list irrespective of their seniority in terms of date of appointment.

2. A Class-IV employee having got promotion as Daftar, will not be stripped off his right accrued to him on the basis of common seniority maintained for promotion to the post of Junior Clerk. So, he will carry his original seniority with him at the time of promotion to the post of Daftari for the purpose of promotion to the post of Junior Clerk.



amongst Class-IV employees of the Board of Intermediate & Secondary Education, Mardan, promoted private respondents, out of 33% quota reserved for promotion to Junior Clerk, out of Class-IV employees.

03. The contention of petitioners, as agitated by them in the present petition, is that private respondents were junior to them and were illegally promoted thereby meted out petitioners with discrimination which is against the Constitution.

04. We have heard learned counsel for the parties in light of law and material available on record.

05. As the Board of Intermediate & Secondary Education, Mardan had already adopted the rules, notified by the Government of Khyber Pakhtunkhwa in regard to reservation of 33% quota in promotion to Class-IV etc, therefore, it requires no further explanation and discussion on the same point, however, both the parties have asserted and denied the same through their respective pleadings.

06. In order to resolve the crucial dispute, vehemently agitated by petitioners herein the

instant Writ Petition is the question of their seniority.

07. The provincial government of Khyber Pakhtunkhwa vide its Notification No.SOR-IV(S&GAD)1-1/95(D) dated 13.03.1997 had already formulated criteria for determination of seniority for the purpose of promotion to higher pay scale which reads as: -

- "(a) 33% by promotion from amongst Daftaries, G/Operator, Qasid & Naib Qasid including others equivalent post in the Secretariat with two years service as such who have passed SSC examination.
- (b) 67% by initial recruitment.

For the purpose of promotion there shall be maintained a common seniority list of Daftaries, G/Operator, Qasid & Naib Qasid etc with reference to the dates of their acquiring Secondary School Certificate provided that.

- i. If two are more officials have acquired the SSC in the same session, the official having longer services shall rank senior to other officials.
- ii. Where a senior official does not possess requisite experience at the time of filling up vacancy, the official next junior to him possessing the requisite experience shall be promoted in preference of the senior official(s)".

08. As very much clear from the record, available with us, placed by both the parties that private respondents had acquired their S.S.C. qualification much prior to petitioners and as per

seniority formula, issued by the Government of Khyber Pakhtunkhwa, adopted by the Board of Intermediate & Secondary Education, Mardan, private respondents were placed senior to petitioners irrespective of their length of service.
