Appeal under Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974, against decision of the Provincial Selection Board for not considering the Petitioner for Promotion to the Post of Principal BPS-19 on the ground of being retired from service and against not taking action upon the departmental appeal of the appellant.

Prayer in Appeal: -

On acceptance of this appeal the respondents may please be directed to consider the appellant for proforma promotion to the post of Principal BPS-19 from the date when the posts were available with all back/consequential benefits.



Respectfully Submitted:

- 1. That the appellant was initialed appointed as SET BPS-14 in the Education Department.
- 2. That while serving in the said capacity the appellant applied for the post of Head Master BPS-17 through Public Service Commission, the appellant was selected and accordingly was appointed vide notification dated 21.4.1993. (Copy of notification dated 21.4.1993 is attached as annexure A).
- 3. That during the course of his service the appellant was promoted as Principal BPS-18 vide notification dated 9.02.2004. (Copy of notification dated 9.2.2004 is attached as annexure B).
- 4. That as per the revised final seniority list of Officers BPS-18, the name of the appellant is at S.No. 33 among the Officers BPS-18 of Elementary & Secondary Education Department Khyber Pakhtunkhwa Peshawar. (Copy of revise seniority list is attached annexure C).
- 5. That the Provincial Govt has created 400 posts of BPS-19 and were required to be filled as per the 4 tier formula besides this 48 posts were already vacant since 01.02.2012.
- 6. That the respondent department has processed the promotion cases, similarly the documents of the appellant were also prepared for including it in the working paper for promotion to BPS-19, however, the matter was un-necessarily delayed.
- 7. That the appellant submitted different representations from time to time stressing upon the respondents to convened the meeting of the PSB so as to consider his case for promotion to BPS-19 in the wake of his retirement, however, that paid no heed to it. (Copies of the representation are attached as annexure D).
- 8. That vide notification dated 11.12.2013 the appellant stood retired from service with effect from 11.12.2013 on attaining the age of superannuation. (Copy of the notification dated 11.12.2013 is attached annexure E).
- 9. That in the meantime the cases of promotion were processed and the PSB held its meeting on 7.01.2014 and considered the cases of colleagues and juniors of the appellant and accordingly vide notification dated 21.4.2014 promotion to BPS-19 of about 225 Officers were issued. (Copies of the notification dated 21.4.2014 is attached as annexure F).

- 10. That feeling aggrieved from the illegal acts and omissions of the respondents, the appellant approached the Honourable Peshawar High Court Peshawar in W.P No. 1619-P/2014, however due to lack of jurisdiction, the Honourable High Court has vide order dated 19.05.2015, while treating the Writ Petition as Service Appeal transferred it to this Honourable Tribunal hence the instant appeal. (Copies of the Memo of Writ Petition is attached as Annexure G)
- 11. That the appellant prays for the acceptance of the instant appeal inter alia on the following grounds:

GROUNDS OF SERVICE APPEAL:

- A. That the appellant has not been treated in accordance with law. The P.S.B has not followed the Law and Rules governing promotion, thus the secured and guaranteed rights of the appellant were violated.
- B. That the decision of the PSB is arbitrary, whimsical and not on accepted norms / rules, the respondents were under legal obligation to have promoted the appellant, but despite the eligibility and fitness of the appellant he was not considered on account of his retirement.
- C. That the mandatory provisions of Section 9 of NWFP Civil Servant Act, 1973 read with NWFP Civil Servant (Appointment, Promotions and Transfer) Rules, 1989 and enabling instructions contained in the ESTA Code have not been adhered to by the respondents as there were vacant posts available, however, due to the slackness of the respondents the necessary process was not completed during the service of the appellant and thus he has been deprived of his legal and due rights.
- D. That as per the seniority list as it stood on 27.5.2013, the name of the appellant was within the promotion zone, similarly his case was duly processed for promotion, his name was included in the working paper albeit was not considered for the reason of his retirement from service in the meantime, such being the case the treatment meted out to him as illegal and unlawful.
- E. That since the appellant was fit, eligible for promotion to the post of Principal BPS-19 during service, however due to the slackness/ inaction of the respondents no promotion process was carried out, hence on his retirement his right subsists and



is entitled to proforma promotion, so as to have its financial benefits in the shape of pension etc.

F. That the Appellant seek the permission of this Honourable Court to rely on additional grounds at the hearing of this appeal.

It is, therefore, humbly prayed that on acceptance of this appeal the respondents may please be directed to consider the appellant for proforma promotion to the post of Principal BPS-19 from the date when the posts were available with <u>all back/consequential benefits.</u>



JUDGMENT

AHMAD HASSAN, MEMBER:- Arguments of the learned counsel for the parties heard and record perused.

ARGUMENTS

Appellant personally argued his case and stated that he initially joined the Education Department as SET (BPS-14). On the recommendations of Khyber Pakhtunkhwa Public Service Commission, he was selected for the post of Head Master (BPS-17) vide notification dated 21.04.1993 and got promoted to Principal (BPS-18) through notification dated 09.02.2004. That in the final seniority list of officers of BPS-18, his name was placed at serial no. 33. The Provincial Government created 400 posts of (BPS-19) under four tier formula, in addition to 49 posts already lying vacant since 01.02.2012. The respondents processed








promotion case of eligible officers including the appellant. Furthermore, his name was included in the working paper prepared for promotion. However, it was unnecessarily delayed for reasons best known to the respondents. The appellant made repeated applications to consider his promotion case but to no avail. Finally, vide notification dated 11.12.2013, he stood retired from service w.e.f. the said date. After his retirement promotion case of eligible officers was considered by the PSB in its meeting held on 07.01.2014 and cases of colleagues/juniors of the appellant were recommended for promotion. Promotion of 225 officers was notified vide notification dated 21.04.2014 including one Saleem Khan, who stood retired from government service on 01.01.2014. He further prayed that the appellant was entitled for notional promotion from the date his colleagues/juniors got promoted to BPS-

Government service on 11.12.2013, therefore, according to Section-9 of Khyber Pakhtunkhwa Civil Servants Act 1973, he was not entitled for promotion after retirement. Allegations of unnecessary delay on the part of respondents leveled by the appellant were unfounded and baseless. All codal formalities were observed by the respondents, while processing his case.

CONCLUSION

The plea taken by the appellant that his name was reflected at serial no. 33 of the seniority list of BPS-18 officer of the respondent-department has been conceded by the respondents. Similarly in para-5 of the appeal, he asserted that 400 newly created posts of BPS-19 created under four tier formula were required to be filled, alongwith 48 posts already laying vacant. However, respondents failed to rebut the

stance of the appellant in their para-wise comments. A copy of working paper prepared for promotion to the post of BPS-19 forwarded by the Director Elementary and Secondary Education vide letter dated 20.02.2012 was placed on record, which indicated that name of the appellant was reflected on serial no. 24 and as per remarks he was eligible for promotion. It is an undeniable proof that promotion case was deliberately delayed by the respondents for one reason or the other. Officers promoted to BPS-19 vide notification dated 21.04.2014 were either colleagues or juniors of the appellant. It clearly stipulated that he had a bonafide claim for promotion to BPS-19 alongwith aforementioned officers. Case of the appellant for promotion to BPS-19 on notional basis has every merit to be considered by the PSB without further loss of time.

5. As a sequel to the above, the instant appeal is accepted and the respondents are directed to consider the case of the appellant for promotion to BPS-19 on notional basis from the date his junior colleagues were promoted. Parties are left to bear their own costs. File be consigned to the record room.

The Chairman of the Committee invited the representatives of E&SE Department Mr. abdul Akram, DS alongwith Mr. Fazal e Subhan, SO (Lit-II) to apprise the Committee about the eckground of the case which they did accordingly and stated that the appellant filed the subject wrice appeal with the prayer that the appellant was entitled for notional promotion from the rate his colleagues/juniors got promoted to BPS-19. The Khyber Pakhtunkhwa Service Tribunal accepted the appeal and directed the respondent to consider the case of the appellant for promotion to BPS-19 on notional pasis from the date his colleagues/juniors were promoted vide order dated 08.08.2019. Now, the Department intended to file CPLA against the judgment on the following grounds:

GROUNDS/DISCUSSIONS:

The grounds as proffered by the representative of the Department were that the Court is ignored the record and material facts placed before it. He further added that the appellant was not entitled for promotion after retirement. The Scrutiny Committee asked the Departmental Representative that on what grounds the Department intends to file CPLA in the Apex Court of Pakistan upon which the Departmental Representative could not forward any plausible grounds for filing of CPLA in the Apex Court of Pakistan. The Scrutiny Committee noticed that the Department had lack of evidence for filing CPLA in the Apex Court of Pakistan.

DECISION:

hence in view of above it was decided with consensus by the Scrutiny Committee that the subject case was not a fit case for filing of Appeal/CPLA in the Supreme Court of Pakistan due to tack of evidence as the Department had no evidence for filing of CPLA in the Apex Court of Pakistan.
