**SERVICE APPEAL UNDER SECTION-4 OF KPK SERVICE TRIBUNAL ACT 1974 AGAINST ORDER DATED 29-06-2021 OF ASSTT. DIRECTOR LOCAL GOVT & RURAL DEVELOPMENT DEPARTMENT HARIPUR WHEREBY APPELLANT'S APPLICATION FOR REJOINING PARENT DEPARTMENT HAS BEEN REJECTED AND APPELLANT'S APPEAL DATED 11-08-2021 HAS NOT BEEN REPLIED BY DIRECTOR GENERAL LG & RURAL DEVELOPMENT DEPTT. KPK PESHAWAR.**

**PRAYER: ON ACCEPTANCE OF INSTANT SERVICE APPEAL IMPUGNED ORDER DATED 29-06-2021 OF ASSISTANT DIRECTOR LG&RDD HARIPUR MAY GRACIOUSLY BE SET ASIDE AND RESPONDENTS BE DIRECTED TO ALLOW APPELLANT TO RE-JOIN HIS PARENT DEPARTMENT LOCAL GOVT AND RURAL DEVELOPMENT DEPARTMENT HARIPUR AS SECRETARY VILLAGE COUNCIL KOTNAJIBULLAH HARIPUR WITH GRANT OF ALL CONSEQUENTIAL SERVICE BACK BENEFITS.**

Respectfully Sheweth:

1. That appellant was appointed as Village Secretary vide Assistant Director Local Government and Rural Development Department Office Haripur order dated 21-09-2015. (**Copy of order dated 21-09-2015 is appended as Annexure-"A"**).

2. That during employment appellant applied for the post of Primary School Teacher in Education Department KPK through proper channel and he was selected and appointed as PST on contract basis vide order dated 18-12-2018. **(Copies of departmental permission certificate dated 24-09-2018 and appointment order of Education Department dated 18-12-2018 are attached Annexure-"B & C")**.
3. That before relieving from LG&RDD Haripur the appellant submitted application dated 24-12-2018 for retention of lien in his parent department. **(Copy of the application dated 24-12-2018 is attached as Annexure-"D")**.
4. That appellant was properly relieved from the LG&RDD Haripur vide Assistant Director LG&RDD Haripur letter dated 31-12-2018 alongwith Service Book. **(Copies of letter dated 31-12-2018 and pages of service are attached as Annexure-"E & F")**.
5. That appellant on 02-12-2020 being not satisfied with services in the Education Department applied to the Assistant Director LC &RDD Haripur for rejoining his parent Department as Village Secretary against his post but of no avail. **(Copy of application dated 02-12-2020 with order on it is attached as Annex-"G")**.
6. That thereafter on 22-03-2021 the appellant again submitted an application to the Assistant Director LG&RDD Haripur for rejoining his parent department but all in vain because on the bottom of the application the

remarks given are reproduced as "Mr. Bilal Ahmed Ex. Jr. Secretary have not getting the lien from Competent Authority at the time of relived order vide this office order No.AD(LG-H)1-55/VCS/NCS/2018/41-44 dated 31-12-2018. Report is submitted for further n/action pl".

**(Copy of application dated 22-03-2021 is attached as Annex-"H").**

7. That aggrieved of the order the appellant submitted an application dated 11-08-2021 to the Director General, LG&RDD KPK Peshawar and also preferred an appeal dated 09-0-2021 to the Secretary LG&RDDKPK Peshawar through registered cover for his rejoining as Village Secretary Kotnajibullah Haripur but no response was received like previous ones. **(Copy of the application dated 11-08-2021 and Appeal dated 09-08-2021 are attached as Annexure-"I &J").**
8. That appellant has rendered about 07 years service. He always performed his assigned duties with the entire satisfaction of his superiors. He has meritorious service record at his credit.
9. That appellant incessantly been moving to the Offices of the AD LG&RDD Haripur, Secretary, LC&RDD KPK at Peshawar as well as Director General LG&RDD KKP Peshawar for the copy of her appellate order, if appeal has been decided, but he is not provided the same on one or the other pretext. Appellant has been made a rolling stone by his parent Department despite rendering her 07 years service. He has been deprived of his legitimate right of re-joining his parent department and that too for no fault on his part. Neither appellant is being

allowed to re-join his parent department nor are his requests and appeal responded. This is a case of hardship in eyes of law and needs sympathetic consideration.

10. Hence instant service appeal, inter alia, on the following:

**GROUND:**

- a) That orders dated 29-06-2021 of respondent is illegal, unlawful, against the departmental rules & regulation, issued in a cursory and whimsical manner which is liable to be set aside.
- b) That no response to the applications and departmental appeal has been given to the appellant despite his running from pillar to post. Response to his requests is legitimate right of the appellant.
- c) That appellate authority has also failed to abide by law, rules & regulations and even did not take into consideration the grounds of appeal agitated by appellant in his memo of departmental appeal. Article 4 and 10-A of the Constitution of Islamic Republic of Pakistan 1973 has been violated.
- d) That as per law the appellant has the legitimate right to re-join his parent department but he has illegally been denied from his legal right.
- e) That instant service appeal is well within time and this honorable Service Tribunal has got every jurisdiction to

entertain & adjudicate upon the lis.

**PRAYER:**

It is, therefore, humbly prayed that on acceptance of instant Service appeal order/remarks dated 29-06-2021 of Assistant Director LG&RDD Haripur may graciously be set aside and respondents be directed to allow the appellant to re-join his parent department as Secretary Village Council Kotnajibullah District Haripur with grant of all consequential service back benefits. Any other relief which this Honorable Tribunal deems fit and proper in circumstances of the case may also be granted.
