





SERVICE APPEAL UNDER SECTION-4 OF KPK SERVICE TRIBUNAL ACT 1974 AGAINST THE ORDER DATED 15-12-2021 OF SENIOR MEMBER/SECRETARY, BOARD OF REVENUE, GOVERNMENT OF KPK PESHAWAR CONVEYED TO APPELLANT THROUGH LETTER DATED 22-12-2021 OF THE ASSTT TO COMMISSIONER HAZARA DIVISION ABBOTTABAD WHEREBY THE APPELLANT'S REPRESENTATION/APEAL FOR POSTING AS TEHSILDAR HAS BEEN FILED ILLEGALLY, CONTRARY TO RULES & REGULATIONS IN A WHIMSICAL AND ARBITRARY MANNER.

PRAYER: ON ACCEPTANCE OF INSTANT SERVICE APPEAL IMPUGNED ORDER DATED 15-12-2021 OF THE RESPONDENT MAY GRACIOUSLY BE SET ASIDE AND APPELLANT BE POSTED AS TEHSILDAR ON CURRENT CHARGE BASIS/IN OWN PAY SCALE .

Respectfully sheweth,

1. That appellant was appointed as Assistant (BPS-16) in the Revenue Department in the year 2009 and since then serving in the office of Commissioner Hazard Division Abbottabad and has rendered about 13 years service. Appellant is M.Sc Clinical Psychology. She always performed his duties with devotion, dedication and honesty without any complaint. Appellant was

appointed solely on securing top position in merit. Appellant has meritorious service record at her credit.

2. That during her long service stretched over 13 years; the appellant has gained ample experience in the field of Revenue work, Acquisition work, Revenue and General Establishment/ Administration and has successfully fulfilled other key responsibilities of Office. Appellant's sincerity with her work and professionalism is evident from her ACRs & service record.
3. That since her appointment in 2009, the appellant has been waiting for further promotion in the same cadre. However, the main factors for waiting promotion since long are low promotion strategies, insufficient quota, non-availability of in-service examinations etc.
4. That presently there are 137 posts of Tehsildars at Provincial level among them 38 are those promoted/posted as PMS Officers. Still there are so many posts of Tehsildars lying vacant due to non-availability of regular Tehsildars. Similarly about 12 posts of Tehsildars are lying vacant in Hazara Division. Due to the reason mostly vacant posts of Tehsildars have been filled by posting of Assistants from ministerial staff and Naib Tehsildar on Current Charge Basis/Own Pay Scale basis as stop-gap-arrangement. Such posting orders of Board of Revenue bearing No.Estt/Posting/Transfer/2021/19313-21 dated 06-08-2021, Estt/ Posting/Transfer/2021/2638795 dated 05-10-2021 and Estt/Posting/Transfer/2021/18509-30 dated 12-08-2015 are worth perusal. **(Copies of orders are attached as-"A, B & C").**

5. That as per prevailing rules Assistant BPS-16 is promoted as Tehsildar (BPS-16). For the purpose Seniority List of Assistants BPS-16 is maintained on provincial level by the Board of Revenue wherein the appellant stands among the senior Assistants BPS-16. There are only 4 female Assistants BPS-16 in the KPK wherein appellant is the senior most one. **(Copy of Seniority List of Assistant BPS-16 as it stood on 31-12-2020 is as Annex-"D")**.
6. That appellant made a departmental appeal/representation dated 15-10-2021 to the Senior Member Board of Revenue KPK Peshawar for her posting as Tehsildar BPS-16 on CCB/OPS basis which was forwarded to the concerned authority through the Asstt to Commissioner (Rev/GA) Hazara Division Abbottabad letter dated 18-10-2021 with recommendation of her eligibility and capability for the said post. **(Copies of Appeal and covering letter dated 18-10-2021 are attached as Annex-"E & F")**.
7. That appellant's above appeal/representation has been filed by appellate authority without giving any consideration vide order dated 15-12-2021 which has been communicated to the appellant by the Asstt to Commissioner (Rev/GA) Hazara Division Abbottabad through letter dated 22-12-2021. **(Copies of both the letter dated 15-12-2021 and 22-12-2021 are attached as Annex "G & H")**.
8. That the Chief Secretary, Govt of Khyber Paktunkhwa vide Notification No. SO(E-1)E&AD/1-1/2017 dated 30-10-2017 has empowered the Divisional Commissioners

in KPK for posting/transfer of Tehsildars within their respective Divisional jurisdiction and in this scenario the Commissioner Peshawar Division Peshawar has passed office order No.6/7/EA/2021/1 dated 04-11-2021. **(Copies of Notification dated 30-10-2017 and order dated 04-11-2021 are attached as Annex "I & J").**

9. That the appellant also deserves to be posted as Tehsildar BPS-16 on the basis of OPS/CCB as she has gained ample experience of Revenue, Acquisition work and revenue & general Establishment/Administration as has been recommended by Asstt to Commissioner (Rev/GA) Hazara Division Abbottabad.
10. Hence instant service appeal, inter alia, on the following amongst others:-

GROUND:

- a) That impugned order dated 15-12-2021 of respondent is illegal, unlawful against the facts and circumstances of the matter hence are liable to be set aside.
- b) That appellant on the basis of channel of promotion deserves to be granted chance of posting as Tehsildar BPS-16 in Own Pay Scale/Current Charge Basis.
- c) That appellant's other colleagues Assistant (BPS-16) have also been given posted as Tehsildar on OPS/CCB thus she also deserves to the same treatment of posting as Tehsildar BPS-16 in OPS/CCB.

- d) That appellant has rendered about 13 years service as Assistant PS-16 and has been waiting her promotion as Tehsildar BPS-16 thus deserves to the given chance of posting as Tehsildar in OPS/CCB.
- e) That appellant's high-ups have recommended her eligibility and capability for her posting/transfer as Tehsildar BPS-16 on Current Charge/Own Pay Scale basis.
- f) That appellant has gained sufficient experience in all the branches of Revenue, Acquisition, General Establishment and Administration.
- g) That instant appeal is well within time and this honorable Service Tribunal has got every jurisdiction to entertain and adjudicate upon the lis.

PRAYER:

It is, therefore, humbly prayed that on acceptance of instant Service Appeal order dated 15-12-2021 of the appellate authority/respondent No.1 may graciously be set aside and the appellant be given a chance of posting/transfer as Thsildar BPS-16 in her Own Pay Scale/Current Charge basis. Any other relief which this Honorable Tribunal may deem fit in circumstances of the instant case may also be granted.


Respectfully Sheweth:
