- 1. That the Appellant is a resident of District Abbottabad and was appointed as "Beldar" BS-1 in the respondents department and joined services on 16/11/2011. (Copy of the appointment letter and joining certificate are attached and marked as annexure "A"&"B" respectively).
- 2. That respondents suddenly stopped the salary of the appellant, as the appellant was on duty.
- 3. That appellant visited the office of the respondents on 15/12/2021 to inquire about his salary which was stopped by the department without mentioning any reasons.
- 4. That the respondents, on the inquiry of the appellant disclosed the fact that he is terminated from the services on 06/09/2021. (Copy of the termination order is attached and marked as Annexure"C").
- 5. That the respondent No 3 Without hearing appellant terminated the appellant from the service.
- 6. That the appellant soon after getting the knowledge of the same, feeling aggrieved filed departmental representation/ appeal on 15/12/2021 before the respondent No.2.(Copy of the departmental appeal is attached and marked as annexure "D")
- 7. That the appellant filed another application on 05/04/2022 to remind the respondent No.2 to make appropriate order

on the departmental representation dated 15/12/2021, who returned the same and told the appellant verbally that departmental representation had already been rejected on 24/02/2022. (Copy of the application is attached and marked as Annexure"E")

- 8. That after getting the knowledge rejection of departmental representation, the appellant requested the respondents to provide the rejection order but copy of the order was not provided and appellant was told to approach the respondent No.3 at Abbottabad, after much efforts the appellant obtained copy of the rejection order on 18/04/2022 (Copy of the rejection of departmental appeal is attached and marked as Annexure"F")
- 9. That feeling aggrieved from the Order Dated 06/09/2021 the appellant approaches this Honorable Tribunal for redressal of his grievances on the following amongst other grounds.

GROUNDS

- a. That impugned order against the law and facts hence liable to be set-aside.
- b. That the Impugned order dated 06/09/2021 is illegal, void ab-initio having no legal effects is liable to be set aside.
- c. That charge against the appellant is baseless having no footings and appellant is terminated from services without



conducting the regular inquiry hence impugned order is liable to be set aside.

- d. That there no evidence against the appellant which amounts to the major penalty.
- e. That the Respondent No.3 has not advanced any reasons while issuing the impugned order.
- f. That no opportunity of hearing has been given to the appellant by the respondent No.3, which is against the law and justice.
- g. That under the law, no major penalty can be imposed upon the appellant or any other employee without adopting the proper procedure under the law.
- h. That the impugned order suffers from the principle of natural justice as the same was passed at the back of the appellant without providing any opportunity of being heard to appellant.
- i. That the respondent suddenly stopped the salary of the without any reasons.
- j. That the appellant served in the respondents department for about 10 years with unblemished service record and the same has not taken into consideration while awarding major penalty.
- k. That impugned order is absolutely wrong illegal, void abanitio hence not maintainable and liable to be struck down.
