
The appellant solicit on the following factual and legal  
grounds;-

1. That the appellant was appointed in Police  
Department as Constable BPS-2 on 23/12/1985  
vide order No. 546, dated 24/12/1985.
2. That later on, the appellant applied for appointed  
for the post of Drawing Master (DM) BPS-9  
through Proper Channel and was appointed as  
untrained Drawing Master (BPS-9) alongwith

others vide order No. 23 (DM) Male, dated 09/05/1992. Copy of appointed order dated 09/05/1992 is annexed as Annexure "A".

3. That after appointed as Drawing Master BPS-9 the appellant took over the charge of his post on 23/05/1992. Copy of certificate of Transfer of Charge is annexed as Annexure "B".
4. That the appellant was adjusted against the vacant post of DM at Govt. High School Nareela Abbottabad vide order dated 18/08/1994. Copy of order dated 18/08/1994 is annexed as Annexure "C".
5. That the appellant passed professional qualification exam on 09/01/1995. Copy of certificate is annexed as Annexure "D".
6. That the respondents-department has prepared the seniority list of DM for promotion to the post of SST but the name of the appellant was wrongly placed at serial No. 68 and the person who was appointed alongwith the petitioner and juniors are

promoted as S.S.T. Copy of seniority list is annexed as Annexure "E".

7. That the respondent department placed the appellant at serial No. 68 of the said seniority list and promoted the most junior Drawing Master from the appellant to the post of SST. Moreover the appellant is senior from all the promotees in age.
8. That on 29/10/2019 the appellant submitted an application before respondent No. 3 for his promotion from the post of SDM to SST and to include his name in the seniority list for promotion but the respondent No. 3 refused to promote the appellant. Copy of application is annexed as Annexure "F".
9. That the appellant again preferred departmental appeal for his promotion for the post of SST vide Daily Dairy No. 9233 dated 04/11/2019. Copy of departmental appeal is annexed as Annexure "G".
10. That the respondent No. 3 rejected the department appeal of the appellant vide order No. 12821 dated



12/12/2019. Copy of order dated 12/12/2019 is annexed as Annexure "H".

11. That thereafter, the appellant preferred an appeal before the respondent No. 2 against the rejection order of respondent No. 3. Copy of appeal is annexed as Annexure "I".
12. That the appellant filed Service Appeal No. 5781/2020 before this Honourable Tribunal, which is dismissed vide order dated 30/12/2021 with the direction that *"However, the appellant would be at liberty to file a fresh appeal for correct of his seniority, if he has got the case that his seniority was wrongly fixed"*. Copies of service appeal and order dated 30/12/2021 is annexed as Annexure "J" & "K".
13. That feeling aggrieved from the illegal and unlawful acts of the respondents and being deprived from his legal and legitimate right, the appellant seeks indulgence of this Honourable Tribunal, inter-alia, on the following grounds; -

GROUNDS:-

- a. That the impugned act of the respondents- department by not promoting the appellant for the post of SST on the basis of initial appointment is illegal, unlawful, against the law and policy on the subject, hence, not maintainable in the eye of law and is liable to be struck down.
- b. That, the impugned act of respondents by not promoting the appellant as SST is a worst example of discrimination and misuse of powers/ authority.
- c. That the act of the respondents is discriminatory and against the law/ policy on the subject. It is further submitted that the appellant was initially appointed as untrained Drawing Master on 09/05/1992 and has passed the professional qualification exam on 09/05/1995. The respondents- department placed the appellant in the seniority list on the basis of passing of his professional qualification exam instead of

his initial date of recruitment. The impugned act of the respondents is against the norms of justice, equity and fair play and is liable to be set-aside.

- d. That impugned act of the respondents by not promoting the appellant from the date of his initial appointment is also against the dictums laid down by the superior court of country that seniority of civil servants was reckoned from the date of initial appointment not from the date of confirmation or regularization. Thus, the impugned act of the respondents is liable to set-aside.
- e. That the respondents are bound to act according to law. It is universally accepted principle of law that when law prescribe something to be done in a particular manner that must be done in same manner and not otherwise. A proper procedure has been prescribed in the law on the subject which has been violated by respondents.

- f. That the respondents -department has promoted the junior to the appellant to the post of SST while the appellant was illegally deprived from his right of promotion by dropping his seniority position.
- g. That at the time of promotion of other SDM to the post of SST the respondents-department ignored all basic principle and requirement of promotion.
- h. That the respondents have not treated the petitioners in accordance with law, rules and policy on the subject and acted in violation of Article-4 and 25 the Constitution of Islamic Republic of Pakistan 1973 and unlawfully refused to promote the appellant which is unjust, unfair, illegal, hence not sustainable in the eyes of law.
- i. That it is inalienable right of every citizen to be treated in accordance with law which envisages that the appellant is entitled to be promoted against the said post.

- j. That the other points shall be urged at the time of arguments.

It is, therefore, humbly prayed that, on acceptance of instant appeal, the impugned act of respondents by not promoting the appellant as SST from the date of his initial appointment/ recruitment may graciously be declared as null and void and the respondents be directed to promote the appellant as SST according to the law, rules and policy on the subject. Any other relief which this Honourable Court deems fit and proper in the circumstances of the case may please be given to the appellant.

According to prayer set up in appeal, the appellant has impugned the promotion notification to the extent of private respondents and sought to declare the same against the spirit of law and its setting aside with further prayer for his promotion as SST (General) w.e.f. 14.02.2020 with all back benefits. In view of the nature of the prayer as set up in Memorandum of Appeal read with the facts and grounds given in it and from the annexures, the prayer of the appellant is misconceived. Actually, the private respondents namely Hukam Dad and Ijaz Ahmad were promoted vide impugned notification on the basis of their seniority reflected in the list annexed with the appeal as it stood on 31.12.2012 wherein they respectively figure out at Serial No. 56 & 57 while the appellant figures out at Serial No. 58. The private respondents have been promoted in their own right on the basis of existing seniority list, which is liable to correction under due course, if appellant is advised to challenge the same under due course of law; but as far as promotion of private respondents is concerned, he has got no locus-standi to challenge the same. Therefore, the appeal of the appellant in its present form is not competent. Thus, it is not fit for regular hearing. However, the appellant would be at liberty to file a fresh appeal for correction of his seniority, if he has got the case that his seniority was wrongly fixed. With the given observations, this appeal is dismissed in limine with liberty to the appellant to file fresh appeal in proper form subject to all legal formalities. File be consigned to the record room.
