In term of normal procedure, the Service Appeal seems to be time-barred but in view of particular legal position to be discussed herein-after, the bar of limitation for the time-being is immaterial. In wake of COVID, 19, the Government of Khyber Pakhtunkhwa for the first time declared Public Health Emergency in March, 2020 for three months which was extended from time to time for further term and presently it has been extended by the Government vide Notification No. SOG/HD/1-102/Covid 19/2020/3062, dated 30.06.2021 for the period from 01.07.2021 to 30.09.2021. The case of the appellant falls within the period of emergency. In view of Section 30 of the Khyber Pakhtunkhwa Epidemic Control and Emergency Relief Act, 2020, the limitation period provided under any law shall remain frozen. This appeal having been filed after promulgation of the said Act, is not affected by bar of limitation. Excluding the case of appellant from rigors of limitation, his appeal is fit for full hearing. Keeping the question of limitation relating to filing of instant appeal intact for determination during full hearing, this appeal, subject to all just and legal objections including objection of limitation is admitted for regular hearing. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments in office within 10 days after receipt of notices, positively. If the written reply/comments are not submitted within the stipulated time, or extension of time is not sought through written application with sufficient cause, the office shall submit the file with a report of non-compliance. Following are the relevant facts leading to the instant appeal are as under: -

That, the appellant was appointed as CT teacher in education department of Mansehra on 21.01.1986 and during service appellant acquired further education and associated in different courses of education and was promoted to the status of SST, BPS-16 and by move over he was serving in BPS-17.

That, before the year 2015 Provincial Government had announced a policy promoting education for and providing facilities to Government school and for this purpose, parents Teacher Council (PTC) was and constituted and in the form of by laws module No.1 and 2 were made circulated and and financial arrangement and management of the council was also introduced in module No.2. In these modules, teacher of the school was appointed as Secretary and Chairman of the Council was selected to perform the financial management of the council.

(Copies of the modules No.1 and 2 are annexed as annexure "A").

That, on 12.08.2015 when appellant was already transferred to Government High Secondary School Jalgali of District Mansehra and he was made Secretary of PTC in that respect order was issued by the D.E.O (Male) Mansehra 12.08.2015.

That, already PTC account was opened in the National Bank of Pakistan Shinkiari Branch of District Mansehra and in that account amount was lying, required to be handled with joint signature of Chairman and Secretary for encashment and investing the same in the projects approved by the PTC. The amount of Rs.8,00,000/-approximately was encashed from the bank in the year 2015-16 and cheque was signed by both the appellant and respondent No.6 as Secretary and Chairman of the Council and cheque was encashed. The project including construction of four walls of the school building, water supply scheme and sports already approved were by the council. For this purpose material was purchased by both the Secretary, Chairman and material was dumped near school building.

That, due to dispute of Chairman and members of the council who were local persons construction work could not be done.

That, illegally inquired was initiated by the D.E.O Mansehra under civil servants efficiency and discipline rules, 2011 and only show cause notice dated 11.06.2016 was issued to appellant and written reply of the same was made by the appellant on 20.06.2016.

That, appellant being Secretary to PTC in respect of financial matters of PTC was not actionable under Civil Servants Rules, rather on the basis of bye lays module No.2 third party was required to be constituted to probe into embezzlement of the PTC funds and order dated 02.07.2016 issued by D.E.O Mansehra on the basis of enquiry report for refund of conditional grant of Rs.9,63,600/-.

(Copy of the order is attached as annexure "E").

That, above stated order dated 02.07.2016 for refund of conditional grant issued to appellant was illegal and malafide so appellant filed Writ Petition No.698-A of 2016 before the Peshawar High Court, Bench which is still pending in which notices were issued to respondents who have made their appearance.

That, thereafter appellant was transferred to Government Middle School Nanoha in the year 2018 and after filing Writ Petition stated above which is pending since 2016 the impugned order dated 22.09.2020 delivered to the appellant on 08.10.2020 whereby an amount of Rs.7,17,950/- was ordered to be recovered from the appellant on account of misappropriation in PTC funds and appellant was also compulsory retired.

That, impugned order is malafide unlawful. In and the modules financial management has been provided and in such situation third party would made audit of the expenditure done by the PTC. In the alleged embezzlement amount no such audit or enquiry by the third party has been made and disciplinaries actions under civil servants laws against the appellant is without jurisdiction and unlawful.

- That, the appellant being Secretary of PTC is not actionable under Civil Servants Laws and rules because acts of PTC do not fall under the ambit of Civil Service Laws.
- That, two enquiries were initiated and two orders were issued against the appellant over the one and same allegation and such action is not legal in the eyes of law.





That account of PTC was opened in NBP Shinkari branch Mansehra in which was transfer by the Government and the amount in the account was drawn with Joint signature of Chairman and Secretary for the purpose of investing the amount in Projects approved by the PTC. And the above stated amounts was drawn in fiscal Year 2015 and 2016 with Joint Signature of appellant as secretary and local Person as Chairman and for the purpose of Construction for the Project material was also Purchased by Secretary and Chairman Jointly and material was dumped near the School building.

6. That due to dispute of Chairman and member of the Council who are local persons construction work could not by progressed and enquiry was illegally initiated against the appellant by the concerned District Education Officer and show cause notice was issued to appellant on 11-02-2016 Under Civil servants efficiency and Discipline rule 2011 and written reply by the appellant on 19-6-2016. (Copies of show cause notice and reply to show cause notice are attached).

- 7. That on 02-06-2016 DEO (M) Mansehra on the basis of enquiry issued to a letter to appellant for refund of Conditional grant Rs. 9, 63, 600/2 (Copy of this order is attached)
- 8. That appellant as secretary to PTC in respect of financial matters of PTC was not actionable under civil servant rules. Rather on the basis of by Laws/module 2 third party was to be constituted to probe in to any financial matter of embezzlement So appellant filed writ Petition No 698-A of 2016. Before Peshawar High Court Abbottabad bench which is still pending. (Copy of write petition is attached)
- 9. That enquires report of DEO (M) Mansehra mentioned in the impugned order dated 22-9-2020 are not known to appellant and he was not associated in any such illegal enquiry.

GROUNDS

- A. That impugned order dated 22-09-2020 Whereby appellant has been compulsory retired from the service and illegal embezzled amount is also to be recovered is illegal, null and void and liable to be set-side.
- B. That the enquiry report dated 06-02-2020 and report of DEO Mansehra Dated 07—5-2020 are illegal. Appellant was never informed to participate in these enquires mention in the impugned order.
- C. That only enquiry in which only one show cause notice were issued to appellant and refund of conditional grant Rs=9,36,600/= was passed by DEO Mansehra was challenge in WP stated above which is still pending.
- D. That any irregulatory found in financial matters of PTC are required to be resolved through, appointment of third party as

arbitrator and Civil servant Efficiency and discipline rule do not apply and as such the impugned order from removed from service recovery of alleged emblazed amount and the alleged enquries referred there in are illegal.

E. It is therefore prayed that impugned order Dated 22-9-2020 delivered to appellant on 08-10-2-2020 may kindly be setaside declare unlawful and appellant be restored to his status as SST with all back benefits.
