**Respectfully Sheweth!**

**The brief facts leading to the instant appeal are arrayed as follows**

1. That, the appellant joined the police force and was promoted as officiating ASI on 08/08/2007. The appellant after spending two year confirmatory Service was entitled to be confirmed on 08/08/2007 but the department issued the order of confirmation of the appellant as ASI on 21/04/2012.

**(The copy of promotion and confirmation are attached as annexure A & B).**

2. That, the appellant was promoted as Sub-Inspector on 07/03/2013 who was confirmed as SI on 10/04/2015.

**(The copy of promotion and confirmation notification are attached as annexure "C & D respectively).**

3. That, the appellant was promoted to the rank of Inspector after rendering

satisfactory service in year 2016 and was confirmed as Inspector in year 2018.

4. That, the ASI's of Malakand Range were not granted their due seniority, who submitted an Appeal and a committee was constituted by IGP to look into their grievances. the Committee unanimously gave their recommendations. The Minutes of the meeting regarding Seniority Case of ASI and promotee ASI's were sent to Malakand Range. In the light of minutes of the meeting of the Committee DIG Malakand Rang passed an order whereby the ASI's were given their due seniority and confirmation.

***(The Copies of Committee Report, Letter of IGP No.16399-40/E-II dated Peshawar 11/07/2013 and the seniority list of Malakand rang is attached as annexure "E", "F" and "G" Respectively).***

5. That, the appellant submitted an appeal before DIG Hazara Rang Abbottabad requesting therein that he was promoted as ASI on 08/08/2007 and entitled to be confirmed on 08/08/2007 but was confirmed vide order dated 21/04/2012 w.e.f 08/08/2009.

*(The Copy of appeal is attached as annexure "H").*

6. That, the appellant seeks his confirmation as ASI from 08/08/2007 on the following amongst other grounds.

### GROUNDS

- a. That, the appellant while promoted to the rank of ASI was entitled to confirmation as ASI on 08/08/2007 but instead an order of confirmation was passed on 21/04/2012.
- b. That, according to police rule 12-2(3) it has been very candidly laid down in the above noted section that in case of

upper subordinates seniority will be reckoned from the date of first appointment. In view of this mandatory provision the appellant was entitled to be confirmed on 08/08/2007 instead of 08/08/2009. Had the appellant been confirmed as ASI on 08/08/2007, the appellant would have been promoted to the higher ranks much earlier than the promotion awarded to him.

c. That, on account of non-confirmation from 08/08/2007, the seniority of the appellant has also been disturbed. The appellant is entitled to seniority in accordance with the date of confirmation as ASI i.e 08/08/2007.

d. That, the ASI's of Malakand Rang who were aggrieved had approached IGP for redressal of their grievances and the said issue was trashed in a committee and in the light of minutes of the committee their grievances were settled

and DIG malakand rang passed an order whereby they were granted there due seniority and other benefits.

- e. That, the appellant case is at par with the cases of ASI's of Malakand rang and property demands that the appellant should also be awarded/granted the same benefits of confirmation/seniority.
- f. That, in case of appellant, there is a potential and ostensible discrimination which requires the indulgence of this Honourable Tribunal.

It is therefore most humbly prayed and requested that on acceptance of appeal directions may kindly be given to Respondent No.1 and 2 to confirmed the appellant from 08/08/2007 and also grant him seniority in accordance

08/08/2007.



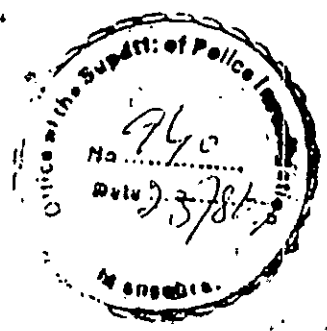

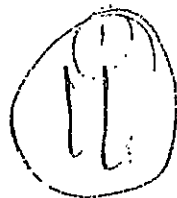
